- Monitors college program outcomes and effectiveness
- Co-administers federal Carl Perkins Career and Technical Education programs with the Department of Education
- Administers General Education (GED) testing program

 Manages state support for community college capital construction projects

- Distributes revenues from general obligation and lottery-backed bonds
- Monitors project progress and use of state funds
- Pays debt service on state bonds




• OYCC provides employment and training opportunities to at-risk youth in conservation and natural resource programs


