#### **SUMMARY**

Creates crime of making an unauthorized arrest. Punishes by maximum of one year's imprisonment, \$6,250 fine, or both.

Creates civil cause of action for unauthorized arrest. Provides prevailing plaintiff with attorney fees and greater of \$10,000 or actual damages.

Limits arrests by private person or magistrate to felonies only. Requires specified investigators to have Department of Public Safety Standards and Training certification to be considered peace officers.

Declares emergency, effective on passage.

- 5 SECTION 1. (1) A person commits the crime of making an unau-6 thorized arrest if:
- 7 (a) The person arrests another person for a crime under state or 8 federal law; and
- 9 (b) The arrest is not authorized by the provisions of ORS 133.220 to 10 133.360.
  - (2) Making an unlawful arrest is a Class A misdemeanor.
- 12 (3) A plaintiff has a civil cause of action for a violation of this 13 section. A prevailing plaintiff in the civil action is entitled to receive:
- 14 (a) The greater of \$10,000 or actual damages; and
- 15 **(b) Reasonable attorney fees.**
