## HB 3112 House Human Services and Housing Committee April 5, 2013

Dear Chair Tomei, Vice Chair Gomberg, Vice Chair Olson, and Members of the Committee:

My name is Janet Byrd. I am the Executive Director of Neighborhood Partnerships, and am writing to you today in my role as convener of the Housing Alliance. The Housing Alliance is a coalition of organizations serving all parts of Oregon. We are concerned about the availability of safe, decent and affordable housing for all Oregon residents.

As a coalition, our advocacy is focused on behalf of Oregonians who have limited incomes, and meeting the housing needs in our communities. Today, too many individuals and families are forced to chose between paying the rent and putting food on the table.

I am here today in support of HB 3112, which would provide that property owned by political subdivisions, such as cities, that is used for affordable housing or is leased or rented to persons with lower incomes is exempt from property taxes.

Property tax exemptions and abatements are an essential tool in the toolbox for ensuring that our communities have adequate affordable housing across the continuum of needs. For affordable rental housing, they reduce the operating costs , thereby allowing rents to be set at a lower amount. For individuals on fixed incomes, any reduction in rent will help ensure residents are stable and able to afford their rent plus utilities or other expenses to meet their basic needs.

The City of Portland is requesting this extension, and we support their efforts. The City of Portland and Multnomah County have undergone an extensive process to evaluate the benefits and impacts of all tax exemption programs, and have set high standards. This bill ties the definition of affordability to statute, which offers additional assurance that the exemption is targeted towards providing housing affordable for those who need it most.

Thank you for your consideration of HB 3112, and we urge your support.

Thank you for the opportunity to testify, and for your work on behalf of Oregon communities.
