I see no hope. The death benefits you obtain from my death are my lasting gift to you and our children. ... I will do what I must. I will collect what is due me, what is owed to you and our children. I will make these people pay for what they have done to my family. I will gladly sacrifice myself for my family.

I will take from these people, what they are taking from my family. It is a simple one for one exchange. No one is willing to negotiate peacefully. Since violence will only end in two dead bodies, so be it. Some child's dad or mom will never come home again. This is my gift to you. Some one's family will suffer as much as you and our children. I only regret that I cannot kill every man woman and child.

Some one here will lose their family. Eye for eye, tooth for tooth. I am a trained murder machine.

SUMMARY

Introduces a new crime for threatening public officials in relation to their public duties.
Declares an emergency, effective on passage.

A BILL FOR AN ACT

Relating to crime; introducing a new crime of Threatening Public Officials; and declaring an emergency.

Be It Enacted by the People of the State of Oregon:

SECTION 1

Threatening public officials.

(a) A person commits the crime of threatening a public official when:

- (1) that person knowingly delivers or conveys, directly or indirectly, to a public official or member of his or her immediate family by any means a threatening communication;
- (2) it is objectively likely that the threatening communication will be followed by unlawful acts; and
- (3) the threat was conveyed because of the performance or nonperformance of some public duty, because of hostility of the person making the threat toward the status or position of the public official, or because of any other factor related to the official's public existence.

(b) For purposes of this Section:

(1) "Threatening communication" is an unequivocal communication that instills in the addressee a fear of imminent and serious personal violence from that person.

(2) "Public official" means a person who is elected to office in accordance with a statute or who is appointed to an office which is established, and the qualifications and duties of which are prescribed, by statute, to discharge a public duty for the State or any of its political subdivisions or in the case of an elective office any person who has filed the required documents for nomination or election to such office. "Public official" also includes a duly appointed assistant District Attorney, assistant Attorney General and staff of any public official, including referees and retired judges sitting on assignment.

(3) "Immediate family" means a public official's spouse or domestic partner and persons related by descending lineal consanguinity, including children, step-children, lawfully adopted children and foster children.

(4) A threatening communication includes communications from an incarcerated prisoner if that person has a pending court date or stated release date and an apparent ability to carry out that threat at any time.

(c) Threatening a public official is a Class C felony for a first offense and a Class B felony for a second or subsequent offense.
