HEALTH LICENSING AGENCY

The Health Licensing Agency is a consumer protection agency providing centralized regulatory oversight for eleven advisory boards and councils which govern twenty-one health and service directed professions. The agency regulates these professions through examination, licensing, inspection, and disciplinary programs. The boards and councils for the respective professions are responsible for establishing educational and professional scope of practice requirements.

MAJOR CHALLENGES AND DECISION POINTS

- 1. Direct Entry Midwifery Board is currently operating with a negative cash balance and is being subsidized by the other boards within OHLA. The agency requested a fee increase during the 2011 session which was reduced by the Legislature. Current fees are not sufficient to make the Board independently financed.
- 2. Risk Management charges have increased based on litigation over the 2009-11 biennium involving the Direct Entry Midwifery Board and other agency personnel issues. The agency has reached an agreement with the Department of Administrative Services, Risk Management to spread these costs over the next two biennia to mitigate the impact to the budget.
- 3. The Agency is currently operating under an interim Executive Director.
- 4. Policy package to adjust personnel; establishes two positions and reclassifies six positions. Total cost: \$355,390.
- 5. Policy package to abolish an Accounting Tech 2 position and establish an Investigator position. Inspector position will be dedicated to inspecting Body Art Facilities. Total cost: \$41,644.

- 6. Policy package reductions in the GRB for statewide PERS Taxation Policy and Other PERS adjustments totaling (\$121,648) Other Funds.
- 7. Policy package reductions in the GRB for statewide administrative savings totaling (\$73,984) Other Funds.
- 8. Proposed legislation (SB 302) would move nine different State Boards to the Oregon Health Licensing Agency.
- 9. Proposed legislation (HB 2074) would move Oregon Health Licensing Agency into Oregon Health Authority.
- 10. Proposed legislation involving Direct Entry Midwifery Board, including potential mandatory licensure.
