My name is Howard Conner. I am 72 years old, a citizen and veteran of the United States of America, and, a citizen of the wonderful state of Oregon for the last 23 years. I greatly appreciate your service for the good of all Oregonians!

My professional background includes designing and managing complex hospital departments such as Cardio-Vascular-Pulmonary, Clinical/Bio-Medical Engineering, Hazardous Materials Handling and community based Health, Safety & Disaster procedures and systems. As you know, effective Resource Management requires that ALL facts and potential consequences be honestly evaluated and decisions made irrespective of outside influences and manipulations.

Senate Bills 401 and 838 are of particular concern to me, because they both represent a Trojan Horse of factual deception and hidden agendas.
