### 22 **"ESTABLISHMENT AND INDEPENDENCE OF GOVERNING BOARDS**

"<u>SECTION 1.</u> (1) The Legislative Assembly finds that the State of
 Oregon will benefit from having public universities with governing
 boards that:

4 "(a) Provide transparency, public accountability and support for the
5 university.

6 "(b) Are close to and closely focused on the individual university.

7 "(c) Do not negatively impact public universities that do not have
8 governing boards.

9 "(d) Lead to greater access and affordability for Oregon residents
10 and do not disadvantage Oregon students relative to out-of-state stu11 dents.

"(e) Act in the best interests of both the university and the State
 of Oregon as a whole.

"(f) Promote the academic success of students in support of the
 mission of all education beyond high school as described in ORS
 351.009.

17 "(2) The Legislative Assembly also finds that:

"(a) Even with universities with governing boards, there are
 economy-of-scale benefits to having a coordinated university system.

"(b) Even with universities with governing boards, shared services
 may continue to be shared among universities.

"(c) Legal title to all real property, whether acquired before or after
the creation of a governing board, through state funding, revenue
bonds or philanthropy, shall be taken and held in the name of the
State of Oregon, acting by and through the governing board.

"(d) The Legislative Assembly has a responsibility to monitor the
 success of governing boards at fulfilling their missions, their compacts
 and the principles stated in this section.

<sup>29</sup> "<u>SECTION 2.</u> As used in sections 1 to 23 of this 2013 Act:

30 "(1) 'Governing board' means a governing board established by a

"(2) 'State bonds' means 'bonds' as defined in ORS 286A.001 that are
issued by the State Treasurer.

8 "(3) 'University with a governing board' means a public university 9 listed in section 3 of this 2013 Act that has established a governing 10 board.

"<u>SECTION 2a.</u> A university with a governing board is a governmental entity performing governmental functions and exercising governmental powers. A university with a governing board is not considered a unit of local or municipal government or a state agency, board, commission or institution for purposes of state statutes or constitutional provisions.

17 "SECTION 2b. (1) A university with a governing board is created to 18 carry out public missions and services in keeping with principles of 19 public accountability and fundamental public policy, guided by the 20 legislative findings in ORS 351.001 and 351.003 and consistent with the 21 goals and mission described in ORS 351.006 and 351.009.

<sup>22</sup> "(2) A university with a governing board is an independent public <sup>23</sup> body with statewide purposes and missions and without territorial <sup>24</sup> boundaries. A university with a governing board shall exercise and <sup>25</sup> carry out all of the powers, rights and privileges, within and outside <sup>26</sup> this state, that are expressly conferred upon the university with a <sup>27</sup> governing board, or that are implied by law or are incident to such <sup>28</sup> powers, rights and duties.

"<u>SECTION 3.</u> (1) A governing board is established for each of the
 following public universities:

1 "(a) University of Oregon;

2 "(b) Portland State University; and

"(c) Oregon State University, if the president of Oregon State University notifies the Governor that the university will become a university with a governing board in the manner set forth in section 168
or 168b of this 2013 Act.

"(2)(a) The University of Oregon governing board shall be known
as the Board of Trustees of the University of Oregon.

9 "(b) The Portland State University governing board shall be known
10 as the Board of Trustees of Portland State University.

"(c) The Oregon State University governing board shall be known as the Board of Trustees of Oregon State University, if the president of Oregon State University notifies the Governor that the university will become a university with a governing board in the manner set forth in section 168 or 168b of this 2013 Act.

16 "SECTION 4. Upon a request to the Governor by the president of 17 Eastern Oregon University, Oregon Institute of Technology, Southern 18 Oregon University or Western Oregon University to establish a gov-19 erning board for the university, or upon a request made by the presi-20 dent of Oregon State University after January 1, 2014, to establish such 21 a board, the Higher Education Coordinating Commission shall:

22 "(1) Evaluate and determine whether:

"(a) There is clear evidence of support for a governing board by the
 university community;

25 "(b) The university has the capacity and capability to be governed
26 by a governing board; and

"(c) A governing board of the university will function in accordance
with the findings set forth in section 1 of this 2013 Act.

"(2) Make recommendations to the Legislative Assembly as to
 whether, in addition to the public universities with governing boards

listed in section 3 of this 2013 Act, a governing board should be estab lished for the university.

3 "SECTION 5. (1) On an annual basis, the Higher Education Coordi-4 nating Commission shall submit to the Legislative Assembly an eval-5 uation of each university with a governing board. The commission 6 may make recommendations to the Legislative Assembly regarding the 7 ability of the university to meet academic goals and fulfill its fiduciary 8 responsibilities.

9 "(2) The evaluation must include:

"(a) A report on the university's achievement of outcomes, meas ures of progress, goals and targets as described in the university's
 achievement compact with the Oregon Education Investment Board;

"(b) An assessment of the university's progress toward achieving
 the mission of all education beyond high school as described in ORS
 351.009; and

"(c) An assessment as to how well the establishment of a governing
 board at the university comports with the findings set forth in section
 1 of this 2013 Act.

"<u>SECTION 6.</u> (1) A governing board for a public university must be
 formed and maintained as provided in this section.

"(2)(a) Except as provided in subsection (3) of this section, the
Governor shall appoint all of the 11 to 15 members of the governing
board, subject to confirmation by the Senate in the manner provided
in ORS 171.562 and 171.565.

25 "(b) The governing board must include one person who is a student
 26 enrolled at the university.

"(c) The governing board must include one person who is a member
of the faculty of the university. The faculty member shall be a nonvoting member of the governing board.

30 "(3) The president of the university shall be an ex officio nonvoting

1 member of the governing board.

"(4)(a) The term of office for each appointed nonstudent member
of the governing board is four years.

4 "(b) The term of office of each student member of the governing
5 board is two years.

6 "(c) A member of the governing board may not be appointed to 7 serve more than two consecutive full terms.

"(d) The Governor may remove any appointed member of the governing board at any time for cause, after notice and public hearing,
but may not remove more than three members within a period of four
years, unless it is for corrupt conduct in office.

"(e) Vacancies shall be filled by appointment by the Governor for
 the remainder of the unexpired term.

"(5) The governing board shall select one of its members as chairperson and another as vice chairperson for such terms and with duties and powers as the board considers necessary for the performance of the functions of those offices. The governing board shall adopt bylaws concerning how a quorum is constituted and when a quorum is necessary.

"(6) The governing board shall meet at least once quarterly, and
 may meet at the call of the chairperson or a majority of the voting
 members of the board.

23 "SECTION 7. Notwithstanding the term of office specified in section 24 6 of this 2013 Act, the initial term of a member appointed to a gov-25 erning board by the Governor may be adjusted so that one-half, as 26 nearly as possible, of the members of the board are appointed 27 biennially.

"<u>SECTION 8.</u> (1) A university with a governing board shall enter
 into an achievement compact with the Oregon Education Investment
 Board for each fiscal year.

"(2) The governing board shall adopt a mission statement for the
university, and shall forward the statement to the Higher Education
Coordinating Commission for approval.

"(3) A university with a governing board shall submit any significant change in the university's academic programs to the Higher Education Coordinating Commission for approval. The commission shall establish, by rule, what constitutes a significant change to a university's academic program. The commission shall further ensure that approved programs:

10 "(a) Are consistent with the mission statement of the university;

"(b) Do not unnecessarily duplicate academic programs offered by
 Oregon's other public universities;

"(c) Are not located in a geographic area that will cause undue
 hardship to Oregon's other public universities; and

"(d) Are allocated among Oregon's public universities to maximize
 the achievement of statewide needs and requirements.

"(4)(a) On or before May 1 of each even-numbered year, a university
with a governing board shall submit to the Higher Education Coordinating Commission a funding request applicable to the biennium beginning on July 1 of the following year.

"(b) Pursuant to ORS 351.052, the Higher Education Coordinating
 Commission shall submit a funding request to the Governor on behalf
 of all public universities listed in ORS 352.002.

"(c) The Governor's biennial budget submitted to the Legislative Assembly may include funding requests from public universities, including universities with governing boards. An appropriation made by the Legislative Assembly must specify that the moneys be appropriated to the Higher Education Coordinating Commission for distribution to public universities listed in ORS 352.002.

30 "(5) As part of a funding request submitted under subsection (4) of

this section, a university with a governing board may request, and 1 appropriations may include, funding for education and general oper- $\mathbf{2}$ ations, statewide public services, state-funded debt service, capital 3 improvements, deferred maintenance, special initiatives and invest-4 ments. Any moneys appropriated to pay debt service for state bonds  $\mathbf{5}$ must be held by the State Treasurer pursuant to an agreement entered 6 into by the State Treasurer and a university with a governing board 7 under section 15 (2) of this 2013 Act. 8

9 "<u>SECTION 9.</u> (1)(a) In consultation with the Governor, or the 10 Governor's designee, the governing board shall appoint and employ a 11 president of the university.

"(b) The governing board shall prescribe the president's compen sation and terms and conditions of employment.

"(2) The president of the university is the president of the faculty. The president is also the executive and governing officer of the university, except as otherwise provided by statute or action of the governing board. Subject to the supervision of the governing board, the president of the university has authority to direct the affairs of the university.

"(3) Except in the case of an interim or acting president, the hiring committee for the president of a university with a governing board shall include representatives of the university community and at least one other president of a public university based in Oregon.

"(4) The governing board is responsible for the reappointment or
 removal of the president of the university.

"(5) A university with a governing board may appoint and employ
any instructional, administrative, professional, trade, occupational
and other personnel as are necessary or appropriate and establish their
compensation and terms and conditions of employment, subject to the
limitations set forth in section 14 (1) and (2) of this 2013 Act.

"SECTION 10. (1) Except as set forth in this section, the governing
 board may authorize, establish, eliminate, collect, manage, use in any
 manner and expend all revenue derived from tuition and mandatory
 enrollment fees.

5 "(2) The governing board shall establish a process for determining 6 tuition and mandatory enrollment fees. The process must provide for 7 participation of enrolled students and the recognized student govern-8 ment of the university.

9 "(3) The governing board shall request that the president of the 10 university transmit to the board the joint recommendation of the 11 president and the recognized student government before the board 12 authorizes, establishes or eliminates any incidental fees for programs 13 under the supervision or control of the board and found by the board 14 to be advantageous to the cultural or physical development of stu-15 dents.

"(4) In determining tuition and mandatory enrollment fees for
 undergraduate students who are enrolled in a degree program and are
 qualified to pay resident tuition:

"(a) The governing board may not increase the total of tuition and
 mandatory enrollment fees by more than five percent annually unless
 the board first receives approval from:

22 "(A) The Higher Education Coordinating Commission; or

23 **"(B) The Legislative Assembly.** 

"(b) The governing board shall attempt to limit annual increases in tuition and mandatory enrollment fees for undergraduate students who are enrolled in a degree program and have established residency in Oregon to a percentage that is not greater than the percentage increase in the Higher Education Price Index, as compiled by the Commonfund Institute.

30 "(5) The governing board may not delegate authority to determine

tuition and mandatory enrollment fees for undergraduate students
who are enrolled in a degree program and are qualified to pay resident
tuition.

4 "<u>SECTION 11.</u> (1) A university with a governing board may:

"(a) Acquire, receive, hold, keep, pledge, control, convey, manage,
use, lend, expend and invest all moneys, appropriations, gifts, bequests, stock and revenue from any source.

"(b) Borrow money for the needs of the university in such amounts
and for such time and upon such terms as may be determined by the
university or the governing board.

"(c) Make any and all contracts and agreements, enter into any partnership, joint venture or other business arrangement and create and participate fully in the operation of any business structure, including but not limited to the development of business structures and networks with any public or private government, nonprofit or forprofit person or entity, that in the judgment of the university or the governing board is necessary or appropriate.

"(d) Establish, collect and use charges, fines and fees for services,
 facilities, operations and programs.

"(e) Purchase, receive, subscribe for or otherwise acquire, own, hold, vote, use, sell, mortgage, lend, pledge, invest in or otherwise dispose of and deal in or with the shares, stock or other equity or interests in or obligations of any other entity. The State of Oregon may not have any proprietary or other interest in investments or funds referenced in this paragraph.

"(f) Acquire, purchase, purchase on a contractual basis, borrow,
receive, own, hold, control, convey, sell, manage, operate, lease,
lease-purchase, license, lend, invest in, issue, improve, develop, use,
expend and dispose of personal property, including intellectual property, of any nature, tangible or intangible.

"(g) Establish employee benefit plans of any type, subject to ORS
 351.094.

"(h) Take, hold, grant and dispose of mortgages and other security
interests on real and personal property.

"(i) Spend all available moneys without appropriation or expendi- $\mathbf{5}$ ture limitation approval from the Legislative Assembly, except for 6 moneys received by a university with a governing board pursuant to 7 a funding request submitted under section 8 (4) of this 2013 Act and 8 the proceeds of state bonds issued for the benefit of a university with 9 a governing board. The proceeds of state bonds issued for the benefit 10 of a university with a governing board must be held pursuant to an 11 agreement entered into by the State Treasurer and a university with 12a governing board under section 15 (2) of this 2013 Act. The provisions 13 of ORS 351.450, 351.455 and 351.460 do not apply to state bonds issued 14 for the benefit of a university with a governing board pursuant to 15Article XI-F(1) or XI-G of the Oregon Constitution. 16

"(j) Acquire, purchase, purchase on a contractual basis, borrow,
receive, own, hold, control, convey, sell, manage, operate, lease,
lease-purchase, license, lend, invest in, improve, develop, use, expend
and dispose of real property.

"(k) Erect, construct, improve, remodel, develop, repair, maintain,
equip, furnish, lease, lend, convey, sell, manage, operate, use and dispose of any building, structure, land or project.

"(L) Acquire, by condemnation or otherwise, private property that
 is necessary or convenient. The right to acquire property by condem nation shall be exercised as provided by ORS chapter 35.

"(m) Establish policies for the organization, administration and development of the university which, to the extent set forth in those policies, shall have the force of law and may be enforced through university procedures that include an opportunity for appeal and in 1 any court of competent jurisdiction.

"(n) Sue in its own name, be sued in its own name and issue and
enforce subpoenas in its own name.

"(o) Hire or retain attorneys for the provision of all legal services.
A university with a governing board shall reimburse the State Treasurer for legal fees incurred in connection with state bonds issued at
the request of the university.

"(p) Purchase any and all insurance, operate a self-insurance program or otherwise arrange for the equivalent of insurance coverage
of any nature and the indemnity and defense of its officers, agents and
employees or other persons designated by the university.

"(q) Subject to the procedures set forth in section 8 of this 2013 Act, establish, supervise and control academic and other programs, units of operation and standards, qualifications, policies and practices relating to university matters such as admissions, curriculum, grading, student conduct, credits, scholarships and the granting of academic degrees, certificates and other forms of recognition.

"(r) Enforce and recover any fees, charges and fines, including but
 not limited to mandatory enrollment fees.

"(s) Make available and perform any and all services on such terms
 as the governing board considers appropriate.

"(t) Delegate and provide for the further delegation of any and all
powers and duties, subject to the limitations expressly set forth in law.
"(2) The budget for a university with a governing board shall be
prepared in accordance with generally accepted accounting principles
and adopted by the governing board in accordance with ORS 192.610
to 192.710.

"(3) A governing board or university with a governing board may
 perform any other acts that in the judgment of the board or university
 are required, necessary or appropriate to accomplish the rights and

1 responsibilities granted to the board or university by law.

"SECTION 12. (1) Legal title to all real property acquired by a uni- $\mathbf{2}$ versity with a governing board shall be taken and held in the name 3 of the State of Oregon, acting by and through the governing board. 4 Legal title to all real property conveyed to a university with a gov- $\mathbf{5}$ erning board is considered to be conveyed to and vested in the State 6 of Oregon, acting by and through the governing board. Authorized 7 conveyances of all real property, other than university lands, acquired 8 by or vested in the State of Oregon for the use or benefit of the uni-9 versity must be executed in the name of the State of Oregon, acting 10 by and through the governing board, by the chairperson of the gov-11 erning board. 12

"(2) The governing board has custody and control of and shall care 13 for all real property used for university purposes. Management, 14 maintenance, disposal and preservation of all real property used for 15university purposes, whether the real property is acquired before or 16 after the establishment of a governing board, is the responsibility of 17 the governing board. Real property taken and held under this section 18 may only be encumbered by the State of Oregon in accordance with 19 state law and in a manner that would not impair the financial condi-20tion of the university or the rights of the holders of any obligations 21of the university issued or incurred under any master indenture or 22other financing agreement. 23

"(3) Unless the State Treasurer has granted prior consent, real or personal property held in the name of the State of Oregon, or in which the State of Oregon has an ownership or other legal interest, that was acquired, constructed, improved with or otherwise directly benefited by the proceeds of outstanding state bonds, may not be:

"(a) Used by a governing board in a manner that would give rise to
 private business use; or

"(b) Sold, transferred, encumbered, leased or otherwise disposed of
by a governing board. The reference to leases in this paragraph does
not apply to residential leases that a governing board enters into with
students, faculty or employees of the university.

5 "<u>SECTION 13.</u> (1) A governing board may, in its sole discretion, do
6 all of the following:

7 "(a) Police, control and regulate traffic and parking of vehicles on
8 university property.

"(b) Establish a police department and commission one or more 9 employees as police officers in the manner and with all of the privi-10 leges and immunities set forth in ORS 352.383. When a governing board 11 establishes a police department and commissions one or more em-12 ployees as police officers, the president of the university, in cooper-13 ation with the chief of the police department, shall establish a process 14 by which the university will receive and respond to complaints in-15 volving the policies of the police department and the conduct of the 16 police officers. 17

"(c) Commission special campus security officers who, when acting 18 in the scope of their employment, shall have stop and frisk authority 19 as set forth in ORS 131.605 to 131.625 and probable cause arrest au-20thority and the accompanying immunities as set forth in ORS 133.310 21and 133.315. Special campus security officers may not be authorized to 22carry firearms as police officers and, except as provided in subsection 23(2) of this section, may not be considered police officers for purposes 24of ORS 181.610, 238.005, 243.005 or 243.736. 25

"(2) A university with a governing board, acting by and through its
 special campus security officers, is a criminal justice agency for pur poses of rules adopted pursuant to ORS 181.730 (3).

"<u>SECTION 14.</u> (1) A university with a governing board shall engage
 in collective bargaining with local bargaining organizations of the

1 employees of the university.

"(2) A university with a governing board shall participate in a collective bargaining partnership with other public universities in this state for the purpose of engaging in collective bargaining with existing statewide bargaining organizations of the employees of the public university. The collective bargaining partnership shall be established by written agreement.

"(3) Subject to the authority of the Secretary of State to audit public accounts, a university with a governing board may conduct an independent audit if the governing board considers the audit advisable. Subject to ORS 297.250, the independent audit is subject to the exclusive discretion and control of the university. The independent audit is subject to disclosure pursuant to ORS 192.410 to 192.505.

14 "SECTION 15. (1) All moneys collected or received by a university 15 with a governing board, placed to the credit of the governing board 16 and remaining unexpended and unobligated on the date that the board 17 is established, and all moneys collected or received by a university 18 with a governing board after the date that the governing board is es-19 tablished, may be:

"(a) Deposited into one or more accounts established by the board
in depositories insured by the Federal Deposit Insurance Corporation
or the National Credit Union Share Insurance Fund, and the governing
board shall ensure that sufficient collateral secures any amount of
funds on deposit that exceeds the limits of the coverage of the Federal
Deposit Insurance Corporation or the National Credit Union Share
Insurance Fund; or

"(b) Held, kept, pledged, controlled, conveyed, managed, used,
loaned, expended and invested as set forth in sections 10 and 11 of this
2013 Act.

30 "(2) Upon a request by the State Treasurer, a university with a

governing board shall enter into a written agreement with the state 1 that provides for the State Treasurer to receive, hold, keep, manage  $\mathbf{2}$ and invest any amounts under the control of the university that the 3 State Treasurer determines should be held by the State Treasurer to 4 provide for payment of state bonds and other state obligations that  $\mathbf{5}$ are to be paid from appropriations described in section 8 (5) of this 2013 6 Act, revenues of the university or other moneys under the control of 7 the university. The agreement may, at the request of the State 8 Treasurer, require the university to pay the costs incurred by the 9 State Treasurer in connection with entering into and carrying out the 10 agreement. 11

"(3) Upon a request by a university with a governing board, the 12 State Treasurer may receive, hold, keep, manage and invest any or all 13 moneys, appropriations, gifts, bequests or revenues of the university 14 from any source in accordance with an agreement entered into be-15 tween the State Treasurer and the university and with the policies and 16 procedures established by the State Treasurer, including the 17 recoupment of costs incurred by the State Treasurer in carrying out 18 these tasks. 19

"(4) As used in this section, 'depository' has the meaning given that
 term in ORS 295.001.

22 "<u>SECTION 16.</u> (1) The following entities are not subject to any 23 provision of law enacted after January 1, 2013, that is unique to gov-24 ernmental entities unless the following entities are expressly named:

<sup>25</sup> "(a) A university with a governing board; and

26 "(b) Any not-for-profit organization or other entity if the equity of 27 the entity is owned or controlled exclusively by a university with a 28 governing board and if the organization or entity is created by the 29 university to advance any of the university's statutory missions.

30 "(2) Notwithstanding subsection (1) of this section, the provisions

of ORS 30.260 to 30.460, 33.710, 33.720, 200.005 to 200.025, 200.045 to 200.090, 236.605 to 236.640, 276.080, 279.835, 279.840, 279.850 and 297.040 and ORS chapters 35, 190, 192 and 244 apply to a university with a governing board under the same terms as they apply to public bodies other than the state.

"(3) Except as otherwise provided by law, the provisions of ORS
35.550 to 35.575, 180.060, 180.210 to 180.235, 184.305 to 184.345, 190.480,
190.490, 200.035, 243.696, 357.805 to 357.895 and 656.017 (2) and ORS
chapters 182, 183, 240, 270, 273, 276, 278, 279A, 279B, 279C, 282, 283, 291,
292, 293, 294, 295 and 297 do not apply to a university with a governing
board.

"(4) Notwithstanding subsections (1) and (3) of this section, ORS
240.167, 279C.600 to 279C.625, 279C.800, 279C.810, 279C.825, 279C.830,

 in the Optional Retirement Plan, who has creditable service under ORS

chapter 238 as defined by ORS 238.005 and who is not vested shall be considered by the Public Employees Retirement Board to be a terminated member under the provisions of ORS 238.095 as of the effective date of the election, and the amount credited to the member account of the member shall be transferred directly to the Optional Retirement Plan by the Public Employees Retirement Board in the manner provided by subsection (7) of this section.

"(b) An administrative or academic employee who elects to participate in 8 the Optional Retirement Plan, who has creditable service under ORS chapter 9 238 as defined by ORS 238.005 and who is vested shall be considered to be 10 an inactive member by the Public Employees Retirement Board and shall 11 retain all the rights, privileges and options under ORS chapter 238 unless the 12 employee makes a written request to the Public Employees Retirement Board 13 for a transfer of the amounts credited to the member account of the member 14 to the Optional Retirement Plan. A request for a transfer must be made at 15 the time the member elects to participate in the Optional Retirement Plan. 16 Upon receiving the request, the Public Employees Retirement Board shall 17 transfer all amounts credited to the member account of the member directly 18 to the Optional Retirement Plan, and shall terminate all rights, privileges 19 and options of the employee under ORS chapter 238. 20

an inactive member of the pension program by the Public Employees Re-1 tirement Board as of the effective date of the election. An employee who is  $\mathbf{2}$ subject to the provisions of this paragraph retains all the rights, privileges 3 and options of an inactive member of the pension program. If the actuarial 4 equivalent of the employee's benefit under the pension program at the time  $\mathbf{5}$ that the election becomes effective is \$5,000 or less, the employee may make 6 a written request to the Public Employees Retirement Board for a transfer 7 of the employee's interest under the pension program to the Optional Re-8 tirement Plan. "(e) 'Student' means a child who is placed in an eligible day treatment program or eligible residential treatment program by a public or private entity or by the child's parent. "(2) The Department of Education shall be responsible for payment of the costs of education of students in eligible day treatment programs and eligible residential treatment programs by contracting with the school district in which the eligible day treatment program or eligible residential treatment program is located. The costs of education do not include transportation, care, treatment or medical expenses.

"(3)(a) The school district in which an eligible day treatment program or eligible residential treatment program is located is responsible for providing the education of a student, including the identification, location and evaluation of the student for the purpose of determining the student's eligibility to receive special education and related services.

able to achieve the goals and mission described in ORS 351.006 and
351.009;

"(B) The achievement of cost efficiencies, economies of scale, cost
effectiveness, accountability, administrative streamlining and the
ability to provide the best quality education possible for the amount
of state dollars spent; and

29 "(C) That the public missions of Oregon's public universities, in-30 cluding access and affordability for residents of this state, are main1 tained and enhanced.

"(5)(a) Any shared services legislation recommended by the special
committee must consider the recommended shared services model
provided by the Work Group on University Shared Services under
section 166a (10) of this 2013 Act.

6 "(b) The shared services subject to review by the special committee 7 shall include, but are not limited to, risk management, cash manage-8 ment, asset management, treasury services, payroll, employee bene-9 fits, accounting, auditing, purchasing and contracting, information 10 technology and any other administrative function that might benefit 11 from the sharing or pooling of public university resources.

"(6) A majority of the members of the special committee constitutes
 a quorum for the transaction of business.

"(7) Official action by the special committee requires the approval
 of a majority of the members of the committee.

"(8) The special committee shall elect two of its members to serve
 as cochairpersons, one from the Senate and one from the House of
 Representatives.

"(9) If there is a vacancy for any cause, the appointing authority
 shall make an appointment to become immediately effective.

"(10) The special committee shall meet at times and places specified
by the call of the cochairpersons or of a majority of the members of
the committee.

"(11) The special committee may adopt rules necessary for the op eration of the committee.

"(12)(a) The special committee shall convene and begin work no
 later than September 15, 2013.

"(b) The special committee shall complete a first draft of its rec ommendations and report to an interim committee of the Legislative
 Assembly related to education no later than December 15, 2013.

"(c) The special committee shall finalize and submit recommendations to the Governor and Legislative Assembly no later than February 1, 2014, for consideration during the 2014 regular Legislative
Session.

"(13) The Legislative Administration Committee shall provide staff
 support to the special committee.

"(14) Members of the special committee who are not members of the
Legislative Assembly are not entitled to compensation.

9 "(15) All agencies of state government, as defined in ORS 174.111, 10 are directed to assist the special committee in the performance of its 11 duties and, to the extent permitted by laws relating to confidentiality, 12 to furnish such information and advice as the members of the com-13 mittee consider necessary to perform their duties.

"(16) The special committee may accept contributions of funds and
 assistance from any source, public or private, for the purposes of the
 consultation with national experts required by subsections (2) to (5)
 of this section.

"SECTION 166a. (1) The Work Group on University Shared Services
 is established, consisting of the presidents of the seven public univer sities listed in ORS 352.002, or the presidents' designees.

"(2) The work group shall develop a shared services model that delivers efficient and effective administrative operations to participating post-secondary institutions in a manner that focuses on quality, responsiveness and customer service and that seeks to achieve cost savings, economies of scale, accountability, transparency and streamlining.

"(3) In developing a shared services model under subsection (2) of
this section, the services that the work group must consider include,
but are not limited to, risk management, cash management, asset
management, treasury services, payroll, employee benefits, account-

ing, auditing, purchasing and contracting, information technology and
any other administrative function that might benefit from the sharing
or pooling of public university resources.

4 "(4) The State Board of Higher Education and the office of the 5 Chancellor of the Oregon University System shall assist the work 6 group in developing the work group's recommendations. The work 7 group may seek and accept consulting or other technical assistance 8 from any source in preparing its recommendations.

9 "(5) A majority of the members of the work group constitutes a 10 quorum for the transaction of business.

"(6) Official action by the work group requires the approval of a
 majority of the members of the work group.

"(7) The work group shall elect one of its members to serve as
 chairperson.

"(8) The work group shall meet at times and places specified by the
 call of the chairperson or of a majority of the members of the work
 group.

"(9) The work group may adopt rules necessary for the operation
 of the work group.

"(10)(a) The work group shall submit a first draft of its recommended shared services model to the Special Committee on Regional
and Technical Universities created in section 166 of this 2013 Act no
later than November 15, 2013.

"(b) The work group shall finalize and submit its recommended
shared services model to the special committee no later than January
7, 2014.

"(11) The Oregon University System shall provide staff support to
 the work group.

"(12) Members of the work group are not entitled to compensation.
"(13) All agencies of state government, as defined in ORS 174.111,

are directed to assist the work group in the performance of its duties and, to the extent permitted by laws relating to confidentiality, to furnish such information and advice as the members of the work group consider necessary to perform their duties.

5 "<u>SECTION 167.</u> Sections 166 and 166a of this 2013 Act are repealed
6 on the date of the convening of the 2014 regular session of the Legis7 lative Assembly as specified in ORS 171.010.

## **"OPERATIVE DATE AND TRANSITIONAL PROVISIONS**

10

"SECTION 168. (1) Notwithstanding the operative date set forth in section 171 of this 2013 Act, the Governor shall appoint all of the members of the Board of Trustees of the University of Oregon and all of the members of the Board of Trustees of Portland State University by August 19, 2013, so that these appointees may be confirmed by the Senate in the manner provided in ORS 171.562 and 171.565 by September 30, 2013.

"(2) If the president of Oregon State University notifies the Gover nor by August 1, 2013, the university will become a university with a
 governing board:

"(a) Within two weeks after receiving the notification, the Governor
 shall inform the President of the Senate, the Speaker of the House of
 Representatives and the Legislative Counsel of the notification; and

"(b) The Governor shall appoint all of the members of the Board
of Trustees of Oregon State University in the same manner and time
frame as set forth in subsection (1) of this section.

"(3) If the president of Oregon State University notifies the Governor between August 2, 2013, and January 1, 2014, that the university
will become a university with a governing board, the Board of Trustees
of Oregon State University shall be established in the manner set forth

1 in section 168b of this 2013 Act.

<u>SECTION 168a.</u> Notwithstanding the operative date set forth in
 section 171 of this 2013 Act:

"(1) The Board of Trustees of the University of Oregon and the
Board of Trustees of Portland State University may first issue bonds
in the manner set forth in sections 19 to 23 of this 2013 Act on January
1, 2014.

"(2) If the president of Oregon State University notifies the Governor in the manner set forth in section 168 (2) of this 2013 Act that the university will become a university with a governing board, the Board of Trustees of Oregon State University may first issue bonds in the manner set forth in sections 19 to 23 of this 2013 Act on January 1, 2014.

"(3) Sections 1, 3, 10 to 12, 15 and 16 of this 2013 Act and the 14 amendments to ORS 174.117, 287A.001, 307.095, 307.110 and 340.310 by 15sections 28, 54 and 132 to 134 of this 2013 Act become operative on 16 January 1, 2014, for any university with a governing board that issues 17 bonds pursuant to the authority granted in this section. The provisions 18 of sections 1, 3, 10 to 12, 15 and 16 of this 2013 Act and the amendments 19 to ORS 174.117, 287A.001, 307.095, 307.110 and 340.310 by sections 28, 54 20and 132 to 134 of this 2013 Act become operative on the date specified 21in this subsection only for purposes of allowing, and only to the extent 22necessary to allow, the university with a governing board to issue 23bonds. Except as otherwise provided in this 2013 Act, the university 24with a governing board may not exercise powers under sections 1, 3, 2510 to 12, 15 and 16 of this 2013 Act and the amendments to ORS 174.117, 26287A.001, 307.095, 307.110 and 340.310 by sections 28, 54 and 132 to 134 of 27this 2013 Act that are unrelated to the issuance of bonds until July 1, 282014. 29

30 "SECTION 168b. If the president of Oregon State University notifies

the Governor between August 2, 2013, and January 1, 2014, that the
 university will become a university with a governing board:

"(1) Within two weeks after receiving the notification, the Governor
shall inform the President of the Senate, the Speaker of the House of
Representatives and the Legislative Counsel of the notification; and

"(2) Not later than February 1, 2014, the Governor shall appoint all
of the members of the governing board in the manner set forth in
section 6 of this 2013 Act.

"SECTION 169. (1) Except as provided in section 168a of this 2013 9 Act, the State Board of Higher Education shall continue to have ju-10 risdiction over the operations of a university with a governing board 11 as defined in section 2 of this 2013 Act for the 2013-2014 academic year. 12 However, the governing board shall propose funding requests pursuant 13 to ORS 351.052, as amended by section 42 of this 2013 Act, and shall 14 prepare budgets, in cooperation with the Higher Education Coordinat-15 ing Commission, for the biennium beginning July 1, 2015. 16

"(2) The president of a university with a governing board shall take
over administrative responsibilities for the university from the State
Board of Higher Education on July 1, 2014.

"SECTION 170. (1) Except as otherwise expressly provided in this 20section, all persons employed by a university with a governing board, 21as defined in section 2 of this 2013 Act, on the effective date of this 2013 22Act shall continue their employment with the university and shall re-23tain any seniority, contractual rights or tenure granted prior to the 24effective date of this 2013 Act. Nothing in this section shall affect any 25term or condition of any collective bargaining agreement in effect on 26the effective date of this 2013 Act. 27

"(2) All of the duties, functions, powers and lawfully incurred rights
 and obligations of the State Board of Higher Education that pertain
 to a university with a governing board are transferred to and vested

in the governing board. The transfer shall include but not be limited 1 to all applicable contractual rights and obligations and title to all ap- $\mathbf{2}$ plicable records, property, supplies and materials, including equip-3 ment, books and papers. For the purpose of succession to these rights 4 and obligations, the governing board is considered to be a continuation  $\mathbf{5}$ of the State Board of Higher Education and not a new authority, and 6 the governing board must exercise such rights and fulfill such obli-7 gations as if they had not been assigned or transferred, except as 8 otherwise provided by law. 9

"(3) All unexpended moneys, including but not limited to General Fund appropriations, gifts, bequests, other funds, assessments, liability and worker's compensation reserves and premiums that are appropriated to, held, managed or invested by or on behalf of or otherwise available to a university with a governing board, are appropriated and transferred to the university.

"(4) A university with a governing board shall conduct and complete
 any proceeding, action, prosecution or other matter that the university commenced before the effective date of this 2013 Act and that is
 pending on the effective date of this 2013 Act.

"(5) The transfer of duties, functions and powers to a governing board or university with a governing board does not affect any action, suit or proceeding relating to the university, except that the university shall be substituted for the State Board of Higher Education and the State of Oregon in any such action, suit or proceeding.

"(6) Any action, proceeding or other matter that was commenced by a state agency, a state officer, the State Board of Higher Education or an officer or employee of the State Board of Higher Education before the effective date of this 2013 Act and relates to the governing board or university with a governing board and is still pending on the effective date of this 2013 Act shall be conducted and completed by the 1 governing board or university.

"(7) Nothing in this 2013 Act relieves any person, public entity or
private entity of any obligation with respect to a tax, fee, fine or other
charge, interest, penalty, forfeiture, rule, policy, document, record or
proceeding.

"(8) Notwithstanding any other provision of this section, the law-6 fully adopted rules and policies of the State Board of Higher Education 7 pertaining to a university with a governing board that are in effect 8 on the effective date of this 2013 Act continue in effect until lawfully 9 superseded or repealed by the standards or policies of the governing 10 board or the university. References in rules or policies of the State 11 Board of Higher Education to the state board or an officer or employee 12 of the state board are considered to be references to the governing 13 board or an officer or employee of a university with a governing board. 14 "SECTION 171. Sections 2, 2a, 2b, 3, 5, 8 to 18, 164, 165, 169 and 170 15 of this 2013 Act, the amendments to statutes and session laws by 16 sections 24, 25, 28 to 37 and 40 to 162 of this 2013 Act and the repeal 17 of statutes by section 163 of this 2013 Act become operative on July 1, 18 2014. 19

"SECTION 172. The State Board of Higher Education and a univer-20sity with a governing board as defined in section 2 of this 2013 Act 21may take any action before the operative date specified in section 171 22of this 2013 Act that is necessary for the State Board of Higher Edu-23cation and the university to exercise, on and after the operative date 24specified in section 171 of this 2013 Act, all of the duties, functions and 25powers conferred on the State Board of Higher Education and univer-26sity by this 2013 Act. 27

"SECTION 173. The unit captions used in this 2013 Act are provided only for the convenience of the reader and do not become part of the statutory law of this state or express any legislative intent in the enactment of this 2013 Act.

## **"EMERGENCY CLAUSE**

8 "SECTION 174. This 2013 Act being necessary for the immediate 9 preservation of the public peace, health and safety, an emergency is 10 declared to exist, and this 2013 Act takes effect on its passage.".
