Context

Major Budget Issues & Other Changes in Last 10 Years

- * Diminishing local government resources and grant funding
- * Increasing demand for planning assistance for smaller communities
- * Dependence on General Fund
- * Significant system fixes and changes underway (urban growth management, population forecasting, territorial sea plan)
- * Transformation initiative (information management modernization initiative)

Major Budget Issues & Other Changes in Last 10 Years

- * Key statutory duties (Urban Growth Boundary (UGB) and urban reserve review, periodic review)
- * Preparing for the effects of climate change
- * Working with ODOT and Metro to reduce greenhouse gas emissions
- * Significant phase out of Measure 49 orders

Agency Reduction Options Summary of 10% as Proposed at Agency Request

- * Reduction in planning program, administrative staffing and services and supplies
- * Additional reduction in grants to local jurisdictions having significant impact to local projects and capacity
- * Proposal is for one time reduction


* This package provides funding for two years of a five-year phased transformation initiative: \$245,857 General Funds



- * Stakeholders Drive Transformation
 - During requirements gathering, DLCD and its local partners identified an overarching need: to access and use current, integrated and reliable land use information
 - As a part of continuous improvement, DLCD identified information management and DLCD services to local governments and the public as critical objectives
 - IMMI addresses this need and the new resources will improve how DLCD meets its mission

- * Return on Investment
 - Enhancing local and state capacity
 - Creating high-quality statewide data with easy access for everyone
 - Publishing planning documents online
 - Making tools and applications available for planners, researchers and policy makers
 - Leveraging opportunities with partners and stakeholders





- * Consequences if not funded
 - Critical information resources will not be available
 - The best policy and practical decisions and sharing the reservoir of expertise will be hampered
 - Local governments, especially in rural areas, will be increasingly unable to meet the challenges of planning for and sustaining livable places



Technical Adjustment Requests

- * Shift General Funds from Operations Program to Grants Program
- * Shift in revenue streams in support of the joint Department of Land Conservation and Development and the Oregon Department of Transportation
 - Transportation and Growth Management Program (Base budget)
 - Oregon Sustainable Transportation Initiative Program (POP 102)
- * Reduce Federal Fund limitation as a result of sequestration
