SB 102: EXISTING CHALLENGES

- Fee structure doesn't match revenue with resource allocation.
- Proposed 2013-2015 budgets indicate fee revenues fully funding ODA operations and staffing. Current fees don't provide for sufficient staffing to meet legislative performance goals (KPMs) due to rising number of low fee reviews in recent years.
- Unfunded ODA functions have been de-prioritized (i.e. response to reports of diploma mill activity and fraudulent degree use).
- Rigid nature of statutory fee structure prevents necessary adaptation of ODA processes and practices to meet emerging workforce needs and impedes ODA responsiveness to new challenges precipitated by rapid change in higher education.

SB 102: CHANGING WORKLOAD

- Growth in workload has outpaced ODA's staffing and fee revenues
- Current fees do not reflect changes in scope and complexity of work

 Current fee structure is based solely on program level. Proposed fee structure includes fees for other types of review and for ongoing oversight and support.

SB 102: EXPECTED OUTCOMES

Restructures ODA fees – Increases/reduces various fees - Adds fees for specific "on-demand" ODA reviews - and supports:

- More staffing flexibility to ensure sustainability of effort and support staff to meet the full range of ODA responsibilities.
- Fewer redundant reviews and increased automation of ODA processes to shorten review/response time and increase public access to useful information on educational options.
- Ongoing school oversight and on-demand technical assistance to improve programs, enhance support for student success.
- Fair fee assessment for ODA services to schools to stabilize
 ODA funding and improve biennial budget planning to
 provide necessary staff training and better program support.
