

**PROPOSED AMENDMENTS TO
SENATE BILL 125**

1 On page 2 of the printed bill, delete lines 21 and 22 and insert:

2 **“(p) A statement that active duty servicemembers have a right to**
3 **stay proceedings under the federal Servicemembers Civil Relief Act**
4 **and may contact the Oregon State Bar or the Oregon Military De-**
5 **partment for more information. The statement must include the toll-**
6 **free telephone numbers for the Oregon State Bar and the Oregon**
7 **Military Department and the Internet address for the United States**
8 **Armed Forces Legal Assistance Legal Services Locator website.”.**

9 After line 28, insert:

10 **“SECTION 2. (1) An agency that, prior to the effective date of this**
11 **2013 Act, provided notice of rights under the federal Servicemembers**
12 **Civil Relief Act to each party to a contested case under ORS 183.413**
13 **is not required to provide the specific information described in ORS**
14 **183.413 (2)(p) in the notice so long as the agency continues to provide**
15 **notice in the same manner as it was previously provided.**

16 **“(2) An agency that, prior to the effective date of this 2013 Act, had**
17 **preprinted forms used for providing notice under ORS 183.413 (2) is not**
18 **required to provide the specific information required in ORS 183.413**
19 **(2)(p) until the supply of preprinted forms has been exhausted.”.**

20 In line 29, delete “2” and insert “3”.

21 Delete lines 42 and 43 and insert:

22 **“(f) A statement that active duty servicemembers have a right to**

7 **“SECTION 4. (1) An agency that, prior to the effective date of this**
8 **2013 Act, provided notice of rights under the federal Servicemembers**
9 **Civil Relief Act to each party to a contested case under ORS 183.415**
10 **is not required to provide the specific information described in ORS**
11 **183.415 (2)(f) in the notice so long as the agency continues to provide**
12 **notice in the same manner as it was previously provided.**

13 **“(2) An agency that, prior to the effective date of this 2013 Act, had**
14 **preprinted forms used for providing notice under ORS 183.415 (2) is not**
15 **required to provide the specific information required in ORS 183.415**
16 **(2)(f) until the supply of preprinted forms has been exhausted.”.**

17 In line 44, delete “3” and insert “5”.

18 After line 45, insert:

19 **“SECTION 6. This 2013 Act being necessary for the immediate**
20 **preservation of the public peace, health and safety, an emergency is**
21 **declared to exist, and this 2013 Act takes effect on its passage.”.**
