

**PROPOSED AMENDMENTS TO  
A-ENGROSSED HOUSE BILL 2549**

1 On page 1 of the printed A-engrossed bill, line 2, delete “147.500,”.

2 On page 5, line 15, after “Board” delete the rest of the line.

3 In line 16, delete “hearing, the board”.

4 In line 23, after “Board” delete the rest of the line.

5 In line 24, delete “the board”.

6 On page 6, line 26, after the period insert “All fees paid under this sub-  
7 section shall be deposited into the General Fund and credited to the account  
8 of the appropriate board.”.

9 In line 34, after the period insert “The agency releasing the information  
10 may not release the identity of the victim of a sex crime.”.

11 Delete lines 35 through 37 and insert:

12 “(b) The Department of State Police may make the information described  
13 in subsections (2) to (4) of this section available to the public, without the  
14 need for a request, by electronic or other means.

15 “(c) Notwithstanding paragraph (b) of this subsection, the department  
16 may not use the Internet to make information available to the public except  
17 as required by subsection (2) of this section.

18 “(d) A notifying agency or a supervising agency may release any infor-  
19 mation concerning a sex offender to a law enforcement agency if the notify-  
20 ing agency or supervising agency determines that the release of information  
21 is in the public interest.

22 “(e) The Law Enforcement Data System may send information concerning

1 a sex offender to the National Crime Information Center as part of the na-  
2 tional sex offender registry in accordance with appropriate state and federal  
3 procedures.”.

4 In line 38, delete “(c)” and insert “(f)”.

5 In line 39, delete “sex offender”.

6 In line 40, after “formation” insert “concerning a sex offender”.

7 Delete lines 43 through 45 and insert:

8 “(a) The Department of State Police shall release the following informa-  
9 tion concerning a sex offender on a website maintained by the department:

10 “(A) The person’s name and address;

11 “(B) A physical description of the person including, but not limited to, the  
12 person’s age, height, weight, hair color and eye color;

13 “(C) The type of vehicle that the person is known to drive;

14 “(D) Any conditions or restrictions of the person’s probation, parole,  
15 post-prison supervision or conditional release;

16 “(E) A description of the person’s primary and secondary targets;

17 “(F) A description of the person’s method of offense;

18 “(G) A current photograph of the person;

19 “(H) If the person is under supervision, the name and telephone number  
20 of the supervising officer; and

21 “(I) If the person is not under supervision, contact information for the  
22 Department of State Police.

23 “(b) The supervising agency or a notifying agency may release the infor-  
24 mation described in paragraph (a) of this subsection and any other informa-  
25 tion concerning a sex offender necessary to protect the public to:”.

26 On page 7, delete line 1.

27 In line 12, after “release” delete the rest of the line and insert “any in-  
28 formation concerning a sex offender necessary to protect the public”.

29 In line 15, after “release” delete the rest of the line and insert “any in-  
30 formation concerning a sex offender necessary to protect the public”.

- 1 Delete lines 21 and 22.
- 2 In line 23, delete “(c)” and insert “(b)”.
- 3 On page 15, delete lines 23 through 45.
- 4 On page 16, delete lines 1 through 30.
- 5 On page 25, line 24, delete “147.500”.
