**DUTIES AND AUTHORITY ORS:**    **480.535, 480.540, 480.615, 480.645, 480.647 480.665**

- Formulate and promulgate rules for the safe construction, installation, inspection, operation, maintenance and repair of boilers and pressure vessels in this state
- Review determinations made by its staff concerning boilers and pressure vessels
- Set safety standards and standards for welding on boilers and pressure vessels
- Hear appeals from appellant who received notice that a restraining order or injunction is sought or that permit has been suspended or revoked
- Hear appeal of appellant with written request to change minimum safety standards or the rules
- Cause standardized examinations to be prepared.
- Meet at least four times per year at time and place specified by Director of Department of Consumer and Business Services after consultation with board
- May adopt rules creating quality control procedures for welding on non-boiler external piping
