  - One from east of the Cascades (WILLIAMS), and one from west of the Cascades (LeJEUNE)
- Two consecutive term limit
- Serve at the pleasure of the Governor
- Governor appoints the chair

**DUTIES AND AUTHORITY:** ORS 536.025, ORS 536.029

- Establish policies for Water Resources Department consistent with state water policy
- Rulemaking
- Delegate duties to Water Resources Director
- Conduct hearings, issue subpoenas, administer oaths; take depositions
