STATUTORY QUALIFICATIONS: **ORS 442.830**

Affirmative action policy: See ORS 182.100. Diversity criteria: See ORS 236.115.

- 17 members: Public Health Officer and 16 directors appointed by the Governor
 - Public Health Officer (HIGGINSON, by position)
 - One faculty member of the Oregon University System or a private Oregon university, who is not involved in the direct delivery of health care (RISSI)
 - Two representatives of group purchasers of health care (CANNARELLA, MARTIN)
 - One employed by a state or governmental entity
 - Neither of whom may provide direct health care services or have an immediate family member involved in the delivery of health care
 - Two representatives of health care consumers (DeMONNIN, PRICE), neither of whom may provide direct health care services or have an immediate family member who is involved in the delivery of health care.
 - Two representatives of health insurers including (FARRIS, MERA)
 - a representative of a domestic not-for-profit health care service contractor
 - a representative of a domestic insurance company licensed to transact health insurance; or
 - a representative of a health maintenance organization
 - One representative of a statewide or national labor organization (TOBIAS-WHITE)
 - Two active physicians licensed under ORS chapter 677 (MULLER, SHEPPARD)
 - Two hospital administrators or their designees (GRUBER, THOMPSON)
 - One pharmacist licensed under ORS chapter 689 (**OBER**)
 - One representative of ambulatory surgical center or outpatient renal dialysis facility (JOHNSON)
 - One nurse licensed under ORS chapter 678 who is in active clinical practice (AGUAS)
 - One nursing home administrator or nursing home director of nursing services (BIGGS)
- Directors shall demonstrate interest, knowledge or experience in the area of patient safety
- Board nominates a slate of candidates for vacancies; maximum service is two terms

DUTIES AND AUTHORITY: **ORS 442.820, ORS 442.831 –ORS 442. 846**

- Improve patient safety by reducing the risk of serious adverse events occurring in Oregon’s health care system and by encouraging a culture of patient safety by:
 - Establishing a confidential, voluntary serious adverse event reporting system
 - Establishing quality improvement techniques to reduce systems’ errors contributing to serious adverse events; and
 - Disseminating evidence-based prevention practices to improve patient outcomes
- Administer the Oregon Patient Safety Reporting Program by adopting rules, assessing fees on participating entities, and reporting to the Legislative Assembly
- Board may appoint subcommittees and advisory groups to assist the board, including but not limited to one or more consumer advisory groups and technical advisory groups
