- Nine members appointed by the Governor to four-year terms
 - Three members from travel agencies, tour operators, private transportation, restaurants or businesses or organizations engaged in tourism promotion for cities or counties, cultural attractions, historic attractions, ski facilities or related recreational industries (AUDETTE, EVANSTAD, WILSON ANGLIN)
 - At least one member shall represent the public at large (**FRANCISCO**)
 - Five members from the lodging industry including hotels, motels, resorts, bed and breakfast facilities, inns, recreational vehicle parks, campgrounds and guest ranches (ERICKSON, HICKOX, MUNGUIA, SNYDER, UTZ)
- Members should represent the state's various regions and areas of tourism activities
- Members may be removed by appointing authority for cause

DUTIES AND AUTHORITY: **ORS 285A.264**

- Select chair and vice-chair and assign powers and duties
- Advise governmental bodies and agencies and private persons on development and implementation of state policies and procedures relating to tourism
- Advise Governor and the executive director of the commission on matters relating to tourism
- Prepare comprehensive marketing plan on tourism
- Develop budget
- Solicit public and private sector views on tourism
- Adopt administrative rules for the operation of the commission
- Cooperate with educational institutions in the development of educational programs critical to the development of a strong tourism industry
- Cooperate with and provide technical assistance to communities and tourism marketing associations to promote tourism
- Cooperate with and provide expertise for communities and tourism marketing associations in the development and promotion of their tourism attractions and businesses
