TERM: Three - year terms; June 1, 2013 – Ma 31, 2016

ECONOMIC INTEREST FILING (ORS 244.050): Not required.

STATUTORY QUALIFICATIONS: ORS 673.410

Affirmative action policy: See ORS 182.100. Diversity criteria: See ORS 236.115.

- Seven members appointed by the Governor to three-year terms:
 - Four members holding CPA permits for at least five years and actively engaged in public accountancy (BRIDGHAM, LAUSENG NEWHOUSE, WRIGHT)
 - One member holding CPA permit for five years and employed in private industry, education or government or actively engaged in public accountancy practice (BROWN)
 - One public member (**GRAHAM**)
 - One public accountant licensed for five years and actively engaged in public accountancy (**CRACKENBERG**)
- No more than three consecutive three-year terms until a period at least equal to the appointed terms has elapsed

DUTIES AND AUTHORITY: ORS 673.010 – 673.457

- Regulate the practice of public accounting
- Grant certificates to CPAs; license public accountants
- Adopt professional code of conduct for CPAs and public accountants
- Rulemaking
- Take disciplinary action against licensees
- Institute injunction proceedings to halt violations; appoint hearings officer
- Appoint Peer Review Committee; approve applications for operation of alternative peer review programs
- Allow holder of a license in another state (verified as being substantially equivalent in requirements or skills) to practice public accountancy in Oregon if the holder maintains a valid certificate and license in good standing as a certified public accountant
