- One from each category above shall be a resident of a district over 4,500 students:
  - GUTIERREZ administrator; COLEMAN teacher; MCKAY administrator,;
     MARBLE school board member, MILLS non-affiliated; PENLAND non-affiliated; SCHUFF teacher; SCHULTZ administrator; TERDAL non-affiliated;
     SCONCE teacher
- Members may serve beyond expired term for purposes specified in ORS 342.930(3)(a)

#### **<u>DUTIES AND AUTHORITY:</u>** ORS 342.905, 342.930

- Elect chair and vice-chair
- Adopt rules
- Hear appeals from teachers dismissed by employing school district, to be heard by panel of three members appointed by the Superintendent of Public Instruction
- Conduct contested case hearings in accordance with ORS 183.310 to 183.550; issue subpoenas
