 - One contractor specializing in building multifamily housing three stories or less above grade (CHMELIR)
 - One home designer or architect (GRAY)
 - One building official (**TAMERHOULET**)
 - One representative of residential building trade subcontractors (MILLS)
 - One structural engineer (HALOG)
 - One representative of a utility or energy supplier (DOBBS)
 - One manufacturer of manufactured dwellings (**TORGERSON**)
 - One seller or distributor of new manufactured dwellings (BONHEIMER)
 - One public member who does not receive compensation from any interest represented by other members of the board (KEMPER)

DUTIES AND AUTHORITY: ORS 455.135

- Assist the Director of the Department of Consumer and Business Services in administering the low-rise residential dwelling program described in this chapter
- Elect a members as chairperson and vice-chairperson
- Will meet at least twice per year at times and places specified by the Director of the Department of Consumer and Business Services after consultation with the board, or at times and places specified by the call of a majority of the members of the board after consultation with the director.
