#### **SUMMARY**

Modifies definitions of "employ," "employee," "employer" and "wages" for purposes of statutes relating to hours, wages, wage claims, employment conditions, employment agencies, farm labor contractors and construction contractors.

Creates presumption of employee status under certain conditions.

- (2) "Employee" means any individual employed by an employer in 2 this state. An individual performing services that are an integral part of the business of another is presumed to be an employee unless the individual is customarily engaged in an independently established 5 business of the same nature as that involved in the services per-6 formed.
- [(1)] (3)(a) "Employer" means [any person who in this state, directly or 8 through an agent, engages personal services of one or more employees and in-9 cludes any successor to the business of any employer, or any lessee or pur-10 chaser of any employer's business property for the continuance of the same 11 12 business, so far as such employer has not paid employees in full. "Employer" includes the State of Oregon or any political subdivision thereof or any county, 13 city, district, authority, public corporation or entity and any of their instru-14 mentalities organized and existing under law or charter but]: 15
  - (A) Any person or a public body as defined in ORS 174.109, that employs an individual, and any other person acting directly or indirectly in the interest of an employer in relation to an employee; and
  - (B) To the extent an employer has not paid employees in full, any successor to the business of the employer or a purchaser of the employer's property for the continuance of the same business.

- 23 (A) Residence that is a site-built home;
- 24 (B) Condominium, rental residential unit or other residential dwelling
- 25 unit that is part of a larger structure, if the property interest in the unit is

- 27 (C) Modular home constructed off-site;
- 28 (D) Manufactured dwelling; or
- 29 (E) Floating home, as defined in ORS 830.700.

- 29 (J) A place constructed primarily for recreational activities.
- [(16)] (19) "Responsible managing individual" means an individual who:

- 3 (c)(A) Successfully completed the training and testing required for li-

- [(19)] (22) "Zero-lot-line dwelling" means a single-family dwelling unit

- (6)(a) Except as provided in paragraphs (b) and (c) of this subsection, an employer may not place an adverse comment in the personnel records of a public safety officer unless the officer has first read and signed the document containing the adverse comment.
- (b) If a public safety officer refuses to sign a document containing an 18 adverse comment, the employer may place the document in the officer's personnel records with a notation that the document was presented to the officer and the officer refused to sign it.
  - (c) If a public safety officer is not available to read and sign the document containing an adverse comment at the work location where the personnel files are maintained, the employer may place the document in the officer's personnel records and mail a copy of the document to the officer by regular mail or interoffice mail.
- (d) A public safety officer may write a response within 30 days of being 27 presented with a document containing an adverse comment. If a public safety 28 officer writes a response to a document containing an adverse comment, the 29 response must be attached to the original document and placed in the 30 31 officer's personnel records.

- (7)(a) Upon request, a public safety officer may inspect the officer's own personnel records at a reasonable time at the location where the records are kept by the employer.
- (b) If, after inspection, a public safety officer believes that any portion of the material is mistakenly or unlawfully placed in the officer's personnel records, the officer may request in writing that the mistaken or unlawful material be corrected or deleted. The request must describe the corrections or deletions requested and the reasons supporting the request and provide any documentation that supports the request. The employer shall respond within 30 days from the date the request is received. If the employer does not correct or delete the material, the employer shall place the request and the employer's response to the request in the officer's personnel records.
