Subject: HB 2370 Work Session Recommendations

HB 2370 relates to the Oregon transparency website. The measure requires additional information to be posted on the state transparency website relating to public meetings, administrative rules and contracts. The measure is effective January 1, 2014.

The measure, the original staff measure summary, preliminary Joint Committee on Ways and Means staff measure summary, revenue impact statement [if available], and fiscal impact statement are available on the Oregon Legislative Information System (OLIS).

The measure previously had a work session in the House Committee on Consumer Protection and Government Efficiency on March 26th, 2013 and was referred to the Joint Committee on Ways and Means with a "do pass as amended" recommendation on an 8-1 vote. The measure had a public hearing in the General Government Subcommittee on June 3rd.

The measure has a minimal fiscal impact.
