**Subject:** HB 3234-A -- Work Session Recommendations

## **Background Information**

HB 3234-A establishes the Early Learning Division in the Oregon Department of Education (ODE) and places control of Early Learning Division under the Early Learning Council (ELC), with Early Learning System Director serving as administrative officer. The bill also provides for the transfer of the records and property and has standard transfer language from one agency to another. Programs transferred include (1) the Child Care Office from the Employment Department and the various programs it currently administers, (2) Oregon's Pre-Kindergarten, and Early Head Start programs in ODE, and (3) the various programs currently part of the Governor's Office many of which were programs formally administered by the Commission on Children and Families (e.g. Healthy Start, Crisis Nurseries, Race to the Top federal grant). The bill also establishes a Child Care Office in the new Division for the purpose of administering child care related programs. The ODE budget assumes the passage of this bill.

## **Recommended Changes to HB 3234-A:**

LFO recommends two amendments (A8 & A9) of which it knows about. The A9 amendment includes the following:

- Clarifies ODE's authority for providing criminal background checks for the employees, contractors and activities of the Child Care Office;
- Changes the name of the Child Care Office (CCO) to the Office of Child Care (OCC);
- Requires the Early Learning Division to enter into contracts with relief nurseries beginning in July 2013 to ensure service continuity and efficient delivery of contracted services; and Changes reference from Early Learning Council to Early Learning Division in language relating to contracts at the suggestion of the Department of Justice.

*Please see the attached amendment for the LFO recommend changes to the bill.*

Sen. /Rep. \_\_\_\_\_ moves the -A9 amendment to HB 3234-A.

The -A8 amendment requires the Legislature to identify the portion of the Child Care and Development Block Grant funds will be used for quality, subsidy, and administrative spending and directs the agency to follow that division. The amendment also requires the agency to report to the Legislative Fiscal Office annually on the expenditures of these funds and estimated ending balances.

**WHAT THE MEASURE DOES:** Establishes Early Learning Division in the Department of Education (ODE). Places control of Early Learning Division under Early Learning Council (ELC), with Early Learning System Director Serving as administrative officer. Tasks Early Learning Division with administration of Oregon prekindergarten program. Directs ODE to establish criteria for early childhood education programs governed by federal Individuals With Disabilities Education Act. Directs Early Learning Division to prepare operating guides for child development and teenage parent programs. Requires State Interagency Coordinating Council to submit report to legislature that provides recommendation about appropriate entity to adopt rules and develop policy related to early childhood special education and early intervention services. Establishes in Early Learning Division a Child Care Office responsible for administering federal funds. Changes name from Child Care Division to Child Care Office. Adds one member to State Board of Education who is also a member of the Oregon Education Investment Board. Transfers duties, functions, and powers relating to administration and enforcement of ELC to Early Learning Division of ODE. Gives ELC rulemaking authority to establish percentage for tax credit certified by Child Care Office. Makes ELC state advisory council for federal Head Start Act. Directs ELC to adopt rules for certification of family child care home of not more than 16 children. Directs ELC to adopt rules relating to disbursement of monies in the Child Care Fund. Directs ELC to establish by rule percentage of child care fees charged by participating child care provider to low income families.

**ISSUES DISCUSSED:**

- Relief nurseries
- Purpose of amendment

**EFFECT OF COMMITTEE AMENDMENT:** Transfers duties, functions, and powers relating to administration and enforcement of ELC to Early Learning Division of ODE. Directs Early Learning System Director to deliver to ODE records and property, and to transfer employees necessary to accomplish purposes of Act. Directs Superintendent of Public Instruction to take possession of records and property, and to take charge of employees without reduction in compensation but subject to change or termination. Provides Governor shall resolve any dispute between ELC and ODE relating to transfer. Directs monies authorized for ELC to ODE and retains expenditure classifications. Renames Early Learning Council Fund as Early Learning Division Fund, established in Treasury as distinct and separate from General Fund. Gives ELC rulemaking authority to establish percentage for tax credit certified by Child Care Office. Makes ELC state advisory council for federal Head Start Act. Directs ELC to adopt rules for certification of family child care home of not more than 16 children. Directs ELC to adopt rules relating to disbursement of monies in the Child Care Fund. Directs ELC to establish by rule percentage of child care fees charged by participating child care provider to low income families.

**BACKGROUND:** Research indicates that high-quality, early care and learning experiences are the foundation of educational success and the first line of defense in closing the achievement gap and reducing the dropout rate.

**Local Government Mandate:**

This bill does not affect local governments' service levels or shared revenues sufficient to trigger Section 15, Article XI of the Oregon Constitution.

**Analysis:** This bill creates the Early Learning Division within the Oregon Department of Education (ODE) and transfers the following programs to this new Division from other agencies or from other divisions within ODE:

- Oregon Pre-Kindergarten (OPK), currently in Department of Education
- Oregon Head Start (OHS), currently in Department of Education
- Early Childhood Program (OPK/OHS Administration), currently in Department of Education
- Child Care Administration, currently in Employment Department
- Child Care Licensing, currently in Employment Department

- Child Care Subsidies, currently in Employment Department
- Children, Youth & Families, currently in Governor's Office
- Great Start, currently in Governor's Office
- Healthy Start, currently in Governor's Office
- Basic Capacity, currently in Governor's Office
- Family Preservation, currently in Governor's Office
- Crisis/Relief Nurseries, currently in Governor's Office
- Social Obligation Bonds (POP 302)
- Race to the Top (federal grant), currently in Governor's Office
- Early Learning Council (ELC) Administration
- ELC Grant-in-Aid

The Governor's budget assumes the transfer of the Early Intervention (EI) program and the Early Childhood Special Education (ECSE), both currently in ODE. Further discussion continues but these programs may stay where they currently are in ODE and not transfer to the new Early Learning Division.

The bill also directs the State Board of Education to establish an advisory committee of effected stakeholders including but not limited to; parents, representatives from the health care profession, early childhood education and development, Oregon Head Start Association, school districts, community colleges, and the Early Intervention Council. In addition, the bill establishes the State Interagency Coordinating Council to advise the Superintendent of Public Instruction, the State Board of Education and Early Learning Council on unmet needs in the Early Childhood Special Education and Early Intervention programs for preschool children with disabilities.

The Governor's Budget includes Policy Option Package 501 – Transfer to Early Learning which moves the Early Learning Council and its programs from the Governor's Office and Child care Division from the Employment Department to ODE, Early Learning Division. The package moves all cash/revenue resources and positions to ODE.

28 **as a contractor, subcontractor, vendor or volunteer; and**

29 **“[(2)] (b) Is, or will be, working or providing services in a position:**

30 **“[(a)] (A) In which the person [has] may have unsupervised access to**

1 children;

2 **“(B) In which the person may have contact with recipients of care;**

3 **“[(b)] (C) In which the person has access to confidential or personal in-**  
4 **formation about children, as may be further defined by the State Board of**  
5 **Education by rule;**

6 **“[(c)] (D) In which the person is providing information technology ser-**  
7 **vices and has control over, or access to, information technology systems that**  
8 **would allow the person to harm the information technology systems or the**  
9 **information contained in the systems;**

10 **“[(d)] (E) In which the person has access to information, the disclosure**  
11 **of which is prohibited by state or federal laws, rules or regulations or in-**  
12 **formation that is defined as confidential under state or federal laws, rules**  
13 **or regulations;**

14 **“[(e)] (F) That has payroll functions or in which the person has respon-**  
15 **sibility for receiving, receipting or depositing money or negotiable instru-**  
16 **ments, for billing, collections or other financial transactions or for**  
17 **purchasing or selling property or has access to property held in trust or to**  
18 **private property in the temporary custody of the department;**

19 **“[(f)] (G) That has mailroom duties as the primary duty or job function**  
20 **of the position;**

21 **“[(g)] (H) In which the person has responsibility for auditing the depart-**  
22 **ment;**

23 **“[(h)] (I) That has personnel or human resources functions as one of the**  
24 **position’s primary responsibilities; or**

25 **“[(i)] (J) In which the person has access to personal information about**  
26 **employees or members of the public, including Social Security numbers, dates**  
27 **of birth, driver license numbers, medical information, personal financial in-**  
28 **formation or criminal background information.**

29 **“(3) In addition to the authority granted by subsection (2) of this**  
30 **section and for the purpose of requesting a state or nationwide crimi-**

1 **nal records check under ORS 181.534, the Department of Education**  
2 **may require the fingerprints of a person for the purposes of licensing,**  
3 **certifying, registering or otherwise regulating or administering pro-**  
4 **grams under the authority of the department.**

5 **“(4) The Department of Education may make fitness determinations**  
6 **based on criminal offender records and information furnished by the**  
7 **Federal Bureau of Investigation through the Department of State Po-**  
8 **lice as provided by ORS 181.534.**

9 **“SECTION 80.** ORS 343.499, as amended by section 41, chapter 37, Oregon  
10 Laws 2012, is amended to read:

11 “343.499. (1)(a) There is created the State Interagency Coordinating  
12 Council.

13 “(b) The Governor shall appoint members of the council from a list of  
14 eligible appointees provided by the council and agencies described in sub-  
15 section (2) of this section and shall ensure that the membership of the  
16 council reasonably represents the population of this state.

17 “(c) The Governor shall designate one member of the council to serve as  
18 the chairperson, or if the Governor chooses not to name a chairperson, the  
19 council may elect one of its members to serve as chairperson. However, any  
20 member of the council who represents the Department of Education may not  
21 serve as the chairperson of the council.

22 “(2) The membership of the council shall be composed as follows:

23 “(a) At least 20 percent of the council members shall be parents, including

2 “(c) At least one council member shall be a member of the Legislative  
3 Assembly.

4 “(d) At least one council member shall be involved in personnel prepara-  
5 tion.

6 “(e) At least one council member shall represent the Department of Hu-  
7 man Services.

8 “(f) At least one council member shall represent the federal Head Start  
9 program.

10 “(g) At least one council member shall represent the [*Child Care Division*  
11 *of the Employment Department*] **Office of Child Care.**

12 “(h) At least one council member shall represent the Department of Edu-  
13 cation.

14 “(i) At least one council member shall represent the Department of Con-  
15 sumer and Business Services.

16 “(j) At least one council member shall represent the Early Learning  
17 [*Council*] **Division.**

18 “(k) At least one council member shall represent the Child Development  
19 and Rehabilitation Center of the Oregon Health and Science University.

20 “(L) At least one council member shall be a member of the State Advisory  
21 Council for Special Education created under ORS 343.287.

22 “(m) At least one council member shall be a representative designated by  
23 the state coordinator for homeless education.

24 “(n) At least one council member shall represent the state child welfare  
25 agency responsible for foster care.

26 “(o) At least one council member shall represent the state agency re-  
27 sponsible for children’s mental health.

28 “(p) At least one council member shall be from the Oregon Health Au-  
29 thority.

30 “(q) The council may include other members appointed by the Governor,

1 including but not limited to one representative from the United States Bu-  
2 reau of Indian Affairs or, where there is no school operated or funded by the  
3 bureau, from the Indian Health Service or the tribe or tribal council.

4 “(3) An individual appointed to represent a state agency that is involved  
5 in the provision of or payment for services for preschool children with disa-  
6 bilities under subsection (2)(e) and (h) to (k) of this section shall have suf-  
7 ficient authority to engage in making and implementing policy on behalf of  
8 the agency.

9 “(4) The State Interagency Coordinating Council shall:

10 “(a) Advise the Superintendent of Public Instruction, the State Board of  
11 Education and the Early Learning Council on unmet needs in the early  
12 childhood special education and early intervention programs for preschool  
13 children with disabilities, review and comment publicly on any rules pro-  
14 posed by the State Board of Education and the distribution of funds for the  
15 programs and assist the state in developing and reporting data on and eval-  
16 uations of the programs and services.

17 “(b) Advise and assist the represented public agencies regarding the ser-  
18 vices and programs they provide to preschool children with disabilities and  
19 their families, including public comments on any proposed rules affecting the  
20 target population and the distribution of funds for such services, and assist  
21 each agency in developing services that reflect the overall goals for the  
22 target population as adopted by the council.

23 “(c) Advise and assist the Department of Education and other state  
24 agencies in the development and implementation of the policies that consti-  
25 tute the statewide system.

26 “(d) Assist all appropriate public agencies in achieving the full partic-  
27 ipation, coordination and cooperation for implementation of a statewide  
28 system that includes but is not limited to:

29 “(A) Seeking information from service providers, service coordinators,  
30 parents and others about any federal, state or local policies that impede

1 timely service delivery; and

2 “(B) Taking steps to ensure that any policy problems identified under  
3 subparagraph (A) of this paragraph are resolved.

4 “(e) Advise and assist the Department of Education in identifying the  
5 sources of fiscal and other support for preschool services, assigning financial  
6 responsibility to the appropriate agencies and ensuring that the provisions  
7 of interagency agreements under ORS 343.511 are carried out.

8 “(f) Review and comment on each agency’s services and policies regarding  
9 services for preschool children with disabilities, or preschool children who  
10 are at risk of developing disabling conditions, and their families to the  
11 maximum extent possible to assure cost-effective and efficient use of re-  
12 sources.

13 “(g) To the extent appropriate, assist the Department of Education in the  
14 resolution of disputes.

15 “(h) Advise and assist the Department of Education in the preparation  
16 of applications and amendments thereto.

17 “(i) Advise and assist the Department of Education regarding the transi-  
18 tion of preschool children with disabilities.

19 “(j) Prepare and submit an annual report to the Governor, **the Early**  
20 **Learning System Director, the Early Learning Council, the Legislative**  
21 **Assembly** and [to] the United States Secretary of Education on the status  
22 of early intervention programs operated within this state.

23 “(5) The council may advise appropriate agencies about integration of  
24 services for preschool children with disabilities and at-risk preschool chil-  
25 dren.

26 “(6) Terms of office for council members shall be three years, except that:

27 “(a) The representative from the State Advisory Council for Special Edu-  
28 cation shall serve a one-year term; and

29 “(b) The representatives from other state agencies and the representative  
30 from the Legislative Assembly shall serve indefinite terms.

1       “(7) Subject to approval by the Governor, the council may use federal  
2 funds appropriated for this purpose and available to the council to:

3       “(a) Conduct hearings and forums;

4       “(b) Reimburse nonagency council members under ORS 292.495 for at-  
5 tending council meetings, for performing council duties, and for necessary  
6 expenses, including child care for parent members;

7       “(c) Pay compensation to a council member if the member is not employed  
8 or if the member must forfeit wages from other employment when performing  
9 official council business;

10       “(d) Hire staff; and

11       “(e) Obtain the services of such professional, technical and clerical per-  
12 sonnel as may be necessary to carry out its functions.

13       “(8) Except as provided in subsection (7) of this section, council members  
14 shall serve without compensation.

15       “(9) The Department of Education shall provide clerical and administra-  
16 tive support, including staff, to the council to carry out the performance of  
17 the council’s function as described in this section.

18       “(10) The council shall meet at least quarterly. The meetings shall be  
19 announced publicly and, to the extent appropriate, be open and accessible to  
20 the general public.

21       “(11) No member of the council shall cast a vote on any matter that would  
22 provide direct financial benefit to that member or otherwise give the ap-  
23 pearance of a conflict of interest under state law.

24       “**SECTION 81.** ORS 343.507, as amended by section 42, chapter 37, Oregon  
25 Laws 2012, is amended to read:

26       “343.507. (1) Each contractor for early childhood special education and  
27 early intervention services shall assist in the development of a local early  
28 intervention interagency advisory council in every county within the  
29 contractor’s service area.

30       “(2) Each local early intervention interagency advisory council shall in-

1 clude as members at least 20 percent parents of preschool children with dis-  
2 abilities, 20 percent providers of early childhood special education and early  
3 intervention services or other services to preschool children with disabilities,  
4 a representative of the Early Learning Council and representatives from  
5 public and private agencies that serve young children and their families, in-  
6 cluding but not limited to Head Start and Oregon prekindergartens, commu-  
7 nity child care, the [*Child Care Division of the Employment Department*]  
8 **Office of Child Care**, local school districts, education service districts, De-  
9 partment of Education regional special education programs, community

14 “(3) Each local early intervention interagency advisory council shall se-

18 State Board of Education for seeking and considering local council advice  
19 regarding the selection of contractors, coordination of services and proce-  
20 dures for local resolution of disputes.

21 **“SECTION 82.** ORS 419B.005, as amended by section 60, chapter 37,  
22 Oregon Laws 2012, and section 1, chapter 92, Oregon Laws 2012, is amended  
23 to read:

24 “419B.005. As used in ORS 419B.005 to 419B.050, unless the context re-  
25 quires otherwise:

26 “(1)(a) ‘Abuse’ means:

27 “(A) Any assault, as defined in ORS chapter 163, of a child and any  
28 physical injury to a child which has been caused by other than accidental  
29 means, including any injury which appears to be at variance with the ex-  
30 planation given of the injury.



1       “(B) Any mental injury to a child, which shall include only observable  
2 and substantial impairment of the child’s mental or psychological ability to  
3 function caused by cruelty to the child, with due regard to the culture of the  
4 child.

5       “(C) Rape of a child, which includes but is not limited to rape, sodomy,  
6 unlawful sexual penetration and incest, as those acts are described in ORS  
7 chapter 163.

8       “(D) Sexual abuse, as described in ORS chapter 163.

9       “(E) Sexual exploitation, including but not limited to:

10       “(i) Contributing to the sexual delinquency of a minor, as defined in ORS  
11 chapter 163, and any other conduct which allows, employs, authorizes, per-  
12 mits, induces or encourages a child to engage in the performing for people  
13 to observe or the photographing, filming, tape recording or other exhibition  
14 which, in whole or in part, depicts sexual conduct or contact, as defined in  
15 ORS 167.002 or described in ORS 163.665 and 163.670, sexual abuse involving  
16 a child or rape of a child, but not including any conduct which is part of  
17 any investigation conducted pursuant to ORS 419B.020 or which is designed  
18 to serve educational or other legitimate purposes; and

19       “(ii) Allowing, permitting, encouraging or hiring a child to engage in  
20 prostitution or to patronize a prostitute, as defined in ORS chapter 167.

21       “(F) Negligent treatment or maltreatment of a child, including but not  
22 limited to the failure to provide adequate food, clothing, shelter or medical  
23 care that is likely to endanger the health or welfare of the child.

24       “(G) Threatened harm to a child, which means subjecting a child to a  
25 substantial risk of harm to the child’s health or welfare.

26       “(H) Buying or selling a person under 18 years of age as described in ORS  
27 163.537.

28       “(I) Permitting a person under 18 years of age to enter or remain in or  
29 upon premises where methamphetamines are being manufactured.

30       “(J) Unlawful exposure to a controlled substance, as defined in ORS

1 475.005, that subjects a child to a substantial risk of harm to the child's  
2 health or safety.

3 “(b) ‘Abuse’ does not include reasonable discipline unless the discipline  
4 results in one of the conditions described in paragraph (a) of this subsection.

5 “(2) ‘Child’ means an unmarried person who is under 18 years of age.

6 “(3) ‘Higher education institution’ means:

7 “(a) A community college as defined in ORS 341.005;

8 “(b) A public university listed in ORS 352.002;

9 “(c) The Oregon Health and Science University; and

10 “(d) A private institution of higher education located in Oregon.

11 “(4) ‘Law enforcement agency’ means:

12 “(a) A city or municipal police department.

13 “(b) A county sheriff's office.

14 “(c) The Oregon State Police.

15 “(d) A police department established by a university under ORS 352.383.

16 “(e) A county juvenile department.

17 “(5) ‘Public or private official’ means:

18 “(a) Physician, osteopathic physician, physician assistant, naturopathic  
19 physician, podiatric physician and surgeon, including any intern or resident.

20 “(b) Dentist.

21 “(c) School employee, including an employee of a higher education insti-  
22 tution.

23 “(d) Licensed practical nurse, registered nurse, nurse practitioner, nurse's  
24 aide, home health aide or employee of an in-home health service.

25 “(e) Employee of the Department of Human Services, Oregon Health Au-  
26 thority, Early Learning [*Council*] **Division**, Youth Development Council,  
27 [*Child Care Division of the Employment Department*] **Office of Child Care**,  
28 the Oregon Youth Authority, a county health department, a community  
29 mental health program, a community developmental disabilities program, a  
30 county juvenile department, a licensed child-caring agency or an alcohol and

1 drug treatment program.

2 “(f) Peace officer.

3 “(g) Psychologist.

4 “(h) Member of the clergy.

5 “(i) Regulated social worker.

6 “(j) Optometrist.

7 “(k) Chiropractor.

8 “(L) Certified provider of foster care, or an employee thereof.

9 “(m) Attorney.

10 “(n) Licensed professional counselor.

11 “(o) Licensed marriage and family therapist.

12 “(p) Firefighter or emergency medical services provider.

13 “(q) A court appointed special advocate, as defined in ORS 419A.004.

14 “(r) A child care provider registered or certified under ORS 657A.030 and  
15 657A.250 to 657A.450.

16 “(s) Member of the Legislative Assembly.

17 “(t) Physical, speech or occupational therapist.

18 “(u) Audiologist.

19 “(v) Speech-language pathologist.

20 “(w) Employee of the Teacher Standards and Practices Commission di-  
21 rectly involved in investigations or discipline by the commission.

22 “(x) Pharmacist.

23 “(y) An operator of a preschool recorded program under ORS 657A.255.

24 “(z) An operator of a school-age recorded program under ORS 657A.257.

25 “(aa) Employee of a private agency or organization facilitating the pro-  
26 vision of respite services, as defined in ORS 418.205, for parents pursuant to  
27 a properly executed power of attorney under ORS 109.056.

28 “(bb) Employee of a public or private organization providing child-related  
29 services or activities:

30 “(A) Including but not limited to youth groups or centers, scout groups

1 or camps, summer or day camps, survival camps or groups, centers or camps  
2 that are operated under the guidance, supervision or auspices of religious,  
3 public or private educational systems or community service organizations;  
4 and

5 “(B) Excluding community-based, nonprofit organizations whose primary  
6 purpose is to provide confidential, direct services to victims of domestic vi-  
7 olence, sexual assault, stalking or human trafficking.

8 “(cc) A coach, assistant coach or trainer of an amateur, semiprofessional  
9 or professional athlete, if compensated and if the athlete is a child.

10 **“SECTION 83.** ORS 419B.020 is amended to read:

11 “419B.020. (1) If the Department of Human Services or a law enforcement  
12 agency receives a report of child abuse, the department or the agency shall  
13 immediately:

14 “(a) Cause an investigation to be made to determine the nature and cause  
15 of the abuse of the child; and

16 “(b) Notify the **Office of Child Care** [*Division*] if the alleged child abuse  
17 occurred in a child care facility as defined in ORS 657A.250.

18 “(2) If the abuse reported in subsection (1) of this section is alleged to  
19 have occurred at a child care facility:

20 “(a) The department and the law enforcement agency shall jointly deter-  
21 mine the roles and responsibilities of the department and the agency in their  
22 respective investigations; and

23 “(b) The department and the agency shall each report the outcomes of  
24 their investigations to the **Office of Child Care** [*Division*].

25 “(3) If the law enforcement agency conducting the investigation finds  
26 reasonable cause to believe that abuse has occurred, the law enforcement  
27 agency shall notify by oral report followed by written report the local office  
28 of the department. The department shall provide protective social services  
29 of its own or of other available social agencies if necessary to prevent fur-  
30 ther abuses to the child or to safeguard the child’s welfare.

1       “(4) If a child is taken into protective custody by the department, the  
2 department shall promptly make reasonable efforts to ascertain the name and  
3 address of the child’s parents or guardian.

4       “(5)(a) If a child is taken into protective custody by the department or a  
5 law enforcement official, the department or law enforcement official shall,  
6 if possible, make reasonable efforts to advise the parents or guardian imme-  
7 diately, regardless of the time of day, that the child has been taken into  
8 custody, the reasons the child has been taken into custody and general in-  
9 formation about the child’s placement, and the telephone number of the local  
10 office of the department and any after-hours telephone numbers.

11       “(b) Notice may be given by any means reasonably certain of notifying  
12 the parents or guardian, including but not limited to written, telephonic or  
13 in-person oral notification. If the initial notification is not in writing, the  
14 information required by paragraph (a) of this subsection also shall be pro-  
15 vided to the parents or guardian in writing as soon as possible.

16       “(c) The department also shall make a reasonable effort to notify the  
17 noncustodial parent of the information required by paragraph (a) of this  
18 subsection in a timely manner.

19       “(d) If a child is taken into custody while under the care and supervision  
20 of a person or organization other than the parent, the department, if possible,  
21 shall immediately notify the person or organization that the child has been  
22 taken into protective custody.

23       “(6) If a law enforcement officer or the department, when taking a child  
24 into protective custody, has reasonable cause to believe that the child has  
25 been affected by sexual abuse and rape of a child as defined in ORS 419B.005  
26 (1)(a)(C) and that physical evidence of the abuse exists and is likely to dis-  
27 appear, the court may authorize a physical examination for the purposes of  
28 preserving evidence if the court finds that it is in the best interest of the  
29 child to have such an examination. Nothing in this section affects the au-  
30 thority of the department to consent to physical examinations of the child

1 at other times.

2 “(7) A minor child of 12 years of age or older may refuse to consent to  
3 the examination described in subsection (6) of this section. The examination  
4 shall be conducted by or under the supervision of a physician licensed under  
5 ORS chapter 677 or a nurse practitioner licensed under ORS chapter 678 and,  
6 whenever practicable, trained in conducting such examinations.

7 “(8) When the department completes an investigation under this section,  
8 if the person who made the report of child abuse provided contact informa-  
9 tion to the department, the department shall notify the person about whether  
10 contact with the child was made, whether the department determined that  
11 child abuse occurred and whether services will be provided. The department

17 “419B.035. (1) Notwithstanding the provisions of ORS 192.001 to 192.170,

19 cessibility for public inspection of public records and public documents, re-  
20 ports and records compiled under the provisions of ORS 419B.010 to 419B.050

30 “(d) Citizen review boards established by the Judicial Department for the

1 purpose of periodically reviewing the status of children, youths and youth  
2 offenders under the jurisdiction of the juvenile court under ORS 419B.100  
3 and 419C.005. Citizen review boards may make such records available to  
4 participants in case reviews;

5 “(e) A court appointed special advocate in any juvenile court proceeding  
6 in which it is alleged that a child has been subjected to child abuse or neg-  
7 lect;

8 “(f) The **Office of Child Care** [*Division*] for certifying, registering or  
9 otherwise regulating child care facilities;

10 “(g) The Office of Children’s Advocate;

11 “(h) The Teacher Standards and Practices Commission for investigations  
12 conducted under ORS 342.176 involving any child or any student in grade 12  
13 or below;

14 “(i) Any person, upon request to the Department of Human Services, if  
15 the reports or records requested regard an incident in which a child, as the  
16 result of abuse, died or suffered serious physical injury as defined in ORS  
17 161.015. Reports or records disclosed under this paragraph must be disclosed  
18 in accordance with ORS 192.410 to 192.505; and

19 “(j) The [*Child Care Division of the Employment Department*] **Office of**  
20 **Child Care** for purposes of ORS 657A.030 (8)(g).

21 “(2)(a) When disclosing reports and records pursuant to subsection (1)(i)  
22 of this section, the Department of Human Services may exempt from dislo-  
23 sure the names, addresses and other identifying information about other  
24 children, witnesses, victims or other persons named in the report or record  
25 if the department determines, in written findings, that the safety or well-  
26 being of a person named in the report or record may be jeopardized by dis-  
27 closure of the names, addresses or other identifying information, and if that  
28 concern outweighs the public’s interest in the disclosure of that information.

29 “(b) If the Department of Human Services does not have a report or re-  
30 cord of abuse regarding a child who, as the result of abuse, died or suffered

1 serious physical injury as defined in ORS 161.015, the department may dis-  
2 close that information.

3 “(3) The Department of Human Services may make reports and records  
4 compiled under the provisions of ORS 419B.010 to 419B.050 available to any  
5 person, administrative hearings officer, court, agency, organization or other  
6 entity when the department determines that such disclosure is necessary to  
7 administer its child welfare services and is in the best interests of the af-  
8 fected child, or that such disclosure is necessary to investigate, prevent or  
9 treat child abuse and neglect, to protect children from abuse and neglect or  
10 for research when the Director of Human Services gives prior written ap-  
11 proval. The Department of Human Services shall adopt rules setting forth the  
12 procedures by which it will make the disclosures authorized under this sub-  
13 section or subsection (1) or (2) of this section. The name, address and other  
14 identifying information about the person who made the report may not be  
15 disclosed pursuant to this subsection and subsection (1) of this section.

16 “(4) A law enforcement agency may make reports and records compiled  
17 under the provisions of ORS 419B.010 to 419B.050 available to other law  
18 enforcement agencies, district attorneys, city attorneys with criminal  
19 prosecutorial functions and the Attorney General when the law enforcement  
20 agency determines that disclosure is necessary for the investigation or  
21 enforcement of laws relating to child abuse and neglect.

22 “(5) A law enforcement agency, upon completing an investigation and  
23 closing the file in a specific case relating to child abuse or neglect, shall  
24 make reports and records in the case available upon request to any law  
25 enforcement agency or community corrections agency in this state, to the  
26 Department of Corrections or to the State Board of Parole and Post-Prison  
27 Supervision for the purpose of managing and supervising offenders in custody  
28 or on probation, parole, post-prison supervision or other form of conditional  
29 or supervised release. A law enforcement agency may make reports and re-  
30 cords compiled under the provisions of ORS 419B.010 to 419B.050 available



1 to law enforcement, community corrections, corrections or parole agencies

3 closure will not interfere with an ongoing investigation in the case. The

7 “(6)(a) Any record made available to a law enforcement agency or com-

11 kept confidential by the agency, department, board or physician. Any record  
12 or report disclosed by the Department of Human Services to other persons  
13 or entities pursuant to subsections (1) and (3) of this section shall be kept  
14 confidential.

15 “(b) Notwithstanding paragraph (a) of this subsection:

16 “(A) A law enforcement agency, a community corrections agency, the  
17 Department of Corrections and the State Board of Parole and Post-Prison  
18 Supervision may disclose records made available to them under subsection  
19 (5) of this section to each other, to law enforcement, community corrections,  
20 corrections and parole agencies of other states and to authorized treatment  
21 providers for the purpose of managing and supervising offenders in custody  
22 or on probation, parole, post-prison supervision or other form of conditional  
23 or supervised release.

24 “(B) A person may disclose records made available to the person under  
25 subsection (1)(i) of this section if the records are disclosed for the purpose

27 “(7) An officer or employee of the Department of Human Services or of  
28 a law enforcement agency or any person or entity to whom disclosure is  
29 made pursuant to subsections (1) to (6) of this section may not release any  
30 information not authorized by subsections (1) to (6) of this section.

1       “(8) As used in this section, ‘law enforcement agency’ has the meaning  
2 given that term in ORS 181.010.

3       “(9) A person who violates subsection (6)(a) or (7) of this section commits  
4 a Class A violation.

7       “(1) ‘Commercial user’ means any person, firm, corporation, association  
8 or nonprofit corporation, or any agent or employee thereof, including child

10 **of Child Care** [*Division*] under ORS 657A.250 to 657A.450, who:
