Subject: HB 2323-A – Repeals sunset of the Oregon Growth Board and transfers Oregon Growth Account to the Oregon Growth Board Work Session Recommendations

During the 2012 session the Legislature passed HB 4040, which established the Oregon Growth Board with a June 30, 2013 sunset date. HB 2323-A abolishes the sunset, and thereby allows a number of provisions approved in HB 4040 to become operative.

These provisions establish the Oregon Growth Fund (OGF), establish authority for the Oregon Growth Board to manage the Oregon Growth Fund, and transfer management of the Oregon Growth Account (OGA) from the State Treasurer to the Oregon Growth Board. The provisions authorize the Board to use the Oregon Growth Fund to encourage investment in and availability of capital to instate businesses and to increase resources available to further economic development; and to use OGF monies to make investments in, and provide loans or grants to, businesses to promote economic development. The allowable use of OGA funds, currently restricted to making investments in or providing seed capital for emerging growth businesses, are expanded to include the allowable uses for Oregon Growth Fund monies, excluding the making of grants.

The measure, the original staff measure summary, and previously-released fiscal impact statement are available on the Oregon Legislative Information System (OLIS) and are attached to the memorandum.

The Transportation and Economic Development Subcommittee held a public hearing on HB 2323-A on 5/7/13.

Amendment

The Legislative Fiscal Office recommends adoption of the HB 2323-A4 amendments. The amendments allocate \$1,900,000 Lottery Funds to the Oregon Growth Fund, allocate \$100,000 of Lottery Funds to the Oregon Business Development Department (OBDD) for administrative costs associated with providing staff support to the Oregon Growth Board, and establish a \$100,000 Lottery Funds expenditure limitation in the OBDD budget for the program. OBDD's expenses include the addition of one half-time Operations & Policy Analyst 4 position (0.50 FTE), and \$9,489 for services and

supplies. The Legislative Fiscal Office notes that the allocation of Lottery Funds to the Oregon Growth Fund is provided on a one-biennium basis, and the allocation will be phased-out in the development of the 2015-17 biennium current service level. If additional allocation to the Oregon Growth Fund is requested for the 2015-17 biennium, the request shall be included in a policy option package.

The amendments additionally repeal a requirement for the Oregon Growth Board to contract with management companies to manage all of the funds in the Oregon Growth Account and the Oregon Growth Fund. Instead, the Oregon Growth Board will be allowed to do so, or to contract with state agencies, but will not be so required.

The amendments also correct the operative dates of certain sections of the bill, and add language to prevent the lapse of provisions before they become operative, to permit the sunset repeal to come into effect without complications.

Motion #1: Move the –A4 amendments to HB 2323-A.

Budget Note

Under the provisions of HB 2323-A with the –A4 amendments, the Oregon Growth Board is projected to have access to approximately \$26 million of uncommitted funds in the Oregon Growth Account, and to \$1.9 million of uncommitted funds in the Oregon Growth Fund, for management during the 2013-15 biennium. The Legislative Fiscal Office recommends adoption of the following budget note relating to the management of those funds:

Budget Note

The Oregon Growth Board shall adopt investment policy statements for management of the Oregon Growth Account and the Oregon Growth Fund. The Board shall report on these statements and include information on how the Board will measure the performance of investments and allocations approved by the Board, and the performance targets proposed by the Board. The report shall be submitted to the Joint Committee on Ways and Means, and to the committees of the Legislative Assembly with authority over the subject area of economic development, for their consideration during the 2014 regular session.

Motion #2: Move the LFO recommended budget note.

Measure Description:

Removes the sunset on the Oregon Growth Board.

Government Unit(s) Affected:

Business Development Department (Business Oregon), Oregon State Treasurer

Local Government Mandate:

This bill does not affect local governments' service levels or shared revenues sufficient to trigger Section 15, Article XI of the Oregon Constitution.

Analysis:

This fiscal impact statement is for the purpose of transmitting this measure from the House Committee on Transportation and Economic Development to the Joint Committee on Ways and Means.

The bill removes the sunset on the Oregon Growth Board. The bill directs the Oregon Growth Board to use moneys in the Oregon Growth Fund to make, purchase, guarantee or hold grants and loans to further economic development in Oregon, including but not limited to traded sector businesses, businesses in the initial and follow-up phases of development, and businesses in the rural regions of Oregon. The bill provides for the funds in the Oregon Growth Account to be used to make, purchase, guarantee, or hold loans for the purpose of earning returns to the Education Stability Fund. The bill allows the board to use moneys in the Oregon Growth Account to pay the administrative costs. The Oregon Growth Board is directed to adopt rules that specify the board's permissible investments, and the activities and services in which the board may engage or provide. The board is to provide a means to evaluate the performance of investments, and report to the Legislature regarding the implementation and administration of the Oregon Growth Board and investments made by the board. Certain sections of the bill become operative on the 91st day after the date on which the 2013 legislative session adjourns sine die. The bill contains an emergency clause and takes effect on passage.

Further Analysis Required

The bill is anticipated to have a fiscal impact on the Business Development Department (Business Oregon), and the Oregon State Treasurer. The full impact is still being determined. A more complete fiscal analysis on the bill will be prepared as the measure is considered in the Joint Committee on Ways and Means.

WHAT THE MEASURE DOES: Establishes Oregon Growth Board Task Force. Specifies 10 member task force including: two appointees from the Senate President; two appointees from the Speaker of the House; four appointees from the Governor with one from banking, one from credit unions, one from managing investments, and one with small business employment experience; one appointee from the Treasurer’s Office; and one appointee from the Oregon Business Development Department; Requires the task force to make recommendations to the Legislative Assembly regarding the formation, functions, duties, and powers of the Oregon Growth Board (renamed from the Oregon Growth Account Board; Adds the Fund to those funds that are not required to have the Oregon Innovation Council’s review policies for investment funds; Stipulates that the Oregon Business Development Department shall provide staff support to the task force ; Repeals sections related to the abolishment and sunset date of the Oregon Growth Board.

ISSUES DISCUSSED:

- Relationship between access to capital and economic recovery
- Importance of access to capital for small businesses
- Benefit to rural economies where the unemployment rate remains high
- Need for state to be active partner in growth objectives
- Need to remove sunset provision in the Oregon Investment Act
- Need to support overarching strategy for investing across business life-cycle
- Need to balance drive for financial returns with creating sustainable high-wage jobs
- Need to create Oregon Growth Fund with different funding sources and disbursement obligations than Oregon Growth Account
- Need to provide the Board with allocation authority
- Importance of confirming that Board will neither invest in any specific project or company, nor compete with private capital resources
- \$35 million allocation to start the Oregon Growth Fund

EFFECT OF COMMITTEE AMENDMENT: Legislative intent and goals of the Oregon Growth Board (the Board) are expanded upon to include objectives to encourage investment and capital availability through all stages of business life cycle, particularly in the traded sector and rural Oregon. The Board duties, functions and powers are specified in greater detail regarding investment and management of the Oregon Growth Fund (the Fund) and the Oregon Growth Account (the Account). Returns earned through the Account are designated for the Education Stability Fund. Management of the Fund is specified to include competitive grants and loans for economic development.

The Board is directed to collaborate with local governments, state agencies, financial institutions and private entities and to delegate any duties or powers to those entities that they are authorized to perform. In addition, the Board is to solicit, obtain and accept local, state, federal and private resources and donations for deposit into the Account and the Fund. Requirements for Board rules are expanded to specify permissible investments and activities , create guidelines for the amount of leverage to maximize investments, provide a performance evaluation framework and methodology, and report biennially to interim committees related to business and economic development.

This summary has not been adopted or officially endorsed by action of the committee.

The Board is to serve in an advisory capacity to the Legislature and make recommendations regarding appropriation of moneys to the Fund, tax modifications designed to promote private investment in the Fund, incentive programs for private sector investment, and Account management policy to earn returns for the Education Stability Fund. Board members are required to submit an annual Statement of Economic Interest. The Board member serving on the Oregon Innovation Council is no longer required to have experience in the field of venture capital. Board administrative costs may be covered through the Account.

BACKGROUND: The Oregon Investment Act, established with enactment of House Bill 4040, was an effort to capitalize on the opportunity to dramatically improve the state's efforts to attract and improve the availability of capital to help catalyze economic development across the state.

While Oregon can point to some notable success stories around capital deployment, many of the state's efforts have been limited and fragmented – a study shows those efforts have fallen short of helping employers across the business spectrum overcome a series of capital gaps. At the same time, the private sector alone has not been able to sufficiently address this capital need for Oregon businesses.

The Investment Act opened the door for Oregon to establish a new framework to address our shortcomings by being more strategic in deploying public resources, in concert with leveraged funding from private investors. Oregon is not unique in looking at new models that help local businesses attract private capital: at least 30 other states have varying investment models that help them assist businesses, particularly in supporting business formation and growth capital.

This new strategy requires an innovative vision regarding capital deployment that brings together the strengths of the public and private sector. It requires clear objectives and safeguards, and a clear methodology to measure results. It requires the private sector to assume a substantial amount of risk. Finally, it requires willingness by government to consolidate disparate economic development dollars, and to collaborate to advance the best opportunities for job and wage growth.

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

[Establishes Oregon Growth Board Task Force. Sunsets task force on June 30, 2015.]

Makes duties, functions and powers of Oregon Growth Board operative January 1, 2014. Establishes Oregon Growth Fund operative January 1, 2014.

Abolishes Oregon Growth Account Board and transfers duties, functions and powers of Oregon Growth Account Board to Oregon Growth Board operative January 1, 2014. Repeals former sunset and repeal provisions relating to Oregon Growth Board and Oregon Growth Fund that were to take effect on June 30, 2013.

Requires Oregon Growth Board to adopt rules that provide means of evaluating performance of investments. Requires board to report annually to Legislative Assembly regarding implementation and administration of board and investments made by board.

Authorizes Oregon Growth Board to use moneys in Oregon Growth Account to pay administrative costs associated with account and with administering duties, functions and powers of board.

Provides that certain amendments to statutes become operative on 91st day after adjournment sine die.

Declares emergency, effective on passage.

39 seek to exempt the judge's or district attorney's address or telephone number, or both, under the
40 terms of ORS 192.445;

41 (b) Does not apply to employees or volunteers to the extent that the party seeking disclosure
42 shows by clear and convincing evidence that the public interest requires disclosure in a particular
43 instance;

44 (c) Does not apply to a substitute teacher as defined in ORS 342.815 when requested by a pro-
45 fessional education association of which the substitute teacher may be a member; and

1 (d) Does not relieve a public employer of any duty under ORS 243.650 to 243.782.

2 (4) Information submitted to a public body in confidence and not otherwise required by law to
3 be submitted, where such information should reasonably be considered confidential, the public body
4 has obliged itself in good faith not to disclose the information, and when the public interest would
5 suffer by the disclosure.

6 (5) Information or records of the Department of Corrections, including the State Board of Parole
7 and Post-Prison Supervision, to the extent that disclosure would interfere with the rehabilitation of
8 a person in custody of the department or substantially prejudice or prevent the carrying out of the
9 functions of the department, if the public interest in confidentiality clearly outweighs the public in-
10 terest in disclosure.

11 (6) Records, reports and other information received or compiled by the Director of the Depart-
12 ment of Consumer and Business Services in the administration of ORS chapters 723 and 725 not
13 otherwise required by law to be made public, to the extent that the interests of lending institutions,
14 their officers, employees and customers in preserving the confidentiality of such information out-
15 weighs the public interest in disclosure.

16 (7) Reports made to or filed with the court under ORS 137.077 or 137.530.

17 (8) Any public records or information the disclosure of which is prohibited by federal law or
18 regulations.

19 (9)(a) Public records or information the disclosure of which is prohibited or restricted or other-
20 wise made confidential or privileged under Oregon law.

21 (b) Subject to ORS 192.423, paragraph (a) of this subsection does not apply to factual information
22 compiled in a public record when:

23 (A) The basis for the claim of exemption is ORS 40.225;

24 (B) The factual information is not prohibited from disclosure under any applicable state or fed-
25 eral law, regulation or court order and is not otherwise exempt from disclosure under ORS 192.410
26 to 192.505;

27 (C) The factual information was compiled by or at the direction of an attorney as part of an
28 investigation on behalf of the public body in response to information of possible wrongdoing by the
29 public body;

30 (D) The factual information was not compiled in preparation for litigation, arbitration or an
31 administrative proceeding that was reasonably likely to be initiated or that has been initiated by
32 or against the public body; and

33 (E) The holder of the privilege under ORS 40.225 has made or authorized a public statement
34 characterizing or partially disclosing the factual information compiled by or at the attorney's di-
35 rection.

36 (10) Public records or information described in this section, furnished by the public body ori-
37 ginally compiling, preparing or receiving them to any other public officer or public body in con-
38 nection with performance of the duties of the recipient, if the considerations originally giving rise
39 to the confidential or exempt nature of the public records or information remain applicable.

40 (11) Records of the Energy Facility Siting Council concerning the review or approval of security
41 programs pursuant to ORS 469.530.

42 (12) Employee and retiree address, telephone number and other nonfinancial membership records
43 and employee financial records maintained by the Public Employees Retirement System pursuant to
44 ORS chapters 238 and 238A.

45 (13) Records of or submitted to the State Treasurer, the Oregon Investment Council or the

1 agents of the treasurer or the council relating to active or proposed publicly traded investments
2 under ORS chapter 293, including but not limited to records regarding the acquisition, exchange or
3 liquidation of the investments. For the purposes of this subsection:

4 (a) The exemption does not apply to:

5 (A) Information in investment records solely related to the amount paid directly into an invest-
6 ment by, or returned from the investment directly to, the treasurer or council; or

7 (B) The identity of the entity to which the amount was paid directly or from which the amount
8 was received directly.

9 (b) An investment in a publicly traded investment is no longer active when acquisition, exchange
10 or liquidation of the investment has been concluded.

11 (14)(a) Records of or submitted to the State Treasurer, the Oregon Investment Council, the
12 Oregon Growth [*Account*] Board or the agents of the treasurer, council or board relating to actual
13 or proposed investments under ORS chapter 293 or 348 in a privately placed investment fund or a
14 private asset including but not limited to records regarding the solicitation, acquisition, deployment,
15 exchange or liquidation of the investments including but not limited to:

16 (A) Due diligence materials that are proprietary to an investment fund, to an asset ownership
17 or to their respective investment vehicles.

18 (B) Financial statements of an investment fund, an asset ownership or their respective invest-
19 ment vehicles.

20 (C) Meeting materials of an investment fund, an asset ownership or their respective investment
21 vehicles.

22 (D) Records containing information regarding the portfolio positions in which an investment
23 fund, an asset ownership or their respective investment vehicles invest.

24 (E) Capital call and distribution notices of an investment fund, an asset ownership or their re-
25 spective investment vehicles.

26 (F) Investment agreements and related documents.

27 (b) The exemption under this subsection does not apply to:

28 (A) The name, address and vintage year of each privately placed investment fund.

29 (B) The dollar amount of the commitment made to each privately placed investment fund since
30 inception of the fund.

31 (C) The dollar amount of cash contributions made to each privately placed investment fund since
32 inception of the fund.

33 (D) The dollar amount, on a fiscal year-end basis, of cash distributions received by the State
34 Treasurer, the Oregon Investment Council, the Oregon Growth [*Account*] Board or the agents of the
35 treasurer, council or board from each privately placed investment fund.

36 (E) The dollar amount, on a fiscal year-end basis, of the remaining value of assets in a privately
37 placed investment fund attributable to an investment by the State Treasurer, the Oregon Investment
38 Council, the Oregon Growth [*Account*] Board or the agents of the treasurer, council or board.

39 (F) The net internal rate of return of each privately placed investment fund since inception of
40 the fund.

41 (G) The investment multiple of each privately placed investment fund since inception of the fund.

42 (H) The dollar amount of the total management fees and costs paid on an annual fiscal year-end
43 basis to each privately placed investment fund.

44 (I) The dollar amount of cash profit received from each privately placed investment fund on a
45 fiscal year-end basis.

1 (15) The monthly reports prepared and submitted under ORS 293.761 and 293.766 concerning the
2 Public Employees Retirement Fund and the Industrial Accident Fund may be uniformly treated as
3 exempt from disclosure for a period of up to 90 days after the end of the calendar quarter.

4 (16) Reports of unclaimed property filed by the holders of such property to the extent permitted
5 by ORS 98.352.

6 (17)(a) The following records, communications and information submitted to the Oregon Business
7 Development Commission, the Oregon Business Development Department, the State Department of

9 ORS 777.005, or a county or city governing body and any board, department, commission, council
10 or agency thereof, by applicants for investment funds, grants, loans, services or economic develop-

14 (C) Customer lists.

15 (D) Information of an applicant pertaining to litigation to which the applicant is a party if the

18 concluded, and nothing in this subparagraph shall limit any right or opportunity granted by discov-

32 ery or deposition statutes to a party to litigation or potential litigation.

36 (18) Records, reports or returns submitted by private concerns or enterprises required by law
37 to be submitted to or inspected by a governmental body to allow it to determine the amount of any

39 information is in a form which would permit identification of the individual concern or enterprise.
40 Nothing in this subsection shall limit the use which can be made of such information for regulatory
41 purposes or its admissibility in any enforcement proceedings. The public body shall notify the tax-
42 payer of the delinquency immediately by certified mail. However, in the event that the payment or
43 delivery of transient lodging taxes otherwise due to a public body is delinquent by over 60 days, the

31 (c) Project appraisals.

32 (d) Market studies and analyses.

33 (e) Articles of incorporation, partnership agreements and operating agreements.

34 (f) Commitment letters.

35 (g) Project pro forma statements.

36 (h) Project cost certifications and cost data.

37 (i) Audits.

38 (j) Project tenant correspondence.

39 (k) Personal information about a tenant.

40 (L) Housing assistance payments.

41 (25) Raster geographic information system (GIS) digital databases, provided by private forestland
42 owners or their representatives, voluntarily and in confidence to the State Forestry Department,
43 that is not otherwise required by law to be submitted.

44 (26) Sensitive business, commercial or financial information furnished to or developed by a
45 public body engaged in the business of providing electricity or electricity services, if the information

1 is directly related to a transaction described in ORS 261.348, or if the information is directly related
2 to a bid, proposal or negotiations for the sale or purchase of electricity or electricity services, and
3 disclosure of the information would cause a competitive disadvantage for the public body or its re-
4 tail electricity customers. This subsection does not apply to cost-of-service studies used in the de-
5 velopment or review of generally applicable rate schedules.

6 (27) Sensitive business, commercial or financial information furnished to or developed by the
7 City of Klamath Falls, acting solely in connection with the ownership and operation of the Klamath
8 Cogeneration Project, if the information is directly related to a transaction described in ORS 225.085
9 and disclosure of the information would cause a competitive disadvantage for the Klamath
10 Cogeneration Project. This subsection does not apply to cost-of-service studies used in the develop-
11 ment or review of generally applicable rate schedules.

12 (28) Personally identifiable information about customers of a municipal electric utility or a
13 people's utility district or the names, dates of birth, driver license numbers, telephone numbers,
14 electronic mail addresses or Social Security numbers of customers who receive water, sewer or
15 storm drain services from a public body as defined in ORS 174.109. The utility or district may re-
16 lease personally identifiable information about a customer, and a public body providing water, sewer
17 or storm drain services may release the name, date of birth, driver license number, telephone num-
18 ber, electronic mail address or Social Security number of a customer, if the customer consents in
19 writing or electronically, if the disclosure is necessary for the utility, district or other public body
20 to render services to the customer, if the disclosure is required pursuant to a court order or if the
21 disclosure is otherwise required by federal or state law. The utility, district or other public body

33 or subsidiaries under ORS 86A.095 to 86A.198, 697.005 to 697.095, 697.602 to 697.842, 705.137, 717.200
34 to 717.320, 717.900 or 717.905, ORS chapter 59, 723, 725 or 726, the Bank Act or the Insurance Code
35 when:

36 (a) The document, material or other information is received upon notice or with an under-
37 standing that it is confidential or privileged under the laws of the jurisdiction that is the source of
38 the document, material or other information; and

39 (b) The director has obligated the Department of Consumer and Business Services not to dis-
40 close the document, material or other information.

41 (32) A county elections security plan developed and filed under ORS 254.074.

42 (33) Information about review or approval of programs relating to the security of:

2 (D) Petroleum products;

5 (b) Telecommunication systems, including cellular, wireless or radio systems.

6 (c) Data transmissions by whatever means provided.

7 (34) The information specified in ORS 25.020 (8) if the Chief Justice of the Supreme Court des-

40 (b) Five members appointed by the Governor who are engaged in the operations of Oregon
41 traded sector industries or Oregon growth businesses.

42 (c) One member appointed by the Governor who is a representative of an Oregon-based, gener-
43 ally accredited, not-for-profit private institution of higher education.

44 (d) A member of the Oregon Growth [Account] Board, appointed by the board[, *who has experi-*
45 *ence in the field of venture capital*].

1 (e) A member of the Engineering and Technology Industry Council, appointed by the Engineer-
2 ing and Technology Industry Council.

3 (f) The Director of the Oregon Business Development Department.

4 (g) The Chancellor of the Oregon University System.

5 (h) The Commissioner for Community College Services.

6 (i) The State Treasurer.

7 (2)(a) The Speaker of the House of Representatives shall appoint two members to the council
8 who are members of the House of Representatives.

9 (b) The President of the Senate shall appoint two members to the council who are members of
10 the Senate.

11 (c) Members of the Legislative Assembly appointed to the council are nonvoting members and
12 may act in an advisory capacity only.

13 (3) The following persons, or their representatives, shall serve as ex officio, nonvoting members
14 of the council:

15 (a) The presiding officer of the Oregon Business Development Commission.

16 (b) The president of the State Board of Higher Education.

17 (c) The chairperson of the State Board of Education.

18 (d) An executive officer of an association representing Oregon-based, generally accredited, not-
19 for-profit private institutions of higher education, appointed by the Governor.

20 (4) The term of office of each appointed voting member of the council is three years, but an
21 appointed member serves at the pleasure of the appointing authority. Before the expiration of the
22 term of an appointed voting member, the appointing authority shall appoint a successor whose term
23 begins on July 1 next following. An appointed member is eligible for reappointment. If there is a
24 vacancy for any cause, the appointing authority shall make an appointment to become immediately
25 effective for the remainder of the unexpired term.

26 (5) A majority of the voting members of the council constitutes a quorum for the transaction
27 of business.

28 (6) Official action by the council requires the approval of a majority of the voting members of
29 the council.

30 (7) The council shall meet at least twice per fiscal year at a place, day and time determined by
31 the chairperson. The council may also meet at other times and places specified by a call of the
32 chairperson or by written request of a majority of the voting members of the council.

33 (8) The council may adopt rules necessary for the operation of the council.

34 (9) The council may establish committees and delegate to the committees duties as the council
35 considers desirable.

36 (10) The Oregon Business Development Department shall provide staff support to the council.

37 (11) Members of the council who are members of the Legislative Assembly are entitled to com-
38 pensation and expense reimbursement as provided in ORS 171.072.

39 (12) Members of the council who are not members of the Legislative Assembly are entitled to
40 compensation and expenses incurred by them in the performance of their official duties in the man-
41 ner and amounts provided for in ORS 292.495. Claims for compensation and expenses of members
42 of the council who are public officers shall be paid out of funds appropriated to the public agency
43 that employs the member. Claims for compensation and expenses of members of the council who are
44 not public officers shall be paid out of funds appropriated to the Oregon Business Development De-
45 partment for that purpose.

1 (13) All agencies of state government, as defined in ORS 174.111, are directed to assist the
2 council in the performance of its duties and, to the extent permitted by laws relating to
3 confidentiality, to furnish such information and advice as the members of the council consider nec-
4 essary to perform their duties.

5 **SECTION 8.** ORS 293.731, as amended by sections 22 and 32, chapter 90, Oregon Laws 2012, is
6 amended to read:

7 293.731. Subject to the objective set forth in ORS 293.721 and the standards set forth in ORS
8 293.726, the Oregon Investment Council shall formulate policies for the investment and reinvestment
9 of moneys in the investment funds and the acquisition, retention, management and disposition of
10 investments of the investment funds. The council, from time to time, shall review those policies and
11 make changes therein as it considers necessary or desirable. The council may formulate separate
12 policies for any fund included in the investment funds. This section does not apply to the Oregon
13 Growth Account, **the Oregon Growth Fund**, the Oregon Growth *[Account]* Board, the Oregon
14 Commercialized Research Fund, the Oregon Innovation Fund or the Oregon Innovation Council.

15 **SECTION 9.** ORS 293.761, as amended by sections 24 and 33, chapter 90, Oregon Laws 2012, is
16 amended to read:

17 293.761. (1) The investment officer shall follow generally accepted accounting practices and
18 provide to the officer or body having control and administration of any investment funds any infor-
19 mation necessary for financial reporting required by law.

20 (2) The investment officer shall separately identify investments held in the Oregon Growth Ac-
21 count established in ORS 348.702 *[and the Oregon Resource and Technology Development Subaccount*
22 *established in ORS 348.706]* as part of the information provided under this section on the Education
23 Stability Fund.

24 **SECTION 10.** ORS 348.702, as amended by section 2, chapter 805, Oregon Laws 2009, and
25 sections 7a and 33a, chapter 90, Oregon Laws 2012, is amended to read:

26 348.702. (1) There is created within the Education Stability Fund the Oregon Growth Account,
27 to which shall be credited, in the manner provided in subsection (2) of this section, 10 percent of the
28 funds transferred under *[section 4,]* Article XV, **section 4**, of the Oregon Constitution, from the
29 Administrative Services Economic Development Fund to the Education Stability Fund. Separate re-
30 cords shall be maintained for moneys in the Oregon Growth Account that are available for the
31 purposes specified in subsection (5) of this section. The account may be credited with unrestricted
32 appropriations, gifts, donations, grants or contract proceeds from any source, with investments or
33 funds from any source and with returns on investments made from the account.

34 (2) The Oregon Department of Administrative Services may credit to the Oregon Growth Ac-
35 count from the first funds transferred in a fiscal year to the Education Stability Fund under *[section*
36 *4,]* Article XV, **section 4**, of the Oregon Constitution, an amount up to the amount the department
37 estimates to be 10 percent of the funds required to be transferred to the Education Stability Fund
38 for that fiscal year.

39 (3) If at the end of the fiscal year the amount credited to the Oregon Growth Account under
40 subsection (2) of this section is less than or greater than 10 percent of the amount required to be
41 transferred under *[section 4,]* Article XV, **section 4**, of the Oregon Constitution, to the Education
42 Stability Fund, the amount credited to the Oregon Growth Account shall be adjusted in one of the
43 following ways:

44 (a) The amount credited to the account in the following fiscal year may be adjusted;

45 (b) Any excess may be transferred from the Oregon Growth Account to the Education Stability

1 Fund; or

2 (c) Any shortage may be transferred from the Education Stability Fund to the Oregon Growth
3 Account from funds available for that purpose.

4 (4) Adjustments required by subsection (3) of this section shall be made without consideration
5 of any interest or other earnings that have accrued during the fiscal year.

6 (5) The purpose of the Oregon Growth Account is to earn returns for the Education Stability
7 Fund [*by making investments in or by providing seed capital for emerging growth businesses*].

8 (6) The investment of funds in the Oregon Growth Account shall be governed by the Oregon
9 Growth [*Account*] Board.

10 (7) **The Oregon Growth Board may use moneys in the Oregon Growth Account to pay the**
11 **administrative costs associated with the account and with administering those portions of**
12 **sections 1 to 7, chapter 90, Oregon Laws 2012, that pertain to the account.**

13 **SECTION 11. The amendments to ORS 192.502, 284.706, 293.731, 293.761 and 348.702 by**
14 **sections 5 and 7 to 10 of this 2013 Act become operative on the 91st day after the date on**
15 **which the 2013 regular session of the Seventy-seventh Legislative Assembly adjourns sine die.**

16 **SECTION 12. This 2013 Act being necessary for the immediate preservation of the public**
17 **peace, health and safety, an emergency is declared to exist, and this 2013 Act takes effect**
18 **on its passage.**
