HB 5017 Commission on Judicial Fitness and Disability

House Bill 5017 is the budget bill for the Commission on Judicial Fitness and Disability.

The Commission's mission is to investigate and act upon complaints of judicial misconduct or disability based on the Oregon Code of Judicial Conduct. The Commission's jurisdiction extends to Oregon's state judges, including circuit and appellate court judges, pro-tem judges, and judicial referees; and to justices of the peace.

The Commission's budget is supported by General Fund. The Subcommittee approved a budget of \$202,770 General Fund and one half-time position (0.50 FTE). This funding level provides support for the continued operation of current services, with reductions to reflect the impact of legislative and administrative actions that reduce the PERS contribution rate.

House Bill 5017 as amended also includes adjustments to both the Commission's 2011-13 biennium budget, and to its 2013-15 biennium budget, to support extraordinary expenses arising from the investigation and prosecution of violation cases. The bill transfers \$5,000 from administration to extraordinary expenses in the 2011-13 biennium budget and \$3,950 from administration to extraordinary expenses for 2013-15.

The Subcommittee on Public Safety Subcommittee recommends House Bill 5017 be amended and reported out do pass, as amended.

Summary of Revenue Changes

The Commission on Judicial Fitness and Disability is supported entirely by General Fund. The Joint Committee on Ways and Means Public Safety Subcommittee recommended no revenue changes.

Summary of Public Safety Subcommittee Action

The Commission on Judicial Fitness and Disability is one of the three independent state entities within the Judicial Branch of government. The Commission investigates complaints or judicial misconduct or disability filed against Oregon judges. It has jurisdiction over the state's 32 justices of the peace, 173 circuit court judges, 17 appellate court judges, the tax court judge, pro-tem judges, and senior "Plan B" judges. It does not have jurisdiction over municipal court judges, arbitrators, or administrative law judges.

Part of the Commission's budget is separately appropriated for extraordinary expenses. These are expenses that arise from prosecution of an apparent violation of the Code of Judicial Conduct. The costs are unpredictable and if needed, could grow significantly causing a budget imbalance.

The Public Safety Subcommittee approved a 2013-15 biennium budget of \$202,770 General Fund and one half-time position (0.50 FTE). This represents a 13.6 percent increase over the 2011-13 legislatively approved budget through December 2012, and a 1.5 percent decrease from the 2013-15 current service level.

The Subcommittee approved the following adjustments to the Commission's budget:

- Package 092: PERS Taxation Policy reduces General Fund by \$342. This package reflects the policy change in SB 822 that eliminates the increased retirement benefits resulting from Oregon income taxation of payments if the person receiving payments does not pay Oregon income tax on those benefits and is not an Oregon resident. This change reduces state employer contribution rates by approximately 0.30 percent.
- Package 093: Other PERS Adjustments reduces General Fund by \$2,732. This package reflects the policy change in SB 822 that modifies the cost-of-living adjustment under the Public Employees Retirement System. This change reduces state employer contribution rates by approximately 2.2 percent.
 - An administrative action by the PERS Board, as directed by a budget note in the SB 822 budget report, will reduce state employer contribution rates by up to an additional 1.9 percent. However, no employer rate is reduced below its 2011-13 biennium rate.
- Package 810: LFO Analyst Adjustments creates separate appropriations for the 2013-15 biennium for administration and extraordinary expenses. The Subcommittee transferred \$3,950 General Fund from administration to extraordinary expenses. The action supplements support for potential extraordinary expenses in the 2013-15 biennium to \$10,324. The agency may not use these funds for regular operating expenses. The packages increases Professional Services in the extraordinary expenses budget and decreases Services and Supplies in the operations budget for a net zero adjustment in the Commission's overall budget.

The dollar amount of the transfer for the 2013-15 biennium is equal to the projected 2011-13 General Fund ending balance for administration, after the 2011-13 biennium transfer of \$5,000 General Fund from administration to extraordinary expenses described below. Under law, this 2011-13 biennium projected ending balance will supplement the 2013-15 biennium appropriation for administration, without additional legislative action.

The Subcommittee also adjusted the Commission's 2011-13 biennium General Fund appropriation to finance extraordinary expenses incurred in the 2011-13 biennium. The Subcommittee transferred \$5,000 General Fund appropriation from administration to extraordinary expenses made by chapter 340, section 1, Oregon Laws 2011, for the 2011-13 biennium as follows:

PROPOSED AMENDMENTS TO HOUSE BILL 5017

Delete lines 5 through 9 of the printed bill and insert:

"SECTION 1. There are appropriated to the Commission on Judicial Fitness and Disability, for the biennium beginning July 1, 2013, out of the General Fund, the following amounts, for the following purposes:

- (1) Administration...... \$ 192,446
- 6 (2) Extraordinary expenses \$ 10,324

"SECTION 2. (1) Notwithstanding any other provision of law, the General Fund appropriation made to the Commission on Judicial Fitness and Disability by section 1 (1), chapter 340, Oregon Laws 2011, for the biennium beginning July 1, 2011, for administration, is decreased by \$5,000.

"(2) Notwithstanding any other provision of law, the General Fund appropriation made to the Commission on Judicial Fitness and Disability by section 1 (2), chapter 340, Oregon Laws 2011, for the biennium beginning July 1, 2011, for extraordinary expenses, is increased by \$5,000.

"SECTION 3. This 2013 Act being necessary for the immediate preservation of the public peace, health and safety, an emergency is declared to exist, and this 2013 Act takes effect on its passage."
