SUMMARY

Requires that minors who are sentenced to more than one year's imprisonment begin service of sentence in physical custody of Oregon Youth Authority.

Declares emergency, effective on passage.

A BILL FOR AN ACT

2 Relating to juvenile offenders; creating new provisions; amending ORS

3 137.124, 137.320 and 420.011; and declaring an emergency.

4 Be It Enacted by the People of the State of Oregon:

5 **SECTION 1.** ORS 137.320 is amended to read:

6 137.320. (1)(a) When a judgment includes commitment to the legal and 7 physical custody of the Department of Corrections, the sheriff shall deliver 8 the defendant, together with a copy of the entry of judgment and a statement 9 signed by the sheriff of the number of days the defendant was imprisoned 10 prior to delivery, to:

(A) The superintendent of the Department of Corrections institution to
 which the defendant is initially assigned pursuant to ORS 137.124, if the
 defendant is 18 years of age or older.

(B) The superintendent of the Oregon Youth Authority institution
to which the defendant is initially assigned, if the defendant is under
18 years of age.

(b) If at the time of entry of a judgment, the defendant was serving a term of incarceration at the direction of the supervisory authority of a county upon conviction of a prior felony, the sheriff shall also deliver to the [*Department of Corrections*] **superintendent** a copy of the prior entry of judg-

1 ment committing the defendant to the supervisory authority of the county 2 of conviction and a statement of the number of days the defendant has re-3 maining to be served on the term or incarceration imposed in the prior 4 judgment.

(2) If the defendant is surrendered to another legal authority prior to $\mathbf{5}$ delivery to an institution [of the Department of Corrections] described in 6 subsection (1)(a) of this section, the sheriff shall forward to the Depart-7 ment of Corrections copies of the entry of all pertinent judgments, a state-8 ment of the number of days the defendant was imprisoned prior to surrender, 9 a statement of the number of days the defendant has remaining to be served 10 on any term of incarceration the defendant was serving at the direction of 11 12the supervisory authority of a county upon conviction of a prior felony and an identification of the authority to whom the prisoner was surrendered. 13

(3) Upon receipt of the information described in subsection (1) or (2) of
this section, the Department of Corrections shall establish a case file and
compute the defendant's sentence in accordance with the provisions of ORS
137.370.

(4) When the judgment is imprisonment in the county jail or a fine and that the defendant be imprisoned until it is paid, the judgment shall be executed by the sheriff of the county. The sheriff shall compute the time the defendant was imprisoned after arrest and prior to the commencement of the term specified in the judgment. Such time shall be credited toward the term of the sentence.

24 **SECTION 2.** ORS 137.124 is amended to read:

137.124. (1) If the court imposes a sentence upon conviction of a felony
that includes a term of incarceration that exceeds 12 months:

(a) The court shall [not designate the correctional facility in which the
defendant is to be confined but shall] commit the defendant to the legal and
physical custody of the Department of Corrections; and

30 (b) If the judgment provides that the term of incarceration be served 31 consecutively to a term of incarceration of 12 months or less that was im-

posed in a previous proceeding by a court of this state upon conviction of a felony, the defendant shall serve any remaining part of the previously imposed term of incarceration in the legal and physical custody of the Department of Corrections.

5 (2)(a) If the court imposes a sentence upon conviction of a felony that 6 includes a term of incarceration that is 12 months or less, the court shall 7 commit the defendant to the legal and physical custody of the supervisory 8 authority of the county in which the crime of conviction occurred.

(b) Notwithstanding paragraph (a) of this subsection, when the court im-9 poses a sentence upon conviction of a felony that includes a term of incar-10 ceration that is 12 months or less, the court shall commit the defendant to 11 12the legal and physical custody of the Department of Corrections if the court orders that the term of incarceration be served consecutively to a term of 13 incarceration that exceeds 12 months that was imposed in a previous pro-14 ceeding or in the same proceeding by a court of this state upon conviction 15 of a felony. 16

17 (3) After assuming custody of the convicted person the Department of 18 Corrections may transfer inmates from one correctional facility to another 19 such facility for the purposes of diagnosis and study, rehabilitation and 20 treatment, as best seems to fit the needs of the inmate and for the protection 21 and welfare of the community and the inmate.

(4) If the court imposes a sentence of imprisonment upon conviction of a
misdemeanor, it shall commit the defendant to the custody of the supervisory
authority of the county in which the crime of conviction occurred.

(5)(a) When a person under 18 years of age at the time of committing the offense and under 20 years of age at the time of sentencing is committed to the Department of Corrections under ORS 137.707, the Department of Corrections shall transfer the physical custody of the person to the Oregon Youth Authority as provided in ORS 420.011 if:

30 (A) The person will complete the sentence imposed before the person at-31 tains 25 years of age; or

1 (B) The Department of Corrections and the Oregon Youth Authority de-2 termine that, because of the person's age, immaturity, mental or emotional 3 condition or risk of physical harm to the person, the person should not be 4 incarcerated initially in a Department of Corrections institution.

5 (b) A person placed in the custody of the Oregon Youth Authority under 6 this subsection shall be returned to the physical custody of the Department 7 of Corrections whenever the Director of the Oregon Youth Authority, after 8 consultation with the Department of Corrections, determines that the condi-9 tions or circumstances that warranted the transfer of custody under this 10 subsection are no longer present.

(6)(a) When a person under 18 years of age at the time of committing the 11 12offense and under 20 years of age at the time of sentencing is committed to the legal and physical custody of the Department of Corrections or the su-13 pervisory authority of a county following waiver under ORS 419C.349, 14 419C.352, 419C.364 or 419C.370 or sentencing under ORS 137.707 (5)(b)(A) or 15 (7)(b) or 137.712, the Department of Corrections or the supervisory authority 16 of a county shall transfer the person to the physical custody of the Oregon 17Youth Authority for placement as provided in ORS 420.011 (3). The terms and 18 19 conditions of the person's incarceration and custody are governed by ORS 420A.200 to 420A.206. 20

21(b) When a person under 16 years of age is waived under ORS 419C.349, 419C.352, 419C.364 or 419C.370 and subsequently is sentenced to a term of 22imprisonment in the county jail, the sheriff shall transfer the person to a 23youth correction facility for physical custody as provided in ORS 420.011 (3). 24(7) If the Director of the Oregon Youth Authority concurs in the decision, 25the Department of Corrections or the supervisory authority of a county shall 26transfer the physical custody of a person committed to the Department of 27Corrections or the supervisory authority of the county under subsection (1) 28or (2) of this section to the Oregon Youth Authority as provided in ORS 29420.011 (2) if: 30

(a) The person was at least 18 years of age but under 20 years of age at

1 the time of committing the felony for which the person is being sentenced2 to a term of incarceration;

3 (b) The person is under 20 years of age at the time of commitment to the
4 Department of Corrections or the supervisory authority of the county;

(c) The person has not been committed previously to the legal and physical custody of the Department of Corrections or the supervisory authority
of a county;

8 (d) The person has not been convicted and sentenced to a term of incar9 ceration for the commission of a felony in any other state;

(e) The person will complete the term of incarceration imposed before the
person attains 25 years of age;

(f) The person is likely in the foreseeable future to benefit from the
rehabilitative and treatment programs administered by the Oregon Youth
Authority;

(g) The person does not pose a substantial danger to Oregon Youth Au thority staff or persons in the custody of the Oregon Youth Authority; and

(h) At the time of the proposed transfer, no more than 50 persons are inthe physical custody of the Oregon Youth Authority under this subsection.

(8) Notwithstanding the provisions of subsections (5)(a)(A) or (7) of this 19 section, the department or the supervisory authority of a county may not 2021transfer the physical custody of the person under subsection (5)(a)(A) or (7) of this section if the Director of the Oregon Youth Authority, after consul-22tation with the Department of Corrections or the supervisory authority of a 23county, determines that, because of the person's age, mental or emotional 24condition or risk of physical harm to other persons, the person should not 25be incarcerated in a youth correction facility. 26

(9) When a person committed to the legal and physical custody of the Department of Corrections under subsection (1) or (2) of this section is under 18 years of age at the time of commitment, the court shall order that the person be temporarily placed in the physical custody of the Oregon Youth Authority as provided in ORS 420.011 (3). A

person placed in the custody of the Oregon Youth Authority under this subsection may be transferred to the physical custody of the Department of Corrections at any time after the person attains 18 years of age, if the Director of the Oregon Youth Authority determines that the transfer is appropriate.

6 **SECTION 3.** ORS 420.011 is amended to read:

7 420.011. (1) Except as provided in subsections (2) and (3) of this section, admissions to the youth correction facilities are limited to youth offenders 8 who are at least 12 but less than 19 years of age, found by the juvenile court 9 to have committed an act that if committed by an adult would constitute 10 aggravated murder, murder, a felony or a Class A misdemeanor and placed 11 12in the legal custody of the Oregon Youth Authority. A youth offender admitted to a youth correction facility may not be transferred by administra-13 tive process to any penal or correctional institution. 14

(2)(a) In addition to the persons placed in the legal custody of the youth 15 authority under ORS 419C.478 (1) or 419C.481, and with the concurrence of 16 the Director of the Oregon Youth Authority or the director's designee, per-17sons who are committed to the Department of Corrections under ORS 137.124 18 and meet the requirements of ORS 137.124 (5) or (7) may be temporarily as-19 signed to a youth correction facility as provided by ORS 137.124 (5) or (7). 2021A person assigned on such a temporary basis remains within the legal custody of the Department of Corrections and such reassignment is subject to 22termination by the Director of the Oregon Youth Authority by referring the 23person back to the Department of Corrections as provided in paragraph (b) 24of this subsection. 25

(b) After a person is transferred to the physical custody of the youth authority under ORS 137.124 (5) or (7), the Director of the Oregon Youth Authority may refer the person back to the Department of Corrections for physical custody and placement if the director, after consulting with the Department of Corrections, determines that the person:

31 (A) Poses a substantial danger to youth authority staff or persons in the

1 custody of the youth authority; or

2 (B) Is not likely, in the foreseeable future, to benefit from the rehabili-3 tation and treatment programs administered by the youth authority and is 4 appropriate for placement in a Department of Corrections institution.

(3) Any person under 18 years of age at the time of committing the crime $\mathbf{5}$ and under 20 years of age at the time of sentencing and commitment who, 6 after waiver under ORS 419C.349, 419C.352, 419C.364 or 419C.370 or sentenc-7 ing under ORS 137.707 (5)(b)(A) or (7)(b) or 137.712, is sentenced to a term 8 of imprisonment in the custody of the Department of Corrections, and any 9 person under 16 years of age who after waiver under ORS 419C.349, 419C.352, 10 419C.364 or 419C.370 or sentencing under ORS 137.707 (5)(b)(A) or (7)(b) or 11 12137.712 is sentenced to a term of imprisonment in the county jail, shall be temporarily assigned to a youth correction facility by the Department of 13 Corrections, or by the sheriff to whose custody the person has been com-14 mitted, pursuant to ORS 137.124 (6). A person under 18 years of age at the 15 time of commitment shall be temporarily assigned to a youth cor-16 rection facility by the court, pursuant to ORS 137.124 (9). The director 17shall designate the appropriate youth correction facility or schools for such 18 assignment. A person assigned to a youth correction facility under ORS 19 137.124 (6) or (9) and this subsection remains within the legal custody of the 20Department of Corrections or sheriff to whose custody the person was com-21mitted. The assignment of such a person to the youth correction facility is 22subject, when the person is [16] 18 years of age or older, to termination by 23the director by referring the person back to the Department of Corrections 24or the sheriff to serve the balance of the person's sentence. Assignment to 25a youth correction facility pursuant to ORS 137.124 (6) or (9) and this sub-26section, if not terminated earlier by the director, shall terminate upon the 27person's attaining the age specified in ORS 420A.010 (5) setting the age limits 28for which the Oregon Youth Authority may retain legal and physical custody 29of the person, and the person shall be referred to the Department of Cor-30 rections or the sheriff having legal custody of the person to serve the balance 31

1 of the person's sentence.

(4) Whenever a person committed to the custody of the Department of
Corrections is temporarily assigned to a youth correction facility pursuant
to this section, the youth authority may provide programs and treatment for
the person, and may adopt rules relating to conditions of confinement at the
youth correction facility, as the youth authority determines are appropriate.
However, the person remains subject to laws and rules of the State Board
of Parole and Post-Prison Supervision relating to parole.

9 <u>SECTION 4.</u> The amendments to ORS 137.124, 137.320 and 420.011 by
10 sections 1 to 3 of this 2013 Act apply to persons sentenced for a crime
11 on or after the effective date of this 2013 Act.

12 <u>SECTION 5.</u> This 2013 Act being necessary for the immediate pres-13 ervation of the public peace, health and safety, an emergency is de-14 clared to exist, and this 2013 Act takes effect on its passage.
