SUMMARY

Removes medical assistance from definition of “public assistance” and conforms applicable statutes to reflect definitional change. Requires grievance procedure for medical assistance applicants and recipients that parallels procedure for public assistance applicants and recipients. Establishes requirement for Oregon Health Authority to allocate funds for each category of medical assistance that parallels Department of Human Services requirement to allocate public assistance funds. Allows both authority and department to determine eligibility for medical assistance. Aligns state law with changes to federal Medicaid and Children’s Health Insurance Program laws. Specifies medical assistance application procedures for authority, department and Oregon Health Insurance Exchange Corporation. Repeals obsolete provisions.

Becomes operative January 1, 2014.

Declares emergency, effective on passage.

5 **Be It Enacted by the People of the State of Oregon:**

6 **SECTION 1. (1) All applicants for and recipients of medical assist-**
7 **ance, as defined in ORS 414.025, shall be treated in a courteous, fair**
8 **and dignified manner by Oregon Health Authority employees.**

9 **(2) Any applicant or recipient who alleges discourteous, unfair or**
10 **undignified treatment by an authority employee or alleges that an**
11 **authority employee has provided incorrect or inadequate information**
12 **regarding medical assistance programs may file a grievance with the**
13 **authority. The authority shall publicize the grievance system in each**
14 **office of the authority that is open to the public.**

15 **(3) The grievance shall be discussed first with the supervisor of the**
16 **employee against whom the grievance is filed. If the grievance is not**
17 **resolved, the applicant or recipient may discuss the grievance with the**
18 **manager of the office.**

19 **(4) The authority shall compile a monthly report that summarizes**
20 **each grievance filed against an authority employee and the action**
21 **taken. The report shall identify each grievance by office and indicate**
22 **the number of grievances filed against each authority employee. The**
23 **report shall protect the anonymity of authority employees. The report**
24 **shall be provided to the Medicaid Advisory Committee established un-**
25 **der ORS 414.211.**

26 **SECTION 2. The Oregon Health Authority, taking into consider-**
27 **ation the total amount of funds available for medical assistance, as**
28 **defined in ORS 414.025, in Oregon during the biennial period beginning**
29 **July 1 of each odd-numbered year, the estimated number of benefici-**
30 **aries in each category of medical assistance, the current and estimated**
31 **costs of essential needs for an individual to maintain a standard of**

1 **living compatible with decency and health and any other matters the**
2 **authority may deem pertinent, shall estimate and allocate the funds**
3 **available for each category of medical assistance on a monthly basis,**
4 **subject to quarterly revisions. Changes in the allocations, if any, shall**
5 **be uniform and, as practicable as possible considering the relevant**
6 **factors, proportionately equal in each such category. The monthly**
7 **amounts estimated and allocated as described in this section shall be**
8 **deemed to be the funds available for each category of medical assist-**
9 **ance.**

10 **SECTION 3.** ORS 1.198 is amended to read:

11 1.198. (1) ORS 1.197 does not apply to liquidated and delinquent accounts
12 that are:

13 (a) Prohibited by state or federal law or regulation from assignment or
14 collection; or

15 (b) Subject to collection through an offset of federal tax refunds pursuant
16 to an agreement entered into under ORS 1.196.

17 (2) Notwithstanding ORS 1.197, a state court or a commission, department
18 or division in the judicial branch of state government, acting in its sole
19 discretion, may choose not to offer a liquidated and delinquent account to
20 a private collection agency or to the Department of Revenue if the account:

21 (a) Is secured by a consensual security interest in real or personal prop-
22 erty;

23 (b) Is based on that part of a judgment that requires payment of
24 restitution or a payment to the Crime Victims' Assistance section of the
25 Criminal Justice Division of the Department of Justice;

26 (c) Is in litigation, mediation or arbitration or is subject to a stay in
27 bankruptcy proceedings;

28 (d) Is owed by a local or state government or by the federal government;

29 (e) Is owed by a debtor who is hospitalized in a state hospital as defined
30 in ORS 162.135 or who [*is on*] **receives** public assistance as defined in ORS
31 **411.010 or medical assistance as defined in ORS 414.025;**

1 (f) Consists of moneys for which a district attorney has assumed col-
2 lection responsibility under ORS 8.680;

3 (g) Consists of moneys owed by a person who is incarcerated;

4 (h) Is an account that was previously offered to a private collection
5 agency and was refused, or that was previously assigned to a private col-
6 lection agency and the agency thereafter relinquished the account;

7 (i) Is less than \$100, including penalties; or

8 (j) Would result in loss of federal funding if assigned.

9 **SECTION 4.** ORS 18.784 is amended to read:

10 18.784. (1) Except as provided in subsection (6) of this section, if a writ
11 of garnishment is delivered to a financial institution that has an account of
12 the debtor, the financial institution shall conduct a garnishment account
13 review of all accounts in the name of the debtor before taking any other
14 action that may affect funds in those accounts. If the financial institution
15 determines from the garnishment account review that one or more payments
16 described in subsection (3) of this section were deposited in an account of
17 the debtor by direct deposit or electronic payment during the lookback pe-
18 riod described in subsection (2) of this section, an amount equal to the lesser
19 of the sum of those payments or the total balance in the debtor's account is
20 not subject to garnishment.

21 (2) The provisions of this section apply only to payments described in
22 subsection (3) of this section that are deposited during the lookback period
23 that ends on the day before the day on which the garnishment account re-
24 view is conducted and begins on:

25 (a) The day in the second calendar month preceding the month in which
26 the garnishment account review is conducted, that has the same number as
27 the day on which the period ends; or

28 (b) If there is no day as described in paragraph (a) of this subsection, the
29 last day of the second calendar month preceding the month in which the
30 garnishment account review is conducted.

31 (3) The provisions of this section apply only to:

1 (a) Federal benefit payments;

2 (b) Payments from a public or private retirement plan as defined in ORS
3 18.358;

4 (c) Public assistance **or medical assistance, as defined in ORS 414.025,**
5 payments from the State of Oregon or an agency of the State of Oregon;

6 (d) Unemployment compensation payments from the State of Oregon or
7 an agency of the State of Oregon;

8 (e) Black lung benefits payments from the United States Department of
9 Labor; and

10 (f) Workers' compensation payments from a workers' compensation car-
11 rier.

12 (4) The provisions of this section apply only to a payment that a financial
13 institution can identify as being one of the types of payments described in
14 subsection (3) of this section from information transmitted to the financial
15 institution by the payor.

16 (5) A financial institution shall perform a garnishment account review
17 only one time for a specific garnishment. If the same garnishment is served
18 on a financial institution more than once, the financial institution may not
19 perform a garnishment account review or take any other action relating to
20 the garnishment based on the second and subsequent service of the
21 garnishment.

22 (6) A financial institution may not conduct a garnishment account review
23 under this section if a Notice of Right to Garnish Federal Benefits from the
24 United States Government or from a state child support enforcement agency
25 is attached to or included in the garnishment as provided in 31 C.F.R. part
26 212. If a Notice of Right to Garnish Federal Benefits is attached to or in-
27 cluded in the garnishment, the financial institution shall proceed on the
28 garnishment as otherwise provided in ORS 18.600 to 18.850.

29 (7) The provisions of this section do not affect the ability of a debtor to
30 claim any exemption that otherwise may be available to the debtor under law
31 for any amounts in an account in a financial institution.

1 **SECTION 5.** ORS 18.838 is amended to read:

2 18.838. Instructions to garnishees must be in substantially the following
3 form:

4 _____
5 INSTRUCTIONS TO GARNISHEE
6

7 Except as specifically provided in these instructions, you must complete
8 and deliver the Garnishee Response within seven calendar days after you
9 receive the writ of garnishment. If the writ does not comply with Oregon
10 law, the writ is not effective to garnish any property of the Debtor, but you
11 still must complete and deliver the Garnishee Response. You must complete
12 and deliver the response even though you cannot determine from the writ
13 whether you hold any property or owe any debt to the Debtor. If the seventh
14 calendar day is a Saturday, Sunday or legal holiday, you must deliver your
15 response on or before the next following day that is not a Saturday, Sunday
16 or legal holiday.

17
18 The writ is not effective, and you need not make a Garnishee Response,
19 if:

- 20
- 21 • You do not receive the writ within 60 days after the date of issuance
22 shown on the face of the writ.
 - 23
 - 24 • You do not receive an original writ of garnishment or a copy of the
25 writ.
 - 26

27 Statutes that may affect your rights and duties under the writ can be
28 found in ORS 18.600 to 18.850.

29
30 NOTE: The Garnishor may be the Creditor, the attorney for the Creditor
31 or some other person who is authorized by law to issue the writ of

1 garnishment. See the writ to determine who the Garnishor is.

2

3 STEP 1. FILL OUT THE GARNISHEE RESPONSE.

4

5 All garnishees who are required to deliver a garnishee response must fill
6 in Part I of the Garnishee Response. Garnishees who employ the Debtor must
7 also fill in Part II of the response. You should keep a copy of the response
8 for your records.

9

10 Completing Part I of the Garnishee Response. If you discover before you
11 deliver your response that a bankruptcy petition has been filed by or on be-
12 half of the Debtor, and the bankruptcy petition was filed after a judgment
13 was entered against the Debtor or after the debt otherwise became subject
14 to garnishment (see the date specified in the writ), you must put a check by
15 the appropriate statement in Part I. If a bankruptcy petition has been filed,
16 you should not make any payments to the Garnishor unless the court orders
17 otherwise. You need not complete any other part of the response, but you
18 still must sign the response and deliver it in the manner described in Step
19 2 of these instructions.

20 In all other cases you must list in Part I all money and personal property
21 of the Debtor that is in your possession, control or custody at the time of
22 delivery of the writ. You must also list all debts that you owe to the Debtor,
23 whether or not those debts are currently due (e.g., money loaned to you by
24 the Debtor that is to be repaid at a later time).

25 If you are the employer of the Debtor at the time the writ is delivered to
26 you, you must put a check by the appropriate statement in Part I. In addi-
27 tion, you must complete Part II of the response.

28 If you believe that you may hold property of the Debtor or that you owe
29 a debt to the Debtor, but you are not sure, you must put a check by the
30 appropriate statement and provide an explanation. When you find out what
31 property you hold that belongs to the Debtor, or you find out whether you

1 owe money to the Debtor and how much, you must prepare and deliver an
2 amended response. You must do this even if you find out that you have no
3 property of the Debtor or that you do not owe anything to the Debtor.

4 If you determine that the writ, on its face, does not comply with Oregon
5 laws governing writs of garnishment, or if you are unable to determine the
6 identity of the Debtor from the information in the writ, then the writ is not
7 effective to garnish any property of the Debtor. You must put a check by the
8 appropriate statement in Part I and provide an explanation. You still must
9 complete the response and deliver the response in the manner described in
10 Step 2 of these instructions.

11 If you have received an order to withhold income that applies to the in-
12 come of the Debtor and that order has priority over the garnishment, and if
13 compliance with the order will reduce or eliminate the money or property
14 that you would otherwise deliver under the garnishment, you must put a
15 check by the appropriate statement in Part I. You still must fill out the re-
16 mainder of the response and deliver the response in the manner described in
17 Step 2 of these instructions. If you employ the Debtor, you still must com-
18 plete Part II of the response.

19 If you receive notice of a challenge to the garnishment before you send
20 your response, you must complete and deliver your response as otherwise
21 required by these instructions. However, see Step 3 of these instructions re-
22 garding payment of money or delivery of property after receipt of notice of
23 a challenge to the garnishment.

24 If you owe a debt to the Debtor and the Debtor owes a debt to the holder
25 of an underlying lien on your property, you may be able to offset the amount
26 payable to the underlying lienholder. See ORS 18.620. You must note that
27 you have made the offset in Part I of the response (under "Other") and
28 specify the amount that was offset.

29

30 Completing Part II of the Garnishee Response (employers only). You must
31 fill in Part II of the response if you employ the Debtor on the date the writ

1 of garnishment is delivered to you, or if you previously employed the Debtor
2 and still owe wages to the Debtor on the date the writ is delivered to you.

3

4 Wages affected. Except as provided below, the writ garnishes all wages
5 that you owe to the Debtor for work performed before the date you received
6 the writ, even though the wages will not be paid until a later date. The writ
7 also garnishes all wages that are attributable to services performed during
8 the 90-day period following the date you received the writ, even though you
9 would not pay the Debtor for all or part of those services until after the end
10 of the 90-day period. Wages subject to garnishment under the writ include
11 all amounts paid by you as an employer, whether on an hourly, weekly or
12 monthly basis, and include commission payments and bonuses.

13

14 Example 1: Debtor A is employed by you and is paid a monthly salary
15 on the first day of each month. You receive a writ of garnishment on
16 July 17. The writ garnishes all wages that you owe to Debtor A for
17 work performed on or before July 17. If Debtor A was paid on July 1
18 for services performed in the month of June, the writ garnishes Debtor
19 A's salary for the period beginning July 1 and ending October 15 (90
20 days after receipt of the writ).

21

22 The writ does not garnish any wages you owe to a Debtor for a specific
23 pay period if:

24 (a) The writ is delivered to you within two business days before the
25 Debtor's normal payday for the pay period;

26 (b) When the writ is delivered to you, the Debtor's wages are paid by di-
27 rect deposit to a financial institution, or you use an independent contractor
28 as payroll administrator for your payroll; and

29 (c) Before the writ was delivered to you, you issued instructions to the
30 financial institution or the payroll administrator to pay the Debtor for the
31 pay period.

1 If any wages are not garnishable by reason of the issuance of instructions
2 to a financial institution or a payroll administrator as described above, you
3 must so note in the Garnishee Response. Thereafter, you must pay to the
4 Garnishor all wages that are subject to garnishment that are attributable to
5 services performed by the Debtor during the 90-day period following the date
6 you received the writ.

7

8 Calculation of wages subject to garnishment. A Wage Exemption Calcula-
9 tion form is attached to the writ of garnishment. You must use this form
10 to calculate the amount of the Debtor's wages that is subject to garnishment.
11 You should read the instructions printed on the Wage Exemption Calculation
12 form to determine the normal wage exemption and the minimum wage ex-
13 emption for each payment you make under the writ.

14 A Wage Exemption Calculation form must be sent with the first payment
15 you make under the writ. For the 90-day period during which the writ is ef-
16 fective, you must also fill out and return a Wage Exemption Calculation
17 form with a subsequent payment any time the initial calculation changes.
18 Finally, you must fill out and return a Wage Exemption Calculation form
19 with the final payment that you make under the writ.

20

21 Payment of amount subject to garnishment. Payments under the writ must
22 be made at the following times, unless the amount owing on the judgment
23 or other debt is fully paid before the final payment is made or the writ is
24 released:

25 (a) You must make a payment to the Garnishor of all wages subject to
26 garnishment at the time you next pay wages to the Debtor. Complete the
27 wage exemption computation, using the Wage Exemption Calculation form,
28 to determine the portion of the Debtor's wages that is subject to
29 garnishment. Be sure to adjust the minimum exemption amount for any
30 payment that covers less than a full pay period. You must include a copy
31 of the Wage Exemption Calculation form with this first payment.

1 Example 2: Using the facts given in Example 1, when you next make
 2 any payment of wages to Debtor A after you receive the writ on July
 3 17, you must complete the Wage Exemption Calculation form and send
 4 the form to the Garnishor along with all amounts determined to be
 5 subject to garnishment that are attributable to the period covered by
 6 the payment. If you pay Debtor A on August 1, the payment will be
 7 for all wages attributable to the period beginning July 1 and ending
 8 July 31.

9
 10 (b) Unless the writ of garnishment is satisfied or released, during the
 11 90-day period following the date you received the writ, you must pay to the
 12 Garnishor all wages that are determined to be subject to garnishment
 13 whenever you issue a paycheck to the Debtor. If the Debtor is paid on a
 14 weekly basis, you must make payment under the writ on a weekly basis. If
 15 the Debtor is paid on a monthly basis, you must make payment under the
 16 writ on a monthly basis. If the amount paid to the Debtor varies from pay-
 17 check to paycheck, or changes at any time from the amount being paid at
 18 the time the writ was delivered to you, you must perform a new wage ex-
 19 emption computation to determine the amount of wages subject to
 20 garnishment under the writ. You must send a copy of the new Wage Ex-
 21 emption Calculation form with your payment to the Garnishor.

22
 23 Example 3: Using the facts given above, as you make each subsequent
 24 payment of wages to Debtor A you must make a payment of that por-
 25 tion of the Debtor's wages that are subject to garnishment. If you
 26 continue to pay Debtor A on the first of each month, payments must
 27 be made on September 1 and October 1.

28
 29 (c) Upon the expiration of the 90-day period, you must make a final pay-
 30 ment to the Garnishor for all wages that were owing to the Debtor for the
 31 work performed by the Debtor through the 90th day following your receipt

1 of the writ. This payment may be made at the time of the Debtor's next
2 paycheck. You will need to complete another Wage Exemption Calculation
3 form to determine the amount of the wages subject to garnishment.

4

5 Example 4: Using the facts given above, you must make a final pay-
6 ment for the wages owing to Debtor A for the period beginning Octo-
7 ber 1 and ending October 15. You may make this payment at the time
8 you issue Debtor A's paycheck on November 1, but you must make the
9 payment at any time you issue a paycheck to Debtor A after October
10 15. Be sure that in completing the wage exemption computation for the
11 final payment you adjust the minimum exemption amount to take into
12 account the fact that the period covered is only 15 days of the full
13 month (see instructions on Wage Exemption Calculation form).

14

15 Processing fee. You may collect a \$2 processing fee for each week of
16 wages, or fraction of a week of wages, for which a payment is made under
17 the writ. The fee must be collected after you make the last payment under
18 the writ. The fee must be withheld from the wages of the debtor, and is in
19 addition to the amounts withheld for payment to the garnishor under the
20 writ or under any other writ you have received.

21

22 If you receive more than one writ of garnishment. If you receive a second
23 writ of garnishment for the same Debtor from another Garnishor, the first
24 writ will have priority for wages. The priority of the first writ lasts for the
25 90-day period following delivery of that writ to you, or until the first writ
26 is paid in full, whichever comes first. In your response to the second writ,
27 you must put a check by the appropriate statement in Part II and indicate
28 the date on which the first writ will expire (90 days after the date you re-
29 ceived the writ). You should make no payments under the second writ until
30 expiration of the first writ. The expiration date of the second writ is 90 days
31 after the date you received the second writ; the expiration date is not af-

1 fected by any delay in payment attributable to the priority of the first writ.

2

3 STEP 2. DELIVER THE GARNISHEE RESPONSE.

4

5 You must deliver your Garnishee Response and copies of the response in
6 the manner provided in this step. The response and copies may be mailed or
7 delivered personally.

8

9 You must complete and deliver the Garnishee Response within seven
10 calendar days after you receive the writ of garnishment. If the seventh cal-
11 endar day is a Saturday, Sunday or legal holiday, you must deliver your re-
12 sponse on or before the next following day that is not a Saturday, Sunday
13 or legal holiday.

14

15 If you are required to hold any property under the writ or make any
16 payment under the writ, either at the time of making your response or later,
17 you must:

18 (a) Send the original of your Garnishee Response to the Garnishor at the
19 address indicated on the writ under Important Addresses.

20 (b) Send a copy of your Garnishee Response to the court administrator
21 at the address indicated on the writ under Important Addresses.

22 (c) Send a copy of your Garnishee Response to the Debtor if an address
23 is indicated on the writ under Important Addresses.

24

25 If you are not required to hold any property under the writ or make any
26 payment under the writ, either at the time of making your response or later,
27 you must:

28 (a) Send the original of your Garnishee Response to the Garnishor at the
29 address indicated on the writ under Important Addresses.

30 (b) Send a copy of your Garnishee Response to the Debtor if an address
31 is indicated on the writ under Important Addresses.

1 STEP 3. DELIVER THE FUNDS OR OTHER PROPERTY.

2

3 As long as the writ is in effect, you may be liable to the Creditor if you
4 pay any debt or turn over any property to the Debtor except as specifically
5 allowed by law. If you have any money or property of the Debtor in your
6 possession, control or custody at the time of delivery of the writ, or owe any
7 debt to the Debtor, you must pay the money or hold the property as required
8 by this step. Exceptions to this requirement are listed below.

9

10 IF YOU ARE HOLDING MONEY FOR THE DEBTOR OR OWE A DEBT
11 THAT IS CURRENTLY DUE, you must pay the money to the Garnishor with
12 your response. You must send your payment to the Garnishor at the address
13 indicated on the writ under Important Addresses. Make your check payable
14 to the Garnishor.

15

16 IF YOU OWE A DEBT TO THE DEBTOR THAT WILL BECOME DUE
17 WITHIN 45 DAYS AFTER THE DATE YOU RECEIVED THE WRIT, you
18 must send your payment directly to the Garnishor at the address provided
19 in the writ when the debt becomes due. Make your check payable to the
20 Garnishor.

21

22 IF YOU ARE HOLDING PROPERTY THAT BELONGS TO THE
23 DEBTOR, OR OWE A DEBT TO THE DEBTOR THAT WILL NOT BECOME
24 DUE WITHIN 45 DAYS AFTER THE DATE YOU RECEIVED THE WRIT,
25 you must keep the property or debt in your possession, control or custody
26 until you receive written notice from the Sheriff. The Sheriff's notice will
27 tell you what to do with the property or debt. If you have followed all of the
28 instructions in the writ and you receive no notice from the Sheriff within
29 30 days after the date on which you delivered your Garnishee Response, you
30 may treat the writ as being of no further force or effect.

31

1 EXCEPTIONS:

2

3 1. Challenge to garnishment or specific directions from court. If you are
4 making any payments under the garnishment and before making a payment
5 you receive notice of a challenge to the garnishment from the court, or re-
6 ceive a specific direction from the court to make payments to the court, you
7 must send or deliver the payment directly to the court administrator. If the
8 money is currently due when you receive the notice, send the payment
9 promptly to the court. If the payment is for a debt that is payable within 45
10 days after you receive the writ, make the payment to the court promptly
11 when it becomes due. If you make payment by check, make the check payable
12 to the State of Oregon. Because you may be liable for any payment that does
13 not reach the court, it is better not to send cash by mail.

14 A challenge to the garnishment does not affect your duty to follow the
15 instructions you receive from the Sheriff for property that belongs to the
16 Debtor and debts that you owe to the Debtor that do not become due within
17 45 days.

18

19 2. Previous writ of garnishment. If you receive a second writ of
20 garnishment for the same Debtor from another Garnishor, the first writ will
21 have priority and you need not make payments or deliver property under the
22 second writ to the extent that compliance with the first writ will reduce or
23 eliminate the payment of money or delivery of property that you would oth-
24 erwise make under the garnishment. You must still deliver a Garnishee Re-
25 sponse to the second writ, and must commence payment under the second
26 writ as soon as the first writ is satisfied or expires.

27

28 3. Offset for payment of underlying lien. If you owe a debt to the Debtor
29 and the Debtor owes a debt to the holder of an underlying lien on your
30 property, you may be able to offset the amount payable to the underlying

2 medical, dental or psychiatric treatment as patients of those under the ju-
3 risdiction of the Department of Corrections.

4 (3) If the individual or a personal representative of the individual pro-
5 vides an authorization, the content of any written account referred to in
6 subsection (2) of this section must be disclosed accordingly, if the authori-
7 zation is in writing and is signed and dated by the individual or the personal
8 representative of the individual and sets forth with specificity the following:

9 (a) Name of the health care services provider authorized to make the
10 disclosure, except when the authorization is provided by recipients of or ap-
11 plicants for public assistance **or medical assistance, as defined in ORS**
12 **414.025**, to a governmental entity for purposes of determining eligibility for
13 benefits or investigating for fraud;

14 (b) Name or title of the persons or organizations to which the information
15 is to be disclosed or that information may be disclosed to the public;

16 (c) Name of the individual;

17 (d) Extent or nature of the information to be disclosed; and

18 (e) Statement that the authorization is subject to revocation at any time
19 except to the extent that action has been taken in reliance thereon, and a
20 specification of the date, event or condition upon which it expires without
21 express revocation. However, a revocation of an authorization is not valid
22 with respect to inspection or records necessary to validate expenditures by
23 or on behalf of governmental entities.

24 (4) The content of any written account referred to in subsection (2) of this
25 section may be disclosed without an authorization:

26 (a) To any person to the extent necessary to meet a medical emergency.

27 (b) At the discretion of the responsible officer of the health care services
28 provider, which in the case of any Oregon Health Authority facility or
29 community mental health program is the Director of the Oregon Health Au-
30 thority, to persons engaged in scientific research, program evaluation, peer
31 review and fiscal audits. However, individual identities may not be disclosed

1 to such persons, except when the disclosure is essential to the research,
2 evaluation, review or audit and is consistent with state and federal law.

3 (c) To governmental agencies when necessary to secure compensation for
4 services rendered in the treatment of the individual.

5 (5) When an individual's identity is disclosed under subsection (4) of this
6 section, a health care services provider shall prepare, and include in the
7 permanent records of the health care services provider, a written statement
8 indicating the reasons for the disclosure, the written accounts disclosed and
9 the recipients of the disclosure.

10 (6) The content of any written account referred to in subsection (2) of this
11 section and held by a health care services provider currently engaged in the
12 treatment of an individual may be disclosed to officers or employees of that
13 provider, its agents or cooperating health care services providers who are
14 currently acting within the official scope of their duties to evaluate treat-
15 ment programs, to diagnose or treat or to assist in diagnosing or treating
16 an individual when the written account is to be used in the course of diag-
17 nosing or treating the individual. Nothing in this subsection prevents the
18 transfer of written accounts referred to in subsection (2) of this section
19 among health care services providers, the Department of Human Services,
20 the Department of Corrections, the Oregon Health Authority or a local
21 correctional facility when the transfer is necessary or beneficial to the
22 treatment of an individual.

23 (7) When an action, suit, claim, arbitration or proceeding is brought un-
24 der ORS 34.105 to 34.240 or 34.310 to 34.730 and involves a claim of consti-
25 tutionally inadequate medical care, diagnosis or treatment, or is brought
26 under ORS 30.260 to 30.300 and involves the Department of Corrections or
27 an institution operated by the department, nothing in this section prohibits
28 the disclosure of any written account referred to in subsection (2) of this
29 section to the Department of Justice, Oregon Department of Administrative
30 Services, or their agents, upon request, or the subsequent disclosure to a
31 court, administrative hearings officer, arbitrator or other administrative de-

1 cision maker.

2 (8)(a) When an action, suit, claim, arbitration or proceeding involves the
3 Department of Human Services, the Oregon Health Authority or an institu-
4 tion operated by the department or authority, nothing in this section pro-
5 hibits the disclosure of any written account referred to in subsection (2) of
6 this section to the Department of Justice, Oregon Department of Adminis-
7 trative Services, or their agents.

8 (b) Disclosure of information in an action, suit, claim, nonlabor arbi-
9 tration or proceeding is limited by the relevancy restrictions of ORS 40.010
10 to 40.585, 183.710 to 183.725, 183.745 and 183.750 and ORS chapter 183. Only
11 written accounts of a plaintiff, claimant or petitioner shall be disclosed un-
12 der this paragraph.

13 (c) Disclosure of information as part of a labor arbitration or proceeding
14 to support a personnel action taken against staff is limited to written ac-
15 counts directly relating to alleged action or inaction by staff for which the
16 personnel action was imposed.

17 (9)(a) The copy of any written account referred to in subsection (2) of this
18 section, upon written request of the individual or a personal representative
19 of the individual, shall be disclosed to the individual or the personal repre-
20 sentative of the individual within a reasonable time not to exceed five
21 working days. The individual or the personal representative of the individual
22 shall have the right to timely access to any written accounts.

23 (b) If the disclosure of psychiatric or psychological information contained
24 in the written account would constitute an immediate and grave detriment
