

## **House Bill 2549**

Thank you for the opportunity to testify on house bill 2549.

The facts of "Pre-Crime" determination are based on fallacy premise and not on actual results over the past 25 years.

The current model of sex offender legislation has shown through many empirical studies from various psychologists, psychiatrists, sociologists, and human behavior scientific evaluation that there is actually no societal benefits to these draconian Regulations, that separating these offenders is not only harmful and extremely difficult for them to reintegrate back into society but also makes their children and families continue to suffer financially and economically.

These laws also do more harm to innocent children in the community by needlessly having them live a life in excessive fear of imagined magnitude of danger. They are stymied from growing up to adventure as children use to do even though the proofs of low crime rates exist.
