SUPPORT THE "RENEW AMERICA'S WATER" CAMPAIGN

WHEREAS, most of the water delivery infrastructure in the United States was constructed over 100 years ago and continues to age and deteriorate; and

WHEREAS, the attendant sewer disposal infrastructure is also badly outdated and actually contributes to the contamination of fresh water delivery to homes, schools and businesses; and

WHEREAS, Federal Funding required to maintain the standards contained in the Clean Water Act(1) and the Safe Drinking Water Act(2) has declined since the Reagan administration and has reached historic lows under the Bush and Obama administrations; and

WHEREAS, the 2004 National Water Quality Inventory assessment reported that 44 percent of the river miles, 64 percent of the lake waters, and 30 percent of the bays and estuaries assessed were too polluted to support their designated uses(3); and

WHEREAS, public schools, the places where our children spend up to 12 years of their life drinking water, currently have zero Federal dollars devoted to the maintenance of their drinking water systems; and

WHEREAS, it is estimated that up to 783,000 jobs(4) could be created nationwide if the "Renew America's Water" campaign is adopted and funded; now therefore be it

RESOLVED that the Oregon AFL-CIO shall support our unemployed sisters and brothers, support our school children, support our freshwater resources, and

support our residential and business communities by signing on in support of the "Renew America's Water" campaign; and be it further

RESOLVED that the Oregon AFL-CIO shall write to the Oregon Congressional delegation to urge their support of the "Renew America's Water" campaign; and now be it finally

RESOLVED that the affiliated Unions of the Oregon AFL-CIO shall also be strongly encouraged to sign on in support of the "Renew America's Water" campaign and to likewise write to the Oregon Congressional delegation to urge their support of the "Renew America's Water" campaign.
