

Other Funds Report


- Other funds are large revenue sources for agencies
 - Can impact the General Fund
- Biannual report DAS sends to Legislature
 - June and December
- OEA provides quarterly updates to General and Lottery Fund outlooks
 - Other Funds update relies upon agencies to report their revenues
- In cooperation with BAM, LRO and individual agencies, OEA is working to increase coverage

Employment Department

State Unemployment Tax Act Revenues

- Source:
 - Employers pay payroll tax on covered employees
 - Rates modified each year on law based on UI Trust fund reserves and employer experience rating


– Use:

- UI benefits paid out of UI Trust fund
- Great Recession depleted the fund
 - Increased claims, reduced wages and lower employment
 - Rates increased to rebuild the fund, will automatically adjust lower as the fund is replenished
 - Oregon's fund remained solvent, unlike many states (36)












BI 11-13 Total Other Funds \$469.1 (\$368.5 without Shared Services) all dollars in millions.



BI 13-15 Total Other Funds \$443.9 (\$332.4 without shared services) all dollars in millions








Park User Fees

- Includes Day Use, Overnight Camping and Reservation Fees \$42 million, 21% of the Department's revenue
- Forecasted revenues include a rate adjustment that raises and additional \$1.6 million for Park Operations
- Rates were last adjusted in May 2010








Recreational Vehicle (RV) Registration Fees

- Registrations declining, temporary or "trip permits" up
- Fee increase in January 2004 masks a long term downward trend
- Split with counties 65% OPRD, 35% Counties
 - SB 331 makes the split 50/50 causing a \$4.8 million loss in revenue to OPRD







Oregon State Fair and Exposition Center


- Annual State Fair \$4.8 million per fair, \$9.6 million biennially
- Exposition Center \$700 thousand per year, \$1.4 million biennially
- Seeking to change the Business Model







Gross State Highway Revenues by Allocation 2013-15 Biennium Forecast




Gross State Highway Revenues by Source & Type 2013-15 Biennium Forecast



Forecast Summary

- Economic contraction had a material impact on use taxes and fee revenues
- Impacts of JTA are very pronounced in our revenue outlook
- Modest growth in revenues going forward in the forecast
- Adjusted for construction and maintenance inflation: revenues are flat
