SUMMARY

Modifies list of state agencies required to designate liaison for emergency preparedness and response. Requires that liaison be individual with authority during emergency to allocate agency resources and assets.

A BILL FOR AN ACT

Relating to emergency services; amending ORS 401.054.

Be It Enacted by the People of the State of Oregon:

SECTION 1. ORS 401.054 is amended to read:

401.054. (1) **Each of** the following state agencies shall designate [*a person within each*] **an individual within the** agency to act as a liaison with the Office of Emergency Management:

[(*a*) *The Department of Transportation;*]

[(*b*) *The State Department of Agriculture;*]

[(*c*) *The Department of Environmental Quality;*]

[(*d*) *The Department of Human Services;*]

[(*e*) *The State Department of Energy;*]

[(*f*) *The Oregon Department of Administrative Services;*]

[(*g*) *The Department of State Police;*]

[(*h*) *The State Department of Geology and Mineral Industries;*]

[(*i*) *The Oregon Health Authority; and*]

[(*j*) *The Oregon Military Department.*]

(a) The Department of Consumer and Business Services;

(b) The Department of Corrections;

(c) The Department of Environmental Quality;

20 **(2) Each state agency required to designate a liaison under this**
21 **section shall designate an individual who has authority during an**
22 **emergency to allocate resources and assets of the agency.**

23 [(2)] **(3) Each [person] individual** designated as a liaison under subsection
24 (1) of this section shall assist in the coordination of the functions of the
25 [person's] **individual's** agency that relate to emergency preparedness and
26 response with similar functions of the Office of Emergency Management.
