The Oregon Brewers Guild (OBG) asks that you support SB 795.

SB 795 permits brewery-public house licensees to store, transport and sell malt beverages at one location other than where manufacturing occurs which clarifies the current law. It also allows temporary sales licensees to sell wine, malt beverages and cider in consumer supplied containers i.e. growlers for off-premises consumption and allows brewery-public house, winery and grower sales privilege licensees to sell wine, malt beverages and cider at special event locations in growlers for off-premises consumption. The bill also allows the applicant for a servers permit to participate in dispensing of wine, malt beverages and cider sold as growlers.

When the growler bill (HB 2443) became law on 04/11/2013 supporting retail licensees to sell beer, wine and cider growlers, it makes sense to allow the same for the same to be done with any temporary sales licenses.

Please support the fixes contained in SB 795.
