**Measure Description:** Appropriates to the Oregon Department of Education (ODE), \$6,235.5 million from the General Fund for the State School Fund (SSF) of the 2013-15 biennium. Allocates for the SSF of the biennium 2013-15, \$314.5 million from the Lottery Funds, and \$0.4 million from miscellaneous ODE revenues.

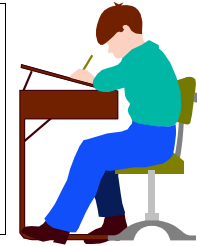
**Impact Explanation:** The total state contribution to the State School Fund (SSF) is \$6,550.4 million. Together with expected Local Revenues of \$3,224.0 million, the total formula revenue available for distribution amounts to \$9.774.4 million for the 2013-15 biennium.

## SCHOOL FINANCE DISTRIBUTION (2013-15)

2013-15 State School Fund \$6.55 billion

- o Assumes SSF is split 49/51 between 2013-14 and 2014-15.
- o Local Revenues: \$1,597.7 million for 2013-14, \$1,626.3 million for 2014-15
- o HB 2506 abolishes RESA and reduces facility grants to \$20 mil from current \$25 mil per biennium
- o NQTL (\$33 mil) is funded by \$5 mil carve-out and \$14 mil each from SD and ESD per biennium
- o Excludes facility grants and assumes the same high cost disability grants as 2012-13 preliminary
- o Uses April 2013 school data and estimates
