

House Bill 2064

Introduced and printed pursuant to House Rule 12.00. Pre-session filed (at the request of House Interim Committee on General Government and Consumer Protection)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Reduces Department of Consumer and Business Services' role in regulating amusement rides, amusement devices and rental amusement devices.

Requires person engaging in occupation of inspecting amusement rides, amusement devices or rental amusement devices to meet and maintain professional qualifications established by department by rule. Changes timing requirement for mandatory annual inspection of ride or device by insurance carrier.

Imposes strict liability on owner of amusement ride, amusement device or rental amusement device for damages caused by operation of ride or device that is contrary to statute, rules or insurer restrictions or conditions.

Makes violation of department rules regulating amusement rides, amusement devices or rental amusement devices punishable by maximum penalty of \$2,500 fine, six months' imprisonment, or both.

5 **Be It Enacted by the People of the State of Oregon:**

6 **SECTION 1. Sections 2 to 5 of this 2013 Act are added to and made a part of ORS 460.310**
7 **to 460.370.**

8 **SECTION 2. A person who engages in the occupation of inspecting amusement rides,**
9 **amusement devices or rental amusement devices must meet and maintain professional**
10 **qualifications as established by the Department of Consumer and Business Services by rule.**
11 **The qualifications established by the department may include, but need not be limited to,**
12 **active certification of the person as an inspector by an amusement industry organization.**

13 **SECTION 3. (1) An owner of an amusement ride, amusement device or rental amusement**
14 **device may not operate, or allow another to operate, the ride or device without first having**
15 **obtained insurance from a company authorized to transact insurance in this state or an eli-**
16 **gible surplus lines insurer as defined in ORS 735.405. The insurance policy must insure the**
17 **public and all persons riding or otherwise in contact with the ride or device against loss or**
18 **injury, in an amount not less than \$1 million per occurrence and an aggregate total of not**
19 **less than \$2 million.**

20 **(2) An owner of an amusement ride, amusement device or rental amusement device may**
21 **not allow the ride or device to be in service unless the ride or device has been inspected by**
22 **an amusement ride inspector on or after the preceding December 15. The inspector must be**
23 **employed, or otherwise be authorized to inspect the ride or device, by the insurance carrier**
24 **insuring the ride or device. The inspector shall note any restrictions and conditions that,**
25 **in the inspector's judgment, should be imposed upon the operation of the ride or device to**

1 protect human life and property. In addition, the inspector shall indicate whether the ride
 2 or device:

3 (a) Meets the insurance carrier's standards;

4 (b) Meets safety standards approved by the American Society for Testing and Materials;
 5 and

6 (c) Is assembled and operated in compliance with the manual supplied by the manufac-
 7 turer of the ride or device.

8 (3) If an insurance carrier notifies the insured that the insurance carrier will no longer
 9 insure an amusement ride, amusement device or rental amusement device, or that insurance
 10 on a ride or device is no longer in force, the owner shall immediately remove the ride or
 11 device from service. The owner may not return the ride or device to service unless the ride
 12 or device is inspected and insurance coverage for the ride or device is obtained as required
 13 by subsection (1) of this section.

14 (4) An owner shall keep records demonstrating that the owner has complied with insur-
 15 ance coverage and annual inspection requirements for the amusement ride, amusement de-
 16 vice or rental amusement device. The owner shall make the records available for public
 17 inspection during reasonable business hours. The owner shall provide copies of the records
 18 to the Department of Consumer and Business Services upon request of the department.

19 **SECTION 4.** (1) The Department of Consumer and Business Services may adopt rules for
 20 the administration and enforcement of ORS 460.310 to 460.370. In adopting rules under this
 21 section, the department shall consider:

22 (a) Safety standards followed, proposed or approved by responsible members of the
 23 amusement ride industry and by the American Society for Testing and Materials.

24 (b) The practicability of following the standards under consideration, if adopted.

25 (c) Technological advances in the amusement ride industry.

26 (d) The probability, extent and gravity of the injury to the public or property that would
 27 result from failure to follow the standards under consideration.

28 (2) Rules adopted under subsection (1) of this section may include rules to:

29 (a) Subject a game, device or associated structure otherwise excluded under ORS 460.310
 30 (1)(b), or any other item commercially used to convey persons for purposes of amusement,
 31 to regulation as an amusement device;

32 (b) Exempt a structure, contrivance or combination of structures and contrivances de-
 33 scribed in ORS 460.310 (1)(a) from regulation as an amusement device;

34 (c) Subject a device, structure or equipment not described in ORS 460.310 (8), or any
 35 other item that is commercially rented and used to convey people for amusement purposes,
 36 to regulation as a rental amusement device; or

37 (d) Exempt a device, structure or equipment described in ORS 460.310 (8) from regulation
 38 as a rental amusement device.

39 (3) The owner of equipment described in ORS 460.310 (2)(a)(B) is not a common carrier.
 40 Subject to ORS 30.970 to 30.990, the owner of the equipment must exercise the highest degree
 41 of care to ensure the safety of persons using the equipment. If the department finds that the
 42 United States Forest Service or other agency of government has jurisdiction over, and reg-
 43 ulates and provides inspection of, equipment described in ORS 460.310 (2)(a)(B) under safety
 44 standards adopted by the service or other agency that are not lower than standards adopted
 45 by the department by rule, the department may not apply the department's standards to the

1 equipment.

2 **SECTION 5. (1) An owner of an amusement ride, amusement device or rental amusement**
 3 **device is strictly liable for damages caused by the ride or device being operated in a manner**
 4 **that violates:**

5 (a) A provision of ORS 460.310 to 460.370;

6 (b) A rule adopted under ORS 460.310 to 460.370; or

7 (c) A restriction or condition on operation of the ride or device that is imposed by the
 8 insurance carrier to protect human life and property.

9 (2) Subsection (1) of this section does not apply to damages caused by a rental
 10 amusement device due to tampering or alteration by the renter. This subsection does not
 11 affect any other basis or standard for imposing liability on a rental amusement device owner.

12 **SECTION 6.** ORS 460.310 is amended to read:

13 460.310. As used in ORS 460.310 to 460.370, unless the context requires otherwise:

14 (1) "Amusement [*devices*]" **device," except as provided in section 4 (2) of this 2013 Act:**

15 (a) Means a structure, electrical or mechanical contrivance or combination [*thereof which*] **of**
 16 **structures or contrivances that** is intended to supply revenue to the owner [*or operator*] of the
 17 device by providing or offering to provide amusement, pleasures, thrills or excitement at carnivals,
 18 fairs or amusement parks. [*Amusement device*"]

19 (b) Does not [*include*] **mean** games, concessions and associated structures.

20 (2) "Amusement ride":

21 (a) **Except as provided in this subsection,** means [*any*] a vehicle, boat or other mechanical
 22 device [*except "water slides" moving*] **used to convey one or more individuals for amusement,**
 23 **entertainment, diversion or recreation** upon or within a flow perimeter or structure, along ca-
 24 bles, rails or ground, through the air by centrifugal force or otherwise, or across water, [*that is used*
 25 *to convey one or more individuals for amusement, entertainment, diversion or recreation. The term*
 26 *"amusement ride" includes, but is not limited to*] **such as the following:**

27 [(a)] (A) [*Rides*] **A ride** commonly known as [*Ferris wheels, carousels, parachute towers, bungee*
 28 *jumping, tunnels of love and roller coasters*] **a Ferris wheel, carousel, parachute tower, bungee**
 29 **jump, tunnel of love or roller coaster.**

30 [(b)] (B) Equipment generally associated with winter sports activities, such as [*ski lifts, ski tows,*
 31 *j-bars, t-bars, ski mobiles, chair lifts and aerial tramways*] **a ski lift, ski tow, j-bar, t-bar, ski mo-**
 32 **bile, chair lift or aerial tramway.**

33 [(c)] (C) **A crane, lifting device or other type of** equipment not originally designed to be used
 34 as an amusement ride, [*such as cranes or other lifting devices, when used as part of an amusement*
 35 *ride or device*] **if used for amusement ride purposes or in conjunction with an amusement**
 36 **device or rental amusement device.**

37 (D) **Model railroad equipment.**

38 (b) **Does not mean:**

39 (A) **A water slide, a go-cart, playground equipment or a coin-operated ride; or**

40 (B) **A privately owned ride located on private property, if the ride is open only to selec-**
 41 **tively admitted or specifically invited individuals who do not pay a fee or other charge for**
 42 **access to or use of the ride.**

43 (3) "Amusement ride inspector" means an employee or representative of a casualty insurance
 44 company or companies who is qualified and regularly employed **by** or otherwise authorized by the
 45 insurance company to inspect amusement rides, **amusement devices** and **rental amusement de-**

1 vices for safety.

2 (4) "Department" means the Department of Consumer and Business Services.

3 (5) "Director" means the Director of the Department of Consumer and Business Services.

4 **(6) "Inflatable device or structure" means an air-supported amusement attraction that:**

5 **(a) Incorporates a structure and mechanical system; and**

6 **(b) Uses a high-strength fabric or film that achieves strength, shape and stability by**
 7 **tensioning from internal air pressure.**

8 **(7) "Owner" means:**

9 **(a) A proprietor, managing partner, corporate officer or other person having directional**
 10 **control over a business, partnership, corporation or other entity engaged in the amusement**
 11 **ride, amusement device or rental amusement device industry;**

12 **(b) A lessee of an amusement ride or amusement device; or**

13 **(c) A lessor of a rental amusement device.**

14 **(8) "Rental amusement device," except as provided in section 4 (2) of this 2013 Act, means**
 15 **an inflatable device or structure or a portable rock wall, and any equipment associated with**
 16 **the device, structure or wall, that the owner makes available for rental by consumers.**

17 [(6)] **(9) "Water slide" means a recreational device designed to provide a descending ride on a**
 18 **flowing water film into a splash down pool at the base of the slide.**

19 **SECTION 7.** ORS 460.310, as amended by section 6 of this 2013 Act, is amended to read:

20 460.310. As used in ORS 460.310 to 460.370, unless the context requires otherwise:

21 (1) "Amusement device," except as provided in section 4 (2) of this 2013 Act:

22 (a) Means a structure, electrical or mechanical contrivance or combination of structures or
 23 contrivances that is intended to supply revenue to the owner of the device by providing or offering
 24 to provide amusement, pleasures, thrills or excitement at carnivals, fairs or amusement parks.

25 (b) Does not mean games, concessions and associated structures.

26 (2) "Amusement ride":

27 (a) Except as provided in this subsection, means a vehicle, boat or other mechanical device used
 28 to convey one or more individuals for amusement, entertainment, diversion or recreation upon or
 29 within a flow perimeter or structure, along cables, rails or ground, through the air by centrifugal
 30 force or otherwise, or across water, such as the following:

31 (A) A ride commonly known as a Ferris wheel, carousel, parachute tower, bungee jump, tunnel
 32 of love or roller coaster.

33 (B) Equipment generally associated with winter sports activities, such as a ski lift, ski tow, j-bar,
 34 t-bar, ski mobile, chair lift or aerial tramway.

35 (C) A crane, lifting device or other type of equipment not originally designed to be used as an
 36 amusement ride, if used for amusement ride purposes or in conjunction with an amusement device
 37 or rental amusement device.

38 (D) Model railroad equipment.

39 (b) Does not mean:

40 (A) A water slide, a go-cart, playground equipment or a coin-operated ride; or

41 (B) A privately owned ride located on private property, if the ride is open only to selectively
 42 admitted or specifically invited individuals who do not pay a fee or other charge for access to or
 43 use of the ride.

44 (3) "Amusement ride inspector" means an employee or representative of a casualty insurance
 45 company or companies who is qualified as described in section 2 of this 2013 Act and regularly

1 employed by or otherwise authorized by the insurance company to inspect amusement rides,
2 amusement devices and rental amusement devices for safety.

3 (4) “Department” means the Department of Consumer and Business Services.

4 (5) “Director” means the Director of the Department of Consumer and Business Services.

5 (6) “Inflatable device or structure” means an air-supported amusement attraction that:

6 (a) Incorporates a structure and mechanical system; and

7 (b) Uses a high-strength fabric or film that achieves strength, shape and stability by tensioning
8 from internal air pressure.

9 (7) “Owner” means:

10 (a) A proprietor, managing partner, corporate officer or other person having directional control
11 over a business, partnership, corporation or other entity engaged in the amusement ride, amusement
12 device or rental amusement device industry;

13 (b) A lessee of an amusement ride or amusement device; or

14 (c) A lessor of a rental amusement device.

18 (9) “Water slide” means a recreational device designed to provide a descending ride on a flowing
19 water film into a splash down pool at the base of the slide.

20 **SECTION 8.** ORS 460.340 is amended to read:

21 460.340. (1) *[Permits issued under ORS 460.330 are valid until]* **An annual inspection per-**
22 **formed under section 3 of this 2013 Act becomes invalid if** the amusement ride, **amusement**
23 **device or rental amusement** device is materially rebuilt or materially modified so as to change the
24 original action of the *[said amusement]* ride or device. **The owner of a ride or device described**
25 **in this subsection must obtain a new inspection prior to returning the ride or device to ser-**
26 **vice.***[, but in no case for longer than one year after the date of issuance as follows:]*

27 *[(1) If an amusement ride or device is altered so as to change the original action of the said*
28 *amusement ride or device, such amusement ride or device shall be subject to a new inspection and shall*
29 *apply for a new permit under ORS 460.330.]*

30 (2) If an amusement ride, **amusement device or rental amusement** device is moved and in-
31 stalled in another place but is not altered so as to change the original action of the *[said amusement*
32 *ride or device, no new permit shall be required; provided, however, a permit has been issued previously*
33 *under ORS 460.330 and has not been operative for longer than a one-year period]* **ride or device, the**
34 **movement and installation does not invalidate the annual inspection performed on the ride**
35 **or device.**

36 **SECTION 9.** ORS 460.990 is amended to read:

37 460.990. (1) Violation of any of the provisions of ORS 460.005 to 460.175 is a Class C
38 misdemeanor.

39 (2) Violation of any **of the** provisions of ORS 460.310 to 460.370 **or rules adopted under ORS**
40 **460.310 to 460.370** is a Class B misdemeanor.

41 **SECTION 10.** ORS 455.010 is amended to read:

42 455.010. As used in this chapter, unless the context requires otherwise:

43 (1)(a) “Advisory board” means the board with responsibility for assisting in the adoption,
44 amendment or administration of a specialty code, specifically:

45 (A) The Building Codes Structures Board established under ORS 455.132;

1 (B) The Electrical and Elevator Board established under ORS 455.138;

2 (C) The State Plumbing Board established under ORS 693.115;

3 (D) The Board of Boiler Rules established under ORS 480.535;

4 (E) The Residential and Manufactured Structures Board established under ORS 455.135;

5 (F) The Mechanical Board established under ORS 455.140; or

6 (G) The Construction Industry Energy Board established under ORS 455.492.

7 (b) "Appropriate advisory board" means the advisory board that has jurisdiction over a partic-
8 ular code, standard, license, certification or matter.

9 (2) "Department" means the Department of Consumer and Business Services.

10 (3) "Director" means the Director of the Department of Consumer and Business Services.

11 (4) "Low-Rise Residential Dwelling Code" means the adopted specialty code prescribing stan-
12 dards for the construction of residential dwellings that are three stories or less above grade and
13 have an exterior door for each dwelling unit, but are not facilities or homes described in ORS
14 443.400 or transient lodging.

15 (5) "Municipality" means a city, county or other unit of local government otherwise authorized
16 by law to administer a building code.

17 (6) "Prefabricated structure" means a building or subassembly that has been in whole or sub-
18 stantial part manufactured or assembled using closed construction at an off-site location to be
19 wholly or partially assembled on-site. "Prefabricated structure" does not include a manufactured
20 dwelling, recreational structure or recreational vehicle, as those terms are defined in ORS 446.003.

21 (7) "Specialty code" means a code of regulations adopted under ORS 446.062, 446.185, 447.020 (2),
22 455.020 (2), 455.496, 455.610, 455.680, 460.085, [460.360,] 479.730 (1) or 480.545 **or section 4 of this**
23 **2013 Act**, but does not include regulations adopted by the State Fire Marshal pursuant to ORS
24 chapter 476 or ORS 479.015 to 479.200 and 479.210 to 479.220.

25 (8) "State building code" means the combined specialty codes.

26 (9) "Structural code" means the specialty code prescribing structural standards for building
27 construction.

28 (10) "Unsafe condition" means a condition caused by earthquake which is determined by the
29 department or any representative of the department to be dangerous to life and property. "Unsafe
30 condition" includes but is not limited to:

31 (a) Any portion, member or appurtenance of a building that has become detached or dislodged
32 or appears likely to fail or collapse and thereby injure persons or damage property; or

33 (b) Any portion, of a building or structure that has been damaged by earthquake, or by fire or
34 explosion resulting from an earthquake, to the extent that the structural strength or stability of the
35 building is substantially less than it was prior to the earthquake.

36 **SECTION 11.** ORS 455.022 is amended to read:

37 455.022. All moneys deposited to the Consumer and Business Services Fund that are derived
38 pursuant to ORS 455.240 [or 460.370], or from state building code or specialty code program fees for
39 which the amounts are established by Department of Consumer and Business Services rule pursuant
40 to ORS 455.020 (2), are continuously appropriated to the department for carrying out any of the
41 duties, functions and powers of the department under ORS 455.240 [or 460.310 to 460.370] or under
42 a program for which a fee amount is established by department rule pursuant to ORS 455.020 (2),
43 without regard to the source of the moneys.

44 **SECTION 12.** ORS 455.148 is amended to read:

45 455.148. (1)(a) A municipality that assumes the administration and enforcement of a building in-

1 inspection program shall administer and enforce the program for all of the following:

2 (A) The state building code, as defined in ORS 455.010, except as set forth in paragraph (b) of
3 this subsection.

4 (B) Manufactured structure installation requirements under ORS 446.155, 446.185 (1) and 446.230.

5 (C) Manufactured dwelling parks and mobile home parks under ORS chapter 446.

6 (D) Park and camp programs regulated under ORS 455.680.

7 (E) Tourist facilities regulated under ORS 446.310 to 446.350.

8 (F) Manufactured dwelling alterations regulated under ORS 446.155.

9 (G) Manufactured structure accessory buildings and structures under ORS 446.253.

10 (H) Boilers and pressure vessels described in rules adopted under ORS 480.525 (5).

11 (b) A building inspection program of a municipality may not include:

12 (A) Boiler and pressure vessel programs under ORS 480.510 to 480.670 except those described
13 in rules adopted under ORS 480.525 (5);

14 (B) Elevator programs under ORS 460.005 to 460.175;

15 (C) Amusement ride, **amusement device or rental amusement device** regulation under ORS
16 460.310 to 460.370;

17 (D) Prefabricated structure regulation under ORS chapter 455;

18 (E) Manufacture of manufactured structures programs under ORS 446.155 to 446.285, including
19 the administration and enforcement of federal manufactured dwelling construction and safety stan-
20 dards adopted under ORS 446.155 or the National Manufactured Housing Construction and Safety
21 Standards Act of 1974;

22 (F) Licensing and certification, or the adoption of statewide codes and standards, under ORS
23 chapter 446, 447, 455, 479 or 693; or

24 (G) Review of plans and specifications as provided in ORS 455.685.

25 (2) A municipality that administers a building inspection program as allowed under this section
26 shall do so for periods of four years. The Department of Consumer and Business Services shall adopt
27 rules to adjust time periods for administration of a building inspection program to allow for vari-
28 ations in the needs of the department and participants.

29 (3) When a municipality administers a building inspection program, the governing body of the
30 municipality shall, unless other means are already provided, appoint a person to administer and
31 enforce the building inspection program, who shall be known as the building official. A building of-
32 ficial shall, in the municipality for which appointed, attend to all aspects of code enforcement, in-
33 cluding the issuance of all building permits. Two or more municipalities may combine in the
34 appointment of a single building official for the purpose of administering a building inspection pro-
35 gram within their communities.

36 (4)(a) By January 1 of the year preceding the expiration of the four-year period described in
37 subsection (2) of this section, the governing body of the municipality shall notify the Director of the
38 Department of Consumer and Business Services and, if the municipality is not a county, notify the
39 county whether the municipality will continue to administer and enforce the building inspection
40 program after expiration of the four-year period.

41 (b) Notwithstanding the January 1 date set forth in paragraph (a) of this subsection, the director
42 and the municipality and, if the municipality is not a county, the county may by agreement extend
43 that date to no later than March 1.

44 (5) If a city does not notify the director, or notifies the director that it will not administer the
45 building inspection program, the county or counties in which the city is located shall administer and

1 enforce the county program within the city in the same manner as the program is administered and
2 enforced outside the city, except as provided by subsection (6) of this section.

3 (6) If a county does not notify the director, or notifies the director that it will not administer
4 and enforce a building inspection program, the director shall contract with a municipality or other
5 person or use such state employees or state agencies as are necessary to administer and enforce a
6 building inspection program, and permit or other fees arising therefrom shall be paid into the Con-
7 sumer and Business Services Fund created by ORS 705.145 and credited to the account responsible
8 for paying the expenses thereof. A state employee may not be displaced as a result of using contract
9 personnel.

10 (7) The governing body of a municipality may commence responsibility for the administration
11 and enforcement of a building inspection program beginning July 1 of any year by notifying the di-
12 rector no later than January 1 of the same year and obtaining the director's approval of an as-
13 sumption plan as described in subsection (11)(c) of this section.

14 (8) The department shall adopt rules to require the governing body of each municipality assum-
15 ing or continuing a building inspection program under this section to submit a written plan with the
16 notice required under subsection (4) or (7) of this section. If the department is the governing body,
17 the department shall have a plan on file. The plan must specify how cooperation with the State Fire
18 Marshal or a designee of the State Fire Marshal will be achieved and how a uniform fire code will
19 be considered in the review process of the design and construction phases of buildings or structures.

20 (9) A municipality that administers and enforces a building inspection program pursuant to this
21 section shall recognize and accept the performances of state building code activities by businesses
22 and persons authorized under ORS 455.457 to perform the activities as if the activities were per-
23 formed by the municipality. A municipality is not required to accept an inspection, a plan or a plan
24 review that does not meet the requirements of the state building code.

25 (10) The department or a municipality that accepts an inspection or plan review as required by
26 this section by a person licensed under ORS 455.457 has no responsibility or liability for the activ-
27 ities of the licensee.

28 (11) In addition to the requirements of ORS 455.100 and 455.110, the director shall regulate
29 building inspection programs that municipalities assume on or after January 1, 2002. Regulation
30 under this subsection shall include but not be limited to:

31 (a) Creating building inspection program application and amendment requirements and proce-
32 dures;

33 (b) Granting or denying applications for building inspection program authority and amendments;

34 (c) Requiring a municipality assuming a building inspection program to submit with the notice
35 given under subsection (7) of this section an assumption plan that includes, at a minimum:

36 (A) A description of the intended availability of program services, including proposed service
37 agreements for carrying out the program during at least the first two years;

38 (B) Demonstration of the ability and intent to provide building inspection program services for
39 at least two years;

40 (C) An estimate of proposed permit revenue and program operating expenses;

41 (D) Proposed staffing levels; and

42 (E) Proposed service levels;

43 (d) Reviewing procedures and program operations of municipalities;

44 (e) Creating standards for efficient, effective, timely and acceptable building inspection pro-
45 grams;

1 (f) Creating standards for justifying increases in building inspection program fees adopted by a
2 municipality;

3 (g) Creating standards for determining whether a county or department building inspection
4 program is economically impaired in its ability to reasonably continue providing the program
5 throughout a county, if another municipality is allowed to provide a building inspection program
6 within the same county; and

7 (h) Enforcing the requirements of this section.

8 (12) The department may assume administration of a building inspection program:

9 (a) During the pendency of activities under ORS 455.770;

10 (b) If a municipality abandons or is no longer able to administer the building inspection program;
11 and

12 (c) If a municipality fails to substantially comply with any provision of this section or of ORS
13 455.465, 455.467 and 455.469.

14 (13) A municipality that abandons or otherwise ceases to administer a building inspection pro-
15 gram that the municipality assumed under this section may not resume the administration or
16 enforcement of the program for at least two years. The municipality may resume the administration
17 and enforcement of the abandoned program only on July 1 of an odd-numbered year. Prior to re-
18 suming the administration and enforcement of the program, the municipality must follow the notifi-
19 cation procedure set forth in subsection (7) of this section.

20 **SECTION 13.** ORS 455.150 is amended to read:

21 455.150. (1) Except as provided in subsection (14) of this section, a municipality that assumes the
22 administration and enforcement of a building inspection program prior to January 1, 2002, may ad-
23 minister and enforce all or part of a building inspection program. A building inspection program:

24 (a) Is a program that includes the following:

25 (A) The state building code, as defined in ORS 455.010, except as set forth in paragraph (b) of
26 this subsection.

27 (B) Manufactured structure installation requirements under ORS 446.155, 446.185 (1) and 446.230.

28 (C) Manufactured dwelling parks and mobile home parks under ORS chapter 446.

29 (D) Park and camp programs regulated under ORS 455.680.

30 (E) Tourist facilities regulated under ORS 446.310 to 446.350.

31 (F) Manufactured dwelling alterations regulated under ORS 446.155.

32 (G) Manufactured structure accessory buildings and structures under ORS 446.253.

33 (H) Boilers and pressure vessels described in rules adopted under ORS 480.525 (5).

34 (b) Is not a program that includes:

35 (A) Boiler and pressure vessel programs under ORS 480.510 to 480.670 except those described
36 in rules adopted under ORS 480.525 (5);

37 (B) Elevator programs under ORS 460.005 to 460.175;

38 (C) Amusement ride, **amusement device or rental amusement device** regulation under ORS
39 460.310 to 460.370;

40 (D) Prefabricated structure regulation under ORS chapter 455;

41 (E) Manufacture of manufactured structures programs under ORS 446.155 to 446.285, including
42 the administration and enforcement of federal manufactured dwelling construction and safety stan-
43 dards adopted under ORS 446.155 or the National Manufactured Housing Construction and Safety
44 Standards Act of 1974;

45 (F) Licensing and certification, or the adoption of statewide codes and standards, under ORS

1 chapter 446, 447, 455, 479 or 693; and

2 (G) Review of plans and specifications as provided in ORS 455.685.

3 (2) A municipality that administers a building inspection program as allowed under this section
4 shall do so for periods of four years. The Department of Consumer and Business Services shall adopt
5 rules to adjust time periods for administration of a building inspection program to allow for vari-
6 ations in the needs of the department and participants.

7 (3) When a municipality administers a building inspection program, the governing body of the
8 municipality shall, unless other means are already provided, appoint a person to administer and
9 enforce the building inspection program or parts thereof, who shall be known as the building official.
10 A building official shall, in the municipality for which appointed, attend to all aspects of code
11 enforcement, including the issuance of all building permits. Two or more municipalities may combine
12 in the appointment of a single building official for the purpose of administering a building inspection
13 program within their communities.

14 (4)(a) By January 1 of the year preceding the expiration of the four-year period described in
15 subsection (2) of this section, the governing body of the municipality shall notify the Director of the
16 Department of Consumer and Business Services and, if not a county, notify the county whether the
17 municipality will continue to administer the building inspection program, or parts thereof, after ex-

19 enforced by a municipality, the parts shall correspond to a classification designated by the director

29 (6) If a county does not notify the director, or notifies the director that it will not administer
30 and enforce certain specialty codes or parts thereof under the building inspection program, the di-
31 rector shall contract with a municipality or other person or use such state employees or state
32 agencies as are necessary to administer and enforce those codes or parts thereof, and permit or
33 other fees arising therefrom shall be paid into the Consumer and Business Services Fund created
34 by ORS 705.145 and credited to the account responsible for paying such expenses. A state employee
35 may not be displaced as a result of using contract personnel.

36 (7) If a municipality administering a building inspection program under this section seeks to
37 administer additional parts of a program, the municipality must comply with ORS 455.148, including
38 the requirement that the municipality administer and enforce all aspects of the building inspection
39 program. Thereafter, the municipality is subject to ORS 455.148 and ceases to be subject to this
40 section.

41 (8) The department shall adopt rules to require the governing body of each municipality to
42 submit a written plan with the notice required under subsection (4) of this section. If the department
43 is the governing body, the department shall have a plan on file. The plan shall specify how coop-
44 eration with the State Fire Marshal or a designee of the State Fire Marshal will be achieved and
45 how a uniform fire code will be considered in the review process of the design and construction

1 phases of buildings or structures.

2 (9) A municipality that administers a code for which persons or businesses are authorized under
3 ORS 455.457 to perform activities shall recognize and accept those activities as if performed by the
4 municipality. A municipality is not required to accept an inspection, a plan or a plan review that
5 does not meet the requirements of the state building code.

6 (10) The department or a municipality that accepts an inspection or plan review as required by
7 this section by a person licensed under ORS 455.457 has no responsibility or liability for the activ-
8 ities of the licensee.

9 (11) In addition to the requirements of ORS 455.100 and 455.110, the director shall regulate
10 building inspection programs of municipalities assumed prior to January 1, 2002. Regulation under
11 this subsection shall include but not be limited to:

12 (a) Creating building inspection program application and amendment requirements and proce-
13 dures;

14 (b) Granting or denying applications for building inspection program authority and amendments;

15 (c) Reviewing procedures and program operations of municipalities;

16 (d) Creating standards for efficient, effective, timely and acceptable building inspection pro-

18 (e) Creating standards for justifying increases in building inspection program fees adopted by a
19 municipality;

20 (f) Creating standards for determining whether a county or department building inspection pro-
21 gram is economically impaired in its ability to reasonably continue providing the program or part

23 spection program or part of a program within the same county; and

24 (g) Enforcing the requirements of this section.

25 (12) The department may assume administration of a building inspection program:

26 (a) During the pendency of activities under ORS 455.770;

27 (b) If a municipality abandons any part of the building inspection program or is no longer able
28 to administer the building inspection program; and

29 (c) If a municipality fails to substantially comply with any provision of this section or of ORS
30 455.465, 455.467 and 455.469.

31 (13) If a municipality abandons or otherwise ceases to administer all or part of a building in-
32 spection program described in this section, the municipality may not resume the administration and
33 enforcement of the abandoned program or part of a program for at least two years. The municipality
34 may resume the administration and enforcement of the abandoned program or part of a program only
35 on July 1 of an odd-numbered year. To resume the administration and enforcement of the abandoned
36 program or part of a program, the municipality must comply with ORS 455.148, including the re-
37 quirement that the municipality administer and enforce all aspects of the building inspection pro-
38 gram. Thereafter, the municipality is subject to ORS 455.148 and ceases to be subject to this
39 section.

40 (14) A municipality that administers and enforces a building inspection program under this sec-
41 tion shall include in the program the inspection of boilers and pressure vessels described in sub-
42 section (1)(a)(H) of this section.

44 455.230. (1) Except as otherwise provided by law, all moneys appropriated or credited to the
45 Consumer and Business Services Fund and received under this chapter, ORS 447.010 to 447.156,

 2 ORS chapter 693 hereby are appropriated continuously for and shall be used by the director for the

18 (c) Located in a private residence, except for initial installation.

19 (2) The owner or user of an elevator described in subsection (1) of this section may request that
 20 the Department of Consumer and Business Services inspect the elevator. If the department performs
 21 the inspection, the department, notwithstanding subsection (1) of this section, may collect the ap-

27 (b) Hoists for raising or lowering materials and that are provided with unguided hooks, slings

31 (d) Stackers that serve one floor only.

32 (e) Window-washing scaffolds.

33 (f) Nonpower-driven lifting devices.

34 (g) Amusement rides, **amusement devices or rental amusement devices.**

35 (h) Mine elevators.

36 (i) Elevators under the supervision of the United States Government.

37 (j) Elevators located in private residences, except for initial installation permits and installation
 38 inspections.

39 (k) Other elevators and equipment as provided by the department by rule.

40 **SECTION 16.** ORS 705.145 is amended to read:

41 705.145. (1) There is created in the State Treasury a fund to be known as the Consumer and
 42 Business Services Fund, separate and distinct from the General Fund. All moneys collected or re-
 43 ceived by the Department of Consumer and Business Services, except moneys collected pursuant to
 44 ORS 735.612 and those moneys required to be paid into the Workers' Benefit Fund, shall be paid into
 45 the State Treasury and credited to the Consumer and Business Services Fund. Moneys in the fund

1 may be invested in the same manner as other state moneys and any interest earned shall be credited
2 to the fund.

3 (2) The department shall keep a record of all moneys deposited in the Consumer and Business

13 programs shall be financed by the fees, assessments and charges established and collected in con-

32 446.756, or education and training programs pertaining thereto, must be assigned to a single account
33 within the fund.

34 (9) Notwithstanding subsections (2), (3) and (5) of this section, the moneys derived pursuant to
35 ORS 455.240 [or 460.370] or from state building code or specialty code program fees for which the
36 amount is established by department rule pursuant to ORS 455.020 (2) and deposited to the fund,
37 interest earned on those moneys and withdrawals of moneys for activities or programs described
38 under ORS 455.240 or 446.566 to 446.646, 446.661 to 446.756 and 460.310 to 460.370, structural or
39 mechanical specialty code programs or activities for which a fee is collected under ORS 455.020 (2),
40 or programs described under subsection (10) of this section that provide training and education for
41 persons employed in producing, selling, installing, delivering or inspecting manufactured structures
42 or manufactured dwelling parks or recreation parks, must be assigned to a single account within the
43 fund.

44 (10) Notwithstanding ORS 279.835 to 279.855 and ORS chapters 279A and 279B, the department
45 may, after consultation with the appropriate specialty code advisory boards established under ORS

1 455.132, 455.135, 455.138, 480.535 and 693.115, contract for public or private parties to develop or
2 provide training and education programs relating to the state building code and associated licensing
3 or certification programs.

5 **repealed.**

6 **SECTION 18. The Department of Consumer and Business Services shall adopt initial rules**
