SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Changes name of Oregon Health Licensing Agency to Health Licensing Office and name of Oregon Health Licensing Agency Account to Health Licensing Office Account. Provides that office is created within Oregon Health Authority. Provides Director of Oregon Health Authority with appointment power over Director of Health Licensing Office.

Becomes operative [January] July 1, 2014. [Declares emergency, effective on passage.]
