

House Bill 2086

Introduced and printed pursuant to House Rule 12.00. Pre-session filed (at the request of Governor John A. Kitzhaber, M.D., for Department of Veterans' Affairs)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Directs Oregon State Lottery Commission to establish lottery games to benefit veterans' education and economic development.

Establishes Veterans' Lottery Fund. Continuously appropriates moneys in fund to Department of Veterans' Affairs for education, training and job creation.

Allocates revenues from veteran-related games to Veterans' Lottery Fund.

A BILL FOR AN ACT

1 Relating to Oregon State Lottery games to benefit veterans; and appropriating money.

2 **Be It Enacted by the People of the State of Oregon:**

3 **SECTION 1. Sections 2 and 3 of this 2013 Act are added to and made a part of ORS**
4 **chapter 461.**

5 **SECTION 2. (1) The Oregon State Lottery Commission shall establish one or more lottery**
6 **games:**

7 **(a) That have a veteran theme or indicate that the proceeds benefit veterans' education**
8 **and economic development; and**

9 **(b) From which the net proceeds must be used to benefit veterans' education and eco-**
10 **nomical development.**

11 **(2) The commission shall separately record and account for the costs and net proceeds**
12 **of games operated under this section.**

13 **(3) When transferring net proceeds to the Administrative Services Economic Develop-**
14 **ment Fund established in ORS 461.540 from the Oregon State Lottery Fund established in**
15 **ORS 461.530, the commission shall certify to the Oregon Department of Administrative Ser-**
16 **vices the amount of the transfer that represents the net proceeds of games described in**
17 **subsection (1) of this section.**

18 **(4) The Oregon Department of Administrative Services shall allocate an amount equal to**
19 **the net proceeds of games provided for in this section for transfer from the Administrative**
20 **Services Economic Development Fund to the Veterans' Lottery Fund established in section**
21 **3 of this 2013 Act.**

22 **SECTION 3. The Veterans' Lottery Fund is established in the State Treasury, separate**
23 **and distinct from the General Fund. Earnings on moneys in the Veterans' Lottery Fund**
24 **must be credited to the fund. All moneys in the fund are continuously appropriated to the**
25 **Department of Veterans' Affairs for the purposes of educating, training and creating jobs for**
26 **veterans and otherwise furthering economic development related to veterans.**

27 **SECTION 4. The Oregon State Lottery Commission shall begin sales of tickets or shares**
28 **for one or more of the lottery games authorized by section 2 of this 2013 Act on or before**
