SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Consolidates provisions relating to Oregon Health Licensing Agency's authority over certificates, permits, licenses and registrations and fees collected for certificates, permits, licenses and registrations. Makes other modifications to provisions relating to Oregon Health Licensing Agency and boards and councils administered by agency.

Becomes operative on January 1, 2014.

Declares emergency, effective on passage.

16 **SECTION 1. Sections 2 to 4 of this 2013 Act are added to and made a part of ORS 676.605**
17 **to 676.625.**

18 **SECTION 2. As used in ORS 676.605 to 676.625:**

19 (1) "Active authorization" means an authorization that is current and not suspended.

20 (2) "Authorization" means a certificate, license, permit or registration issued by the
21 Oregon Health Licensing Agency that allows a person to practice one of the occupations or
22 professions or maintain a facility subject to the authority of the boards and councils listed
23 in ORS 676.606.

24 (3) "Expired authorization" means an authorization that has been not current for more
25 than three years.

NOTE: Matter in **boldfaced** type in an amended section is new; matter *[italic and bracketed]* is existing law to be omitted. New sections are in **boldfaced** type.

1 (4) "Inactive authorization" means an authorization that has been not current for three
2 years or less.

3 **SECTION 3.** (1) Except as provided in subsection (2) or (7) of this section, an authori-
4 zation issued by the Oregon Health Licensing Agency becomes not current on the last day
5 of the month, one year from the date of issuance.

6 (2) A certificate issued under ORS 690.005 to 690.235 becomes not current on the last day
7 of the month, two years from the date of issuance.

8 (3) In order to renew an authorization, the holder of the authorization shall submit to
9 the agency on or before the date on which the authorization becomes not current:

10 (a) A renewal application;

11 (b) Fees established by the agency under section 4 of this 2013 Act; and

12 (c) Any other information required by the agency by rule.

13 (4) In order to activate an inactive authorization, the holder of the authorization shall
14 submit to the agency within three years after the authorization becomes not current:

15 (a) An activation application;

16 (b) Fees established by the agency under section 4 of this 2013 Act; and

17 (c) Any other information required by the agency by rule.

18 (5) In order to obtain a new authorization, the holder of an expired authorization shall
19 submit a new application, pay fees established by the agency under section 4 of this 2013 Act
20 and meet all requirements for a new authorization.

21 (6) If an authorization has been denied, suspended or revoked for commission of a pro-
22 hibited act under ORS 676.612, the agency may not issue or renew the authorization for at
23 least one year after the denial, suspension or revocation.

24 (7) The agency may vary the date on which an authorization becomes not current by
25 providing the holder of the authorization with written notice of the new date and prorating
26 the renewal fee accordingly.

27 (8)(a) An authorization must be posted at all times in public view at the location where
28 services are rendered, in accordance with rules adopted by the agency.

29 (b) A facility authorization must be posted at all times in public view at the facility ad-
30 dress on file with the agency.

31 (9) This section does not apply to temporary authorizations or authorizations related to
32 demonstration permits.

33 **SECTION 4.** (1) The Oregon Health Licensing Agency shall establish by rule and collect
34 fees for:

35 (a) Application for authorization;

36 (b) Original authorization;

37 (c) Renewal of authorization;

38 (d) Examinations and reexaminations;

39 (e) Authorizations related to demonstration permits;

40 (f) Temporary or provisional authorization;

41 (g) Replacement authorization;

42 (h) Late renewal of authorization;

43 (i) Reciprocity;

44 (j) Authorizations related to freelance licenses and independent contractor registrations;

45 (k) Authorizations related to facilities;

1 (L) Renewal of dormant authorization;

2 (m) Activation of inactive authorization;

3 (n) Verification of authorization;

4 (o) Duplicate authorization;

5 (p) Education or training provided by the agency; and

6 (q) Providing copies of official documentation or records and for recovering administra-
7 tive costs associated with compiling, photocopying, preparing and delivering the documenta-
8 tion or records.

9 (2) All moneys collected by the agency under this section shall be paid into the General
10 Fund of the State Treasury and credited to the Oregon Health Licensing Agency Account
11 established under ORS 676.625.

20 **SECTION 6.** ORS 676.185 is amended to read:

21 676.185. As used in ORS 676.185 to 676.200:

22 (1) "Health profession licensing board" means:

23 (a) A health professional regulatory board as defined in ORS 676.160; or

24 (b) The Oregon Health Licensing Agency for a board[, or council [*or program*]] listed in ORS
25 676.606.

26 (2) "Impaired professional" means a licensee who is unable to practice with professional skill
27 and safety by reason of habitual or excessive use or abuse of drugs, alcohol or other substances that
28 impair ability or by reason of a mental health disorder.

29 (3) "Licensee" means a health professional licensed or certified by or registered with a health
30 profession licensing board.

31 **SECTION 7.** ORS 676.605 is amended to read:

32 676.605. (1) To provide for the more effective coordination of administrative and regulatory
33 functions of certain health boards[, *councils and programs*] **and councils** involved in protecting the
34 public through the licensing and regulation of health-related professions and occupations practiced
35 in this state under uniform mission and goals, there is hereby created the Oregon Health Licensing
36 Agency.

37 (2) The mission of the agency is to serve the public by providing a uniform structure and ac-
38 countability for the boards[, *councils and programs*] **and councils** under its administration to protect
39 the public from harm. The agency's focus is to:

40 (a) Promote effective health policy that protects the public from incompetent or unauthorized
41 individuals and allows consumers to select a provider from a range of safe options.

42 (b) Provide outreach and training to stakeholders to improve compliance with public health and
43 safety standards, and to involve stakeholders in the regulation of the various disciplines and fields
44 of practice.

45 (c) Form partnerships and work in collaboration with each constituency, local and state gov-

1 ernmental agencies, educators, organizations and other affected entities to encourage diverse opin-
2 ions and perspectives.

3 (d) Provide the boards[, *councils and programs*] **and councils** with a standardized administrative
4 forum and procedures for operation, fiscal services, licensing, enforcement and complaint resolution.

5 (e) Resolve disputes between regulatory entities regarding the scope of practice of persons [*li-*
6 *censed*] **with authorization** by those entities **in the professions and occupations overseen by**
7 **those boards and councils.**

8 **SECTION 8.** ORS 676.606 is amended to read:

9 676.606. Pursuant to ORS 676.607, the Oregon Health Licensing Agency shall provide adminis-
10 trative and regulatory oversight and centralized service for the following boards[, *advisory councils*
11 *and programs*] **and councils**:

12 (1) Board of Athletic Trainers, as provided in ORS 688.701 to 688.734;

13 (2) Board of Cosmetology, as provided in ORS 690.005 to 690.235;

14 (3) State Board of Denture Technology, as provided in ORS 680.500 to 680.565;

15 (4) State Board of Direct Entry Midwifery, as provided in ORS 687.405 to 687.495;

16 (5) Respiratory Therapist and Polysomnographic Technologist Licensing Board, as provided in
17 ORS 688.800 to 688.840;

18 (6) Environmental Health Registration Board, as provided in ORS chapter 700;

19 (7) Board of Body Art Practitioners, as provided in ORS 690.350 to 690.415;

20 (8) Advisory Council on Hearing Aids, as provided in ORS 694.015 to 694.185;

24 **SECTION 9.** ORS 676.607 is amended to read:

25 676.607. (1) The Oregon Health Licensing Agency is responsible for the administration and reg-
26 ulatory oversight of the boards[, *councils and programs*] **and councils** listed in ORS 676.606. The
27 responsibilities of the agency include, but are not limited to:

28 (a) Budgeting;

29 (b) Record keeping;

30 (c) Staffing;

31 (d) Contracting;

32 (e) Consumer protection and investigating complaints;

33 (f) [*Approving*] **Establishing** and collecting fees;

34 (g) Establishing and administering uniform application processes for the issuance of [*certificates,*
35 *licenses, permits and registrations*] **authorizations**;

36 (h) Issuing and renewing [*certificates, licenses, permits and registrations*] **authorizations**;

37 (i) Conditioning, limiting, suspending, revoking or refusing to issue or renew [*a certificate, li-*
38 *cence, permit or registration*] **an authorization** or otherwise disciplining applicants[, *certificate*
39 *holders, licensees, permit holders and registration*] **and authorization** holders;

40 (j) Sanctioning any examination service provider, interpreter or proctor who is under contract
41 or agreement with the agency and who compromises the security, confidentiality or integrity of ex-
42 aminations developed or conducted pursuant to the statutory authority of the boards and councils
43 listed in ORS 676.606;

44 (k) Enforcing all administrative rules adopted under any statute the agency is charged with
45 enforcing, including board[, *council and program*] **and council** administrative rules establishing

1 professional code of conduct and practice standards, [*continuing education requirements*,] the scope
2 of professional practice and requirements for obtaining informed consent before providing certain
3 services or performing any procedure on clients;

4 (L) Preparing, tracking and reporting agency performance measures;

5 (m) Implementing regulatory streamlining initiatives to reduce regulatory burdens without com-
6 promising regulatory standards;

7 (n) Preparing and circulating printed and electronic materials for educating or otherwise as-
8 sisting applicants, [*certificate holders, licensees, permit holders and registration*] **authorization** hold-
9 ers and the public;

10 (o) Adopting rules for the issuance of waivers or provisional authorizations to practice, and es-
11 tablishing special conditions of practice, during a state of emergency declared by the Governor un-
12 der ORS 401.165;

13 (p) Referring impaired practitioners to a diversion program approved or recognized by the
14 agency and establishing criteria by rule for monitoring the impaired practitioner's progress and
15 successful completion of the program; [*and*]

16 (q) Establishing requirements for additional education, training or supervised experience to
17 achieve compliance with the laws and rules governing professional practice[.];

18 (r) **Establishing by rule continuing education requirements for renewal of an authori-**
19 **zation if the agency determines that continuing education is appropriate for renewal of the**

21 (s) **Exempting from authorization requirements a person who provides services at chari-**
22 **table or fund raising events, after the agency has considered and evaluated the written re-**
23 **quest for an exemption on an individual basis; and**

26 (2) The enumeration of duties, functions and powers in subsection (1) of this section is not in-
27 tended to be exclusive or to limit the duties, functions and powers imposed on or vested in the

29 **SECTION 10.** ORS 676.608 is amended to read:

30 676.608. (1) As used in this section,[:]

31 [(a) "*Holder*" means a person who holds a certificate, license, permit or registration to practice is-
32 sued by the Oregon Health Licensing Agency.]

33 [(b)] "public entity" has the meaning given that term in ORS 676.177.

34 (2)(a) The **Oregon Health Licensing** Agency shall carry out all investigatory duties **relating**
35 **to the boards and councils listed in ORS 676.606.**

36 (b) Upon its own motion, the agency may initiate and conduct investigations of matters relating
37 to the practice of occupations or professions subject to the authority of the boards[, *councils and*
38 *programs*] **and councils** listed in ORS 676.606.

39 (c) When the agency receives a complaint by any person against [*a*] **an authorization** holder,
40 the agency shall investigate the complaint as provided in ORS 676.165.

41 (3) While conducting an investigation authorized under subsection (2) of this section or a hear-
42 ing related to an investigation, the agency may:

43 (a) Take evidence;

44 (b) Administer oaths;

45 (c) Take the depositions of witnesses, including the person charged;

1 (d) Compel the appearance of witnesses, including the person charged;

2 (e) Require answers to interrogatories;

3 (f) Compel the production of books, papers, accounts, documents and testimony pertaining to the
4 matter under investigation; and

5 (g) Conduct criminal and civil background checks to determine conviction of a crime that bears
6 a demonstrable relationship to the field of practice.

7 (4) In exercising its authority under this section, the agency may issue subpoenas over the sig-
8 nature of the Director of the Oregon Health Licensing Agency or designated employee thereof and
9 in the name of the State of Oregon.

10 (5) If a person fails to comply with a subpoena issued under this section, the judge of the Circuit
11 Court for Marion County may compel obedience by initiating proceedings for contempt as in the
12 case of disobedience of the requirements of a subpoena issued from the court.

13 (6) If necessary, the director, or an employee designated by the director, may appear before a
14 magistrate empowered to issue warrants in criminal cases to request that the magistrate issue a
15 warrant. The magistrate shall issue a warrant, directing it to any sheriff or deputy or police officer,
16 to enter the described property, to remove any person or obstacle, to defend any threatened violence
17 to the director or a designee of the director or an officer, upon entering private property, or to as-
18 sist the director in enforcing the agency's authority in any way.

19 (7) In all investigations and hearings, the agency and any person affected *[thereby]* **by the in-**
20 **vestigation or hearing** may have the benefit of counsel.

21 (8) If *[a]* **an authorization** holder who is the subject of a complaint or an investigation is to
22 appear before the agency, the agency shall provide the **authorization** holder with a current sum-
23 mary of the complaint or the matter being investigated not less than 10 days before the date that
24 the **authorization** holder is to appear. At the time the summary of the complaint or the matter be-
25 ing investigated is provided, the agency shall provide the **authorization** holder with a current
26 summary of documents or alleged facts that the agency has acquired as a result of the investigation.
27 The name of the complainant may be withheld from the **authorization** holder.

28 (9) *[A]* **An authorization** holder who is the subject of an investigation, and any person acting
29 on behalf of the **authorization** holder, may not contact the complainant until the **authorization**
30 holder has requested a contested case hearing and the agency has authorized the taking of the
31 complainant's deposition pursuant to ORS 183.425.

32 (10) Except in an investigation or proceeding conducted by the agency or another public entity,
33 or in an action, suit or proceeding in which a public entity is a party, *[a]* **an authorization** holder
34 may not be questioned or examined regarding any communication with the agency made in an ap-
35 pearance before the agency as part of an investigation.

36 (11) This section does not prohibit examination or questioning of *[a]* **an authorization** holder
37 regarding records about the **authorization** holder's care and treatment of a patient or affect the
38 admissibility of those records.

40 676.610. (1)(a) The Oregon Health Licensing Agency is under the supervision and control of a
41 director, who is responsible for the performance of the duties, functions and powers and for the or-
42 ganization of the agency.

43 (b) The Director of the Oregon Department of Administrative Services shall establish the qual-
44 ifications for and appoint the Director of the Oregon Health Licensing Agency, who holds office at
45 the pleasure of the Director of the Oregon Department of Administrative Services.

1 (c) The Director of the Oregon Health Licensing Agency shall receive a salary as provided by
2 law or, if not so provided, as prescribed by the Director of the Oregon Department of Administrative
3 Services.

4 (d) The Director of the Oregon Health Licensing Agency is in the unclassified service.

17 **SECTION 12.** ORS 676.612 is amended to read:

18 676.612. (1) In the manner prescribed in ORS chapter 183 for contested cases and as specified
19 in ORS 675.385, 678.780, 680.535, 687.445, 688.734, 688.836, 690.167, 690.407, 691.477, 694.147 and
20 700.111, the Oregon Health Licensing Agency may refuse to issue or renew, may suspend or revoke
21 or may otherwise condition or limit [a *certificate, license, permit or registration to practice issued by*
22 *the agency*] **an authorization** or may discipline or place on probation [a *holder of a certificate, li-*
23 *cence, permit or registration*] **an authorization holder** for commission of the prohibited acts listed
24 in subsection (2) of this section.

25 (2) A person subject to the authority of a board[, *council or program*] **or council** listed in ORS
26 676.606 commits a prohibited act if the person engages in:

27 (a) Fraud, misrepresentation, concealment of material facts or deception in applying for or ob-
28 taining an authorization to practice in this state, or in any written or oral communication to the
29 agency concerning the issuance or retention of the authorization.

30 (b) Using, causing or promoting the use of any advertising matter, promotional literature, testi-
31 monial, guarantee, warranty, label, insignia or any other representation, however disseminated or
32 published, that is false, misleading or deceptive.

33 (c) Making a representation that the [*certificate, license, permit or registration*] **authorization**
34 holder knew or should have known is false or misleading regarding skill or the efficacy or value of
35 treatment or remedy administered by the **authorization** holder.

36 (d) Practicing under a false, misleading or deceptive name, or impersonating another [*certificate,*
37 *license, permit or registration*] **authorization** holder.

38 (e) Permitting a person other than the [*certificate, license, permit or registration*] **authorization**
39 holder to use the [*certificate, license, permit or registration*] **authorization**.

40 (f) Practicing with a physical or mental condition that presents an unreasonable risk of harm
41 to the **authorization** holder [*of a certificate, license, permit or registration*] or to the person or
42 property of others in the course of performing the **authorization** holder's duties.

43 (g) Practicing while under the influence of alcohol, controlled substances or other skill-impairing
44 substances, or engaging in the illegal use of controlled substances or other skill-impairing sub-
45 stances so as to create a risk of harm to the person or property of others in the course of per-

1 forming the duties of [a] **an authorization** holder [of a certificate, license, permit or registration].

2 (h) Failing to properly and reasonably accept responsibility for the actions of employees.

3 (i) Employing, directly or indirectly, any suspended, uncertified, unlicensed or unregistered per-
4 son to practice a regulated occupation or profession subject to the authority of the boards[, *councils*
5 *and programs*] **and councils** listed in ORS 676.606.

6 (j) Unprofessional conduct, negligence, incompetence, repeated violations or any departure from
7 or failure to conform to standards of practice in performing services or practicing in a regulated
8 occupation or profession subject to the authority of the boards[, *councils and programs*] **and coun-**
9 **cils** listed under ORS 676.606.

10 (k) Conviction of any criminal offense, subject to ORS 670.280. A copy of the record of con-
11 viction, certified by the clerk of the court entering the conviction, is conclusive evidence of the
12 conviction. A plea of no contest or an admission of guilt [*shall be considered*] **is** a conviction for
13 purposes of this paragraph.

14 (L) Failing to report any adverse action, as required by statute or rule, taken against the [*cer-*
15 *tificate, license, permit or registration*] **authorization** holder by another regulatory jurisdiction or
16 any peer review body, health care institution, professional association, governmental agency, law
17 enforcement agency or court for acts or conduct similar to acts or conduct that would constitute
18 grounds for disciplinary action as described in this section.

19 (m) Violation of a statute regulating an occupation or profession subject to the authority of the
20 boards[, *councils and programs*] **and councils** listed in ORS 676.606.

21 (n) Violation of any rule regulating an occupation or profession subject to the authority of the
22 boards[, *councils and programs*] **and councils** listed in ORS 676.606.

23 (o) Failing to cooperate with the agency in any investigation, inspection or request for infor-
24 mation.

25 (p) Selling or fraudulently obtaining or furnishing [*any certificate, license, permit or registration*]
26 **an authorization** to practice in a regulated occupation or profession subject to the authority of the
27 boards[, *councils and programs*] **and councils** listed in ORS 676.606, or aiding or abetting such an
28 act.

29 (q) Selling or fraudulently obtaining or furnishing any record related to practice in a regulated
30 occupation or profession subject to the authority of the boards[, *councils and programs*] **and coun-**
31 **cils** listed in ORS 676.606, or aiding or abetting such an act.

32 (r) Failing to pay an outstanding civil penalty or fee that is due or failing to meet the terms of
33 any order issued by the agency that has become final.

34 (3) For the purpose of requesting a state or nationwide criminal records check under ORS
35 181.534, the agency may require the fingerprints of a person who is:

36 (a) Applying for [*a certificate, license, permit or registration that is issued by the agency*] **an au-**
37 **thorization;**

38 (b) Applying for renewal of [*a certificate, license, permit or registration that is issued by the*
39 *agency*] **an authorization;** or

40 (c) Under investigation by the agency.

41 (4) If the agency places [*a holder of a certificate, license, permit or registration*] **an authorization**
42 **holder** on probation under subsection (1) of this section, the agency, in consultation with the ap-
43 propriate board[, *council or program*] **or council**, may determine and at any time modify the condi-
44 tions of the probation.

45 (5) If [*a certificate, license, permit or registration*] **an authorization** is suspended, the **authori-**

1 **zation** holder may not practice during the term of suspension. Upon the expiration of the term of
 2 suspension, the [*certificate, license, permit or registration*] **authorization** may be reinstated by the
 3 agency if the conditions of suspension no longer exist and the **authorization** holder has satisfied
 4 all requirements in the relevant statutes or administrative rules for issuance, renewal or rein-
 5 statement.

7 676.613. (1) In addition to all other remedies, when it appears to the Oregon Health Licensing
 8 Agency that a person is engaged in, has engaged in or is about to engage in any act, practice or
 9 transaction that violates any provision of ORS 675.360 to 675.410, [676.617,] 678.710 to 678.820,
 10 680.500 to 680.565, 687.405 to 687.495, 688.701 to 688.734, 688.800 to 688.840, 690.005 to 690.235,
 11 690.350 to 690.415, 691.405 to 691.485 or 694.015 to 694.185 or ORS chapter 700, the agency may,
 12 through the Attorney General or the district attorney of the county in which the act, practice or
 13 transaction occurs or will occur, apply to the court for an injunction restraining the person from

 16 junction issued under this section does not relieve a person from any other prosecution or enforce-
 17 ment action taken for violation of statutes listed in subsection (1) of this section.

(2) The Oregon Health Licensing Agency may take any action before the operative date specified in subsection (1) of this section that is necessary to enable the agency to exercise, on and after the operative date specified in subsection (1) of this section, all the duties, functions and powers conferred on the agency by sections 1 to 5 of this 2013 Act, the amendments to statutes by sections 6 to 64 of this 2013 Act and the repeal of statutes by section 65 of this 2013 Act.

UNIT CAPTIONS

SECTION 67. The unit captions used in this 2013 Act are provided only for the convenience of the reader and do not become part of the statutory law of this state or express any legislative intent in the enactment of this 2013 Act.

EMERGENCY CLAUSE

SECTION 68. This 2013 Act being necessary for the immediate preservation of the public peace, health and safety, an emergency is declared to exist, and this 2013 Act takes effect on its passage.
