

HOUSE AMENDMENTS TO HOUSE BILL 2191

2 line.

3 Delete lines 4 through 31 and delete page 2 and insert:

4 “**SECTION 1.** ORS 345.010 is amended to read:

5 “345.010. As used in ORS 345.010 to 345.450 and 345.992 to 345.997:

6 “(1) ‘Agent’ means [*a person*] **an individual who is** employed by or for a career school, **or is**
7 **working on behalf of the school under a contract**, for the purpose of **actively** procuring students,
8 enrollees or subscribers **of the school** by solicitation in any form[,] **that is** made at a place or
9 places other than the school office or place of business of [*such*] **the** school.

10 “(2) ‘Barbering’ has the meaning given that term in ORS 690.005.

11 “(3) ‘Board’ means the State Board of Education.

12 “(4) ‘Career school’ or ‘school’ means any private proprietary professional, technical, home
13 study, correspondence, business or other school instruction, organization or person that offers any
14 instruction or training for the purpose or purported purpose of instructing, training or preparing
15 persons for any profession.

16 “(5) ‘Esthetics’ has the meaning given in ORS 690.005.

17 “(6) ‘Hair design’ has the meaning given in ORS 690.005.

18 “(7) ‘License’ means the authority the career school has been granted to operate under ORS
19 345.010 to 345.450.

20 “(8) ‘Nail technology’ has the meaning given in ORS 690.005.

21 “(9) ‘Registration’ means the approval by the Superintendent of Public Instruction of a teacher
22 or agent to instruct in or to represent the school.

23 “(10) ‘Superintendent’ means Superintendent of Public Instruction.

24 “**SECTION 2.** ORS 345.010, as amended by section 20, chapter 104, Oregon Laws 2012, is
25 amended to read:

26 “345.010. As used in ORS 345.010 to 345.450 and 345.992 to 345.997:

27 “(1) ‘Agent’ means [*a person*] **an individual who is** employed by or for a career school, **or is**
