

# A-Engrossed House Bill 2240

Ordered by the House March 22  
Including House Amendments dated March 22

Introduced and printed pursuant to House Rule 12.00. Pre-session filed (at the request of Governor John A. Kitzhaber, M.D., for Department of Consumer and Business Services)

## SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Aligns Oregon health insurance law with changes in federal law.

Abolishes Office of Private Health Partnerships and ends Family Health Insurance Assistance Program.

Modifies Health Care for All Oregon Children program to terminate eligibility at 19 years of age, allow Department of Human Services or Oregon Health Authority to specify eligibility requirements for private health option that are different from requirements for other medical assistance, allow purchase of insurance through Oregon Health Insurance Exchange for private health option and prohibit child from qualifying for both private health option and other medical assistance programs.

*[Abolishes Oregon Medical Insurance Pool on June 30, 2015.]*

Declares emergency, effective on passage.

**Be It Enacted by the People of the State of Oregon:**

## IMPLEMENTATION OF FEDERAL REQUIREMENTS

**SECTION 1.** Sections 2, 3, 4, 5 and 6 of this 2013 Act are added to and made a part of the Insurance Code.

**SECTION 2.** "Essential health benefits" are the items and services prescribed by the Department of Consumer and Business Services by rule in accordance with federal law, including:

(1) Ambulatory patient services.

(2) Emergency services.

**NOTE:** Matter in **boldfaced** type in an amended section is new; matter *[italic and bracketed]* is existing law to be omitted. New sections are in **boldfaced** type.

1 (3) Hospitalization.

2 (4) Maternity and newborn care.

3 (5) Mental health and substance use disorder services, including behavioral health treat-  
4 ment.

5 (6) Prescription drugs.

6 (7) Rehabilitative and habilitative services and devices.

7 (8) Laboratory services.

8 (9) Preventive and wellness services and chronic disease management.

9 (10) Pediatric services, including oral and vision care.

10 **SECTION 3.** (1) As used in this section, “health benefit plan” means a health benefit plan,  
11 as defined in ORS 743.730, that is offered in the individual or small group market.

12 (2) The Department of Consumer and Business Services may establish by rule a proce-  
13 dure for adjusting risk between insurers. If a procedure is established, the procedure may  
14 include:

15 (a) An assessment imposed on an insurer if the actuarial risk of the enrollees in the  
16 insurer’s health benefit plans is less than the average actuarial risk of all enrollees in all  
17 health benefit plans in this state; and

18 (b) Payments to insurers if the actuarial risk of the enrollees in the insurer’s health  
19 benefit plans is greater than the average actuarial risk of all enrollees in all health benefit  
20 plans in this state.

21 (3) A procedure established under this section must be consistent with 42 U.S.C. 18063  
22 and regulations adopted by the Secretary of the United States Department of Health and  
23 Human Services to carry out 42 U.S.C. 18063.

24 **SECTION 4.** (1) As used in this section, “student health benefit plan” means a plan that  
25 is subject to rules adopted by the United States Department of Health and Human Services  
26 under 42 U.S.C. 18118(c).

27 (2) Notwithstanding any other provision of law, the Department of Consumer and Busi-  
28 ness Services shall by rule and in a manner consistent with federal law, adopt requirements  
29 for student health benefit plans.

30 **SECTION 5.** (1) The Department of Consumer and Business Services may require an  
31 insurer to provide a written notice to an insured to fully effectuate any law the department  
32 is responsible for enforcing, including, but not limited to, laws regarding:

33 (a) Enrollment periods.

34 (b) The termination of coverage.

35 (c) The availability of coverage outside of an open enrollment period.

36 (d) The rights of insureds.

37 (2) The department may prescribe by rule the form, manner and contents of any required  
38 notices. Any requirements must be designed to minimize the administrative burden on  
39 insurers, including by allowing notices to be combined into one notice, as appropriate.

40 **SECTION 6.** (1) Notwithstanding ORS 743.737 (8)(d) and 743.767 (3), at one time during the  
41 2014 calendar year, insurers may increase their rates by an amount that reflects:

42 (a) The health insurance providers fee imposed under section 9010 of the Patient Pro-  
43 tection and Affordable Care Act (P.L. 111-148), as amended by section 10905 of the Patient  
44 Protection and Affordable Care Act, and as amended by the Health Care and Education Re-  
45 conciliation Act of 2010 (P.L. 111-152); and

1       **(b) A federal fee, tax or assessment imposed to pay for the costs of a federal reinsurance**  
2 **program.**

3       **(2) To the extent the existing rate was approved by the Department of Consumer and**  
4 **Business Services, the resulting rate, including the additional amount reflecting the health**  
5 **insurance providers fee and a federal fee, tax or assessment, shall be considered an approved**  
6 **rate.**

7       **NOTE:** Sections 7 and 8 were deleted by amendment. Subsequent sections were not renumbered.

8       **SECTION 9.** ORS 731.146, as amended by section 6, chapter 752, Oregon Laws 2007, is amended  
9 to read:

10       731.146. (1) "Transact insurance" means one or more of the following acts effected by mail or  
11 otherwise:

12       (a) Making or proposing to make an insurance contract.

13       (b) Taking or receiving any application for insurance.

14       (c) Receiving or collecting any premium, commission, membership fee, assessment, due or other  
15 consideration for any insurance or any part thereof.

16       (d) Issuing or delivering policies of insurance.

17       (e) Directly or indirectly acting as an insurance producer for, or otherwise representing or aid-  
18 ing on behalf of another, any person in the solicitation, negotiation, procurement or effectuation of  
19 insurance or renewals thereof, the dissemination of information as to coverage or rates, the for-  
20 warding of applications, the delivering of policies, the inspection of risks, the fixing of rates, the  
21 investigation or adjustment of claims or losses, the transaction of matters subsequent to effectuation  
22 of the policy and arising out of it, or in any other manner representing or assisting a person with  
23 respect to insurance.

24       (f) Advertising locally or circularizing therein without regard for the source of such  
25 circularization, whenever such advertising or circularization is for the purpose of solicitation of in-  
26 surance business.

27       (g) Doing any other kind of business specifically recognized as constituting the doing of an in-  
28 surance business within the meaning of the Insurance Code.

29       **(h) Offering individual or small group coverage under a multistate health benefit plan,**  
30 **as defined in ORS 743.730.**

31       [(h)] (i) Doing or proposing to do any insurance business in substance equivalent to any of par-  
32 agraphs (a) to [(g)] (h) of this subsection in a manner designed to evade the provisions of the In-  
33 surance Code.

34       (2) Subsection (1) of this section does not include, apply to or affect the following:

35       (a) Making investments within a state by an insurer not admitted or authorized to do business  
36 within such state.

37       (b) Except as provided in ORS 743.015, doing or proposing to do any insurance business arising  
38 out of a policy of group life insurance [or *group health insurance, or both,*] or a policy of blanket  
39 health insurance, if the master policy was validly issued to cover a group organized primarily for  
40 purposes other than the procurement of insurance and was delivered in and pursuant to the laws  
41 of another state in which:

42       (A) The insurer was authorized to do an insurance business;

43       (B) The policyholder is domiciled or otherwise has a bona fide situs; and

44       (C) With respect to a policy of blanket health insurance, the policy was approved by the director  
45 of such state.

1 (c) Investigating, settling, or litigating claims under policies lawfully written within a state, or  
2 liquidating assets and liabilities, all resulting from the insurer's former authorized operations within  
3 such state.

4 (d) Transactions within a state under a policy subsequent to its issuance if the policy was law-  
5 fully solicited, written and delivered outside the state and did not cover a subject of insurance res-  
6 ident, located or to be performed in the state when issued.

7 (e) The continuation and servicing of life or health insurance policies remaining in force on  
8 residents of a state if the insurer has withdrawn from such state and is not transacting new insur-  
9 ance therein.

10 (3) If mail is used, an act shall be deemed to take place at the point where the matter trans-  
11 mitted by mail is delivered and takes effect.

12 **SECTION 10.** ORS 741.300 is amended to read:

13 741.300. As used in ORS 741.001 to 741.540:

14 (1) "Essential health benefits" [*means the health care services identified by the United States*  
15 *Secretary of Health and Human Services pursuant to 42 U.S.C. 18022 or approved by the secretary*  
16 *pursuant to a waiver granted under 42 U.S.C. 18052*] **has the meaning given that term in section**  
17 **2 of this 2013 Act.**

18 (2) "Health care service contractor" has the meaning given that term in ORS 750.005.

19 (3) "Health insurance" has the meaning given that term in ORS 731.162, excluding disability  
20 income insurance.

21 (4) "Health insurance exchange" or "exchange" means an American Health Benefit Exchange  
22 as described in 42 U.S.C. 18031, 18032, 18033 and 18041 that is operated by the Oregon Health In-  
23 surance Exchange Corporation.

24 (5) "Health plan" means health insurance or health care coverage offered by an insurer.

25 (6) "Insurer" means an insurer as defined in ORS 731.106 that offers health insurance, a health  
26 care service contractor or a prepaid managed care health services organization.

27 (7) "Insurance producer" has the meaning given that term in ORS 731.104.

28 (8) "Prepaid managed care health services organization" has the meaning given that term in  
29 ORS 414.736.

30 (9) "State program" means a program providing medical assistance, as defined in ORS 414.025,  
31 and any health plan offered through the Public Employees' Benefit Board or the Oregon Educators  
32 Benefit Board.

33 **SECTION 11.** ORS 743.018 is amended to read:

34 743.018. (1) Except for group life and health insurance, and except as provided in ORS 743.015,  
35 every insurer shall file with the Director of the Department of Consumer and Business Services all  
36 schedules and tables of premium rates for life and health insurance to be used on risks in this state,  
37 and shall file any amendments to or corrections of such schedules and tables. Premium rates are  
38 subject to approval, disapproval or withdrawal of approval by the director as provided in ORS  
39 742.003, 742.005 and 742.007.

40 (2) Except as provided in ORS 743.737 [*and 743.760*] and subsection (3) of this section, a rate  
41 filing by a carrier for any of the following health benefit plans subject to ORS 743.730 to 743.773  
42 shall be available for public inspection immediately upon submission of the filing to the director:

43 (a) Health benefit plans for small employers.

44 [*(b) Portability health benefit plans.*]

45 [*(c)*] **(b)** Individual health benefit plans.

1 (3) The director may by rule:

2 (a) Specify all information a carrier must submit as part of a rate filing under this section; and

3 (b) Identify the information submitted that will be exempt from disclosure under this section  
4 because the information constitutes a trade secret and would, if disclosed, harm competition.

5 (4) The director, after conducting an actuarial review of the rate filing, may approve a proposed  
6 premium rate for a health benefit plan for small employers or for an individual health benefit plan  
7 if, in the director's discretion, the proposed rates are:

8 (a) Actuarially sound;

9 (b) Reasonable and not excessive, inadequate or unfairly discriminatory; and

10 (c) Based upon reasonable administrative expenses.

11 (5) In order to determine whether the proposed premium rates for a health benefit plan for small  
12 employers or for an individual health benefit plan are reasonable and not excessive, inadequate or  
13 unfairly discriminatory, the director may consider:

14 (a) The insurer's financial position, including but not limited to profitability, surplus, reserves  
15 and investment savings.

16 (b) Historical and projected administrative costs and medical and hospital expenses.

17 (c) Historical and projected loss ratio between the amounts spent on medical services and  
18 earned premiums.

19 (d) Any anticipated change in the number of enrollees if the proposed premium rate is approved.

20 (e) Changes to covered benefits or health benefit plan design.

21 (f) Changes in the insurer's health care cost containment and quality improvement efforts since  
22 the insurer's last rate filing for the same category of health benefit plan.

23 (g) Whether the proposed change in the premium rate is necessary to maintain the insurer's  
24 solvency or to maintain rate stability and prevent excessive rate increases in the future.

25 (h) Any public comments received under ORS 743.019 pertaining to the standards set forth in  
26 subsection (4) of this section and this subsection.

27 (6) With the written consent of the insurer, the director may modify a schedule or table of pre-  
28 mium rates filed in accordance with subsection (1) of this section.

29 (7) The requirements of this section do not supersede other provisions of law that require  
30 insurers, health care service contractors or multiple employer welfare arrangements providing  
31 health insurance to file schedules or tables of premium rates or proposed premium rates with the  
32 director or to seek the director's approval of rates or changes to rates.

33 **SECTION 12.** ORS 743.405 is amended to read:

34 743.405. An individual health insurance policy must meet the following requirements:

35 (1) **The policy must include a statement of** the entire money and other considerations [*there-*  
36 *for shall be expressed therein*] **due.**

37 (2) **The policy must state** the time at which the insurance takes effect and terminates [*shall*  
38 *be expressed therein*].

39 (3) [*It shall*] **The policy may** purport to insure only one person, [*except that a policy may insure,*  
40 *originally or by subsequent amendment, upon the application of an adult member of a family who shall*  
41 *be deemed the policyholder, any two or more eligible members of that family, including husband, wife,*  
42 *dependent children or any children under a specified age and any other person dependent upon the*  
43 *policyholder*] **unless an adult member of a family applies for coverage of family members or**  
44 **other dependents.**

45 (4) The policy may not be issued individually to an individual in a group of persons [*as*] de-

1 scribed in ORS 743.522 **(3)** for the purpose of separating the individual from health insurance bene-  
 2 fits offered or provided in connection with a group health benefit plan.

3 (5)(a) Except as provided in ORS 743.498, the style, arrangement and overall appearance of the  
 4 policy may not give undue prominence to any portion of the text, and every printed portion of the  
 5 text of the policy and of any indorsements or attached papers shall be plainly printed in lightfaced  
 6 type of a style in general use, the size of which shall be uniform and not less than [10 point with a  
 7 lower case unspaced alphabet length not less than 120 point. Captions shall be printed in not less  
 8 than] 12-point type.

9 (b) As used in this subsection, “text” includes all printed matter except the name and address  
 10 of the insurer, name or title of the policy, the brief description if any, and captions and subcaptions.

11 (6) **The policy must state** the exceptions and reductions of indemnity [*must be set forth in the*  
 12 *policy*]. Except those required by ORS 743.411 to 743.477, exceptions and reductions shall be printed  
 13 at the insurer’s option either included with the applicable benefit provision or under an appropriate  
 14 caption such as EXCEPTIONS, or EXCEPTIONS AND REDUCTIONS. However, if an exception or  
 15 reduction specifically applies only to a particular benefit of the policy, a statement of the exception  
 16 or reduction must be included with the applicable benefit provision.

17 (7) Each form constituting the policy, including riders and indorsements, must be identified by  
 18 a form number in the lower left-hand corner of the first page of the policy.

19 (8) The policy may not contain provisions purporting to make any portion of the charter, rules,  
 20 constitution or bylaws of the insurer a part of the policy unless such portion is set forth in full in  
 21 the policy, except in the case of the incorporation of or reference to a statement of rates or classi-  
 22 fication of risks, or short rate table filed with the Director of the Department of Consumer and  
 23 Business Services.

24 **SECTION 13.** ORS 743.417 is amended to read:

25 743.417. (1) An individual health insurance policy shall [*contain a provision as follows: “GRACE*  
 26 *PERIOD:*] **specify** a minimum grace period of **at least** 10 days after the premium due date [*will be*  
 27 *granted*] for the payment of each premium falling due after the first premium, during which grace  
 28 period the policy shall continue in force.[”]

29 (2) A policy that contains a cancellation provision may add the following clause at the end of  
 30 the provision [*set forth*] **described** in subsection (1) of this section: “subject to the right of the  
 31 insurer to cancel in accordance with the cancellation provision hereof.”

32 (3) A policy in which the insurer reserves the right to refuse renewal shall have the following  
 33 clause at the beginning of the provision [*set forth*] **described** in subsection (1) of this section: “Un-  
 34 less not less than 30 days prior to the premium due date the insurer has delivered to the insured  
 35 or has mailed to the last address of the insured as shown by the records of the insurer written no-  
 36 tice of its intention not to renew this policy beyond the period for which the premium has been  
 37 accepted. The insurer shall state in the notice the reason for its refusal to renew this policy.”

38 **SECTION 13a.** ORS 743.420 is amended to read:

39 743.420. (1) A health insurance policy, **other than a health benefit plan as defined in ORS**  
 40 **743.730**, shall contain a provision as follows: “REINSTATEMENT: If any renewal premium is not  
 41 paid within the grace period, a subsequent acceptance of premium by the insurer or by any insur-  
 42 ance producer duly authorized by the insurer to accept such premium, without requiring in con-  
 43 nection therewith an application for reinstatement, shall reinstate the policy; provided, however,  
 44 that if the insurer or such insurance producer requires an application for reinstatement and issues  
 45 a conditional receipt for the premium tendered, the policy will be reinstated upon approval of such

1 application by the insurer or, lacking such approval, upon the 45th day following the date of such  
 2 conditional receipt unless the insurer has previously notified the insured in writing of its disap-  
 3 proval of such application. The reinstated policy shall cover only loss resulting from such accidental  
 4 injury as may be sustained after the date of reinstatement and loss due to such sickness as may  
 5 begin more than 10 days after such date. In all other respects the insured and insurer shall have the  
 6 same rights thereunder as they had under the policy immediately before the due date of the de-  
 7 faulted premium, subject to any provisions indorsed hereon or attached hereto in connection with  
 8 the reinstatement. Any premium accepted in connection with a reinstatement shall be applied to a  
 9 period for which premium has not been previously paid, but not to any period more than 60 days  
 10 prior to the date of reinstatement.”

11 (2) The last sentence of the provision set forth in subsection (1) of this section may be omitted  
 12 from any policy which the insured has the right to continue in force subject to its terms by the  
 13 timely payment of premiums until at least age 50 or, in the case of a policy issued after age 44, for  
 14 at least five years from its date of issue.

15 **SECTION 14.** ORS 743.522 is amended to read:

16 743.522. [(1) “Group health insurance” means that form of health insurance covering groups of  
 17 persons described in this section, with or without one or more members of their families or one or more  
 18 of their dependents, or covering one or more members of the families or one or more dependents of such  
 19 groups of persons, and issued upon one of the following bases:]

20 [(a) Under a policy issued to an employer or trustees of a fund established by an employer, who  
 21 shall be deemed the policyholder, insuring employees of such employer for the benefit of persons other  
 22 than the employer. As used in this paragraph, “employees” includes:]

23 [(A) The officers, managers and employees of the employer;]

24 [(B) The individual proprietor or partners if the employer is an individual proprietor or partner-  
 25 ship;]

26 [(C) The officers, managers and employees of subsidiary or affiliated corporations;]

27 [(D) The individual proprietors, partners and employees of individuals and firms, if the business  
 28 of the employer and such individual or firm is under common control through stock ownership, contract  
 29 or otherwise;]

30 [(E) The trustees or their employees, or both, if their duties are principally connected with such  
 31 trusteeship;]

32 [(F) The leased workers of a client employer; and]

33 [(G) Elected or appointed officials if a policy issued to insure employees of a public body provides  
 34 that the term “employees” includes elected or appointed officials.]

35 [(b) Under a policy issued to an association, including a labor union, that has an active existence  
 36 for at least one year, that has a constitution and bylaws and that has been organized and is maintained  
 37 in good faith primarily for purposes other than that of obtaining insurance, which shall be deemed the  
 38 policyholder, insuring members, employees or employees of members of the association for the benefit  
 39 of persons other than the association or its officers or trustees.]

40 [(c) Under a policy issued to the trustees of a fund established by two or more employers in the  
 41 same or related industry or by one or more labor unions or by one or more employers and one or more  
 42 labor unions or by an association as described in paragraph (b) of this subsection, insuring employees  
 43 of the employers or members of the unions or of such association, or employees of members of such  
 44 association for the benefit of persons other than the employers or the unions or such association. As  
 45 used in this paragraph, “employees” may include the officers, managers and employees of the employer,

1 *and the individual proprietor or partners if the employer is an individual proprietor or partnership.*  
2 *The policy may provide that the term “employees” includes the trustees or their employees, or both, if*  
3 *their duties are principally connected with such trusteeship.]*

4 *[(d) Under a policy issued to any person or organization to which a policy of group life insurance*  
5 *may be issued or delivered in this state, to insure any class or classes of individuals that could be in-*  
6 *ured under such group life policy.]*

7 **(1) As used in this section and ORS 743.533:**

8 **(a) “Client employer” means an employer to whom workers are provided under contract**  
9 **and for a fee on a leased basis by a worker leasing company licensed under ORS 656.850.**

10 **(b) “Employee” may include a retired employee.**

11 **(c) “Leased worker” means a worker provided by a worker leasing company licensed un-**  
12 **der ORS 656.850.**

13 **(2) Group health insurance offered to a resident of this state under a group health insurance**  
14 **policy [issued to a group other than one described in subsection (1) of this section] may be delivered**  
15 **if:**

16 **(a) The Director of the Department of Consumer and Business Services finds that:**

17 **(A) The issuance of the policy is in the best interest of the public;**

18 **(B) The issuance of the policy would result in economies of acquisition or administration; and**

19 **(C) The benefits are reasonable in relation to the premiums charged; and**

20 **(b) The premium for the policy is paid either from funds of a policyholder, from funds contrib-**  
21 **uted by a covered person or from both.**

22 **(3) Subsection (2) of this section does not apply to health insurance covering groups of**  
23 **persons described in this subsection, with or without one or more members of their families**  
24 **or one or more of their dependents, or covering one or more members of the families or one**  
25 **or more dependents of such groups of persons, and issued upon one of the following bases:**

26 **(a) Under a policy issued to an employer or trustees of a fund established by an employer,**  
27 **who shall be deemed the policyholder, insuring employees of such employer for the benefit**  
28 **of persons other than the employer. As used in this paragraph, “employees” includes:**

29 **(A) The officers, managers and employees of the employer;**

30 **(B) The individual proprietor or partners if the employer is an individual proprietor or**  
31 **partnership;**

32 **(C) The officers, managers and employees of subsidiary or affiliated corporations;**

33 **(D) The individual proprietors, partners and employees of individuals and firms, if the**  
34 **business of the employer and such individual or firm is under common control through stock**  
35 **ownership, contract or otherwise;**

36 **(E) The trustees or their employees, or both, if their duties are principally connected**  
37 **with such trusteeship;**

38 **(F) The leased workers of a client employer; and**

39 **(G) Elected or appointed officials if a policy issued to insure employees of a public body**  
40 **provides that the term “employees” includes elected or appointed officials.**

41 **(b) Under a policy issued to an association, including a labor union, that has an active**  
42 **existence for at least one year, that has a constitution and bylaws and that has been or-**  
43 **ganized and is maintained in good faith primarily for purposes other than that of obtaining**  
44 **insurance, which shall be deemed the policyholder, insuring members, employees or employ-**  
45 **ees of members of the association for the benefit of persons other than the association or**



1 **its officers or trustees.**

2 (c) **Under a policy issued to the trustees of a fund established by two or more employers**  
3 **in the same or related industry or by one or more labor unions or by one or more employers**  
4 **and one or more labor unions or by an association as described in paragraph (b) of this**  
5 **subsection, insuring employees of the employers or members of the unions or of such asso-**  
6 **ciation, or employees of members of such association for the benefit of persons other than**  
7 **the employers or the unions or such association. As used in this paragraph, “employees”**  
8 **may include the officers, managers and employees of the employer, and the individual pro-**  
9 **prietor or partners if the employer is an individual proprietor or partnership. The policy may**  
10 **provide that the term “employees” includes the trustees or their employees, or both, if their**

18        (2) To prevent abusive rating practices;

19        (3) To require disclosure of rating practices to purchasers of small employer[, portability] and  
20 individual health benefit plans;

21        (4) To [establish limitations on] **prohibit** the use of preexisting condition exclusions **except in**  
22 **grandfathered health plans;**

23        [(5) To make basic health benefit plans available to all small employers;]

24        [(6)] **(5)** To encourage the availability of [portability and] individual health benefit plans for in-  
25 dividuals who are not enrolled in group health benefit plans;

26        [(7)] **(6)** To improve renewability and continuity of coverage for employers and covered individ-  
27 uals;

28        [(8)] **(7)** To improve the efficiency and fairness of the health insurance marketplace; and

29        [(9)] **(8)** To ensure that health insurance coverage in Oregon satisfies the requirements of the  
30 Health Insurance Portability and Accountability Act of 1996 (P.L. 104-191) and the Patient Pro-  
31 tection and Affordable Care Act (P.L. 111-148) as amended by the Health Care and Education Re-  
32 conciliation Act (P.L. 111-152), and that enforcement authority for those requirements is retained  
33 by the Director of the Department of Consumer and Business Services.

34        **SECTION 19.** ORS 743.733 is amended to read:

35        743.733. (1) If an affiliated group of employers is treated as a single employer under [subsection  
36 (b), (c), (m) or (o) of] section 414 **(b), (c), (m) or (o)** of the Internal Revenue Code of 1986, a carrier  
37 may issue a single group health benefit plan to the affiliated group on the basis of the number of  
38 employees in the affiliated group if the group requests such coverage.

3 **(3)(a)** *[The provisions of]* ORS 743.733 to 743.737 shall continue to apply to a health benefit plan  
4 issued **outside of the exchange** to a small employer until the plan anniversary date following the  
5 date the employer no longer meets the definition of a small employer.

6 **(b) ORS 743.733 to 743.737 shall continue to apply to an employer that receives coverage**  
7 **through the exchange until the employer no longer receives coverage through the exchange**  
8 **and is no longer a small employer.**

9 **SECTION 20.** ORS 743.734, as amended by section 13, chapter 500, Oregon Laws 2011, is

11 743.734. (1) Every health benefit plan shall be subject to the provisions of ORS 743.733 to  
12 743.737, if the plan provides health benefits covering one or more employees of a small employer and

23 *[(3)]* **(2)** Except as otherwise provided by ORS 743.733 to 743.737 or other law, no health benefit  
24 plan offered to a small employer shall:

25 (a) Inhibit a carrier from contracting with providers or groups of providers with respect to  
26 health care services or benefits; or

27 (b) Impose any restriction on the ability of a carrier to negotiate with providers regarding the  
28 level or method of reimbursing care or services provided under health benefit plans.

29 *[(4) Except to determine the application of a preexisting condition exclusion for a late enrollee who*  
30 *is 19 years of age or older, a carrier shall not use health statements when offering small employer*

38 **SECTION 22.** ORS 743.737 is amended to read:

39 743.737. [(1) A preexisting condition exclusion in a small employer health benefit plan shall apply  
40 only to a condition for which medical advice, diagnosis, care or treatment was recommended or received  
41 during the six-month period immediately preceding the enrollment date of an enrollee or late enrollee.  
42 As used in this section, the enrollment date of an enrollee shall be the earlier of the effective date of

4 *[(B) Ten months after the start of any required group eligibility waiting period.]*

5 *[(b) For a late enrollee, not later than 12 months after the late enrollee's effective date of*

7 *[(3) In applying a preexisting condition exclusion to an enrollee or late enrollee, except as provided*  
8 *in this subsection, all small employer health benefit plans shall reduce the duration of the provision*

22 *[(4)] (C) [A health benefit plan issued to a small employer may] Not apply a preexisting condition*  
23 *exclusion to [a person under 19 years of age] **any enrollee.***

24 *[(5)] (2) Late enrollees in a small employer health benefit plan may be subjected to a group el-*  
25 *igibility waiting period [of up to 12 months or, if 19 years of age or older, may be subjected to a pre-*

41 *to discontinue plans under this paragraph, the carrier:*

42 *(A) Must give notice of the decision to the Department of Consumer and Business Services and*  
43 *to all policyholders covered by the plans;*

44 *(B) May not cancel coverage under the plans for 180 days after the date of the notice required*  
45 *under subparagraph (A) of this paragraph if coverage is discontinued in the entire state or, except*

3 [(8)] **(5)** Notwithstanding any provision of subsection [(6)] **(3)** of this section to the contrary, a  
 4 carrier may not rescind the coverage of an enrollee in a small employer health benefit plan unless:

5 (a) The enrollee or a person seeking coverage on behalf of the enrollee:

6 (A) Performs an act, practice or omission that constitutes fraud; or

7 (B) Makes an intentional misrepresentation of a material fact as prohibited by the terms of the  
 8 plan;

9 (b) The carrier provides at least 30 days' advance written notice, in the form and manner pre-  
 10 scribed by the department, to the enrollee; and

11 (c) The carrier provides notice of the rescission to the department in the form, manner and time  
 12 frame prescribed by the department by rule.

13 [(9)] **(6)** Notwithstanding any provision of subsection [(6)] **(3)** of this section to the contrary, a  
 14 carrier may not rescind a small employer health benefit plan unless:

15 (a) The small employer or a representative of the small employer:

16 (A) Performs an act, practice or omission that constitutes fraud; or

17 (B) Makes an intentional misrepresentation of a material fact as prohibited by the terms of the  
 18 plan;

19 (b) The carrier provides at least 30 days' advance written notice, in the form and manner pre-  
 20 scribed by the department, to each plan enrollee who would be affected by the rescission of cover-  
 21 age; and

22 (c) The carrier provides notice of the rescission to the department in the form, manner and time  
 23 frame prescribed by the department by rule.

24 [(10)] **(7)(a)** A carrier may continue to enforce reasonable employer participation and contribu-

 26 tion requirements shall be applied uniformly among all small employer groups with the same number

16 [(vi) *The period of time during which a small employer retains uninterrupted coverage in force with*  
 17 *the same carrier; and*]

18 [(vii)] (iii) Adjustments to reflect [*the provision of benefits not required to be covered by the basic*  
 19 *health benefit plan and*] differences in family composition.

20 [(D)(i) *The premium rates determined in accordance with this paragraph may be further adjusted*  
 21 *by a carrier to reflect the expected claims experience of the covered small employer, but the extent of*  
 22 *this adjustment may not exceed five percent of the annual premium rate otherwise payable by the small*  
 23 *employer. The adjustment under this subparagraph may not be cumulative from year to year.*]

24 [(ii) *The premium rates adjusted under this subparagraph, except rates for small employers with*  
 25 *25 or fewer employees, are not subject to the provisions of subparagraph (A) of this paragraph.*]

26 [(E)] (D) A carrier shall apply the carrier's schedule of premium rate variations as approved by  
 27 the department and in accordance with this paragraph. Except as otherwise provided in this section,  
 28 the premium rate established by a carrier for a small employer health benefit plan shall apply uni-  
 29 formly to all employees of the small employer enrolled in that plan.

1 [(12)] (9) In connection with the offering for sale of any health benefit plan to a small employer,  
2 each carrier shall make a reasonable disclosure as part of its solicitation and sales materials of:

3 (a) The full array of health benefit plans that are offered to small employers by the carrier;

4 (b) The authority of the carrier to adjust rates **and premiums**, and the extent to which the  
5 carrier will consider age, **tobacco use**, family composition and geographic factors in establishing  
6 and adjusting rates[,] **and premiums; and**

7 **(c) The benefits and premiums for all health insurance coverage for which the employer**

9 *[(c) Provisions relating to renewability of policies and contracts; and]*

10 *[(d) Provisions affecting any preexisting condition exclusion.]*

11 [(13)(a)] (10)(a) Each carrier shall maintain at its principal place of business a complete and  
12 detailed description of its rating practices and renewal underwriting practices relating to its small  
13 employer health benefit plans, including information and documentation that demonstrate that its  
14 rating methods and practices are based upon commonly accepted actuarial practices and are in ac-  
15 cordance with sound actuarial principles.

16 (b) A carrier offering a small employer health benefit plan shall file with the department at least  
17 once every 12 months an actuarial certification that the carrier is in compliance with ORS 743.733

21 (B) May not cancel coverage under the plan for 90 days after the date of the notice required

23 (C) Must offer in writing to each policyholder covered by the plan, all other individual health  
24 benefit plans that the carrier offers in the specified service area. The carrier shall offer the plans  
25 at least 90 days prior to discontinuation.

2 (2) The director shall give written notice to an insurer approving or disapproving a rate filing

25 organization under ORS 743.862, the enrollee may sue the insurer under ORS 743.864;

28 (D) A description of the process for filing a complaint with the department.

37 (E) Procedures for the coverage of prescription drugs not included on the formulary; and

38 (F) A summary of the criteria for determining whether a drug is experimental or investigational.

39 (e) A list of network providers and how the enrollee can obtain current information about the  
40 availability of providers and how to access and schedule services with providers, including clinic  
41 and hospital networks.

42 (f) Notice of the enrollee's right to select a primary care provider and specialty care providers.

43 (g) How to obtain referrals for specialty care in accordance with ORS 743.856.

44 (h) Restrictions on services obtained outside of the insurer's network or service area.

45 (i) The availability of continuity of care as required by ORS 743.854.

1 (j) Procedures for accessing after-hours care and emergency services as required by ORS  
2 743A.012.

3 (k) Cost-sharing requirements and other charges to enrollees.

4 (L) Procedures, if any, for changing providers.

5 (m) Procedures, if any, by which enrollees may participate in the development of the insurer's  
6 corporate policies.

7 (n) A summary of how the insurer makes decisions regarding coverage and payment for treat-  
8 ment or services, including a general description of any prior authorization and utilization control  
9 requirements that affect coverage or payment.

10 (o) Disclosure of any risk-sharing arrangement the insurer has with physicians or other provid-  
11 ers.

12 (p) A summary of the insurer's procedures for protecting the confidentiality of medical records  
13 and other enrollee information.

14 (q) An explanation of assistance provided to non-English-speaking enrollees.

15 (r) Notice of the information available from the department that is filed by insurers as required  
16 under ORS 743.807, 743.814 and 743.817.

17 (2) Establish procedures for making coverage determinations and resolving grievances that pro-  
18 vide for all of the following:

19 (a) Timely notice of adverse benefit determinations in a form and manner approved by the de-  
20 partment or prescribed by the department by rule.

21 (b) A method for recording all grievances, including the nature of the grievance and significant  
22 action taken.

23 (c) Written decisions meeting criteria established by the Director of the Department of Con-  
24 sumer and Business Services by rule.

25 (d) An expedited response to a request for an internal appeal that accommodates the clinical  
26 urgency of the situation.

27 (e) At least one but not more than two levels of internal appeal for group health benefit plans  
28 and one level of internal appeal for individual [*and portability*] health benefit plans. If an insurer  
29 provides:

30 (A) Two levels of internal appeal, a person who was involved in the consideration of the initial  
31 denial or the first level of internal appeal may not be involved in the second level of internal appeal;

45 (A) Submit for consideration by the insurer any written comments, documents, records and other

2 (B) Receive from the insurer, upon request and free of charge, reasonable access to and copies  
3 of all documents, records and other information relevant to the adverse benefit determination.

4 (3) Establish procedures for notifying affected enrollees of:

5 (a) A change in or termination of any benefit; and

6 (b)(A) The termination of a primary care delivery office or site; and

7 (B) Assistance available to enrollees in selecting a new primary care delivery office or site.

15           the program. **The Department of Human Services or the Oregon Health Authority may pre-**

18           **nanacial participation in the costs of the program and consistent with this section.**

43 (2) A fraternal benefit society that has maintained lodges in this state and other states for 50  
44 years prior to January 1, 1961, and for which a certificate of authority was not required on that  
45 date.

1 (3) A religious organization providing insurance benefits only to its employees, if the organiza-  
2 tion is in existence and exempt from taxation under section 501(c)(3) of the federal Internal Revenue  
3 Code on September 13, 1975.

4 (4) Public bodies, as defined in ORS 30.260, that either individually or jointly establish a self-  
5 insurance program for tort liability in accordance with ORS 30.282.

6 (5) Public bodies, as defined in ORS 30.260, that either individually or jointly establish a self-  
7 insurance program for property damage in accordance with ORS 30.282.

8 (6) Cities, counties, school districts, community college districts, community college service dis-  
9 tricts or districts, as defined in ORS 198.010 and 198.180, that either individually or jointly insure  
10 for health insurance coverage, excluding disability insurance, their employees or retired employees,  
11 or their dependents, or students engaged in school activities, or combination of employees and de-  
12 pendants, with or without employee or student contributions, if all of the following conditions are  
13 met:

14 (a) The individual or jointly self-insured program meets the following minimum requirements:

15 (A) In the case of a school district, community college district or community college service  
16 district, the number of covered employees and dependents and retired employees and dependents  
17 aggregates at least 500 individuals;

18 (B) In the case of an individual public body program other than a school district, community  
19 college district or community college service district, the number of covered employees and depen-  
20 dents and retired employees and dependents aggregates at least 500 individuals; and

21 (C) In the case of a joint program of two or more public bodies, the number of covered em-  
22 ployees and dependents and retired employees and dependents aggregates at least 1,000 individuals;

23 (b) The individual or jointly self-insured health insurance program includes all coverages and  
24 benefits required of group health insurance policies under ORS chapters 743 and 743A;

25 (c) The individual or jointly self-insured program must have program documents that define  
26 program benefits and administration;

27 (d) Enrollees must be provided copies of summary plan descriptions including:

28 (A) Written general information about services provided, access to services, charges and sched-  
29 uling applicable to each enrollee's coverage;

30 (B) The program's grievance and appeal process; and

31 (C) Other group health plan enrollee rights, disclosure or written procedure requirements es-  
32 tablished under ORS chapters 743 and 743A;

33 (e) The financial administration of an individual or jointly self-insured program must include the  
34 following requirements:

35 (A) Program contributions and reserves must be held in separate accounts and used for the ex-  
36 clusive benefit of the program;

37 (B) The program must maintain adequate reserves. Reserves may be invested in accordance with  
38 the provisions of ORS chapter 293. Reserve adequacy must be calculated annually with proper  
39 actuarial calculations including the following:

40 (i) Known claims, paid and outstanding;

41 (ii) A history of incurred but not reported claims;

42 (iii) Claims handling expenses;

43 (iv) Unearned contributions; and

44 (v) A claims trend factor; and

45 (C) The program must maintain adequate reinsurance against the risk of economic loss in ac-

1 cordance with the provisions of ORS 742.065 unless the program has received written approval for  
2 an alternative arrangement for protection against economic loss from the Director of the Depart-  
3 ment of Consumer and Business Services;

4 (f) The individual or jointly self-insured program must have sufficient personnel to service the  
5 employee benefit program or must contract with a third party administrator licensed under ORS  
6 chapter 744 as a third party administrator to provide such services;

7 (g) The individual or jointly self-insured program shall be subject to assessment in accordance  
8 with ORS 735.614 [*and former enrollees shall be eligible for portability coverage in accordance with*  
9 *ORS 735.616*];

10 (h) The public body, or the program administrator in the case of a joint insurance program of  
11 two or more public bodies, files with the Director of the Department of Consumer and Business  
12 Services copies of all documents creating and governing the program, all forms used to communicate

25 (b) Emergency road service, which means adjustment, repair or replacement of the equipment,  
26 tires or mechanical parts of a motor vehicle in order to permit the motor vehicle to be operated

29 necessary and appropriate preparations for and actual transportation provided to return a

29 735.625. (1) Except as provided in subsection (3)(c) of this section, the Oregon Medical Insurance  
30 Pool Board shall offer major medical expense coverage to every eligible person.

31 (2) The coverage to be issued by the board, its schedule of benefits, exclusions and other limi-  
32 tations, shall be established through rules adopted by the board, taking into consideration the advice

15 (c) The board shall determine the applicable medical and portability risk rates either by calcu-  
16 lating the average rate charged by insurers offering coverages in the state comparable to the pool

17 expenses, other than coverage limited to expenses from accidents or specific diseases, that seeks to

12 (K) Stop-loss coverage that meets the requirements of ORS 742.065;

13 (L) Coverage issued as a supplement to liability insurance;

14 (M) Insurance arising out of a workers' compensation or similar law;

15 (N) Automobile medical payment insurance or insurance under which benefits are payable with  
16 or without regard to fault and that is statutorily required to be contained in any liability insurance  
17 policy or equivalent self-insurance; or

18 (O) Any employee welfare benefit plan that is exempt from state regulation because of the fed-  
19 eral Employee Retirement Income Security Act of 1974, as amended.

20 (c) For purposes of this subsection, renewal of a short term health insurance policy includes the  
21 issuance of a new short term health insurance policy by an insurer to a policyholder within 60 days  
22 after the expiration of a policy previously issued by the insurer to the policyholder.

23 (19) "Individual coverage waiting period" means a period in an individual health benefit plan  
24 during which no premiums may be collected and health benefit plan coverage issued is not effective.

25 (20) "Individual health benefit plan" means a health benefit plan:

26 (a) That is issued to an individual policyholder; or

27 (b) That provides individual coverage through a trust, association or similar group, regardless  
28 of the situs of the policy or contract.

29 (21) "Initial enrollment period" means a period of at least 30 days following commencement of  
30 the first eligibility period for an individual.

31 (22) "Late enrollee" means an individual who enrolls in a group health benefit plan subsequent  
32 to the initial enrollment period during which the individual was eligible for coverage but declined  
33 to enroll. However, an eligible individual shall not be considered a late enrollee if:

34 (a) The individual qualifies for a special enrollment period in accordance with 42 U.S.C. 300gg  
35 or as prescribed by rule by the Department of Consumer and Business Services;

36 (b) The individual applies for coverage during an open enrollment period;

37 (c) A court issues an order that coverage be provided for a spouse or minor child under an  
38 employee's employer sponsored health benefit plan and request for enrollment is made within 30  
39 days after issuance of the court order;

40 (d) The individual is employed by an employer that offers multiple health benefit plans and the  
41 individual elects a different health benefit plan during an open enrollment period; or

42 (e) The individual's coverage under Medicaid, Medicare, TRICARE, Indian Health Service or a  
43 publicly sponsored or subsidized health plan, including, but not limited to, the medical assistance  
44 program under ORS chapter 414, has been involuntarily terminated within 63 days after applying for  
45 coverage in a group health benefit plan.

1 (23) "Minimal essential coverage" has the meaning given that term in section 5000A(f) of the  
2 Internal Revenue Code.

3 (24) "Multiple employer welfare arrangement" means a multiple employer welfare arrangement  
4 as defined in section 3 of the federal Employee Retirement Income Security Act of 1974, as amended,  
5 29 U.S.C. 1002, that is subject to ORS 750.301 to 750.341.

6 (25) "Oregon Medical Insurance Pool" means the pool created under ORS 735.610.

7 (26) "Preexisting condition exclusion" means:

8 (a) Except for a grandfathered health plan, a limitation or exclusion of benefits or a denial of  
9 coverage based on a medical condition being present before the effective date of coverage or before  
10 the date coverage is denied, whether or not any medical advice, diagnosis, care or treatment was  
11 recommended or received for the condition before the date of coverage or denial of coverage.

12 (b) With respect to a grandfathered health plan, a provision applicable to an enrollee or late  
13 enrollee that excludes coverage for services, charges or expenses incurred during a specified period  
14 immediately following enrollment for a condition for which medical advice, diagnosis, care or treat-  
15 ment was recommended or received during a specified period immediately preceding enrollment. For  
16 purposes of this paragraph pregnancy and genetic information do not constitute preexisting condi-  
17 tions.

18 (27) "Premium" includes insurance premiums or other fees charged for a health benefit plan,  
19 including the costs of benefits paid or reimbursements made to or on behalf of enrollees covered by  
20 the plan.

21 (28) "Rating period" means the 12-month calendar period for which premium rates established  
22 by a carrier are in effect, as determined by the carrier.

23 (29) "Representative" does not include an insurance producer or an employee or authorized  
24 representative of an insurance producer or carrier.

25 (30)(a) "Small employer" means an employer that employed an average of at least one but not  
26 more than [50] **100** employees on business days during the preceding calendar year, the majority of  
27 whom are employed within this state, and that employs at least one eligible employee on the first  
28 day of the plan year.

29 (b) Any person that is treated as a single employer under section 414 (b), (c), (m) or (o) of the  
30 Internal Revenue Code of 1986 shall be treated as one employer for purposes of this subsection.

31 (c) The determination of whether an employer that was not in existence throughout the pre-  
32 ceding calendar year is a small employer shall be based on the average number of employees that  
33 it is reasonably expected the employer will employ on business days in the current calendar year.

34 **SECTION 60.** ORS 743.757 is amended to read:

35 743.757. (1) As used in this section, "guaranteed association" means an association that:

36 (a) The Director of the Department of Consumer and Business Services has determined under  
37 ORS 743.524 meets the requirements described in ORS 743.522 [(1)(b)] **(3)(b)**; and

38 (b) Is a statewide nonprofit organization representing the interests of individuals licensed under  
39 ORS chapter 696.

40 (2) A carrier may offer a health benefit plan to a guaranteed association if the plan provides  
41 health benefits covering 500 or more members or dependents of members of the association.

42 (3) When a carrier offers coverage to a guaranteed association under subsection (2) of this sec-  
43 tion, the carrier shall offer coverage to all members of the association and all dependents of the  
44 members of the association without regard to the actual or expected health status of any member  
45 or any dependent of a member of the association.

1 (4) A carrier offering a health benefit plan under subsection (2) of this section shall establish  
2 premium rates as follows:

3 (a) For the initial 12-month period of coverage, the carrier shall submit to the director a certi-  
4 fied statement that the premium rates charged to the guaranteed association are actuarially sound.  
5 The statement must be signed by an actuary certifying the accuracy of the rating methodology as  
6 established by the American Academy of Actuaries.

7 (b) For any subsequent 12-month period of coverage, according to a rating methodology as es-  
8 tablished by the American Academy of Actuaries.

9 (5) A member of a guaranteed association may apply for coverage offered by a carrier under  
10 subsection (2) of this section only:

11 (a) If the member has been an active member of the association for no less than 30 days;

12 (b) During an annual open enrollment period offered by the association; and

13 (c) After meeting any additional eligibility requirements agreed upon by the association and the  
14 carrier.

15 (6) Notwithstanding subsection (5) of this section, if a member or a dependent of a member of  
16 a guaranteed association terminates coverage under the health benefit plan, the member or de-  
17 pendent shall be excluded from coverage for 12 months from the date of termination of coverage.  
18 The member may enroll for coverage of the member or the dependent during an annual open en-  
19 rollment period following the expiration of the exclusion period.

21 743.769. (1) Each carrier shall actively market all individual health benefit plans sold by the  
22 carrier **that are not grandfathered health plans.**

23 (2) Except as provided in subsection (3) of this section, no carrier or insurance producer shall,  
24 directly or indirectly, discourage an individual from filing an application for coverage because of the  
25 health status, claims experience, occupation or geographic location of the individual.

26 (3) Subsection (2) of this section does not apply with respect to information provided by a carrier  
27 to an individual regarding the established geographic service area or a restricted network provision  
28 of a carrier.

29 (4) Rejection by a carrier of an application for coverage shall be in writing and shall state the  
30 reason or reasons for the rejection.

31 (5) The Director of the Department of Consumer and Business Services may establish by rule  
32 additional standards to provide for the fair marketing and broad availability of individual health  
33 benefit plans.

34 (6) A carrier that elects to discontinue offering all of its individual health benefit plans under  
35 ORS 743.766 [(5)(c)] **(4)(c)** or to discontinue offering and renewing all such plans is prohibited from  
36 offering and renewing health benefit plans in the individual market in this state for a period of five  
37 years from the date of notice to the director pursuant to ORS 743.766 [(5)(c)] **(4)(c)** or, if such notice  
38 is not provided, from the date on which the director provides notice to the carrier that the director  
39 has determined that the carrier has effectively discontinued offering individual health benefit plans  
40 in this state. This subsection does not apply with respect to a health benefit plan discontinued in  
41 a specified service area by a carrier that covers services provided only by a particular organization  
42 of health care providers or only by health care providers who are under contract with the carrier.

43 **SECTION 62.** ORS 743A.168 is amended to read:

44 743A.168. A group health insurance policy providing coverage for hospital or medical expenses  
45 shall provide coverage for expenses arising from treatment for chemical dependency, including

1 alcoholism, and for mental or nervous conditions at the same level as, and subject to limitations no  
2 more restrictive than, those imposed on coverage or reimbursement of expenses arising from treat-  
3 ment for other medical conditions. The following apply to coverage for chemical dependency and for  
4 mental or nervous conditions:

5 (1) As used in this section:

6 (a) "Chemical dependency" means the addictive relationship with any drug or alcohol charac-  
7 terized by a physical or psychological relationship, or both, that interferes on a recurring basis with  
8 the individual's social, psychological or physical adjustment to common problems. For purposes of  
9 this section, "chemical dependency" does not include addiction to, or dependency on, tobacco, to-  
10 bacco products or foods.

11 (b) "Facility" means a corporate or governmental entity or other provider of services for the  
12 treatment of chemical dependency or for the treatment of mental or nervous conditions.

13 (c) "Group health insurer" means an insurer, a health maintenance organization or a health care  
14 service contractor.

15 (d) "Program" means a particular type or level of service that is organizationally distinct within  
16 a facility.

17 (e) "Provider" means a person that has met the credentialing requirement of a group health  
18 insurer, is otherwise eligible to receive reimbursement for coverage under the policy and is:

19 (A) A health care facility;

20 (B) A residential program or facility;

21 (C) A day or partial hospitalization program;

22 (D) An outpatient service; or

23 (E) An individual behavioral health or medical professional authorized for reimbursement under  
24 Oregon law.

25 (2) The coverage may be made subject to provisions of the policy that apply to other benefits  
26 under the policy, including but not limited to provisions relating to deductibles and coinsurance.  
27 Deductibles and coinsurance for treatment in health care facilities or residential programs or facil-  
28 ities may not be greater than those under the policy for expenses of hospitalization in the treatment  
29 of other medical conditions. Deductibles and coinsurance for outpatient treatment may not be  
30 greater than those under the policy for expenses of outpatient treatment of other medical conditions.

31 (3) The coverage may not be made subject to treatment limitations, limits on total payments for  
32 treatment, limits on duration of treatment or financial requirements unless similar limitations or  
33 requirements are imposed on coverage of other medical conditions. The coverage of eligible expenses  
34 may be limited to treatment that is medically necessary as determined under the policy for other  
35 medical conditions.

36 (4)(a) Nothing in this section requires coverage for:

37 (A) Educational or correctional services or sheltered living provided by a school or halfway  
38 house;

39 (B) A long-term residential mental health program that lasts longer than 45 days;

40 (C) Psychoanalysis or psychotherapy received as part of an educational or training program,  
41 regardless of diagnosis or symptoms that may be present;

42 (D) A court-ordered sex offender treatment program; or

43 (E) A screening interview or treatment program under ORS 813.021.

44 (b) Notwithstanding paragraph (a)(A) of this subsection, an insured may receive covered outpa-  
45 tient services under the terms of the insured's policy while the insured is living temporarily in a

1 sheltered living situation.

2 (5) A provider is eligible for reimbursement under this section if:

3 (a) The provider is approved by the [*Department of Human Services*] **Oregon Health**  
4 **Authority**;

5 (b) The provider is accredited for the particular level of care for which reimbursement is being  
6 requested by the Joint Commission on Accreditation of Hospitals or the Commission on Accredi-  
7 tation of Rehabilitation Facilities;

8 (c) The patient is staying overnight at the facility and is involved in a structured program at  
9 least eight hours per day, five days per week; or

10 (d) The provider is providing a covered benefit under the policy.

11 (6) Payments may not be made under this section for support groups.

12 (7) If specified in the policy, outpatient coverage may include follow-up in-home service or out-  
13 patient services. The policy may limit coverage for in-home service to persons who are homebound  
14 under the care of a physician.

15 (8) Nothing in this section prohibits a group health insurer from managing the provision of  
16 benefits through common methods, including but not limited to selectively contracted panels, health  
17 plan benefit differential designs, preadmission screening, prior authorization of services, utilization  
18 review or other mechanisms designed to limit eligible expenses to those described in subsection (3)  
19 of this section.

20 (9) The Legislative Assembly has found that health care cost containment is necessary and in-  
21 tends to encourage insurance policies designed to achieve cost containment by ensuring that re-  
22 imbursement is limited to appropriate utilization under criteria incorporated into such policies,  
23 either directly or by reference.

24 (10)(a) Subject to the patient or client confidentiality provisions of ORS 40.235 relating to phy-  
25 sicians, ORS 40.240 relating to nurse practitioners, ORS 40.230 relating to psychologists, ORS 40.250  
26 and 675.580 relating to licensed clinical social workers and ORS 40.262 relating to licensed profes-  
27 sional counselors and licensed marriage and family therapists, a group health insurer may provide  
28 for review for level of treatment of admissions and continued stays for treatment in health care fa-  
29 cilities, residential programs or facilities, day or partial hospitalization programs and outpatient  
30 services by either group health insurer staff or personnel under contract to the group health insurer,  
31 or by a utilization review contractor, who shall have the authority to certify for or deny level of  
32 payment.

33 (b) Review shall be made according to criteria made available to providers in advance upon re-  
34 quest.

35 (c) Review shall be performed by or under the direction of a medical or osteopathic physician  
36 licensed by the Oregon Medical Board, a psychologist licensed by the State Board of Psychologist  
37 Examiners, a clinical social worker licensed by the State Board of Licensed Social Workers or a  
38 professional counselor or marriage and family therapist licensed by the Oregon Board of Licensed  
39 Professional Counselors and Therapists, in accordance with standards of the National Committee for  
40 Quality Assurance or Medicare review standards of the Centers for Medicare and Medicaid Ser-  
41 vices.

42 (d) Review may involve prior approval, concurrent review of the continuation of treatment,  
43 post-treatment review or any combination of these. However, if prior approval is required, provision  
44 shall be made to allow for payment of urgent or emergency admissions, subject to subsequent re-  
45 view. If prior approval is not required, group health insurers shall permit providers, policyholders

1 or persons acting on their behalf to make advance inquiries regarding the appropriateness of a  
2 particular admission to a treatment program. Group health insurers shall provide a timely response  
3 to such inquiries. Noncontracting providers must cooperate with these procedures to the same ex-  
4 tent as contracting providers to be eligible for reimbursement.

5 (11) Health maintenance organizations may limit the receipt of covered services by enrollees to  
6 services provided by or upon referral by providers contracting with the health maintenance organ-  
7 ization. Health maintenance organizations and health care service contractors may create substan-  
8 tive plan benefit and reimbursement differentials at the same level as, and subject to limitations no  
9 more restrictive than, those imposed on coverage or reimbursement of expenses arising out of other  
10 medical conditions and apply them to contracting and noncontracting providers.

11 (12) Nothing in this section prevents a group health insurer from contracting with providers of  
12 health care services to furnish services to policyholders or certificate holders according to ORS  
13 743.531 or 750.005, subject to the following conditions:

14 (a) A group health insurer is not required to contract with all eligible providers.

15 (b) An insurer or health care service contractor shall, subject to subsections (2) and (3) of this  
16 section, pay benefits toward the covered charges of noncontracting providers of services for the  
17 treatment of chemical dependency or mental or nervous conditions. The insured shall, subject to  
18 subsections (2) and (3) of this section, have the right to use the services of a noncontracting provider  
19 of services for the treatment of chemical dependency or mental or nervous conditions, whether or  
20 not the services for chemical dependency or mental or nervous conditions are provided by con-  
21 tracting or noncontracting providers.

22 (13) The intent of the Legislative Assembly in adopting this section is to reserve benefits for  
23 different types of care to encourage cost effective care and to ensure continuing access to levels  
24 of care most appropriate for the insured's condition and progress.

25 (14) The Director of the Department of Consumer and Business Services, after notice and hear-  
26 ing, may adopt reasonable rules not inconsistent with this section that are considered necessary for  
27 the proper administration of these provisions.
