

HOUSE AMENDMENTS TO HOUSE BILL 2253

1 On page 1 of the printed bill, delete lines 5 through 30 and delete pages 2 and 3 and insert:

2 **“SECTION 1. Section 2 of this 2013 Act is added to and made a part of ORS chapter 195.**

3 **“SECTION 2. (1) As used in this section, ‘affected local government’ means:**

4 **“(a) A city or county for which the Portland State University Population Research Center**
5 **is preparing a population forecast;**

6 **“(b) A county that contains all or part of a city or an urban growth boundary for which**
7 **the center is preparing a population forecast; and**

8 **“(c) A local service district, as defined in ORS 174.116, that includes territory within the**
9 **area subject to the population forecast.**

10 **“(2) For the purpose of land use planning, the center shall issue a population forecast for:**

11 **“(a) Each county except Multnomah, Clackamas and Washington Counties;**

12 **“(b) The portions of Multnomah, Clackamas and Washington Counties that are not within**
13 **Metro; and**

14 **“(c) The area within each urban growth boundary other than the urban growth boundary**
15 **of Metro.**

16 **“(3) A local government with land use jurisdiction over land for which the center issues**
17 **population forecasts under subsection (2) of this section shall apply the current final popu-**
18 **lation forecast when changing the comprehensive plan or a land use regulation of the local**
19 **government.**

20 **“(4) The center shall issue population forecasts for each area described in subsection (2)**
21 **of this section not less than once every four years on a schedule established by rule of the**
22 **State Board of Higher Education adopted in consultation with the Department of Land Con-**
23 **servation and Development.**

24 **“(5) When issuing a population forecast, the center shall:**

25 **“(a) Consider and, if appropriate, incorporate available local data and information about**
26 **local conditions received from representatives of local governments and members of the**
27 **public;**

28 **“(b) Cause, directly or with the assistance of the Department of Land Conservation and**
29 **Development, the issuance of notice to all affected local governments and to members of the**
30 **public that have provided a written request for notice to the center; and**

31 **“(c) Post the methodology and supporting data used to make the population forecast on**
32 **a publicly available website when the center causes notice to be issued as described in para-**
33 **graph (b) of this subsection.**

34 **“(6) A population forecast must forecast population for a 50-year period including:**

35 **“(a) Forecasts for intervals, within the 50-year period, that are established by rule of the**

1 State Board of Higher Education adopted in consultation with the Department of Land Con-
2 servation and Development; and

3 “(b) Population cohorts as provided by rule of the board adopted in consultation with the
4 department.

5 “(7) Within 45 days after the center issues a proposed population forecast under this
6 section, a member of the public or an affected local government may file objections with the
7 center. An objection must be supported by the inclusion of data or information that supports
8 the objection. If the center:

9 “(a) Does not receive an objection within the 45-day period, the proposed population
10 forecast becomes final.

11 “(b) Receives an objection within the 45-day period, the center shall review the objections
12 filed, make changes to the proposed population forecast, if necessary in the discretion of the
13 center, and issue a final population forecast.

14 “(8) Periodically, the Department of Land Conservation and Development may require the
15 center to submit its forecasting methodology and local data collection practices for review
16 by an advisory committee established by the department and composed of experts in the field
17 of population forecasting, representatives of cities and counties and members of the public.

18 “(9) The issuance of a final population forecast under this section is:

19 “(a) Not a land use decision; and

20 “(b) A final decision not subject to further review or appeal.

21 “(10) The Land Conservation and Development Commission, in consultation with the
22 State Board of Higher Education, shall adopt rules to implement the population forecasting
23 program required by this section.

24 “(11) Each biennium, the commission shall allocate, from the grant funding described in
25 ORS 197.639 (5), an amount of moneys that the Land Conservation and Development Com-
26 mission, in consultation with the State Board of Higher Education, determines is sufficient
27 to operate the population forecasting program required by this section.

28 “SECTION 3. (1) The first complete set of final population forecasts required by section
29 2 of this 2013 Act must be issued and made available for use within four years after the ef-
30 fective date of this 2013 Act.

31 “(2) The Portland State University Population Research Center shall phase in production
32 of the first set of population forecasts required by section 2 of this 2013 Act and shall make
33 each population forecast available for use as produced.

34 “(3) Notwithstanding the amendments to ORS 195.036 by section 4 of this 2013 Act and
35 the repeal of ORS 195.034 by section 6 of this 2013 Act:

36 “(a) A local government for which the center is to issue population forecasts under sec-
37 tion 2 (2) of this 2013 Act that initiates a periodic review, or any other legislative review of
38 its comprehensive plan that concerns the urban growth boundary, on or before the date the
39 center issues a final population forecast for the urban growth boundary may continue its
40 review under a population forecast that satisfies the requirements of ORS 195.034 and
41 195.036, as those sections were in effect immediately before the effective date of this 2013
42 Act.

43 “(b) The Land Conservation and Development Commission shall adopt rules to regulate
44 the transition from the application of population forecasts produced under ORS 195.034 and
45 195.036, as those sections were in effect immediately before the effective date of this 2013

1 **Act, to the application of population forecasts produced under section 2 of this 2013 Act and**
2 **ORS 195.036, as amended by section 4 of this 2013 Act.**

3 **“SECTION 4.** ORS 195.036 is amended to read:

4 *“195.036. [The coordinating body under ORS 195.025 (1) shall establish and maintain a population*
5 *forecast for the entire area within its boundary for use in maintaining and updating comprehensive*
6 *plans, and shall coordinate the forecast with the local governments within its boundary.]* **Metro, in**
7 **coordination with local governments within its boundary, shall issue a population forecast**
8 **for the entire area within its boundary to be applied by Metro and local governments within**
9 **the boundary of Metro as a basis for changes to comprehensive plans and land use regu-**
10 **lations.**

11 **“SECTION 5.** ORS 197.639 is amended to read:

12 *“197.639. (1) In addition to coordination between state agencies and local government estab-*
13 *lished in certified state agency coordination programs, the Department of Land Conservation and*
14 *Development may establish one or more state assistance teams made up of representatives of various*
15 *agencies and local governments, utilize the Economic Revitalization Team established under ORS*
16 *284.555 or institute an alternative process for coordinating agency participation in the periodic re-*
17 *view of comprehensive plans.*

18 *“(2) The Economic Revitalization Team may work with a city to create a voluntary compre-*
19 *hensive plan review that focuses on the unique vision of the city, instead of conducting a standard*
20 *periodic review, if the team identifies a city that the team determines can benefit from a customized*
21 *voluntary comprehensive plan review.*

22 *“(3) The department may develop model ordinance provisions to assist local governments in the*
23 *periodic review plan update process and in complying with new statutory requirements or new land*
24 *use planning goal or rule requirements adopted by the Land Conservation and Development Com-*
25 *mission outside the periodic review process.*

26 *“(4) A local government may arrange with the department for the provision of periodic review*
27 *planning services and those services may be paid with grant program funds* **allocated under sub-**
28 **section (5) of this section.**

29 *“(5) The commission shall establish an advisory committee composed, at a minimum, of repre-*
30 *sentatives from the League of Oregon Cities, the Association of Oregon Counties, metropolitan ser-*
31 *vice districts, the Special Districts Association of Oregon, land use planning public interest groups*
32 *and developer interest groups. The advisory committee shall advise the commission and the depart-*
33 *ment on the allocation of grants and technical assistance funding from General Fund sources and*
34 *other issues assigned by the commission.*

35 *“(6) The population forecasting program operated by the Portland State University Pop-*
36 *ulation Research Center pursuant to section 2 of this 2013 Act is the highest priority for the*
37 **allocation of grant funding under subsection (5) of this section.**

38 **“SECTION 6.** ORS 195.034 is repealed.

39 **“SECTION 7.** This 2013 Act being necessary for the immediate preservation of the public
40 **peace, health and safety, an emergency is declared to exist, and this 2013 Act takes effect**
41 **July 1, 2013.”.**
