

House Bill 2259

Introduced and printed pursuant to House Rule 12.00. Pre-session filed (at the request of Governor John A. Kitzhaber, M.D., for Water Resources Department)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Increases certain fees charged by Water Resources Department.
Declares emergency, effective on passage.

2 Relating to fees charged by the Water Resources Department; creating new provisions; amending
3 ORS 536.050, 537.150, 537.153, 537.610, 537.620, 537.621, 539.081 and 543A.120; repealing section
4 18, chapter 819, Oregon Laws 2009; and declaring an emergency.

5 **Be It Enacted by the People of the State of Oregon:**

6 **SECTION 1.** ORS 536.050 is amended to read:

7 536.050. (1) The Water Resources Department may collect the following fees in advance:

8 (a) For examining an application for a permit:

9 (A) To appropriate water, except as provided under ORS 543.280 for an application for a hy-
10 droelectric project:

11 (i) A base fee of [~~\$700~~] **\$800** for an appropriation of water through a single use, point of diver-
12 sion or point of appropriation;

13 (ii) [~~\$250~~] **\$300** for the first second-foot or fraction thereof appropriated under the permit;

14 (iii) [~~\$250~~] **\$300** for each additional second-foot or fraction thereof appropriated under the permit;

15 (iv) [~~\$250~~] **\$300** for each additional use, point of diversion or point of appropriation included in
16 the application;

17 (v) If appropriating stored water, [~~\$25~~] **\$30** for the first acre-foot or fraction thereof up to 20
18 acre-feet, plus \$1 for each additional acre-foot or fraction thereof; and

19 (vi) If appropriating ground water, in addition to any other fees, [~~\$300~~] **\$350** for each application
20 filed.

21 (B) To store water under ORS 537.400 or 537.534 (4):

22 (i) A base fee of [~~\$700~~] **\$800**;

23 (ii) [~~\$25~~] **\$30** for the first acre-foot or fraction thereof up to 20 acre-feet, plus \$1 for each addi-
24 tional acre-foot or fraction thereof; and

25 (iii) [~~\$100~~] **\$125** for each additional storage location.

26 (C) To exclusively appropriate stored water:

27 (i) A base fee of [~~\$400~~] **\$450**; and

28 (ii) [~~\$25~~] **\$30** for the first acre-foot or fraction thereof up to 20 acre-feet, plus \$1 for each addi-
29 tional acre-foot or fraction thereof.

30 (b) For a permit issued under ORS 537.147, 537.211, 537.409 or 537.625 to appropriate or store

- 4 (c) For filing and recording the assignment or partial assignment of a water right application,
- 5 permit or license under ORS 537.220 or 537.635, [~~\$75~~] **\$85**.
- 6 (d) For copying records in the department, \$2 for the first page and 50 cents for each additional
- 7 page.

- 13 (B) [~~\$700~~] **\$800** for each additional type of change requested;
- 14 (C) For a request for a change in place of use or type of use or for a water exchange under ORS
- 15 540.533, [~~\$250~~] **\$300** for each second-foot or fraction thereof requested beyond the first second-foot;
- 16 (D) [~~\$400~~] **\$450** for each additional water right or permit included in the application; and
- 17 (E) An additional fee of [~~\$300~~] **\$350** per application, if the application is for an additional point
- 18 of appropriation, a change in a point of appropriation or a change from surface water to ground
- 19 water or for substitution as described in ORS 540.524.
- 20 (i) For examining an application for a temporary change in place of use under ORS 540.523, for
- 21 a temporary transfer under ORS 540.585 or for a temporary change in place of use, a change in the
- 22 point of diversion to allow for the appropriation of ground water or a change of a primary right to
- 23 a supplemental right under ORS 540.570, a base fee of [~~\$600~~] **\$700** for the first water right or permit,
- 24 plus [~~\$200~~] **\$225** for each additional water right or permit included in the application and:
- 25 (A) For nonirrigation uses, [~~\$150~~] **\$175** for each second-foot or fraction thereof requested beyond
- 26 the first second-foot; or
- 27 (B) For irrigation uses, \$2 per acre of land irrigated or, if the application and required map are
- 28 submitted to the department in a department-approved digital format, 50 cents per acre of land ir-
- 29 rigated.
- 30 (j) For submitting a protest to the department:
- 31 (A) [~~\$600~~] **\$700** if the protest is by a nonapplicant; and
- 32 (B) [~~\$300~~] **\$350** if the protest is by an applicant.
- 33 (k) For filing an application for extension of time within which irrigation or other works shall
- 34 be completed or a water right perfected, [~~\$500~~] **\$575**.
- 35 (L) For a limited license under ORS 537.143 or 537.534 (2), the fee established by rule by the
- 36 Water Resources Commission.
- 37 (m) For filing, examining and certifying a petition under ORS 541.329, [~~\$300~~] **\$350** plus 10 cents
- 38 per acre of water involved in the application. For purposes of computing this fee, when any acreage
- 39 within a quarter quarter of a section is involved, the 10 cents per acre shall apply to all acres in
- 40 that quarter quarter of a section. Notwithstanding the fee amount established in this paragraph, a
- 41 district notifying the department under ORS 541.327 (4) shall pay the actual cost of filing, examining
- 42 and certifying the petition.

- 44 (o) For participating in a contested case proceeding under ORS 537.170, 537.622 or 543A.130,

 2 for a water right application under ORS 537.140 to 537.252, 537.505 to 537.795 or 543A.005 to
 3 543A.300 or an extension issued under ORS 537.230, 537.248 or 537.630, [~~\$20~~] **\$25**.

4 (q) For examining an application to store water under ORS 537.409:

5 (A) A base fee of [~~\$300~~] **\$350**; and

6 (B) [~~\$25~~] **\$30** for each acre-foot or fraction thereof.

7 (r) For submitting a notice of intent under ORS 543A.030 or 543A.075, the amount established
 8 by the Water Resources Director under ORS 543A.410.

9 (s) For examining an application for a substitution made under ORS 540.524:

11 (B) A fee of [~~\$300~~] **\$350** for each additional well substitution.

34 (2)(a) The department may charge a dam owner an annual fee based upon the dam's hazard
 35 rating as determined by the department. The fees the department may charge the dam owner are:

36 (A) [~~\$75~~] **\$85** for a dam with a low hazard rating.

37 (B) [~~\$150~~] **\$170** for a dam with a significant hazard rating.

38 (C) [~~\$500~~] **\$575** for a dam with a high hazard rating.

39 (D) If the dam owner fails to pay an annual fee on or before six months after the billing date,
 40 a late fee of \$100.

41 (b) If a dam owner fails to pay an annual fee or a late fee charged by the department, the de-
 42 partment may, after giving the dam owner notice by certified mail, place a lien on the real property
 43 where the dam is located for the fees owed by the dam owner.

15 (b) Necessary to complete a project funded under ORS 541.932; or

16 (c) Approved by the State Department of Fish and Wildlife as a change or allocation of con-
17 served water that will result in a net benefit to fish and wildlife habitat.

19 rule reduced fees for persons submitting materials to the department in a digital format approved
20 by the department.

21 (7) All moneys received under this section, less any amounts refunded under subsection (4) of
22 this section, shall be deposited in the Water Resources Department Water Right Operating Fund.

23 (8) Notwithstanding subsection (7) of this section, all fees received by the department for power
24 purposes under ORS 543.280 shall be deposited in the Water Resources Department Hydroelectric
25 Fund established by ORS 536.015.

39 [(7)] (8) Notwithstanding subsection [(6)] (7) of this section, all fees received by the department
 40 for power purposes under ORS 543.280 shall be deposited in the Water Resources Department Hy-
 41 droelectric Fund established by ORS 536.015.

42 **SECTION 3.** ORS 537.150 is amended to read:

43 537.150. (1) Within 15 days after receiving an application, the Water Resources Department shall
 44 determine whether the application contains the information listed under ORS 537.140 (1) and is
 45 complete and not defective, including the payment of all fees required under ORS 537.140 (5). If the

1 department determines that the application is incomplete or defective or that not all fees have been
 2 paid, the department shall return the fees paid and the application.

3 (2) Upon determining that an application contains the information listed under ORS 537.140 (1)
 4 and is complete and not defective, the department shall indorse on the application the date upon
 5 which the application was received at the department, which shall be the priority date for any water
 6 right issued in response to the application. All applications that comply with the provisions of law
 7 shall be recorded in a suitable book kept for that purpose.

8 (3) If an application is complete and not defective, the department shall determine whether the
 9 proposed use is prohibited by ORS chapter 538. If the proposed use is prohibited by ORS chapter
 10 538, the department shall reject the application and return all fees to the applicant with an expla-
 11 nation of the statutory prohibition.

12 (4) If the proposed use is not prohibited by ORS chapter 538, the department shall undertake
 13 an initial review of the application and make a preliminary determination of:

14 (a) Whether the proposed use is restricted or limited by statute or rule;

15 (b) The extent to which water is available from the proposed source during the times and in the
 16 amounts requested; and

17 (c) Any other issue the department identifies as a result of the initial review that may preclude
 18 approval of or restrict the proposed use.

19 (5) Upon completion of the initial review and no later than 30 days after determining an appli-
 20 cation to be complete and not defective as described in subsection (1) of this section, the department
 21 shall notify the applicant of its preliminary determinations and allow the applicant 14 days from the
 22 date of mailing within which to notify the department to stop processing the application or to pro-
 23 ceed with the application. If the applicant notifies the department to stop processing the application,
 24 the department shall return the application and all fees paid in excess of [~~\$200~~] **\$225**. If the depart-
 25 ment receives no timely response from the applicant, the department shall proceed with the appli-
 26 cation.

27 (6) Within seven days after proceeding with the application under subsection (5) of this section,
 28 the department shall give public notice of the application in the weekly notice published by the de-
 29 partment. The notice shall include a request for comments on the application and information per-
 30 taining to how an interested person may obtain future notices about the application and a copy of
 31 the proposed final order.

32 (7) Within 30 days after the public notice under subsection (6) of this section, any person inter-
 33 ested in the application shall submit written comments to the department. Any person who asks to
 34 receive a copy of the department's proposed final order shall submit to the department the fee re-
 35 quired under ORS 536.050 (1).

- 8 (3) The department shall mail copies of the proposed final order, as submitted by the team, to
- 9 the applicant and to persons who have requested copies and paid the fee required under ORS 536.050
- 10 (1)(p). The department also shall give public notice of the proposed final order in the weekly notice
- 11 published by the department.
- 12 (4) Any person may request standing for purposes of participating in any contested case pro-
- 13 ceeding on the proposed final order or for judicial review of a final order. A request for standing
- 14 shall be in writing and shall be accompanied by the fee established under ORS 536.050 (1)(n).
- 15 (5) Any person may submit a protest against a proposed final order. A protest shall be in writing
- 16 and shall include:
- 17 (a) The name, address and telephone number of the protestant;
- 18 (b) A description of the protestant's interest in the proposed final order and, if the protestant
- 19 claims to represent the public interest, a precise statement of the public interest represented;
- 20 (c) A detailed description of how the action proposed in the proposed final order would impair
- 21 or be detrimental to the protestant's interest;
- 22 (d) A detailed description of how the proposed final order is in error or deficient and how to
- 23 correct the alleged error or deficiency;
- 24 (e) Any citation of legal authority supporting the protest, if known; and
- 25 (f) [*For persons other than the applicant,*] The protest fee required under ORS 536.050 (1)(j).
- 26 (6) Requests for standing and protests on the proposed final order shall be submitted within 45
- 27 days after publication of the notice of the proposed final order in the weekly notice published by the
- 28 department. Any person who asks to receive a copy of the department's final order shall submit to
- 29 the department the fee required under ORS 536.050 (1)(p), unless the person has previously requested
- 30 copies and paid the required fee.
- 31 (7) The Hydroelectric Application Review Team shall review any protest received and provide
- 32 to the Water Resources Director a recommended response to any protest received.
- 33 (8) Within 120 days after the close of the period for receiving protests and after consultation
- 34 with the Hydroelectric Application Review Team, the director shall:
- 35 (a) Issue a final order as provided under ORS 543A.130; or
- 36 (b) Schedule a contested case hearing if a protest has been submitted and if:
- 37 (A) Upon review of the issues, the director finds that there are significant disputes related to
- 38 the proposed reauthorization of the project; or
- 39 (B) Within 30 days after the close of the period for submitting protests, the applicant requests
- 40 a contested case hearing.
- 41 (9) At the request of the applicant, the department may extend the time periods set forth in
- 42 subsection (8) of this section for a reasonable period of time.
- 43 (10) If the application is for reauthorization of a water right for a federally licensed project, the
- 44 department may postpone the issuance of the final order until the Federal Energy Regulatory Com-
- 45 mission license is issued.

1 **SECTION 13.** Section 18, chapter 819, Oregon Laws 2009, is repealed.

2 **SECTION 14.** If this 2013 Act does not become effective until after July 1, 2013, the Leg-
3 islative Assembly intends that the amendments to ORS 536.050, 537.150, 537.153, 537.610,
4 537.620, 537.621, 539.081 and 543A.120 by sections 2, 4, 5, 7, 9, 10, 11 and 12 of this 2013 Act
5 and any fee amounts established under those amendments apply retroactively to July 1, 2013.

6 **SECTION 15.** This 2013 Act being necessary for the immediate preservation of the public
7 peace, health and safety, an emergency is declared to exist, and this 2013 Act takes effect
8 on its passage.
