SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Defines commercial driving privileges for purposes of Oregon Vehicle Code. Describes persons who hold commercial driving privileges for purposes of Oregon Vehicle Code.

Revises laws relating to suspension of commercial driving privileges.

Creates commercial learner driver permit. Prescribes fees, privileges and limitations of permit. [*Requires criminal background check of persons administering examinations for commercial driving licenses and commercial learner driver permits.*]

Declares emergency, effective on passage.

A BILL FOR AN ACT

Relating to commercial driving privileges; creating new provisions; amending ORS 153.090, 801.208, 801.250, 801.303, 801.522, 802.179, 802.200, 807.035, 807.040, 807.045, 807.050, 807.070, 807.100, 807.120, 807.200, 807.280, 807.370, 809.240, 809.360, 809.406, 809.407, 809.412, 809.415, 809.430, 809.440, 809.460, 810.375, 810.530, 811.182, 813.130, 813.215 and 813.410 and section 2, chapter 14, Oregon Laws 2012; repealing ORS 801.307, 801.477, 809.404, 809.413, 813.403 and 813.404; and declaring an emergency.

Be It Enacted by the People of the State of Oregon:

COMMERCIAL DRIVING PRIVILEGES (Definition of "Commercial Driving Privileges")

SECTION 1. Sections 2 to 11 of this 2013 Act are added to and made a part of the Oregon Vehicle Code.

SECTION 2. Definition. "Commercial driving privileges" means the driving privileges granted by a commercial driver license or a commercial learner driver permit issued by this state or any other jurisdiction, either of which authorizes the individual to operate a class of commercial motor vehicle as permitted by the commercial driver license or commercial learner driver permit, subject to any endorsements or restrictions.

(Persons Considered To Hold Commercial Driving Privileges)

SECTION 3. Persons considered to hold commercial driving privileges. (1) Except as provided in subsections (2) and (3) of this section, a person holds commercial driving privileges for the purposes of the Oregon Vehicle Code if the person's most recently issued driver

1 license or driver permit is or was a commercial driver license or commercial learner driver
2 permit issued by the Department of Transportation or the licensing agency of another ju-
3 risdiction, without regard to whether:

4 (a) The person's commercial driver license has expired; or

5 (b) The person's commercial driving privileges are suspended, canceled or revoked.

6 (2) Except as provided in subsection (3) of this section, a person does not hold commer-
7 cial driving privileges for the purposes of the Oregon Vehicle Code if:

8 (a) The person has voluntarily surrendered commercial driving privileges and has been
9 issued a noncommercial driver license or driver permit by the department or the licensing
10 agency of another jurisdiction; or

11 (b) The person's commercial learner driver permit has expired and the person's most
12 recently issued driver license was not a commercial driver license.

13 (3) A person holds commercial driving privileges for the purposes of the Oregon Vehicle
14 Code if:

15 (a) The person's commercial driving privileges have been suspended, canceled or revoked
16 by the department or the licensing agency of another jurisdiction; and

17 (b) The person has been issued a hardship permit under ORS 807.240 or a comparable law
18 of another jurisdiction that authorizes the person to drive noncommercial motor vehicles.

20 (Suspension of Commercial Driving Privileges)

22 **SECTION 4. Conviction of crime; refusal or failure of blood alcohol test; suspension in**
23 **another jurisdiction.** (1) Except as otherwise provided by sections 4 to 11 of this 2013 Act, the
24 Department of Transportation shall suspend the commercial driving privileges of a person
25 for a period of one year when the department receives:

26 (a) A record of conviction under ORS 811.700 or 811.705 of failure to perform the duties
27 of a driver.

28 (b) A record of conviction of a crime punishable as a felony involving the operation of a
29 motor vehicle.

30 (c) A record of conviction for driving a commercial motor vehicle while, as a result of
31 prior violations committed while operating a commercial motor vehicle, the commercial
32 driving privileges of the driver were suspended.

33 (d) A record of conviction of assault in the first degree, or any degree of criminally
34 negligent homicide, manslaughter or murder, if the conviction results from the operation of
35 a commercial motor vehicle.

36 (e) A record of conviction of aggravated vehicular homicide or aggravated driving while
37 suspended or revoked.

38 (f) A record of conviction for driving while under the influence of intoxicants under ORS
39 813.010.

40 (2) The department shall suspend the commercial driving privileges of a person for a pe-
41 riod of three years if the department receives a record of a conviction under subsection (1)
42 of this section and the person was driving a commercial motor vehicle containing a hazard-
43 ous material at the time of the offense.

44 (3) The department shall suspend the commercial driving privileges of a person for a pe-
45 riod of one year if the department receives a report from a police officer pursuant to ORS

1 813.120 that the person was driving a commercial motor vehicle and submitted to a breath
2 or blood test and the person's blood, as shown by the test, had 0.04 percent or more by
3 weight of alcohol. The department shall suspend the commercial driving privileges of the
4 person for a period of three years if the person was driving a commercial motor vehicle
5 containing a hazardous material at the time of the offense.

6 (4) The department shall suspend the commercial driving privileges of a person for a pe-
7 riod of three years if the department receives a report from a police officer pursuant to ORS
8 813.120 that the person was driving a motor vehicle and refused to submit to a test under
9 ORS 813.100. The department shall suspend the commercial driving privileges of the person
10 for a period of five years if the person was driving a commercial motor vehicle containing a
11 hazardous material at the time of the offense.

12 (5) The department shall suspend the commercial driving privileges of a person if the
13 department receives a notice of a conviction in another jurisdiction of an offense that, if
14 committed in this state, would be grounds for the suspension of the person's commercial
15 driving privileges. The period of suspension under this subsection shall be the same as would
16 be imposed on the person if the conviction were for an offense committed in this state. For
17 the purposes of this subsection, "conviction" means an unvacated adjudication of guilt, a
18 determination that a person has violated or failed to comply with the law in a court of ori-
19 ginal jurisdiction or in an authorized administrative tribunal, an unvacated forfeiture of bail
20 or collateral deposited to secure the person's appearance in court, a plea of guilty or nolo
21 contendere accepted by the court, the payment of a fine or court cost or the violation of a
22 condition of release without bail, regardless of whether or not the penalty is rebated, sus-
23 pended or probated.

24 (6) The department shall suspend the commercial driving privileges of a person in this
25 state if the department receives a notice from another jurisdiction that the person has had
26 commercial driving privileges suspended or revoked in another jurisdiction for reasons that
27 would be grounds for suspension of the person's commercial driving privileges in this state.
28 The period of suspension under this subsection is the same as would be imposed on the per-
29 son if the violation were committed in this state.

30 (7) If the department receives a record, report or notice under this section for a person
31 who does not hold commercial driving privileges in this state, the department shall suspend
32 the person's right to apply for commercial driving privileges as provided in section 10 (1) of
33 this 2013 Act.

34 (8) A suspension imposed under this section is consecutive to any other suspension im-
35 posed under section 7 or 8 of this 2013 Act or ORS 809.407 if the suspensions do not arise out
36 of the same incident.

37 SECTION 5. Failure to appear, pay fine or obey court order in another jurisdiction; dis-
38 qualification by Federal Motor Carrier Safety Administration. (1)(a) The Department of
39 Transportation shall suspend the commercial driving privileges of a person if the department
40 receives a notice from another jurisdiction that the person failed to appear, pay a fine or
41 comply with an order of the court in a prosecution on a citation for a traffic offense or for
42 a violation in the other jurisdiction that, if committed in this state, would be grounds for
43 suspension under ORS 809.210 or 809.220, and the person held commercial driving privileges
44 or was operating a commercial motor vehicle at the time of the offense. The period of a
45 suspension under this subsection is the shorter of:

1 (A) Ten years; or

2 (B) Until the department receives notice from the other jurisdiction that the person ap-
3 peared, paid the fine or complied with the court's order.

4 (b) The department shall suspend a person's commercial driving privileges under this
5 subsection without regard to whether the other jurisdiction suspends any driving privileges
6 of the person by reason of the person's failure to appear, pay a fine or comply with an order
7 of the court.

8 (c) This subsection does not apply to failure to appear, pay a fine or comply with an order
9 of the court in a proceeding relating to a parking, pedestrian, vehicle defect or bicycling of-
10 fense.

11 (2) The department shall suspend the commercial driving privileges of a person if the
12 department receives a notice from the Federal Motor Carrier Safety Administration that the
13 person has been disqualified from operating a commercial motor vehicle and that the dis-
14 qualification is due to a determination that the driving of that person constitutes an immi-
15 nent hazard. The department shall immediately suspend commercial driving privileges under
16 this subsection without hearing, but the person may request a post-imposition hearing under
17 ORS 809.440 (4), without regard to any hearings conducted by the Federal Motor Carrier
18 Safety Administration. The period of a suspension under this section is the period of sus-
19 pension prescribed by the Federal Motor Carrier Safety Administration, or one year, which-
20 ever is shorter.

21 **SECTION 6. Lifetime suspension of commercial driving privileges.** (1) Notwithstanding
22 section 4 of this 2013 Act, the Department of Transportation shall permanently suspend a
23 person's commercial driving privileges for the lifetime of the person if the department re-
24 ceives a record of conviction for a crime punishable as a felony in which a motor vehicle was
25 used and that involved the manufacturing, distributing or dispensing of a controlled sub-
26 stance, as defined in ORS 475.005. The department may not reinstate commercial driving
27 privileges of a person whose commercial driving privileges are suspended under this sub-
28 section.

29 (2) Notwithstanding section 4 of this 2013 Act, the department shall suspend a person's
30 commercial driving privileges for the lifetime of the person if the department receives a
31 second or subsequent record, report or notice described in section 4 of this 2013 Act that
32 does not arise out of the same incident and that would be grounds for suspension of the
33 person's commercial driving privileges under section 4 of this 2013 Act.

34 (3) Except as provided in subsections (1) and (4) of this section, a person whose com-
35 mercial driving privileges were suspended under subsection (2) of this section may apply to
36 the department for reinstatement of the person's commercial driving privileges. An applica-
37 tion for reinstatement may not be made under this subsection earlier than 10 years after the
38 date that the person's commercial driving privileges were suspended under subsection (2) of
39 this section. The department may reinstate the person's commercial driving privileges if:

40 (a) The person meets all other requirements for the granting of commercial driving
41 privileges;

42 (b) The department, in its sole discretion, finds good cause exists for reinstatement; and

43 (c) The department finds that the person has successfully completed rehabilitation as
44 approved by the department.

45 (4) The department shall permanently suspend a person's commercial driving privileges

1 for the lifetime of the person if the department receives a record, report or notice described
2 in subsection (2) of this section that relates to conduct that occurred after the person's
3 commercial driving privileges were reinstated under subsection (3) of this section. The de-
4 partment may not reinstate the commercial driving privileges for the lifetime of a person
5 whose commercial driving privileges are suspended under this subsection.

6 **SECTION 7. Serious traffic violations.** (1) Except as provided in this section, the De-
7 partment of Transportation shall suspend the commercial driving privileges of a person for
8 a period of 60 days if:

9 (a) The department receives a record of a conviction of a serious traffic violation;

10 (b) The violation was committed within three years of the commission of another serious
11 traffic violation for which the department received a record of a conviction; and

12 (c) The violations did not arise out of the same incident.

13 (2) The department shall suspend the commercial driving privileges of a person for a pe-
14 riod of 120 days if:

15 (a) The department receives a record of a conviction of a serious traffic violation;

16 (b) The violation was committed within three years of the commission of two or more
17 other serious traffic violations for which the department received records of conviction; and

18 (c) The violations did not arise out of the same incident.

19 (3) The department by rule shall designate traffic violations that constitute serious traf-
20 fic violations for the purposes of this section. To the extent practicable, rules adopted by the
21 department under this section shall be uniform with any applicable federal regulations re-
22 lated to offenses that constitute serious traffic violations.

23 (4) A report of a conviction in another jurisdiction has the same effect as if the serious
24 traffic violation conviction had occurred in this state.

25 (5) A suspension imposed under this section is consecutive to any other suspension im-
26 posed under this section or section 4 or 8 of this 2013 Act or ORS 809.407 if the suspensions
27 do not arise out of the same incident.

28 **SECTION 8. Violation of out-of-service order.** (1) Except as provided in this section, the
29 Department of Transportation shall suspend the commercial driving privileges of a person
30 for a period of 180 days if the department receives a report that the person violated an out-
31 of-service order issued under ORS 813.050 or has violated any other out-of-service order or
32 notice. A report under this section may include, but need not be limited to, a record of
33 conviction or a record of a determination by a state or federal agency with jurisdiction to
34 make a determination that the person has violated an out-of-service order or notice.

35 (2) The department shall suspend the commercial driving privileges of a person for a pe-
36 riod of one year if the department receives a report as described in subsection (1) of this
37 section and:

38 (a) The person committed the violation while transporting hazardous materials; or

39 (b) The person committed the violation while operating a motor vehicle designed to
40 transport 16 or more persons, including the driver.

41 (3) The department shall suspend the commercial driving privileges of a person for a pe-
42 riod of three years if:

43 (a) The department receives a report as described in subsection (1) of this section; and

44 (b) The violation was committed within 10 years of the commission of one or more other
45 violations of out-of-service orders for which the department received reports as described in

1 subsection (1) of this section.

2 (4) The department shall suspend the commercial driving privileges of a person for a pe-
3 riod of five years if the department receives a report that meets the requirements of sub-
4 section (3) of this section and:

5 (a) The violation that is the subject of the report occurred while the person was trans-
6 porting hazardous materials; or

7 (b) The person committed the violation while operating a motor vehicle designed to
8 transport 16 or more persons, including the driver.

9 (5) A suspension imposed under this section is consecutive to any other suspension im-
10 posed under this section or section 4 or 7 of this 2013 Act or ORS 809.407 if the suspensions
11 do not arise out of the same incident.

12 NOTE: Section 9 was deleted. Subsequent sections were not renumbered.

14 (Suspension of Right To Apply for Commercial Driving Privileges)

15
16 SECTION 10. Suspension of right to apply for commercial driving privileges. (1) If the
17 Department of Transportation receives a record, report or notice described in sections 4 to
18 11 of this 2013 Act, and the person who is the subject of the record, report or notice was
19 driving a commercial motor vehicle at the time of the incident giving rise to the record, re-
20 port or notice but did not hold commercial driving privileges at the time of the incident, the
21 department shall suspend the person's right to apply for commercial driving privileges for
22 the period specified in sections 4 to 11 of this 2013 Act.

23 (2) If the department receives a record, report or notice described in sections 4 to 11 of
24 this 2013 Act, and the commercial driving privileges of the person who is the subject of the
25 record, report or notice are due to expire during the suspension period, the department shall
26 suspend the person's right to apply for commercial driving privileges for the suspension pe-
27 riod specified in sections 4 to 11 of this 2013 Act.

28
29 (Administrative Review)

30
31 SECTION 11. Administrative review of suspension. (1) Except as provided in subsections
32 (2) and (3) of this section, a person is entitled to administrative review under ORS 809.440 for
33 a suspension of commercial driving privileges under sections 4 to 11 of this 2013 Act, or a
34 suspension of the right to apply for commercial driving privileges under section 10 of this
35 2013 Act.

36 (2) A person is entitled to a hearing under ORS 813.410 for a suspension of commercial
37 driving privileges under section 4 (3) or (4) of this 2013 Act, or a suspension of the right to
38 apply for commercial driving privileges under section 10 of this 2013 Act based on section 4
39 (3) or (4) of this 2013 Act.

40 (3) A person is entitled to a hearing under ORS 813.410 for a suspension of commercial
41 driving privileges under section 6 (2) or (4) of this 2013 Act when the suspension is based on
42 conduct described in section 4 (3) or (4) of this 2013 Act, or a suspension of the right to apply
43 for commercial driving privileges under section 10 of this 2013 Act when the suspension is
44 based on conduct described in section 4 (3) or (4) of this 2013 Act.

(Repeals)

SECTION 12. ORS 801.307, 801.477, 809.404, 809.413, 813.403 and 813.404 are repealed.

(Applicability)

SECTION 13. Sections 4 to 11 of this 2013 Act and the repeal of ORS 809.404, 809.413, 813.403 and 813.404 by section 12 of this 2013 Act apply only to conduct occurring on or after July 8, 2014, for which a record, report or notice as described in sections 4 to 11 of this 2013 Act is received by the Department of Transportation. Records, reports and notices as described in sections 4 to 11 of this 2013 Act for conduct that occurred before July 8, 2014, shall continue to be governed by ORS 809.404, 809.413, 813.403 and 813.404 as those statutes were in effect immediately before July 8, 2014.

(Conforming Amendments)

SECTION 14. ORS 809.407 is added to and made a part of sections 4 to 11 of this 2013 Act.

SECTION 15. ORS 809.240 is amended to read:

809.240. (1) If a person is convicted of an offense that will result in mandatory suspension or revocation under **sections 4 to 11 of this 2013 Act or** ORS 809.409, 809.411[, 809.413,] **or** 813.400 [or 813.403] **or any other law requiring suspension or revocation of driving privileges upon conviction of an offense**, the trial judge shall:

(a) Order the revocation or suspension at the time of conviction for the required period; and

(b) Comply with the requirements under ORS 809.275 to take possession of the license or driver permit of the person.

(2) When necessary to give full effect to this section, a court shall issue a temporary driver permit under ORS 807.320.

SECTION 16. ORS 809.360 is amended to read:

809.360. (1) For purposes of determining whether grounds exist for revoking or suspending driving privileges, an unvacated forfeiture of bail in another state equals a conviction.

(2) A suspension or revocation of driving privileges ordered by a court shall run concurrently with any mandatory suspension or revocation ordered by the Department of Transportation and arising out of the same conviction.

(3) Judicial review of orders denying, suspending or revoking a license, except where such suspension or revocation is mandatory, shall be as provided in ORS chapter 183.

(4) Whenever the department or a court has reason under any laws of this state to suspend or revoke the driving privileges of any person who does not hold current driving privileges to operate motor vehicles or whose driving privileges are due to expire during a suspension period, the department or court shall suspend or revoke the right of such person to apply for driving privileges to operate motor vehicles in this state. A suspension or revocation of a right to apply for driving privileges under this subsection shall be for the period provided by law.

[(5) Whenever the department or a court has reason under any laws of this state to suspend the commercial driver license of any person who does not hold a current commercial driver license or whose commercial driver license is due to expire during a suspension period, the department or court shall suspend the right of such person to apply for a commercial driver license in this state. A sus-

1 *pension of a right to apply for a commercial driver license under this subsection shall be for the period*
2 *provided by law.]*

3 **SECTION 17.** ORS 809.406 is amended to read:

4 809.406. (1) The Department of Transportation shall cancel a driver license with a Class A or
5 Class B farm endorsement or deny a person the right to apply for a Class A or Class B farm
6 endorsement if the [*person is disqualified from holding a commercial driver license*] **person's com-**
7 **mercial driving privileges are suspended** under [*ORS 809.404*] **section 6 of this 2013 Act.**

8 (2) If the department cancels a driver license with a Class A or Class B farm endorsement under
9 this section, the person whose license is canceled is entitled to an administrative review under ORS
10 809.440.

11 **SECTION 18.** ORS 809.407 is amended to read:

12 809.407. (1) The driver of a commercial motor vehicle is subject to suspension of the driver's
13 commercial [*driver license*] **driving privileges** upon conviction of any of the following offenses:

14 (a) Failure to stop for a railroad signal in violation of ORS 811.455.

15 (b) Failure to follow rail crossing procedures for high-risk vehicles in violation of ORS 811.460.

16 (c) Obstructing a rail crossing in violation of ORS 811.475.

17 (d) Failure of the operator of a commercial motor vehicle to slow down and check that tracks
18 are clear of an approaching train in violation of ORS 811.462.

19 (2) Upon receipt of a record of conviction for an offense described in subsection (1) of this sec-
20 tion, the Department of Transportation shall suspend the convicted person's commercial [*driver li-*
21 *cence*] **driving privileges** for the following periods of time:

22 (a) Sixty days if:

23 (A) The conviction is the person's first conviction of an offense described in subsection (1) of
24 this section; or

25 (B) The date the person committed an offense described in subsection (1) of this section is not
26 within three years of the date the person committed another offense, as described in subsection (1)
27 of this section and for which there was a conviction.

28 (b) One hundred and twenty days if:

29 (A) The conviction is the person's second conviction of an offense described in subsection (1)
30 of this section;

31 (B) The date the person committed the second offense is within three years of the date the
32 person committed another offense, as described in subsection (1) of this section and for which there
33 was a conviction; and

34 (C) The convictions arose out of separate incidents.

35 (c) One year if:

36 (A) The conviction is the person's third or subsequent conviction for an offense described in
37 subsection (1) of this section;

38 (B) The date the person committed the latest offense is within three years of the dates the per-
39 son committed two or more other offenses, as described in subsection (1) of this section and for
40 which there were convictions; and

41 (C) The convictions arose out of separate incidents.

42 (3) A person is entitled to administrative review under ORS 809.440 of a suspension under this
43 section.

44 (4) **A report of a conviction in another jurisdiction of an offense described in subsection**
45 **(1) of this section has the same effect as if the conviction had occurred in this state.**

1 **(5) A suspension imposed under this section is consecutive to any other suspension im-**
2 **posed under this section or section 4, 7 or 8 of this 2013 Act if the suspensions do not arise**
3 **out of the same incident.**

4 **SECTION 19.** ORS 809.412 is amended to read:

5 809.412. If a juvenile court finds a youth to be within the jurisdiction of the juvenile court under
6 ORS 419C.005 for committing an offense that is a ground for suspension or revocation upon con-
7 viction under **sections 4 to 11 of this 2013 Act** or ORS 809.409, 809.411[, 809.413,] or 813.400 [*or*
8 *813.403*] or any other law requiring suspension or revocation of driving privileges upon conviction
9 of an offense, the juvenile court shall order the suspension or revocation of driving privileges that
10 is required upon conviction of the offense.

11 **SECTION 20.** ORS 809.415 is amended to read:

12 809.415. (1)(a) The Department of Transportation shall suspend the driving privileges of a person
13 who has a judgment of the type described under ORS 806.040 rendered against the person if the
14 person does not settle the judgment in the manner described under ORS 809.470 within 60 days after
15 its entry.

16 (b) A suspension under this subsection shall continue until the person does one of the following:

17 (A) Settles the judgment in the manner described in ORS 809.470.

18 (B) Has an insurer that has been found by the department to be obligated to pay the judgment,
19 provided that there has been no final adjudication by a court that the insurer has no such obli-
20 gation.

21 (C) Gives evidence to the department that a period of seven years has elapsed since the entry
22 of the judgment.

23 (D) Receives from the court that rendered the judgment an order permitting the payment of the
24 judgment in installments.

25 (c) A person is entitled to administrative review under ORS 809.440 of a suspension under this
26 subsection.

27 (2)(a) The department shall suspend the driving privileges of a person who falsely certifies the
28 existence of a motor vehicle liability insurance policy or the existence of some other means of sat-
29 isfying financial responsibility requirements or of a person who, after certifying the existence of a
30 motor vehicle liability insurance policy or other means of satisfying the requirements, allows the
31 policy to lapse or be canceled or otherwise fails to remain in compliance with financial responsi-
32 bility requirements.

33 (b) Notwithstanding paragraph (a) of this subsection, the department may suspend under this
34 subsection only if proof of compliance with financial responsibility requirements as of the date of
35 the letter of verification from the department under ORS 806.150 is not submitted within 30 days
36 after the date of the mailing of the department's demand under ORS 806.160.

37 (c) A suspension under this subsection shall continue until the person complies with future re-
38 sponsibility filings.

39 (3)(a) The department shall suspend the driving privileges of a person who fails to comply with
40 future responsibility filings whenever required under the vehicle code or fails to provide new proof
41 for future responsibility filings when requested by the department.

42 (b) A suspension under this subsection shall continue until the person complies with future re-
43 sponsibility filings.

44 (c) A person whose initial obligation to make future responsibility filings is not based upon a
45 conviction or other action by a court is entitled to a hearing under ORS 809.440 prior to a suspen-

1 sion under this subsection. A person whose obligation to make future responsibility filings is based
2 upon a conviction or other action by a court is entitled to administrative review under ORS 809.440
3 of a suspension under this subsection. A person whose suspension under this subsection is based on

6 (4)(a) The department shall suspend driving privileges when provided under ORS 809.416. The
7 suspension shall continue until the earlier of the following:

8 (A) The person establishes to the satisfaction of the department that the person has performed
9 all acts necessary under ORS 809.416 to make the person not subject to suspension.

10 (B) Ten years from the date the suspension is imposed if the suspension is imposed for a reason
11 described in ORS 809.416 (1) or (2) or five years from the date the suspension is imposed if the
12 suspension is imposed for the reason described in ORS 809.416 (3).

13 (b) A person is entitled to administrative review under ORS 809.440 of a suspension under this
14 subsection.

20 purposes of the Motorist Implied Consent Law if the test discloses a blood alcohol content of:

21 (A) 0.08 percent or more by weight if the person was not driving a commercial motor vehicle;

22 (B) 0.04 percent or more by weight if the person was driving a commercial motor vehicle; or

23 (C) Any amount if the person was under 21 years of age.

24 (c) If the person refuses or fails a test under ORS 813.100, the person's driving privileges will
25 be suspended. The outcome of a criminal charge for driving under the influence of intoxicants will
26 not affect the suspension. The suspension will be substantially longer if the person refuses a test.

27 (d) If the person refuses a test or fails a breath test under ORS 813.100 and has an Oregon
28 driver license or permit, the license or permit will be taken immediately and, unless the person does
29 not currently have full valid driving privileges, a temporary driving permit will be issued to the

32 permit for at least 90 days, and possibly for three years, depending on the following factors set forth

1 diversion program in this state or in any similar alcohol or drug rehabilitation program in this or
2 another jurisdiction, as described in ORS 813.430.

3 (f) If the person refuses a breath test under ORS 813.100, or refuses a urine test under ORS
4 813.131 and 813.132, the person is subject to a fine of at least \$500 and not more than \$1,000.

5 (g) After taking a test under ORS 813.100, the person will have a reasonable opportunity, upon
6 request, for an additional chemical test for blood alcohol content to be performed at the person's
7 own expense by a qualified individual of the person's choosing.

8 (h) The person has a right to a hearing to challenge the validity of the suspension before the
9 suspension becomes effective. The person must make a written request to the department for such
10 a hearing. If the person wins at the hearing, the person's driving privileges will not be suspended.
11 If the person loses at the hearing, the suspension will remain in effect during any court review of
12 the hearing.

13 (i) If the person is issued a temporary driving permit under ORS 813.100, the information pro-
14 vided to the person shall include the number of hours before the driving permit will be effective and
15 the number of days the permit will be effective.

23 sequences shall include, in addition to the provisions of subsection (2) of this section, substantially

25 (a) If the person refuses a test under ORS 813.100 or submits to a breath or blood test and the
26 level of alcohol in the person's blood is 0.04 percent or more by weight, the person's commercial
27 [*driver license*] **driving privileges** or right to apply for [*a commercial driver license*] **commercial**
28 **driving privileges** will be suspended and no hardship permit authorizing the person to drive a
29 commercial motor vehicle will be issued. The suspension will be substantially longer if the person
30 refuses a test.

31 (b) The suspension of the person's commercial [*driver license*] **driving privileges** or right to ap-
32 ply for [*a commercial driver license*] **commercial driving privileges** will be for the person's lifetime
33 if the person refuses a test under ORS 813.100 or submits to a breath or blood test and the level
34 of alcohol in the person's blood is 0.04 percent or more by weight and:

35 (A) The person previously has been convicted of failure to perform the duties of a driver;

36 (B) The person previously has been convicted of a crime punishable as a felony and the person
37 was driving a motor vehicle at the time the offense was committed;

38 [*(C) The person previously has been convicted of driving a commercial motor vehicle while the*
39 *person's commercial driver license or right to apply for a commercial driver license was suspended or*
40 *revoked;*]

41 **(C) The person previously has been convicted of driving a commercial motor vehicle while**
42 **the person's commercial driving privileges or right to apply for commercial driving privileges**
43 **was suspended or revoked for offenses committed while operating a commercial motor vehi-**
44 **cle;**

45 (D) The person previously has been convicted of any degree of murder, manslaughter or

1 criminally negligent homicide resulting from the operation of a commercial motor vehicle or assault
2 in the first degree resulting from the operation of a commercial motor vehicle;

3 (E) The person previously has been convicted of driving while under the influence of intoxicants;

4 (F) The person's commercial [*driver license*] **driving privileges** previously [*has*] **have** been sus-
5 pended or revoked for refusal to submit to, or failure of, a breath or blood test under ORS 813.100;
6 or

7 (G) The person's right to apply for [*a commercial driver license*] **commercial driving privileges**
8 previously has been suspended or revoked for refusal to submit to, or failure of, a breath or blood
9 test under ORS 813.100 resulting from the operation of a commercial motor vehicle.

10 (4) Nothing in this section prohibits the department from providing additional information con-
11 cerning rights and consequences that the department considers convenient or appropriate.

15 (a) On the date the defendant filed the petition for a driving while under the influence of
16 intoxicants diversion agreement, the defendant had no charge, other than the charge for the present
17 offense, pending for:

18 (A) An offense of driving while under the influence of intoxicants in violation of:

19 (i) ORS 813.010; or

20 (ii) The statutory counterpart to ORS 813.010 in another jurisdiction;

21 (B) A driving under the influence of intoxicants offense in another jurisdiction that involved the
22 impaired driving of a vehicle due to the use of intoxicating liquor, a controlled substance, an
23 inhalant or any combination thereof; or

24 (C) A driving offense in another jurisdiction that involved operating a vehicle while having a
25 blood alcohol content above that jurisdiction's permissible blood alcohol content.

26 (b) The defendant has not been convicted of an offense described in paragraph (a) of this sub-
27 section within the period beginning 15 years before the date of the commission of the present offense
28 and ending on the date the defendant filed the petition for a driving while under the influence of
29 intoxicants diversion agreement.

30 (c) The defendant has not been convicted of a felony offense described in ORS 813.010 (5)(a).

31 (d) The defendant was not participating in a driving while under the influence of intoxicants
32 diversion program or in any similar alcohol or drug rehabilitation program, other than a program
33 entered into as a result of the charge for the present offense, in this state or in another jurisdiction
34 on the date the defendant filed the petition for a driving while under the influence of intoxicants
35 diversion agreement.

36 (e) The defendant did not participate in a diversion or rehabilitation program described in par-
37 agraph (d) of this subsection, other than a program entered into as a result of the charge for the
38 present offense, within the period beginning 15 years before the date of the commission of the
39 present offense and ending on the date the defendant filed the petition for a driving while under the
40 influence of intoxicants diversion agreement.

41 (f) The defendant had no charge of an offense of aggravated vehicular homicide or of murder,
42 manslaughter, criminally negligent homicide or assault that resulted from the operation of a motor
43 vehicle pending in this state or in another jurisdiction on the date the defendant filed the petition
44 for a driving while under the influence of intoxicants diversion agreement.

45 (g) The defendant has not been convicted of an offense described in paragraph (f) of this sub-

1 section within the period beginning 15 years before the date of the commission of the present offense
2 and ending on the date the defendant filed the petition for a driving while under the influence of
3 intoxicants diversion agreement.

4 (h) The defendant did not hold [*a commercial driver license*] **commercial driving privileges** on
5 the date of the commission of the offense.

6 (i) The defendant was not operating a commercial motor vehicle at the time of the offense.

7 (j) The present driving while under the influence of intoxicants offense did not involve an acci-
8 dent resulting in:

9 (A) Death of any person; or

10 (B) Physical injury as defined in ORS 161.015 to any person other than the defendant.

11 (2) For the purposes of subsection (1)(a) of this section, a conviction for a driving offense in
12 another jurisdiction based solely on a person under 21 years of age having a blood alcohol content
13 that is lower than the permissible blood alcohol content in that jurisdiction for a person 21 years
14 of age or older does not constitute a prior conviction.

15 (3) A defendant is eligible for a second or subsequent diversion if the defendant meets all of the
16 conditions of subsection (1) of this section and the defendant has not been convicted of any other
17 criminal offense involving a motor vehicle within the period beginning 15 years before the date of
18 the commission of the present offense and ending on the date the defendant filed the petition for the
19 second or subsequent driving while under the influence of intoxicants diversion agreement.

15 any court, government agency or self-regulatory body. Nothing in this paragraph limits the activities
16 of a process server when acting as an agent for an attorney, collection agency or like person or for
17 a government agency.

18 (5) The department shall disclose personal information other than names to a researcher for use
19 in researching health and educational questions and providing statistical reports, as long as the
20 personal information is not published, redisclosed or used to contact individuals. The department
21 may disclose information under this subsection only for research sponsored by an educational insti-
22 tution or a health research institution.

23 (6) The department shall disclose personal information to an insurer, an insurance support or-
24 ganization or a self-insured entity in connection with claims investigation activities, antifraud ac-
25 tivities, underwriting or rating.

26 (7) The department shall disclose personal information regarding ownership or other financial
27 interests in a vehicle to a person who is required by the state or federal Constitution, a statute or
28 an ordinance to give notice to another person concerning the vehicle. Personal information disclosed
29 under this subsection may be used only for giving the required notice. Persons authorized to receive
30 personal information under this subsection include, but are not limited to:

31 (a) Tow companies;

32 (b) Persons who have or are entitled to have liens on the vehicle; and

33 (c) Persons taking an action that could affect ownership rights to the vehicle.

34 (8) The department shall disclose personal information to any private security professional cer-
35 tified under ORS 181.878, to be used for the purpose of determining ownership of vehicles parked in
36 a place over which the private security professional, acting within the scope of the professional's
37 employment, exercises control.

38 (9) The department shall disclose personal information to the employer of an individual who
39 holds [*a commercial driver license*] **commercial driving privileges**, or the insurer of the employer,
40 to obtain or verify information about the [*holder of the commercial driver license*] **individual**.

41 (10) The department shall disclose personal information to the operator of a private toll facility
42 for use in collecting tolls.

43 (11) The department may not disclose personal information for bulk distributors of surveys,
44 marketing materials or solicitations except as provided in this subsection. The department shall
45 implement methods and procedures to ensure:

1 (a) That individuals are offered an opportunity to request that personal information about
2 themselves be disclosed to bulk distributors; and

3 (b) That the personal information provided by the department will be used, rented or sold solely
4 for bulk distribution of surveys, marketing materials and solicitations.

5 (12) The department shall disclose personal information to a person who requests the informa-
6 tion if the requester provides the department with written permission from the individual whose
7 personal information is requested. The written permission from the individual must be notarized.

8 (13) The department shall disclose personal information to a person who is in the business of
9 disseminating such information under the following conditions:

10 (a) In addition to any other requirements under the contract executed pursuant to paragraph (b)
11 of this subsection, the person requesting the information must file a performance bond with the de-
12 partment in the amount of \$25,000. The bond must be executed in favor of the State of Oregon and
13 its form is subject to approval by the Attorney General.

14 (b) The disseminator shall enter into a contract with the department. A contract under this
15 paragraph shall contain at least the following provisions:

16 (A) That the disseminator will not reproduce or distribute the personal information in bulk but
17 only in response to an individual record inquiry.

18 (B) That the disseminator will provide the personal information only to a person or government
19 agency authorized to receive the information under this section and only if the person or govern-
20 ment agency has been authorized by the department to receive the information.

21 (C) That the disseminator will have a method of ensuring that the disseminator can delay for a
22 period of up to two days the giving of personal information to a requester who is not a subscriber.

23 (14) The department shall disclose personal information to representatives of the news media for
24 the gathering or dissemination of information related to the operation of a motor vehicle or to public
25 safety.

26 (15) The department shall disclose personal information as provided in ORS 802.220 (5).

27 (16) The department shall adopt rules providing for the release of personal information from
28 motor vehicle records to a person who has a financial interest in the vehicle. Rules adopted under
29 this subsection may include, but need not be limited to, rules establishing procedures for the de-
30 partment to verify the financial interest of the person making the request for personal information.

31 (17) The department shall adopt rules providing for the release of personal information from
32 motor vehicle records to a person who is injured by the unsafe operation of a vehicle or who owns
33 property that is damaged because of the unsafe operation of a vehicle.

34 (18) The department shall disclose personal information to a private investigator licensed by any
35 licensing authority within the State of Oregon, to be used for any purpose permitted any person
36 under this section. A licensed private investigator requesting information must prove to the de-
37 partment that the person has a corporate surety bond, an irrevocable letter of credit issued by an
38 insured institution as defined in ORS 706.008 or such other security as the Department of Public
39 Safety Standards and Training may prescribe by rule in the minimum amount of \$5,000 or errors and
40 omissions insurance in the minimum amount of \$5,000.

41 (19) The department shall disclose personal information to a procurement organization as de-
42 fined in ORS 97.953 for the purpose of facilitating the making of anatomical gifts under the pro-
43 visions of ORS 97.955.

44 **SECTION 36.** ORS 802.200 is amended to read:

45 802.200. In addition to any other records the Department of Transportation may establish, the

1 department is subject to the following provisions concerning records:

2 (1) The department shall maintain records concerning the titling of vehicles in this state. The
3 records under this subsection shall include the following:

4 (a) For vehicles issued a title by this state, the records shall identify the vehicle and contain
5 the following:

6 (A) The name of the vehicle owner and any security interest holders in order of priority, except
7 that a security interest holder need not be identified if the debtor who granted the interest is in the
8 business of selling vehicles and the vehicles constitute inventory held for sale;

9 (B) The name of any lessor of the vehicle;

10 (C) The vehicle description; and

11 (D) Whether a certificate of title was issued for the vehicle.

12 (b) If the vehicle is an antique vehicle that is reconstructed, the records shall indicate that the
13 vehicle is reconstructed.

14 (c) If the vehicle is a replica, the records shall indicate that the vehicle is a replica.

15 (d) Any other information concerning the titling of vehicles that the department considers con-
16 venient or appropriate.

17 (e) All odometer readings for a vehicle that are reported to the department under provisions of
18 the vehicle code.

19 (f) If the vehicle has been reported to the department as a totaled vehicle under the provisions
20 of ORS 819.012 or 819.014, the records shall indicate that the vehicle is a totaled vehicle unless the
21 reason for the report was theft and the vehicle has been recovered.

22 (2) If a vehicle that has been registered or titled in another jurisdiction is registered or titled
23 in this state, the department shall retain a record of any odometer readings shown on the title or
24 registration documents submitted to the department at the time of registration or title.

25 (3) Except as otherwise provided in ORS 826.003, the department shall maintain records con-
26 cerning the registration of vehicles required to be registered by the department. The records con-
27 cerning the registration of vehicles may be stored along with records concerning the titling of
28 vehicles. The records under this subsection shall include the following:

29 (a) For vehicles registered by the department, the records shall identify the vehicle and contain
30 the following:

31 (A) The registration plate number assigned by the department to the vehicle;

32 (B) The name of the vehicle owner;

33 (C) The vehicle description and vehicle identification number; and

34 (D) An indication that the vehicle is a totaled vehicle if it has been reported to the department
35 as a totaled vehicle under the provisions of ORS 819.012 or 819.014, unless the reason for the report
36 was theft and the vehicle has been recovered.

37 (b) Any other information concerning the registration of vehicles that the department considers
38 convenient or appropriate.

39 (4) The department shall maintain separate records for the regulation of vehicle dealers. The
40 records required under this subsection shall include the following information about persons issued
41 dealer certificates:

42 (a) The person's application for a vehicle dealer certificate.

43 (b) An alphabetical index of the name of each person applying for a vehicle dealer certificate.

44 (c) A numerical index according to the distinctive number assigned to each vehicle dealer.

45 (5) The department shall maintain a file on vehicles for which the title record is canceled under

1 ORS 819.030. The records required under this subsection shall disclose the last registered owner of
2 each vehicle, any security interest holder or holders and lessors of each vehicle as shown by the
3 canceled title record for each vehicle and the make and year model for each vehicle.

4 (6) The department shall maintain a record of each agreement or declaration under ORS 802.500
5 and 802.520.

6 (7) The department shall maintain separate and comprehensive records of all transactions af-
7 fecting the Revolving Account for Emergency Cash Advances described under ORS 802.100.

8 (8) The department shall maintain suitable records of driver licenses, driver permits and iden-
9 tification cards. The records required under this subsection shall include all of the following:

10 (a) An index by name and number.

11 (b) Supporting documentation of all driver licenses, driver permits or identification cards issued.

12 (c) Every application for a driver license, driver permit or identification card.

13 (d) All driver licenses or driver permits that have been suspended or revoked.

14 (e) For each driver license, driver permit or identification card, the Social Security number of
15 the person to whom the driver license, driver permit or identification card is issued or proof that
16 the person is not eligible for a Social Security number.

17 (f) For each commercial driver license **and commercial learner driver permit**, the Social Se-
18 curity number of the person to whom the license **or permit** is issued, or any other number or
19 identifying information that the Secretary of the United States Department of Transportation de-

35 that shows drug test results reported under ORS 825.410 is permitted only in accordance with ORS
36 802.202. The employment driving record shall also include all motor vehicle accidents that the per-
37 son is required to report under ORS 811.720, all suspensions of driving privileges required to be
38 placed on the record under ORS 809.280, all suspensions of the person's commercial [*driver license*]
39 **driving privileges** that result from operation or use of a commercial motor vehicle and all con-
40 victions of the person for violation of motor vehicle laws except convictions for offenses requiring

- 9 (c) The nonemployment driving record shall include the person's:
- 10 (A) Motor vehicle accidents that the person is required to report under ORS 811.720, other than
11 the motor vehicle accidents that are included on the person's employment driving record;
- 12 (B) Suspensions, cancellations and revocations of licenses, permits and driving privileges;
- 13 (C) Convictions for violation of the motor vehicle laws other than those included in the em-

1 803.600, as provided under this subsection. The records required by this subsection shall include the

3 (a) A description of the vehicle sufficient to identify the vehicle.

4 (b) The person to whom the permit was issued.

5 (c) When the permit was issued.

6 (d) The type of permit issued.

7 (e) For registration weight trip permits, the maximum allowable registration weight permitted
8 for operation under the permit.

9 (f) Any other information the department determines appropriate or convenient.

10 **SECTION 37.** ORS 807.035 is amended to read:

11 807.035. This section describes the type of driving privileges granted by various endorsements
12 issued by this state. **Except as provided in section 32 of this 2013 Act**, the following endorse-
13 ments grant the driving privileges described:

14 (1) A motorcycle endorsement authorizes a person to operate any motorcycle.

15 (2) A hazardous materials endorsement authorizes a person to operate a vehicle transporting
16 hazardous materials.

17 (3) A tank vehicle endorsement authorizes a person to operate tank vehicles.

18 (4) A passenger endorsement authorizes a person to operate a vehicle that is designed to
19 transport 16 or more persons, including the driver, but that is not a school bus.

20 (5) A school bus endorsement authorizes a person to operate a school bus if the person also
21 holds a valid passenger endorsement.

22 (6) A double and triple trailer endorsement authorizes a person to operate a commercial motor
23 vehicle with double and triple trailer combinations.

24 (7) A combined endorsement authorizes a person to operate a tank vehicle, transport hazardous
25 materials and transport hazardous materials in a tank vehicle.

26 (8) A Class A farm endorsement authorizes a person to:

27 (a) Operate or tow any vehicle that can be operated by the holder of a Class A commercial
28 driver license if the vehicle is:

29 (A) Controlled or operated by a farmer;

30 (B) Used to transport agricultural products, farm machinery or farm supplies to or from a farm;

31 (C) Not used in the operation of a common or contract motor carrier; and

32 (D) Used within 150 miles of the farmer's farm.

33 (b) Operate any vehicle described in paragraph (a) of this subsection that is transporting haz-
34 ardous materials if the vehicle is placarded in accordance with law.

35 (c) Operate any vehicle described in paragraph (a) of this subsection that is a tank vehicle or
36 a double trailer combination without holding a tank vehicle endorsement or a double and triple
37 trailer endorsement.

38 (9) A Class B farm endorsement authorizes a person to:

39 (a) Operate or tow any vehicle that can be operated or towed by the holder of a Class B com-
40 mercial driver license if the vehicle is:

41 (A) Controlled or operated by a farmer;

42 (B) Used to transport agricultural products, farm machinery or farm supplies to or from a farm;

43 (C) Not used in the operation of a common or contract motor carrier; and

44 (D) Used within 150 miles of the farmer's farm.

45 (b) Operate any vehicle described in paragraph (a) of this subsection that is transporting haz-

ardous materials if the vehicle is placarded in accordance with law.

(c) Operate any vehicle described in paragraph (a) of this subsection that is a tank vehicle without holding a tank vehicle endorsement.

SECTION 38. ORS 807.040, as amended by section 30, chapter 43, Oregon Laws 2012, is amended to read:

807.040. (1) The Department of Transportation shall issue a driver license to any person who complies with all of the following requirements:

(a) The person must complete an application for a license under ORS 807.050.

(b) As required by ORS 807.021 and 807.730, the person must provide the Social Security number assigned to the person by the United States Social Security Administration and proof of legal presence in the United States or, if the person is not eligible for a Social Security number, proof of legal presence in the United States and proof that the person is not eligible for a Social Security number.

(c) The person must submit to collection of biometric data by the department that establish the identity of the person as described in ORS 807.024.

(d) The person must not be ineligible for the license under ORS 807.060 and must be eligible for the license under ORS 807.062.

(f) The person must pay the appropriate license fee under ORS 807.370 for the class of license sought.

(g) The person must pay the Student Driver Training Fund eligibility fee.

(h) If the application is for a commercial driver license, the person must be the holder of a Class C license or any higher class of license.

(i) If the application is for a commercial driver license, the person must submit to the department, in a form approved by the department, the report of a medical examination that establishes that the person meets the medical requirements for the particular class of license. The department, by rule, shall establish medical requirements for purposes of this paragraph. The medical requirements established under this paragraph may include any requirements the department determines are necessary for the safe operation of vehicles permitted to be operated under the class of license for which the requirements are established.

(j) If the application is for a commercial driver license, the person must:

(A) Have at least one year's driving experience, including relevant experience obtained in the military;

(B) Not be *[disqualified from holding a commercial driver license under ORS 809.404]* **subject to a lifetime suspension of commercial driving privileges under section 6 of this 2013 Act;** *[and]*

(C) Not be otherwise ineligible to hold a commercial driver license;

(D) Hold a commercial learner driver permit if the person must complete a skills demonstration under ORS 807.070 (3); and

(E) In addition to meeting the requirement of providing proof of legal presence under ORS 807.021 and this section, the person must submit valid documentation, as defined by the department by rule, that the person is a citizen or permanent legal resident of the United States.

(2) The department shall work with other agencies and organizations to attempt to improve the issuance system for driver licenses.

SECTION 39. ORS 807.045 is amended to read:

1 807.045. (1) In order to be authorized to drive a commercial motor vehicle in this state, a person
2 who holds a commercial driver license issued by a jurisdiction other than Oregon must, within 30
3 days of becoming domiciled in Oregon:

4 (a) Apply to the Department of Transportation for an Oregon commercial driver license;

5 (b) Certify to the department that the person's current commercial driver license is not subject

3 807.070. The Department of Transportation shall administer an examination to establish quali-
4 fication for each class of license and endorsement. The examination for each class of license or
5 endorsement must include all of the following as described:

6 (1) A test of the applicant's eyesight. This subsection does not apply to an applicant with a
7 limited vision condition as defined in ORS 807.355.

8 (2) A test of the applicant's knowledge and understanding of the traffic laws of this state, safe
9 driving practices and factors that cause accidents. The following all apply to the test under this

21 (E) Practices necessary for safe operation of a vehicle around pedestrians and bicyclists.

22 (F) Practices necessary for safe operation of a vehicle around motorcyclists.

23 (d) The test must include at least two questions pertaining to the practices necessary for safe
24 operation of a vehicle around motorcyclists.

25 (e) The test may include a question regarding fuel efficient driving techniques.

26 (f) The department may waive the test under circumstances described in ORS 807.072.

27 (3) A test that is an actual demonstration of the applicant's ability to operate a motor vehicle
28 without endangering the safety of persons or property. The following apply to this subsection:

29 (a) The actual demonstration for each class of license shall be performed in a vehicle that may
30 be operated under the class of license sought, but that may not be operated under lower classes of
31 license.

32 (b) An actual demonstration for a passenger endorsement shall be performed in a vehicle that
33 is designed to transport 16 or more persons, including the driver.

34 (c) An actual demonstration for a school bus endorsement shall be performed in a school bus.

41 (4) Any other examination or test, including demonstrations, that the department determines

43 cense under ORS 807.060 or whether the applicant is fit to operate a motor vehicle safely on the
44 highways of this state. In any examination or test under this subsection, the department shall only
45 conduct an investigation for facts relating directly to the ability of the applicant to operate a motor

1 vehicle safely or other facts that are specifically required to show the fitness of the applicant for
2 license.

10 (2) The department may not issue or renew [a] commercial [*driver license or permit*] **driving**
11 **privileges** and may cancel [a] commercial [*driver license or permit*] **driving privileges** if the person
12 does not submit to the department, in a form approved by rule, proof of medical qualification to
13 operate a commercial motor vehicle by such a date as required by rule by the department.

14 (3) A person is entitled to administrative review under ORS 809.440 when the department does
15 not issue or renew [a] commercial [*driver license or permit*] **driving privileges** under this section
16 or cancels [a] commercial [*driver license or permit*] **driving privileges** under this section.

17 (4) To the extent possible, rules adopted by the department under this section should be uniform
18 with any applicable federal regulations related to commercial driver license medical qualifications.

19 **SECTION 43.** ORS 807.120 is amended to read:

20 807.120. (1) The Department of Transportation may place restrictions on **any** driving privileges
21 granted a person if the department determines that there is good cause to restrict the driving priv-
22 ileges of the person in order to [*insure*] **ensure** the safe operation of a motor vehicle by the person.

23 (2) Restrictions placed on a **driver** license **or driver permit** by the department under this sec-
24 tion shall be suitable to the driving ability of the person whose driving privileges are restricted. The
25 restrictions may include:

26 (a) Restrictions on the type of motor vehicle the person may operate;

27 (b) Requirements for special mechanical control devices on motor vehicles operated by the per-
28 son; or

29 (c) Any other restrictions the department determines appropriate to [*insure*] **ensure** the safe
30 operation of a motor vehicle by the person.

31 (3) The department shall place a restriction on the commercial driver license of a person who
32 performs the skill demonstration required under ORS 807.070 for issuance of a commercial **driver**
33 license in a vehicle that:

34 (a) Is not equipped with air brakes. A restriction imposed under this [*subsection*] **paragraph**
35 prohibits the person from operating commercial motor vehicles equipped with **service brakes that**
36 **operate fully or partially by air [*brakes*] pressure.**

37 (b) **Is equipped with air over hydraulic brakes. Air over hydraulic brakes includes any**
38 **braking system operating partially by air pressure and partially by hydraulic pressure. A**
39 **restriction imposed under this paragraph prohibits the person from operating commercial**
40 **motor vehicles equipped with service brakes that operate solely by air pressure.**

41 (c) **Is equipped with an automatic transmission. A restriction imposed under this para-**
42 **graph prohibits the person from operating commercial motor vehicles equipped with manual**
43 **transmissions.**

44 (d) **Uses any connection other than a fifth wheel hitch between the power unit and a**
45 **vehicle towed in combination with the power unit. A restriction under this paragraph pro-**

1 **hibits the person from operating a commercial motor vehicle in combination with any other**
2 **vehicle using a fifth wheel hitch between the power unit and first towed unit.**

3 **(4) The department shall place a restriction on the commercial driver license and the**
4 **commercial learner driver permit of a person who does not pass an air brakes knowledge test**
5 **administered under ORS 807.070. The restriction shall prohibit the person from operating a**
6 **commercial motor vehicle with service brakes that operate fully or partially by air pressure.**

7 [(4)] (5) The department may impose restrictions under this section by setting forth the re-
8 strictions on the regular license form or by issuing a special form for licenses with restrictions.

9 [(5)] (6) The department shall place restrictions on driving privileges under this section when
10 ordered by a court under ORS 809.210 or 809.270. Any restriction imposed under this subsection
11 shall be made a part of the person's driving record and shall remain in effect until the court notifies

13 [(6)] (7) The department may impose restrictions under this section on driving privileges that
14 are restored after having been suspended or revoked. The restrictions imposed under this subsection

16 [(7)] (8) The use of the term "restrictions" in this section includes any restrictions, conditions
17 or requirements.

18 [(8)] (9) Violation of any restrictions placed on driving privileges under this section is
19 punishable as provided under ORS 807.010.

21 807.200. (1) The following permits may be issued as restricted Class C licenses:

22 (a) Disability golf cart driver permits described under ORS 807.210.

23 (b) Emergency driver permits described under ORS 807.220.

24 (c) Special student driver permits described under ORS 807.230.

25 (2) Hardship driver permits described under ORS 807.240 and probationary driver permits de-
26 scribed under ORS 807.270 may be issued as Class C licenses. Restrictions on the license are as
27 provided under ORS 807.240 and 807.270.

28 (3) Instruction driver permits described under ORS 807.280 may be issued for [*any class of com-*
29 *mercial driver license and for*] a Class C license. [*A person must have a Class C license before ob-*

39 which the permit is issued except as provided in this section or under the permit. Except as other-
40 wise provided in this section, an instruction driver permit is subject to the fees, provisions, condi-

4 (a) The holder may [only] operate a motorcycle **only** during daylight hours.

5 (b) The holder may not carry any passengers on the motorcycle.

6 (c) The holder of the **instruction driver** permit must wear an approved helmet while operating
7 a motorcycle.

8 (10)(a) The department may issue an instruction driver permit to a person with a limited vision
9 condition if a rehabilitation training specialist certifies to the department that the person has suc-

32 should be reinstated and may reinstate the person’s suspended driving privileges or right to apply

7 (7) To reinstate an identification card or the right to apply for an identification card after the
8 department determines that the person meets the objective criteria under subsection (4) of this sec-
9 tion, the person shall pay the fee for reinstatement of an identification card as described in ORS
10 807.410 (4).

11 (8) The department's authority to reinstate a suspension of a person's driving privileges or right
12 to apply for driving privileges under this section does not impinge on a court's authority to impose
13 a suspension under ORS 165.805 or 471.430.

3 nently or temporarily attached to the vehicle or the chassis. "Tank vehicle" does not include a
