House Bill 2263

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure as introduced.

Establishes and adjusts certain fees for Department of Transportation.

3 Be It Enacted by the People of the State of Oregon:

SECTION 1. ORS 822.084 is amended to read:

822.084. (1) A person who organizes a show, as defined in ORS 822.083, shall apply to the De-5 6 partment of Transportation at least 30 days prior to the commencement of the show for a show li-7 cense for each recreational vehicle dealer participating in the show. The application must include for each dealer participating in the show the name under which the business is being conducted and 8 the street address, city and county of the dealer's place of business, both as listed in the dealer 9

certificate application described in ORS 822.025. 10

[(2) The department may establish an appropriate fee schedule for show licenses.]

12 (2) A person who receives a show license from the department shall pay the fee for a 13show license established under ORS 822.700.

(1) The Department of Transportation Operating Fund is established in the State 32Treasury separate and distinct from the General Fund and separate and distinct from the State 33 34 Highway Fund. Except as otherwise provided in subsection (3)(e) of this section, moneys in the Department of Transportation Operating Fund are continuously appropriated to the Department of 35 Transportation to pay expenses of the department that are incurred in the performance of functions 36 37 the department is statutorily required or authorized to perform and that may not constitutionally 38 be paid from revenues described in section 3a, Article IX of the Oregon Constitution. (2) The operating fund shall consist of the following: 39 (a) Taxes paid on motor vehicle fuels or on the use of fuel in a motor vehicle for which a person 40 is entitled to a refund under a provision described in this paragraph but for which no refund is 41 claimed, in amounts determined under ORS 184.643.
