

House Bill 2294

Sponsored by Representative READ (Pre-session filed.)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Creates task force on funding Columbia River Crossing Project.
Sunsets task force on date of convening of 2015 regular session of Legislative Assembly.
Declares emergency, effective on passage.

A BILL FOR AN ACT

1
2 Relating to highway projects; and declaring an emergency.

3 **Be It Enacted by the People of the State of Oregon:**

4 **SECTION 1. (1) The Columbia River Crossing Project Task Force is established, consist-**
5 **ing of six members appointed as follows:**

6 (a) **The President of the Senate shall appoint three members from among members of the**
7 **Senate.**

8 (b) **The Speaker of the House of Representatives shall appoint three members from**
9 **among members of the House of Representatives.**

10 (2) **The task force shall recommend funding sources to pay the costs of Oregon's portion**
11 **of the Columbia River Crossing Project.**

12 (3) **A majority of the members of the task force constitutes a quorum for the transaction**
13 **of business.**

14 (4) **Official action by the task force requires the approval of a majority of the members**
15 **of the task force.**

16 (5) **The task force shall elect one of its members to serve as chairperson.**

17 (6) **If there is a vacancy for any cause, the appointing authority shall make an appoint-**
18 **ment to become immediately effective.**

19 (7) **The task force shall meet at times and places specified by the call of the chairperson**
20 **or of a majority of the members of the task force.**

21 (8) **The task force may adopt rules necessary for the operation of the task force.**

22 (9) **The task force may pre-session file legislation in the manner provided in ORS 171.130**
23 **for interim committees. All legislation recommended by official action of the task force must**
24 **indicate that it is introduced at the request of the task force.**

25 (10) **The task force shall report to the Legislative Assembly in the manner provided in**
26 **ORS 192.245 at any time within 30 days after its final meeting or at such later time as the**
27 **President and Speaker may designate.**

28 (11) **The Legislative Administrator may employ persons necessary for the performance**
29 **of the functions of the task force. The Legislative Administrator shall fix the duties and**
30 **amounts of compensation of these employees. The task force shall use the services of con-**
31 **tinuing legislative staff, without employing additional persons, to the greatest extent practi-**

2 (12) All agencies of state government, as defined in ORS 174.111, are directed to assist
3 the task force in the performance of its duties and, to the extent permitted by laws relating
4 to confidentiality, to furnish such information and advice as the members of the task force
5 consider necessary to perform their duties.

6 SECTION 2. Section 1 of this 2013 Act is repealed on the date of the convening of the 2015
7 regular session of the Legislative Assembly as specified in ORS 171.010.

8 SECTION 3. This 2013 Act being necessary for the immediate preservation of the public
9 peace, health and safety, an emergency is declared to exist, and this 2013 Act takes effect
10 on its passage.
