SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Prohibits merchant from requiring statement of account as condition for cardholder to obtain refund of amount in payment card transaction.

Makes violation of prohibition unlawful practice that is subject to action under Unlawful Trade Practices Act.

4 **Be It Enacted by the People of the State of Oregon:**

5 **SECTION 1. (1) As used in this section:**

6 (a) "Cardholder" means a person that a payment card is issued to or a person that is
7 authorized to use a payment card.

8 (b) "Merchant" means a person that, in the ordinary course of the person's business,
9 accepts the use of a payment card to obtain goods or services by purchase or through an
10 extension of credit.

11 (c) "Payment card" means a credit card, charge card, debit card, stored value card or
12 other device that enables a cardholder to obtain goods or services from a merchant by pre-
13 senting the card or device as payment.

14 (d) "Payment card transaction" means an exchange in which a cardholder presents and
15 a merchant accepts a payment card as a method by which the cardholder obtains and the
16 merchant provides goods or services.

17 (e) "Person" means an individual, corporation, limited liability company, partnership or
18 other association or entity.

19 (f) "Statement of account" means a record or document that a person that issues a
20 payment card maintains, in any form or format, as evidence of and information about a
21 cardholder's payment card transactions.

22 (2)(a) A merchant may not require a cardholder to present a statement of account to the
23 merchant in order for the cardholder to obtain a refund of all or a portion of the amount
24 of a payment card transaction to which the cardholder is otherwise entitled, whether or not
25 a receipt, a sales draft or any other record or evidence of the payment card transaction ex-

2 **(b) Paragraph (a) of this subsection does not relieve a cardholder of the requirement to**
3 **comply with any other terms and conditions a merchant may lawfully impose on a**
4 **cardholder's right to obtain a refund for all or a portion of the amount of a payment card**
5 **transaction between the cardholder and the merchant.**

6 **(3) A merchant's violation of a provision of this section is an unlawful practice under**
7 **ORS 646.608 that is subject to an action under ORS 646.638.**

8 **SECTION 2.** ORS 646.608, as amended by section 6, chapter 52, Oregon Laws 2012, is amended
9 to read:

10 646.608. (1) A person engages in an unlawful practice [*when*] **if** in the course of the person's
11 business, vocation or occupation the person does any of the following:

12 (a) Passes off real estate, goods or services as [*those*] **the real estate, goods or services** of
13 another.

14 (b) Causes likelihood of confusion or of misunderstanding as to the source, sponsorship, ap-
15 proval, or certification of real estate, goods or services.

16 (c) Causes likelihood of confusion or of misunderstanding as to affiliation, connection, or asso-
17 ciation with, or certification by, another.

18 (d) Uses deceptive representations or designations of geographic origin in connection with real
19 estate, goods or services.

20 (e) Represents that real estate, goods or services have sponsorship, approval, characteristics,
21 ingredients, uses, benefits, quantities or qualities that [*they*] **the real estate, goods or services** do
22 not have or that a person has a sponsorship, approval, status, qualification, affiliation, or connection
23 that the person does not have.

24 (f) Represents that real estate or goods are original or new if [*they*] **the real estate or goods**
25 are deteriorated, altered, reconditioned, reclaimed, used or secondhand.

26 (g) Represents that real estate, goods or services are of a particular standard, quality, or grade,
27 or that real estate or goods are of a particular style or model, if [*they*] **the real estate, goods or**
28 **services** are of another.

29 (h) Disparages the real estate, goods, services, property or business of a customer or another
30 by false or misleading representations of fact.

31 (i) Advertises real estate, goods or services with intent not to provide [*them*] **the real estate,**
32 **goods or services** as advertised, or with intent not to supply reasonably expectable public demand,
33 unless the advertisement discloses a limitation of quantity.

34 (j) Makes false or misleading representations of fact concerning the reasons for, existence of,
35 or amounts of price reductions.

36 (k) Makes false or misleading representations concerning credit availability or the nature of the
37 transaction or obligation incurred.

38 (L) Makes false or misleading representations relating to commissions or other compensation to
39 be paid in exchange for permitting real estate, goods or services to be used for model or demon-
40 stration purposes or in exchange for submitting names of potential customers.

41 (m) Performs service on or dismantles any goods or real estate [*when not authorized by*] **if** the
42 owner or apparent owner [*thereof*] **of the goods or real estate does not authorize the service**
43 **or dismantling.**

44 (n) Solicits potential customers by telephone or door to door as a seller unless the person pro-
45 vides the information required under ORS 646.611.

1 (o) In a sale, rental or other disposition of real estate, goods or services, gives or offers to give
2 a rebate or discount or otherwise pays or offers to pay value to the customer in consideration of
3 the customer giving to the person the names of prospective purchasers, lessees, or borrowers, or
4 otherwise aiding the person in making a sale, lease, or loan to another person, if earning the rebate,
5 discount or other value is contingent upon [*occurrence of*] an event [*subsequent to*] **occurring after**
6 the time the customer enters into the transaction.

7 (p) Makes any false or misleading statement about a prize, contest or promotion used to publi-
8 cize a product, business or service.

9 (q) Promises to deliver real estate, goods or services within a certain period of time with intent
10 not to deliver [*them*] **the real estate, goods or services** as promised.

11 (r) Organizes or induces or attempts to induce membership in a pyramid club.

12 (s) Makes false or misleading representations of fact concerning the offering price of, or the
13 person's cost for real estate, goods or services.

14 (t) Concurrent with tender or delivery of any real estate, goods or services fails to disclose any
15 known material defect or material nonconformity.

16 (u) Engages in any other unfair or deceptive conduct in trade or commerce.

17 (v) Violates any of the provisions relating to auction sales, auctioneers or auction marts under
18 ORS 698.640, whether in a commercial or noncommercial situation.

19 (w) Manufactures mercury fever thermometers.

20 (x) Sells or supplies mercury fever thermometers unless the thermometer is required by federal
21 law, or is:

22 (A) Prescribed by a person licensed under ORS chapter 677; and

23 (B) Supplied with instructions on the careful handling of the thermometer to avoid breakage and
24 on the proper cleanup of mercury should breakage occur.

5 **SECTION 3. If House Bill 2573 becomes law, section 2 of this 2013 Act (amending ORS**

5 **SECTION 4. If House Bill 3160 becomes law, section 3 of this 2013 Act (amending ORS**
6 **646.608) is repealed.**
