

House Bill 2538

Sponsored by Representative JOHNSON (at the request of Oregon School Boards Association) (Pre-session filed.)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Adds one member to Oregon Education Investment Board who serves as member of school district board.

Declares emergency, effective on passage.

A BILL FOR AN ACT

2 Relating to the Oregon Education Investment Board; amending section 1, chapter 519, Oregon Laws
3 2011; and declaring an emergency.

4 **Be It Enacted by the People of the State of Oregon:**

5 **SECTION 1.** Section 1, chapter 519, Oregon Laws 2011, as amended by section 8, chapter 519,
6 Oregon Laws 2011, and section 20, chapter 36, Oregon Laws 2012, is amended to read:

7 **Sec. 1.** (1) The Oregon Education Investment Board is established for the purpose of ensuring
8 that all public school students in this state reach the education outcomes established for the state.
9 The board shall accomplish this goal by overseeing a unified public education system that begins
10 with early childhood services and continues throughout public education from kindergarten to
11 post-secondary education.

12 (2)(a) The board consists of *[13]* **14** members as follows:

13 (A) The Governor, or the designee of the Governor; and

14 (B) *[Twelve]* **Thirteen** members who are appointed by the Governor, subject to confirmation by
15 the Senate in the manner provided in ORS 171.562 and 171.565, and who serve at the pleasure of the
16 Governor.

17 (b) When determining who to appoint to the board, the Governor shall:

18 (A) Ensure that each congressional district of this state is represented by at least one member
19 of the board; *[and]*

20 **(B) Ensure that one member serves as a member of a school district board; and**

21 *[(B)]* **(C)** Solicit recommendations from:

22 **(i)** The Speaker of the House of Representatives for at least two members *[and from];*

23 **(ii)** The President of the Senate for at least two members*[,]*; **and**

24 **(iii) An organization that represents school districts in this state for the member de-**
25 **scribed in subparagraph (B) of this paragraph.**

26 (3) The Governor, or the Governor's designee, shall serve as chairperson of the Oregon Educa-
27 tion Investment Board.

28 (4) The duties of the board include:

29 (a) Ensuring that early childhood services are streamlined and connected to public education
30 from kindergarten through grade 12 and that public education from kindergarten through grade 12
31 is streamlined and connected to post-secondary education. To assist the board in fulfilling this duty,

4 (b) Recommending strategic investments in order to ensure that the public education budget is
5 integrated and is targeted to achieve the education outcomes established for the state.

6 (c) Providing an integrated, statewide, student-based data system that monitors expenditures and
7 outcomes to determine the return on statewide education investments. The board shall provide the
8 data system described in this paragraph by:

9 (A) Developing the data system or identifying or modifying an existing data system that ac-
10 complishes the goals of the data system; and

11 (B) Ensuring that the data system is maintained.

12 (d) Entering into achievement compacts and administering sections 14, 15 and 18, **chapter 36,**
13 **Oregon Laws 2012** *[of this 2012 Act]*.

14 (e) Working with the Quality Education Commission to identify best practices for school dis-
15 tricts and the costs and benefits of the adoption of those best practices by school districts.

16 (5) An appointed member of the board is entitled to compensation and expenses as provided in
17 ORS 292.495.

18 (6) A majority of the members of the board constitutes a quorum for the transaction of business.

19 (7) The board shall meet at such times and places specified by the call of the chairperson or of
20 a majority of the members of the board.

21 (8) In accordance with applicable provisions of ORS chapter 183, the board may adopt rules
22 necessary for the administration of the laws that the board is charged with administering, including
23 any rules necessary for the oversight of the direction and control of the Higher Education Coordi-
24 nating Commission.

25 **SECTION 2.** Section 1, chapter 519, Oregon Laws 2011, as amended by section 8, chapter 519,

29 **SECTION 3. This 2013 Act being necessary for the immediate preservation of the public**
30 **peace, health and safety, an emergency is declared to exist, and this 2013 Act takes effect**
31 **on its passage.**
