SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Directs Department of Corrections to establish risk assessment tool applicable to sex offenders. Establishes general rules regarding community notification based on results of risk assessment.

Authorizes State Board of Parole and Post-Prison Supervision **and Psychiatric Security Review Board** to conduct hearings to reclassify certain sex offenders and to relieve certain sex offenders of obligation to report. **Specifies factors boards must consider and standards boards must apply when reclassifying sex offenders or relieving sex offenders of obligation to report.**

Adds reclassification hearings to list of proceedings of which victims must be notified.

Applies to recent offenders on January 1, 2014, and remaining offenders on January 1, 2017.

Declares emergency, effective on passage.

6 **Be It Enacted by the People of the State of Oregon:**

RISK ASSESSMENT

10 **SECTION 1. The Department of Corrections shall adopt by rule a sex offender risk as-**
11 **essment tool for use in classifying sex offenders based on the statistical likelihood that an**
12 **individual sex offender will commit another sex crime. Application of the risk assessment**
13 **tool to a sex offender must result in placing the sex offender in one of the following levels:**

14 (1) **A level one sex offender who presents the lowest risk of reoffending and requires a**
15 **limited range of notification.**

16 (2) **A level two sex offender who presents a moderate risk of reoffending and requires a**
17 **moderate range of notification.**

18 (3) **A level three sex offender who presents the highest risk of reoffending and requires**
19 **the widest range of notification.**

20 **SECTION 2. (1) When a person convicted of a sex crime is sentenced to a term of**
21 **imprisonment in a Department of Corrections institution, the department shall conduct a**
22 **risk assessment of the person utilizing the risk assessment tool described in section 1 of this**
23 **2013 Act before the person is released from custody.**

NOTE: Matter in **boldfaced** type in an amended section is new; matter *[italic and bracketed]* is existing law to be omitted. New sections are in **boldfaced** type.

1 (2) When a person convicted of a sex crime is sentenced to a term of incarceration in a
2 jail, or is discharged, released or placed on probation by the court, the supervisory authority
3 as defined in ORS 144.087 shall conduct a risk assessment of the person utilizing the risk
4 assessment tool described in section 1 of this 2013 Act no later than 60 days after the person
5 is released from jail or discharged, released or placed on probation by the court.

6 (3)(a) When a person is found guilty except for insanity of a sex crime, the Psychiatric
7 Security Review Board shall conduct, or cause to be conducted, a risk assessment of the
8 person utilizing the risk assessment tool described in section 1 of this 2013 Act:

9 (A) Before the person is placed on conditional release by the board or the Oregon Health
10 Authority or is discharged from the jurisdiction of the board or the authority, if the person
11 is confined in a correctional facility by the court under ORS 161.327 after being found guilty
12 except for insanity.

13 (B) No later than 60 days after the person is placed on conditional release by the court
14 under ORS 161.327 or discharged by the court under ORS 161.329.

15 (b) The court shall notify the board when the court discharges a person under ORS
16 161.329.

17 (4) At the request of a person required to report as a sex offender under ORS 181.595,
18 181.596 or 181.597 who has not been subjected to a risk assessment utilizing the risk assess-
19 ment tool described in section 1 of this 2013 Act, the State Board of Parole and Post-Prison
20 Supervision shall conduct a risk assessment of the person utilizing the risk assessment tool
21 described in section 1 of this 2013 Act if the person:

22 (a) Has been convicted in another United States court of a crime that would constitute
23 a sex crime if committed in this state; or

24 (b) Is required to register in another state for having committed a sex offense in the
25 other state, regardless of whether the crime would constitute a sex crime in this state.

26 (5) When the Department of Corrections, the State Board of Parole and Post-Prison
27 Supervision, a supervisory authority or the Psychiatric Security Review Board conducts a
28 risk assessment under this section, the agency shall notify the Department of State Police
29 of the results of the risk assessment. Upon receipt, the Department of State Police shall
30 enter the results of the risk assessment into the Law Enforcement Data System.

31 **SECTION 3.** (1) Section 2 of this 2013 Act applies to persons for whom the event trig-
32 gering the obligation to make an initial report under ORS 181.595 (3)(a)(A), 181.596 (4)(a)(A),
33 181.597 (1)(a)(A), (2)(a)(A) or (3)(a)(A) occurs on or after January 1, 2014.

34 (2) As used in this section, “event triggering the obligation to make an initial report”
35 means:

36 (a) If the initial report is described in ORS 181.595 (3)(a)(A):

37 (A) Discharge, parole or release on any form of supervised or conditional release from a
38 jail, prison or other correctional facility in this state;

39 (B) Parole to this state under ORS 144.610 after being convicted in another United States
40 court of a crime that would constitute a sex crime if committed in this state; or

41 (C) Discharge by the court under ORS 161.329.

42 (b) If the initial report is described in ORS 181.596 (4)(a)(A), discharge, release or place-
43 ment on probation:

44 (A) By the court; or

45 (B) To or in this state under ORS 144.610 after being convicted in another United States

1 court of a crime that would constitute a sex crime if committed in this state.

2 (c) If the initial report is described ORS 181.597 (1)(a)(A), moving into this state.

3 (d) If the initial report is described in ORS 181.597 (2)(a)(A), the first day of school at-
4 tendance or the 14th day of employment in this state.

5 (e) If the initial report is described in ORS 181.597 (3)(a)(A):

6 (A) Discharge, release on parole or release on any form of supervised or conditional re-
7 lease, from a jail, prison or other correctional facility or detention facility; or

8 (B) Discharge, release or placement on probation, by another United States court.

9 **SECTION 4.** Notwithstanding any other provision of law:

10 (1) A person required to report as a sex offender under ORS 181.595, 181.596 or 181.597 is
11 classified as a level three sex offender under section 1 (3) of this 2013 Act unless:

12 (a) Following a risk assessment conducted under section 2 of this 2013 Act, the person
13 is classified as a level two sex offender under section 1 (2) of this 2013 Act or as a level one
14 sex offender under section 1 (1) of this 2013 Act; or

15 (b) After filing a petition under section 5 (2) of this 2013 Act, the person is reclassified
16 as a level two sex offender under section 1 (2) of this 2013 Act by the State Board of Parole
17 and Post-Prison Supervision or the Psychiatric Security Review Board.

18 (2) A person who is a sexually violent dangerous offender under ORS 137.765:

19 (a) Must be classified as a level three sex offender under section 1 (3) of this 2013 Act;
20 and

21 (b) Is not eligible for relief from the obligation to report as a sex offender or reclassi-
22 fication as a level two sex offender under section 1 (2) of this 2013 Act, pursuant to a petition
23 filed under section 5 of this 2013 Act.

24 (3) A person who has been convicted or found guilty except for insanity of one of the
25 following offenses is not eligible for relief from the obligation to report as a sex offender
26 pursuant to a petition filed under section 5 (1) of this 2013 Act:

27 (a) Rape in the first degree;

28 (b) Sodomy in the first degree;

29 (c) Unlawful sexual penetration in the first degree;

30 (d) Kidnapping in the first degree as described in ORS 163.235 (1)(e) or when the victim
31 is under 18 years of age; or

32 (e) Burglary in the first degree when committed with the intent to commit any of the
33 offenses listed in ORS 181.594 (5)(a) to (r) or (u).

35 **RECLASSIFICATION AND RELIEF HEARINGS**

36
37 **SECTION 5.** (1)(a) A person who is required to report as a sex offender under ORS
38 181.595, 181.596 or 181.597 due to a conviction for a sex crime and is classified as a level one
39 sex offender under section 1 (1) of this 2013 Act may petition the State Board of Parole and
40 Post-Prison Supervision to relieve the person from the obligation to report as a sex offender
41 under ORS 181.595, 181.596 or 181.597.

42 (b) A person who is required to report as a sex offender under ORS 181.595, 181.596 or
43 181.597 due to being found guilty except for insanity under ORS 161.295 for a sex crime, and
44 is classified as a level one sex offender under section 1 (1) of this 2013 Act, may petition the
45 Psychiatric Security Review Board to relieve the person from the obligation to report as a

1 sex offender under ORS 181.595, 181.596 or 181.597.

2 (c)(A) Except as otherwise provided in subparagraph (B) of this paragraph, a person de-
3 scribed in paragraph (a) or (b) of this subsection may file the petition no sooner than five
4 years after the date supervision for the sex crime is terminated or, if the person was not
5 subject to supervision for the sex crime, five years after the date the person was discharged
6 from the jurisdiction of the court, Psychiatric Security Review Board or Oregon Health Au-
7 thority.

8 (B) A person who was reclassified under subsection (2) of this section from a level two
9 sex offender under section 1 (2) of this 2013 Act to a level one sex offender under section 1
10 (1) of this 2013 Act may file the petition no sooner than five years after the date of reclas-
11 sification.

12 (d) Notwithstanding paragraph (c) of this subsection, if a person is required to report
13 because of a conviction or finding of guilty except for insanity from another United States
14 court as that term is defined in ORS 181.594, the person may not petition for relief from re-
15 porting as a sex offender in Oregon unless the laws of the jurisdiction where the person was
16 convicted or found guilty except for insanity would permit a petition for relief from reporting
17 as a sex offender.

18 (2)(a) A person who is required to report as a sex offender under ORS 181.595, 181.596 or
19 181.597 due to a conviction for a sex crime and is classified as a level three sex offender un-
20 der section 1 (3) of this 2013 Act may petition the State Board of Parole and Post-Prison
21 Supervision to reclassify the person as a level two sex offender under section 1 (2) of this
22 2013 Act.

23 (b) A person who is required to report as a sex offender under ORS 181.595, 181.596 or
24 181.597 due to being found guilty except for insanity under ORS 161.295 for a sex crime, and
25 is classified as a level three sex offender under section 1 (3) of this 2013 Act, may petition
26 the Psychiatric Security Review Board to reclassify the person as a level two sex offender
27 under section 1 (2) of this 2013 Act.

28 (c) A person who is required to report as a sex offender under ORS 181.595, 181.596 or
29 181.597 due to a conviction for a sex crime and is classified as a level two sex offender under
30 section 1 (2) of this 2013 Act may petition the State Board of Parole and Post-Prison Super-
31 vision to reclassify the person as a level one sex offender under section 1 (1) of this 2013 Act.

32 (d) A person who is required to report as a sex offender under ORS 181.595, 181.596 or
33 181.597 due to being found guilty except for insanity under ORS 161.295 for a sex crime, and
34 is classified as a level two sex offender under section 1 (2) of this 2013 Act, may petition the
35 Psychiatric Security Review Board to reclassify the person as a level one sex offender under
36 section 1 (1) of this 2013 Act.

37 (e) The petition described in this subsection may be filed no sooner than 10 years after
38 the date supervision for the sex crime is terminated or, if the person was not subject to
39 supervision for the sex crime, 10 years after the date the person was discharged from the
40 jurisdiction of the court, Psychiatric Security Review Board or Oregon Health Authority.

41 (3)(a) The State Board of Parole and Post-Prison Supervision or the Psychiatric Security
42 Review Board shall deny a petition filed under this section if, at any time after the person
43 is convicted or found guilty except for insanity of a sex crime, the person is convicted of or
44 found guilty except for insanity of a person felony or a person Class A misdemeanor, as those
45 terms are defined in the rules of the Oregon Criminal Justice Commission.

1 **(b) The appropriate board shall deny a petition filed under subsection (2)(c) or (d) of this**
2 **section if the board has previously reclassified the person as a level two sex offender under**
3 **section 1 (2) of this 2013 Act as the result of a petition filed under subsection (2)(a) or (b)**
4 **of this section.**

5 **(4)(a) Except as otherwise provided in subsection (3) of this section, if a person files a**
6 **petition under subsection (1) of this section, the State Board of Parole and Post-Prison**
7 **Supervision or the Psychiatric Security Review Board shall hold a hearing. At the hearing,**
8 **the board shall enter an order relieving the person of the obligation to report as a sex**
9 **offender under ORS 181.595, 181.596 or 181.597 if the board determines, by clear and con-**
10 **vincing evidence, that the person:**

11 **(A) Is statistically unlikely to reoffend; and**

12 **(B) Does not pose a threat to the safety of the public.**

13 **(b)(A) Except as otherwise provided in subsection (3) of this section, if a person files a**
14 **petition under subsection (2)(a) or (b) of this section, the State Board of Parole and Post-**
15 **Prison Supervision or the Psychiatric Security Review Board shall hold a hearing. At the**
16 **hearing, the board shall enter an order reclassifying the person as a level two sex offender**
17 **under section 1 (2) of this 2013 Act if, after completion of a new risk assessment utilizing the**
18 **risk assessment tool described in section 1 of this 2013 Act, the person is classified as pre-**
19 **senting a low or moderate risk of reoffending and the board determines that a lower level**
20 **of notification is sufficient to protect public safety.**

21 **(B) Except as otherwise provided in subsection (3) of this section, if a person files a pe-**
22 **tition under subsection (2)(c) or (d) of this section, the State Board of Parole and Post-Prison**
23 **Supervision or the Psychiatric Security Review Board shall hold a hearing. At the hearing,**
24 **the board shall enter an order reclassifying the person as a level one sex offender under**
25 **section 1 (1) of this 2013 Act if, after completion of a new risk assessment utilizing the risk**
26 **assessment tool described in section 1 of this 2013 Act, the person is classified as presenting**
27 **a low risk of reoffending and the board determines that a lower level of notification is suffi-**
28 **cient to protect public safety.**

29 **(5) In making the determinations described in subsection (4) of this section, the State**
30 **Board of Parole and Post-Prison Supervision or the Psychiatric Security Review Board shall**
31 **consider:**

32 **(a) The nature of and degree of violence involved in the offense that requires reporting;**

33 **(b) The age and number of victims of the offense that requires reporting;**

34 **(c) The age of the person at the time of the offense that requires reporting;**

35 **(d) The length of time since the offense that requires reporting and the time period**
36 **during which the person has not reoffended;**

37 **(e) The person's performance on supervision for the offense that requires reporting;**

38 **(f) Whether the person has participated in or successfully completed a court-approved**
39 **sex offender treatment program or any other rehabilitative programs;**

40 **(g) The person's stability in employment and housing;**

41 **(h) The person's community and personal support system;**

42 **(i) Other criminal and relevant noncriminal behavior of the person both before and after**
43 **the offense that requires reporting; and**

44 **(j) Any other relevant factors.**

45 **(6)(a) The Attorney General may represent the state at a hearing conducted under this**

1 section unless the district attorney of the county in which the person was convicted or, if
2 the conviction for which the person is required to report as a sex offender was entered in
3 another United States court, the district attorney of the county in which the person resides,
4 elects to represent the state.

5 (b) If a district attorney elects to represent the state, the district attorney shall give
6 timely written notice of the election to the Attorney General, the State Board of Parole and
7 Post-Prison Supervision or the Psychiatric Security Review Board and the person who is the
8 subject of the hearing.

9 (c) If the district attorney declines to represent the state, the district attorney shall co-
10 operate with the Attorney General in securing the material necessary to represent the state.

11 (7)(a) When the State Board of Parole and Post-Prison Supervision or the Psychiatric
12 Security Review Board enters an order under this section relieving a person of the obligation
13 to report as a sex offender under ORS 181.595, 181.596 or 181.597 or enters an order reclassi-
14 fying a person as a level two sex offender under section 1 (2) of this 2013 Act or as a level
15 one sex offender under section 1 (1) of this 2013 Act, the board shall forward a copy of the
16 order to the Department of State Police.

17 (b) Upon receipt of an order relieving a person of the obligation to report, the department
18 shall remove from the Law Enforcement Data System the sex offender information obtained
19 from the sex offender registration form submitted under ORS 181.595, 181.596 or 181.597.

20 (c) Upon receipt of an order reclassifying a person as a level two sex offender under
21 section 1 (2) of this 2013 Act or as a level one sex offender under section 1 (1) of this 2013
22 Act, the department shall update the Law Enforcement Data System to reflect the reclassi-
23 fication.

24 (8) The State Board of Parole and Post-Prison Supervision and the Psychiatric Security
25 Review Board shall adopt rules to carry out the provisions of this section. The rules may
26 include a filing fee in an amount determined by the appropriate board.

27 (9) As used in this section, "supervision" means probation, parole, post-prison super-
28 vision or any other form of supervised or conditional release.

30 NOTIFICATION

31
32 **SECTION 6.** (1)(a) A notifying agency or a supervising agency shall release, upon request,
33 any information that may be necessary to protect the public concerning sex offenders who
34 reside in a specific area or concerning a specific sex offender.

35 (b) A notifying agency or a supervising agency may release sex offender information to
36 a law enforcement agency if the notifying agency or supervising agency determines that the
37 release of information is in the public interest.

38 (c) In addition to the release of information described in this subsection and ORS 137.540,
39 144.260 and 441.373, a notifying agency or a supervising agency may release sex offender in-
40 formation to the public in accordance with subsections (2) to (4) of this section.

41 (2) If the sex offender is classified as a level three sex offender under section 1 (3) of this
42 2013 Act:

43 (a) The Department of State Police shall release sex offender information on a website
44 maintained by the department; and

45 (b) The supervising agency or a notifying agency may release sex offender information

1 to:

2 (A) A person that resides with the sex offender;

3 (B) A person with whom the sex offender has a significant relationship;

4 (C) Residential neighbors and churches, community parks, schools and child care centers,
5 convenience stores, businesses and other places that children or other potential victims may
6 frequent;

7 (D) A long term care facility, as defined in ORS 442.015, or a residential care facility, as
8 defined in ORS 443.400, if the agency knows that the sex offender is seeking admission to the
9 facility; and

10 (E) Local or regional media sources.

11 (3) If the sex offender is classified as a level two sex offender under section 1 (2) of this
12 2013 Act, the supervising agency or a notifying agency may release sex offender information
13 to the persons or entities described in subsection (2)(b)(A) to (D) of this section.

14 (4) If the sex offender is classified as a level one sex offender under section 1 (1) of this
15 2013 Act, the supervising agency or a notifying agency may release sex offender information
16 to a person described in subsection (2)(b)(A) of this section.

17 (5) As used in this section:

18 (a) "Notifying agency" means the Department of State Police, a city police department,
19 a county sheriff's office or a police department established by a university under ORS
20 352.383.

21 (b) "Sex offender information" means information that the Department of State Police
22 determines by rule is appropriate for release to the public.

23 (c) "Supervising agency" means a governmental entity responsible for supervising a per-
24 son required to report as a sex offender under ORS 181.595 or 181.596.

25
26 **CURRENT SEX OFFENDER REGISTRANTS**

27
28 **SECTION 7. (1) As used in this section:**

29 (a) "Event triggering the obligation to make an initial report" has the meaning given that
30 term in section 3 of this 2013 Act.

31 (b) "Existing registrant" means a person for whom the event triggering the obligation
32 to make an initial report under ORS 181.595 (3)(a)(A), 181.596 (4)(a)(A), 181.597 (1)(a)(A),
33 (2)(a)(A) or (3)(a)(A) occurs before January 1, 2014.

34 (2)(a) No later than December 1, 2016, the State Board of Parole and Post-Prison Super-
35 vision or the Psychiatric Security Review Board, as appropriate, shall classify existing reg-
36 istrants in one of the levels described in section 1 of this 2013 Act. No later than February
37 1, 2017, the Department of State Police shall enter the results of the classifications described
38 in this section into the Law Enforcement Data System.

39 (b) The board shall classify an existing registrant as a level three sex offender under
40 section 1 (3) of this 2013 Act, if:

41 (A) The person was previously designated a predatory sex offender and the designation
42 was made after the person was afforded notice and an opportunity to be heard as to all fac-
43 tual questions at a meaningful time and in a meaningful manner; or

44 (B) The person is a sexually violent dangerous offender under ORS 137.765.

45 (3) As soon as practicable following the classification of an existing registrant under this

1 section, the board shall notify the person of the classification by certified mail.

2 (4) If, for any reason, the board does not classify an existing registrant under subsection
3 (2) of this section, the person is, by operation of law, classified as a level three sex offender
4 under section 1 (3) of this 2013 Act on January 1, 2017.

5 (5)(a) An existing registrant who seeks review of a classification made under this section
6 may petition the board for review. The petition may be filed no later than:

7 (A) Sixty days after the board provides the notice described in subsection (3) of this
8 section; or

9 (B) Sixty days after the person receives actual notice of the classification, if the person
10 is classified under subsection (4) of this section.

11 (b) Upon receipt of a petition described in this subsection, the board shall afford the
12 person an opportunity to be heard as to all factual questions related to the classification.

13 (c) After providing the person with notice and an opportunity to be heard in accordance
14 with this subsection, the board shall classify the person in accordance with the classifica-
15 tions described in section 1 of this 2013 Act, based on all of the information available to the
16 board.

17 (6) The board shall adopt rules to carry out the provisions of this section.

19 **NOTIFICATION FOR SEX OFFENDERS ADJUDICATED IN**
20 **JUVENILE COURT**

21
22 **SECTION 8.** ORS 181.592 is amended to read:

23 181.592. [(1) *The Department of State Police shall enter into the Law Enforcement Data System the*
24 *sex offender information obtained from the sex offender registration forms submitted under ORS*
25 *181.595, 181.596, 181.597 and 181.609. The department shall remove from the Law Enforcement Data*
26 *System the sex offender information obtained from the sex offender registration form submitted under*
27 *ORS 181.595, 181.596, 181.597 or 181.609 if the conviction or adjudication that gave rise to the regis-*
28 *tration obligation is reversed or vacated or if the registrant is pardoned.]*

29 [(2)(a) *When a person is under supervision for the first time as a result of a conviction for an of-*
30 *fense requiring reporting as a sex offender, the Department of State Police, a city police department*
31 *or a county sheriff's office shall release, upon request, only the following information about the sex*
32 *offender:]*

33 [(A) *The sex offender's name and date of birth;]*

34 [(B) *A physical description of the sex offender and a photograph, if applicable;]*

35 [(C) *The name and zip code of the city where the sex offender resides;]*

36 [(D) *The name and telephone number of a contact person at the agency that is supervising the sex*
37 *offender; and]*

38 [(E) *The name of institutions of higher education that the sex offender attends or at which the sex*
39 *offender works or carries on a vocation.]*

40 [(b)] (1)(a) [Notwithstanding paragraph (a) of this subsection, if the] **Except as otherwise pro-**
41 **vided in ORS 181.586 or this section, when a sex offender is under the supervision of the Oregon**
42 **Youth Authority or a county juvenile department for the first time as a result of committing**
43 **an act that if committed by an adult would constitute a sex crime, the Department of State**
44 **Police, city police department or county sheriff's office shall release, upon request, only:**

45 (A) The sex offender's name and year of birth;

1 (B) The name and zip code of the city where the sex offender resides;

2 (C) The name and telephone number of a contact person at the agency that is supervising the
3 sex offender; and

4 (D) The name of institutions of higher education that the sex offender attends or at which the
5 sex offender works or carries on a vocation.

6 [(c)] (b) [An agency that supervises a sex offender] **Notwithstanding paragraph (a) of this**
7 **section, the Oregon Youth Authority or a county juvenile department** shall release, upon re-
8 quest, any information that may be necessary to protect the public concerning [the] a sex offender
9 **under the supervision of the authority or department.**

10 [(3)] (2) Except as otherwise limited by subsection [(2)(a) and (b)] (1)(a) of this section regarding
11 persons who are under supervision for the first time as sex offenders, the Department of State Po-
12 lice, a city police department or a county sheriff's office shall release, upon request, any information
13 that may be necessary to protect the public concerning sex offenders **required to report under**
14 **ORS 181.609** who reside in a specific area or concerning a specific sex offender **required to report**
15 **under ORS 181.609.** However, the entity releasing the information may not release the identity of
16 a victim of a sex crime.

17 [(4)(a)] (3)(a) The Department of State Police may make the information described in subsections
18 [(2) and (3)] (1) and (2) of this section available to the public, without the need for a request, by
19 electronic or other means. The Department of State Police shall make information about a person
