SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Allows Chief Justice of Supreme Court to adopt rules governing use of electronic applications for all state court records.

Removes requirement that state courts maintain separate probate index.

Allows State Court Administrator to establish procedures for destruction of all state court records, not just circuit court records.

Modifies laws on filing of transcript on appeal to allow electronic filing of transcript.

Reduces from \$60 to ~~[\$44]~~ **\$45** amount paid by justice and municipal courts to Criminal Fine Account from fines. Modifies priority for application of partial payments on fines in justice and municipal courts. Provides that last \$16 collected from fine in justice or municipal court be paid to county and used for drug and alcohol programs, county juvenile and adult corrections programs and facilities and security in certain court facilities.

Provides that certain appellate motion fees may not be collected from state, county, city or school district.

Increases certain filing fees, fees for writs of garnishment, marriage solemnization fees and prevailing party fees.

Establishes State Court Technology Fund and continuously appropriates moneys in fund to Judicial Department for purposes of state court electronic applications, services and systems. Directs State Court Administrator to deposit amount of increases in fees paid to court and fees received for use of Oregon Judicial Information Network in fund.

Adjusts biennial limitations on expenditures from fees, moneys or other revenues, including Miscellaneous Receipts and including reimbursements from federal service agreements, but excluding lottery funds and other federal funds, collected or received by Judicial Department for purposes of Act.

Sunsets increases in fees paid to court on July 1, 2014.

Declares emergency, effective on passage.

11 **SECTION 1.** ORS 1.002 is amended to read:

12 1.002. (1) The Supreme Court is the highest judicial tribunal of the judicial department of gov-
13 ernment in this state. The Chief Justice of the Supreme Court is the presiding judge of the court

1 and the administrative head of the judicial department of government in this state. The Chief Justice
2 shall exercise administrative authority and supervision over the courts of this state consistent with
3 applicable provisions of law and the Oregon Rules of Civil Procedure. The Chief Justice, to facilitate
4 exercise of that administrative authority and supervision, may:

5 (a) Make rules and issue orders appropriate to that exercise.

6 (b) Require appropriate reports from the judges, other officers and employees of the courts of
7 this state and municipal courts.

8 (c) Pursuant to policies approved by the Judicial Conference of the State of Oregon, assign or
9 reassign on a temporary basis all judges of the courts of this state to serve in designated locations
10 within or without the county or judicial district for which the judge was elected.

11 (d) Set staffing levels for all courts of the state operating under the Judicial Department and for
12 all operations in the Judicial Department.

13 (e) Establish time standards for disposition of cases.

14 (f) Establish budgets for the Judicial Department and all courts operating under the Judicial
15 Department.

16 (g) Assign or reassign all court staff of courts operating under the Judicial Department.

17 (h) Pursuant to policies approved by the Judicial Conference of the State of Oregon, establish
18 personnel rules and policies for judges of courts operating under the Judicial Department.

19 (i) Establish procedures for closing courts in emergencies.

20 (j) Establish standards for determining when courts are closed for purposes of ORCP 10, ORS
21 174.120 and other rules and laws that refer to periods of time when courts are closed.

22 (k) Take any other action appropriate to the exercise of the powers specified in this section and
23 other law, and appropriate to the exercise of administrative authority and supervision by the Chief
24 Justice over the courts of this state.

25 (2) The Chief Justice may make rules for the use of electronic applications in the courts, in-
26 cluding but not limited to rules relating to **any of the following**:

27 (a) Applications based on the use of the Internet and other similar technologies[;].

28 (b) The use of an electronic document, or use of an electronic image of a paper document in lieu
29 of the original paper copy, for [a] **any record of the courts maintained under ORS 7.095 and for**
30 **any** document, process or paper that is served, delivered, received, filed, entered or retained in any
31 action or proceeding[;].

32 (c) The use of electronic signatures or another form of identification for any document, process
33 or paper that is [served, delivered, received, filed, entered or retained in any action or proceeding and
34 that is] required by any law or rule to be signed[;] **and that is:**

35 **(A) Served, delivered, received, filed, entered or retained in any action or proceeding; or**

36 **(B) Maintained under ORS 7.095.**

37 (d) The use of electronic transmission for:

38 **(A) [The service of] Serving** documents in [a] **an action or** proceeding, other than [service of]
39 a summons or [service of] an initial complaint or petition;

40 **(B) Filing documents with a court; and**

41 **(C) Providing certified electronic copies of court documents and other Judicial Depart-**
42 **ment records to another person or public body.**

43 (e) Payment of statutory or court-ordered monetary obligations through electronic media[;].

44 (f) Electronic storage of court documents[;].

45 (g) Use of electronic citations in lieu of the paper citation forms as allowed under ORS 153.770,

1 including use of electronic citations for parking ordinance violations that are subject to ORS 221.333
2 or 810.425[;].

3 (h) Public access through electronic means to court documents that are required or authorized
4 to be made available to the public by law[; and].

5 (i) Transmission of open court proceedings through electronic media.

6 (3) The Chief Justice may make rules relating to the data that state courts may require parties
7 and other persons to submit for the purpose of distinguishing particular persons from other persons.
8 If the rules require the submission of data that state or federal law does not require that the courts
9 make public, the rules may also require courts to keep the data confidential and not release the data
10 except pursuant to a court order issued for good cause shown. Data that is made confidential under
11 the rules is not subject to disclosure under ORS 192.410 to 192.505.

12 (4) Rules adopted by the Chief Justice under subsection (2) of this section must be consistent
13 with the laws governing courts and court procedures, but any person who serves, delivers, receives,
14 files, enters or retains an electronic document, or an electronic image of a paper document in lieu
15 of the original paper copy, in the manner provided by a rule of the Chief Justice under subsection
16 (2) of this section shall be considered to have complied with any rule or law governing service, de-
17 livery, reception, filing, entry or retention of a paper document.

18 (5) Rules made and orders issued by the Chief Justice under this section shall permit as much
19 variation and flexibility in the administration of the courts of this state as are appropriate to the
20 most efficient manner of administering each court, considering the particular needs and circum-
21 stances of the court, and consistent with the sound and efficient administration of the judicial de-
22 partment of government in this state.

23 (6) The Chief Justice may establish fees for the use of the Oregon Judicial Information Network.

24 (7) The judges, other officers and employees of the courts of this state shall comply with rules
25 made and orders issued by the Chief Justice. Rules and orders of a court of this state, or a judge
26 thereof, relating to the conduct of the business of the court shall be consistent with applicable rules
27 made and orders issued by the Chief Justice.

28 (8) The Chief Judge of the Court of Appeals and the presiding judge of each judicial district of
29 this state are the administrative heads of their respective courts. They are responsible and ac-
30 countable to the Chief Justice of the Supreme Court in the exercise of their administrative authority
31 and supervision over their respective courts. Other judges of the Court of Appeals or court under
32 a presiding judge are responsible and accountable to the Chief Judge or presiding judge, and to the
33 Chief Justice, in respect to exercise by the Chief Justice, Chief Judge or presiding judge of admin-
34 istrative authority and supervision.

35 (9) The Chief Justice may delegate the exercise of any of the powers specified by this section
36 to the presiding judge of a court, and may delegate the exercise of any of the administrative powers
37 specified by this section to the State Court Administrator, as may be appropriate.

38 (10) This section applies to justices of the peace and the justice courts of this state solely for
39 the purpose of disciplining of justices of the peace and for the purpose of continuing legal education
40 of justices of the peace.

45 7.240. *[The proceedings in probate matters shall be entered and recorded by the clerk or court*

2 (1) For probate matters in state courts, the clerk or court administrator shall enter and
3 record the proceedings in the register described in ORS 7.020.

4 (2) For probate matters in courts other than state courts, the clerk or court adminis-
5 trator shall enter and record the proceedings in the following records:

6 [(1)] (a) A register, in which shall be entered a memorandum of all official business transacted
7 by the court or judge thereof pertaining to the estate of each decedent, under the name of the
8 decedent, and that pertaining to each protective proceeding under ORS chapter 125, under the name

16 **SECTION 3.** ORS 7.124 is amended to read:

17 7.124. (1) Pursuant to ORS 8.125 (11), the State Court Administrator may establish procedures
18 that provide for the destruction of records, instruments, books, papers, transcripts and other docu-
19 ments filed in a [circuit] state court after making a photographic film, microphotographic film,
20 electronic image or other photographic or electronic copy of each document that is destroyed.

21 (2) A [circuit] state court may use procedures established under subsection (1) of this section
22 only if at the time of making the copy of the document or group of documents, the [trial] court
23 administrator [for the court] attaches to the copy, attaches to the sealed container in which the copy
24 is placed or incorporates or causes to be incorporated into the copy:

25 (a) A [certification] statement that the copy is a correct copy of the original, or of a specified
26 part of the original document or group of documents; and

27 (b) The date on which the copy of the document or group of documents was made; and].

28 [(c) A certification that the copy was made under the trial court administrator's direction and
29 control.]

30 (3) A [trial] court administrator using film for copies under this section must promptly seal and
31 store at least one original or negative copy of the film in a manner and place that will ensure that
32 the film will not be lost, stolen or destroyed.

33 (4) A [trial] court administrator using electronic images for copies under procedures established
34 under subsection (1) of this section must ensure that the electronic images are continuously updated
35 into commonly used formats and, if necessary, transferred to media necessary to ensure that [they]
36 the electronic images are accessible through commonly used electronic or computerized systems.

37 (5) [Copies of documents] If a copy of a document created under this section [must be] is re-
38 tained in lieu of the original [documents] document, the copy is the official court record for all

44 **SECTION 4.** ORS 19.250 is amended to read:

45 19.250. (1) The notice of appeal [shall] must contain the following:

1 (a) The title of the cause. The party appealing a judgment *[shall]* **must** be designated the
2 appellant and the adverse party the respondent, but the title of the action or proceeding is not
3 otherwise changed by reason of the appeal.

4 (b) The names of the parties and their attorneys.

5 *[(c) A notice to all parties or their attorneys as have appeared in the action or proceedings that*
6 *an appeal is taken from the judgment or some specified part thereof and designating who are the ad-*
7 *verse parties to the appeal.]*

8 **(c)(A) If an appellant is not represented by an attorney, a postal address for the appellant**
9 **and either an electronic mail address for the appellant or a statement that the appellant does**
10 **not have an electronic mail address.**

11 **(B) If the appellant is represented by an attorney, a postal address and electronic mail**
12 **address for the attorney.**

13 **(d) A notice to each party that appeared in the action or proceeding, or to the attorney**
14 **for the party, that an appeal is taken from the judgment or some specified part of the judg-**
15 **ment and designating the adverse parties to the appeal. The notice of appeal must contain**
16 **the postal address and electronic mail address, if known to the appellant, for all other parties**
17 **designated as parties to the appeal.**

18 *[(d)]* **(e) A designation of those portions of the proceedings and exhibits to be included in the**
19 **record in addition to the trial court file. The appellant may amend the designation of record at any**
20 **time after filing the notice of appeal until 35 days after the *[transcript is filed]* filing of a certificate**
21 **of preparation for the transcript under ORS 19.370 (3). The amendment must be made** by fil-
22 **ing and serving in the same manner as a notice of appeal a notice of amended designation of record.**
23 **The amended *[notice shall]* designation must** clearly indicate those portions of the proceedings and
24 **exhibits being added to or deleted from the original designation of record. The designation may not**
25 **be later amended by the appellant unless the appellate court so orders.**

26 *[(e)]* **(f) A plain and concise statement of the points on which the appellant intends to rely. On**
27 **appeal, the appellant may rely on no other points than those set forth in such statement. If the**
28 **appellant has designated for inclusion in the record all the testimony and all the instructions given**
29 **and requested, no statement of points is necessary. Not later than the 15th day following the filing**
30 **of the certificate of preparation for the transcript under ORS 19.370 (3), the appellant may serve**
31 **and file an amended statement of points. Except by approval of the court, the appellant may then**
32 **rely on no other points than those set forth in such amended statement.**

33 *[(f)]* **(g) The signature of the appellant or attorney for the appellant.**

34 **(2) Within 14 days after the filing of the notice of appeal or *[notice of]* amended designation of**
35 **record, any other party may serve and file a designation of additional parts of the proceedings and**
36 **exhibits to be included in the record. Such designation *[shall]* must** be served and filed as provided
37 **for the serving and filing of a notice of appeal under ORS 19.240 and 19.260. If such party also ap-**
38 **peals, the designation *[shall]* must** be included in the notice of appeal of the party and *[shall]* **may**
39 **not be served and filed separately.**

40 *[(3) The reporter shall prepare a transcript of such parts of the proceedings as are designated*
41 *pursuant to subsection (1)(d) of this section and subsection (2) of this section.]*

43 19.365. (1) The record of the case *[shall]* **must** be prepared and transmitted to the court to which
44 the appeal is made in the manner provided in this chapter.

45 (2) The record on appeal *[shall consist]* **consists** of those parts of the trial court file, exhibits

1 and record of oral proceedings in the trial court that are designated under ORS 19.250. The record
2 of oral proceedings *[shall be]* is the transcript prepared under ORS 19.370, an agreed narrative
3 statement prepared under ORS 19.380 or the audio record if the appellate court has waived prepa-
4 ration of a transcript under ORS 19.385.

5 (3) *[The trial court administrator shall, upon request of the State Court Administrator, deliver the*
6 *record of the case to the appellate court.]* **The trial court administrator shall make the trial court**
7 **record available to the State Court Administrator in the manner specified by rules of the**
8 **appellate court.**

9 (4) When it appears to the appellate court that the record on appeal is erroneous or that the
10 record does not contain material that should have been part of the trial court file, and the erroneous
11 or incomplete record substantially affects the merits of the appeal, on motion of a party or on its
12 own motion the **appellate** court may make such order to correct or supplement the record as may
13 be just.

14 (5) If the record on appeal is not sufficient to allow the appellate court to review an assignment
15 of error, the **appellate** court may decline to review the assignment of error and may dismiss the
16 appeal if there are no other assignments of error that may be reviewed.

17 (6) *[Unless otherwise ordered by the appellate court,]* **Except as provided by rules of the ap-**
18 **pellate court,** the State Court Administrator shall return the trial court file and the exhibits to the
19 trial court administrator upon issuance of the appellate judgment disposing of the appeal.

20 **SECTION 6.** ORS 19.370, as amended by section 7, chapter 48, Oregon Laws 2012, is amended
21 to read:

22 19.370. *[(1) If a transcript is prepared from audio records by a person other than the reporter, then*
23 *the reporter shall certify the audio records and the transcript shall be certified by the person preparing*
24 *it. In all other cases the transcript shall be certified by the reporter or the trial judge.]*

25 *[(2) Except as provided in subsection (3) of this section, the person preparing the transcript shall*
26 *file the transcript with the trial court administrator within 30 days after the filing of the notice of ap-*
27 *peal. The person preparing the transcript shall give immediate notice in writing to the parties that the*
28 *transcript has been filed. Except as provided in subsection (4) of this section, the person preparing the*
29 *transcript shall serve the respondent with a copy of the transcript and shall, at the time of filing the*
30 *original transcript, file proof of such service with the trial court administrator, and with the State*
31 *Court Administrator.]*

32 *[(3) If an appeal is referred to the appellate settlement program established by the Court of Appeals*
33 *pursuant to ORS 2.560, the transcript must be filed within 30 days after expiration of the period of time*
34 *specified in the rules during which the appeal is held in abeyance, or within 30 days after the court*
35 *directs that the appeal no longer be held in abeyance, whichever occurs first.]*

36 *[(4) If there are two or more parties in addition to the appellant who have appeared in the trial*
37 *court and who are represented by different attorneys, the person preparing the transcript shall at the*
38 *time of filing the original transcript deposit a copy thereof with the trial court administrator for use*
39 *by all such other parties. The person preparing the transcript shall serve notice of such deposit upon*
40 *all such parties and file proof of such service with the trial court administrator and with the State*
41 *Court Administrator.]*

42 *[(5) Except as provided in subsection (6) of this section, within 15 days after the transcript is filed,*
43 *any party may move the trial court for an order to correct any errors appearing in the transcript or,*
44 *where the interests of justice require, to have additional parts of the proceedings included in the tran-*
45 *script. If two or more persons are preparing parts of the transcript, the motion must be filed within*

1 15 days after the last part of the transcript is filed. A copy of any such motion shall be filed with the
2 court to which the appeal is made. The trial court shall direct the making of such corrections and the
3 adding of such matter as may be appropriate and shall fix the time within which such corrections or
4 additions shall be made.]

5 [(6) If an appeal is referred to the appellate settlement program established by the Court of Appeals
6 pursuant to ORS 2.560, and the transcript is filed during any period of time specified in the rules
7 during which the appeal is held in abeyance, a motion under subsection (5) of this section must be filed
8 within 15 days after expiration of the period of time the appeal is held in abeyance, or within 15 days
9 after the court directs that the appeal no longer be held in abeyance, whichever occurs first.]

10 [(7) Upon the denial of a motion to correct or add to the transcript under subsection (5) of this
11 section, or upon the making of such corrections or additions as may be ordered, whichever last occurs,
12 the trial court shall enter an order settling the transcript and send copies thereof to each of the parties
13 or their attorneys and to the State Court Administrator. In the absence of a motion to correct or add
14 to the transcript, the transcript shall be deemed automatically settled 15 days after it is filed.]

15 **(1) If a transcript is prepared from audio records by a person other than the reporter,**
16 **the reporter shall certify the records and the transcriber shall certify the transcript. In all**
17 **other cases, the transcript must be certified by the reporter or the trial judge.**

18 **(2) A transcriber shall prepare a transcript in the format prescribed by the court by the**
19 **later of:**

20 **(a) Thirty days after the filing of the notice of appeal; or**

21 **(b) Thirty days after the expiration of any abeyance of the appeal imposed by reason of**
22 **the referral of the appeal to the appellate settlement program established by the Court of**
23 **Appeals pursuant to ORS 2.560.**

24 **(3) Immediately after preparing a transcript, the transcriber shall:**

25 **(a) Serve a copy of the transcript on the parties to the appeal in the manner required**
26 **by subsection (4) of this section; and**

27 **(b) File a certificate of preparation for the transcript with the State Court Administra-**
28 **tor. The certificate must indicate that the transcript has been served in the manner required**
29 **by subsection (4) of this section. A copy of the certificate must be served on the trial court**
30 **administrator, the transcript coordinator and the parties.**

31 **(4) A transcriber may agree with a party or an attorney on the manner in which a**
32 **transcript will be served. If there is no agreement, a transcriber shall serve a transcript in**
33 **the following manner:**

34 **(a) Subject to paragraph (d) of this subsection, if an appellant is not represented by an**
35 **attorney, the transcriber shall serve an electronic copy of the transcript on the appellant**
36 **at the electronic mail address provided by the appellant unless the appellant specifically re-**
37 **quests that a paper copy of the transcript be mailed to the appellant at the postal address**
38 **indicated in the notice of appeal. If an electronic mail address for the appellant does not**
39 **appear in the notice of appeal, the transcriber shall mail a paper copy of the transcript to**
40 **the appellant at the postal address indicated in the notice of appeal.**

41 **(b) Subject to paragraph (d) of this subsection, if a respondent is not represented by an**
42 **attorney, the transcriber shall mail a paper copy of the transcript to the respondent at the**
43 **postal address indicated in the notice of appeal unless the respondent specifically requests**
44 **that the transcriber serve an electronic copy of the transcript on the respondent at the**
45 **electronic mail address provided by the respondent.**

1 (c) If a party is represented by an attorney, the transcriber shall serve an electronic copy
2 of the transcript on the attorney at the electronic mail address of the attorney identified in
3 the notice of appeal.

4 (d) If two or more unrepresented appellants request paper copies of a transcript under
5 paragraph (a) of this subsection, or two or more unrepresented respondents request paper
6 copies of a transcript under paragraph (b) of this subsection, the transcriber shall deposit a
7 copy of the transcript with the trial court administrator for the use of the unrepresented
8 parties. The copy must be in the medium specified by the trial court administrator. The
9 transcriber shall serve notice on the unrepresented parties that the transcript has been de-
10 posited with the trial court administrator, and file proof of that service with the trial court
11 administrator and with the State Court Administrator. Deposit of a copy of a transcript with
12 the trial court administrator under this paragraph constitutes service of the transcript on
13 the unrepresented parties to the appeal.

14 (5) If two or more transcribers are preparing parts of the transcript, the certificate of
15 preparation is considered filed under subsection (3) of this section when the final certificate
16 of preparation is filed with the State Court Administrator.

17 (6)(a) Within 15 days after a certificate of preparation is filed under subsection (3) of this
18 section, any party may file a motion with the trial court for correction of errors appearing
19 in the transcript or to have additional parts of the proceedings included in the transcript.
20 If a certificate of preparation is filed with the State Court Administrator during any period
21 that the appeal is in abeyance by reason of the referral of the appeal to the appellate
22 settlement program established by the Court of Appeals pursuant to ORS 2.560, a motion
23 under this subsection must be filed within 15 days after the expiration of the abeyance.

24 (b) A copy of a motion to correct or add to the transcript made under this subsection
25 must be served on the State Court Administrator. If the motion is denied, the trial court
26 shall enter an order settling the transcript and transmit a copy of the order to the State
27 Court Administrator.

28 (c) If a motion is granted under this subsection, the trial court shall direct the making
29 of such corrections and the adding of such matter as may be appropriate and shall fix the
30 time within which such corrections or additions must be made. Immediately after preparing
31 the corrected or additional transcript, the transcriber shall serve a copy of the transcript
32 on the parties in the manner required by subsection (4) of this section, and file proof of that
33 service with the trial court administrator, the transcript coordinator and the State Court
34 Administrator. Upon receiving proof of service from all transcribers of the proceedings, the
35 State Court Administrator shall issue a notice to the parties indicating that the transcript
36 has been settled.

37 (7) Unless a motion to correct or add to the transcript is made under subsection (6) of
38 this section, a transcript is automatically settled 15 days after a certificate of preparation
39 is filed under subsection (3) of this section. If a motion to correct or add to the transcript
40 is made, the transcript is settled on the date that the State Court Administrator issues the
41 notice to the parties under subsection (6) of this section.

42 (8) When a transcript is settled, the State Court Administrator shall notify each
43 transcriber who filed a certificate of preparation. Upon receiving the notice, a transcriber
44 shall file an electronic copy of the transcript with the State Court Administrator in the
45 manner and format prescribed by rules of the appellate court.

21.345. (1)(a) A [reporter appointed under ORS 8.340 (2)] **transcriber** may not charge more than [\$2.50] **\$3** per page for [the original transcript, or more than 25 cents per page for each additional copy, for preparing transcripts on appeal as provided in ORS 8.350] **preparation of a transcript.**

(b) A transcriber may not charge a fee in addition to the fee established under this subsection for:

(A) An electronic copy required to be served on a party;

(B) A paper copy required to be served on an unrepresented party under ORS 19.370 (4)(a) or (b); or

(C) A paper copy required to be filed with the trial court under ORS 19.370 (4)(d).

(2) Except as provided in subsection (3) of this section, a reporter employed by one of the parties may charge fees as agreed to between the reporter and all of the parties to the proceeding for preparing transcripts on appeal [as provided in ORS 8.350]. The reporter and the parties [shall] **must** agree to the fees to be charged [prior to] **before** the commencement of the proceeding to be recorded. **A share of** any fees agreed upon shall be charged to parties joining the proceeding after the commencement of the proceeding [for preparing transcripts on appeal as provided in ORS 8.350].

(3) A reporter employed by one of the parties may not charge a public body, as defined by ORS 174.109, fees for preparing transcripts on appeal [as provided in ORS 8.350] that exceed the fees established by subsection (1) of this section.

(2) Moneys recovered under subsection (1)(a) of this section shall not be considered moneys paid on and to be credited against the original judgment or debt sought to be enforced. No additional judgment is necessary to recover moneys in the manner provided in subsection (1)(a) of this section.

(3) The only moneys a plaintiff may recover under subsection (1)(a) of this section are those described in subsection (4) of this section that the plaintiff has paid to enforce the existing specific judgment or debt that the specific garnishment or attachment was issued to enforce or upon which the payment was received. Moneys recoverable under subsection (1)(a) of this section remain recoverable and, except as provided under subsection (8) of this section, may be recovered from moneys received by the plaintiff under subsequent garnishments, attachments or payments on the same specific judgment or debt.
