

House Bill 2563

Introduced and printed pursuant to House Rule 12.00. Pre-session filed (at the request of House Interim Committee on Judiciary for Judicial Department and Oregon Circuit Court Judges Association)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Modifies annual salaries of justices of Supreme Court and judges of Court of Appeals, Oregon Tax Court and circuit courts.

Declares emergency, effective July 1, 2013.

4 **Be It Enacted by the People of the State of Oregon:**

5 **SECTION 1.** ORS 292.406 is amended to read:

6 292.406. (1) The annual salary of the Chief Judge of the Court of Appeals shall be [*\$125,688*]
7 \$_____ for the year beginning July 1, [2009] **2013**, and for each year thereafter.

8 (2) The annual salary of each other judge of the Court of Appeals shall be [*\$122,820*] \$_____
9 for the year beginning July 1, [2009] **2013**, and for each year thereafter.

10 **SECTION 2.** ORS 292.411 is amended to read:

11 292.411. (1) The annual salary of the Chief Justice of the Supreme Court shall be [*\$128,556*]
12 \$_____ for the year beginning July 1, [2009] **2013**, and for each year thereafter.

13 (2) The annual salary of each other [*judge*] **justice** of the Supreme Court shall be [*\$125,688*]
14 \$_____ for the year beginning July 1, [2009] **2013**, and for each year thereafter.

15 **SECTION 3.** ORS 292.416 is amended to read:

16 292.416. The annual salary of each judge of a circuit court shall be [*\$114,468*] \$_____ for the
17 year beginning July 1, [2009] **2013**, and for each year thereafter.

18 **SECTION 4.** ORS 292.426 is amended to read:

19 292.426. The annual salary of the judge of the Oregon Tax Court shall be [*\$118,164*] \$_____
20 for the year beginning July 1, [2009] **2013**, and for each year thereafter.

21 **SECTION 5.** **This 2013 Act being necessary for the immediate preservation of the public**
22 **peace, health and safety, an emergency is declared to exist, and this 2013 Act takes effect**
