

House Bill 2594

Introduced and printed pursuant to House Rule 12.00. Pre-session filed (at the request of House Interim Committee on Judiciary)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Modifies standard for court commitment of person with mental illness. Updates terminology.

Be It Enacted by the People of the State of Oregon:

STANDARD FOR CIVIL COMMITMENT OF PERSON WITH MENTAL ILLNESS

SECTION 1. ORS 426.005 is amended to read:

426.005. (1) As used in ORS 426.005 to 426.390, unless the context requires otherwise:

[(a) "Authority" means the Oregon Health Authority.]

[(b) (a) "Community mental health program director" means the director of an entity that provides the services described in ORS 430.630 (3) to (5).]

[(c) (b) "Director of the facility" means a superintendent of a state [mental] hospital, the chief of psychiatric services in a community hospital or the person in charge of treatment and rehabilitation programs at other treatment facilities.]

*[(d) (c) "Facility" means a state [mental] hospital, community hospital, residential facility, detoxification center, day treatment facility or such other facility as the authority determines suitable, any of which may provide] **that provides** diagnosis and evaluation, medical care, detoxification, social services or rehabilitation [for committed mentally ill persons] **to persons committed to the Oregon Health Authority under ORS 426.130.***

[(e) "Mentally ill person" means a person who, because of a mental disorder, is one or more of the following:]

[(A) Dangerous to self or others.]

[(B) Unable to provide for basic personal needs and is not receiving such care as is necessary for

1 *health or safety.]*

2 [(C) A person:]

3 [(i) With a chronic mental illness, as defined in ORS 426.495;]

4 [(ii) Who, within the previous three years, has twice been placed in a hospital or approved inpatient
5 facility by the authority or the Department of Human Services under ORS 426.060;]

6 [(iii) Who is exhibiting symptoms or behavior substantially similar to those that preceded and led
7 to one or more of the hospitalizations or inpatient placements referred to in sub-subparagraph (ii) of
8 this subparagraph; and]

9 [(iv) Who, unless treated, will continue, to a reasonable medical probability, to physically or men-
10 tally deteriorate so that the person will become a person described under either subparagraph (A) or
11 (B) of this paragraph or both.]

12 [(f)] (d) “Nonhospital facility” means any facility, other than a hospital, that is approved by the
13 authority to provide adequate security, psychiatric, nursing and other services to persons under ORS
14 426.232 or 426.233.

15 (e) “Person with mental illness” means a person who, because of a mental disorder:

16 (A) Is dangerous to self or to any other person;

17 (B)(i) Is incapable of making an informed medical decision;

18 (ii) Behaves in a manner that indicates that the person is unlikely, without supervision
19 and the assistance of others, to satisfy the person’s needs for nourishment, personal or
20 medical care, shelter or self-protection and safety; and

21 (iii) Unless treated, will suffer, to a reasonable probability, substantial bodily harm, sig-
22 nificant psychiatric deterioration or debilitation or serious illness; or

23 (C)(i) Is a person with a chronic mental illness, as defined in ORS 426.495;

24 (ii) Has a history of noncompliance with treatment or of criminal acts related to the
25 person’s mental illness; and

26 (iii) Unless treated, will continue, to a reasonable medical probability, to physically or
27 mentally deteriorate so that the person will become a person described under either sub-
28 paragraph (A) or (B) of this paragraph or both.

29 [(g)] (f) “Prehearing period of detention” means a period of time calculated from the initiation
30 of custody during which a person may be detained under ORS 426.228, 426.231, 426.232 or 426.233.

31 (2) Whenever a community mental health program director, director of the facility, superinten-
32 dent of a state hospital or administrator of a facility is referred to, the reference includes any
33 designee such person has designated to act on the person’s behalf in the exercise of duties.

37 **SECTION 2.** ORS 21.010 is amended to read:

38 21.010. (1) Except as provided in this section, the appellant in an appeal or the petitioner in a
39 judicial review in the Supreme Court or the Court of Appeals shall pay a filing fee of \$355 in the
40 manner prescribed by ORS 19.265. The respondent in such case and any other person appearing in
41 the appeal, upon entering first appearance or filing first brief in the court, shall pay to the State
42 Court Administrator a filing fee of \$355. The party entitled to costs and disbursements on such ap-
43 peal shall recover from the opponent the amount so paid.

44 (2) Filing and appearance fees may not be assessed in appeals from habeas corpus proceedings
45 under ORS 34.710, post-conviction relief proceedings under ORS 138.650, juvenile court under ORS

1 419A.200, the involuntary commitment of persons determined to be *[mentally ill]* **persons with**
 2 **mental illness** under ORS 426.135 or persons determined to have an intellectual disability under
 3 ORS 427.295 or orders of the State Board of Parole and Post-Prison Supervision or on judicial review
 4 of orders entered under ORS 161.315 to 161.351 by the Psychiatric Security Review Board or the
 5 Oregon Health Authority.

6 (3) Filing and appearance fees shall be assessed in an appeal from an appeal to a circuit court
 7 from a justice court or municipal court in an action alleging commission of a state offense desig-
 8 nated as a violation or an action alleging violation of a city charter or ordinance, but not in an
 9 action alleging commission of a state crime.

10 (4) Filing and appearance fees shall only be assessed in an appeal in a contempt proceeding
 11 seeking imposition of remedial sanctions under the provisions of ORS 33.055.

12 (5) The filing and appearance fees established by this section apply to cases of original juris-
 13 diction in the Supreme Court.

14 **SECTION 3.** ORS 109.322 is amended to read:

15 109.322. (1) If a parent has been adjudged *[mentally ill or mentally retarded]* **to be a person with**
 16 **mental illness under ORS 426.130 or a person with an intellectual disability who is in need**
 17 **of commitment for residential care, treatment and training under ORS 427.290**, and remains
 18 so at the time of the adoption proceedings, or if a parent is imprisoned in a state or federal prison
 19 under a sentence for a term of not less than three years and has actually served three years, the
 20 petitioner, in accordance with ORS 109.330, shall serve on the parent, if the parent has not con-
 21 sented in writing to the adoption, a summons and a motion and order to show cause why the
 22 adoption of the child should not be ordered without the parent’s consent.

23 (2) In the case of a parent adjudged *[mentally ill or mentally retarded]* **to be a person with**
 24 **mental illness under ORS 426.130 or a person with an intellectual disability who is in need**
 25 **of commitment for residential care, treatment and training under ORS 427.290**, the petitioner
 26 shall also serve the summons and the motion and order to show cause upon the guardian of the
 27 parent. If the parent has no guardian, the court shall appoint a guardian ad litem to appear for the
 28 parent in the adoption proceedings.

29 (3) Upon hearing, if the court finds that the adoption is in the best interests of the child, the
 30 consent of the parent who is imprisoned or adjudged *[mentally ill or mentally retarded]* **to be a**
 31 **person with mental illness or an intellectual disability** is not required, and the court may pro-
 32 ceed regardless of the objection of the parent.

33 (4) This section does not apply when consent is given in loco parentis under ORS 109.316 or
 34 109.318.

35 **SECTION 4.** ORS 135.775 is amended to read:

36 135.775. The Agreement on Detainers is hereby enacted into law and entered into by this state
 37 with all other jurisdictions legally joining therein in the form substantially as follows:
 38

 40 **AGREEMENT ON DETAINERS**

41 The contracting states solemnly agree that:

42 **ARTICLE I**

43 The party states find that charges outstanding against a prisoner, detainers based on untried
 44 indictments, informations or complaints, and difficulties in securing speedy trial of persons already
 45 incarcerated in other jurisdictions, produce uncertainties which obstruct programs of prisoner

1 treatment and rehabilitation. Accordingly, it is the policy of the party states and the purpose of this
 2 agreement to encourage the expeditious and orderly disposition of such charges and determination
 3 of the proper status of any and all detainees based on untried indictments, informations or com-
 4 plaints. The party states also find that proceedings with reference to such charges and detainees,
 5 when emanating from another jurisdiction, cannot properly be had in the absence of cooperative
 6 procedures. It is the further purpose of this agreement to provide such cooperative procedures.

7 ARTICLE II

8 As used in this agreement:

9 (a) "State" shall mean a state of the United States; the United States of America; a territory
 10 or possession of the United States; the District of Columbia; the Commonwealth of Puerto Rico.

11 (b) "Sending state" shall mean a state in which a prisoner is incarcerated at the time that the
 12 prisoner initiates a request for final disposition pursuant to Article III of this agreement or at the
 13 time that a request for custody or availability is initiated pursuant to Article IV of this agreement.

14 (c) "Receiving state" shall mean the state in which trial is to be had on an indictment, infor-
 15 mation or complaint pursuant to Article III or Article IV of this agreement.

16 (d) "Department of Corrections institution" of this state shall mean any institution operated by
 17 the Department of Corrections.

18 ARTICLE III

19 (a) Whenever a person has entered upon a term of imprisonment in a penal or correctional in-
 20 stitution of a party state, and whenever during the continuance of the term of imprisonment there
 21 is pending in any other party state any untried indictment, information or complaint on the basis
 22 of which a detainee has been lodged against the prisoner, the prisoner shall be brought to trial
 23 within 180 days after the prisoner shall have caused to be delivered to the prosecuting officer and
 24 the appropriate court of the prosecuting officer's jurisdiction written notice of the place of
 25 imprisonment and the request of the prisoner for a final disposition to be made of the indictment,
 26 information or complaint: Provided, that for good cause shown in open court, the prisoner or the
 27 counsel of the prisoner being present, the court having jurisdiction of the matter may grant any
 28 necessary or reasonable continuance. The request of the prisoner shall be accompanied by a certif-
 29 icate of the appropriate official having custody of the prisoner, stating the term of commitment un-
 30 der which the prisoner is being held, the time already served, the time remaining to be served on
 31 the sentence, the amount of good time earned, the time of parole eligibility of the prisoner, and any
 32 decisions of the state parole agency relating to the prisoner.

33 (b) The written notice and request for final disposition referred to in paragraph (a) of this Ar-
 34 ticle shall be given or sent by the prisoner to the warden or other official having custody of the
 35 prisoner, who shall promptly forward it together with the certificate to the prosecuting official and
 36 court by registered or certified mail, return receipt requested.

37 (c) The warden or other official having custody of the prisoner shall promptly inform the pris-
 38 oner of the source and contents of any detainee lodged against the prisoner and shall also inform
 39 the prisoner of the right to make a request for final disposition of the indictment, information or
 40 complaint on which the detainee is based.

41 (d) Any request for final disposition made by a prisoner pursuant to paragraph (a) of this Article
 42 shall operate as a request for final disposition of all untried indictments, informations or complaints
 43 on the basis of which detainees have been lodged against the prisoner from the state to whose
 44 prosecuting official the request for final disposition is specifically directed. The warden or other
 45 official having custody of the prisoner shall forthwith notify all appropriate prosecuting officers and

1 courts in the several jurisdictions within the state to which the prisoner's request for final disposi-
 2 tion is being sent of the proceeding being initiated by the prisoner. Any notification sent pursuant
 3 to this paragraph shall be accompanied by copies of the prisoner's written notice, request and the
 4 certificate. If trial is not had on any indictment, information or complaint contemplated hereby prior
 5 to the return of the prisoner to the original place of imprisonment, such indictment, information or
 6 complaint shall not be of any further force or effect, and the court shall enter an order dismissing
 7 the same with prejudice.

8 (e) Any request for final disposition made by a prisoner pursuant to paragraph (a) of this Article
 9 shall also be deemed to be a waiver of extradition with respect to any charge or proceeding con-
 10 templated thereby or included therein by reason of paragraph (d) of this Article, and a waiver of
 11 extradition to the receiving state to serve any sentence there imposed upon the prisoner, after
 12 completion of the term of imprisonment in the sending state. The request for final disposition shall
 13 also constitute a consent by the prisoner to the production of the body of the prisoner in any court
 14 where the presence of the prisoner may be required in order to effectuate the purposes of this
 15 agreement and a further consent voluntarily to be returned to the original place of imprisonment in
 16 accordance with the provisions of this agreement. Nothing in this paragraph shall prevent the im-
 17 position of a concurrent sentence if otherwise permitted by law.

18 (f) Escape from custody by the prisoner subsequent to the execution of the request for final
 19 disposition referred to in paragraph (a) of this Article shall void the request.

20 ARTICLE IV

21 (a) The appropriate officer of the jurisdiction in which an untried indictment, information or
 22 complaint is pending shall be entitled to have a prisoner against whom the officer has lodged a
 23 detainer and who is serving a term of imprisonment in any party state made available in accordance
 24 with paragraph (a) of Article V of this agreement upon presentation of a written request for tem-
 25 porary custody or availability to the appropriate authorities of the state in which the prisoner is
 26 incarcerated: Provided, that the court having jurisdiction of such indictment, information or com-
 27 plaint shall have duly approved, recorded and transmitted the request; And provided further, that
 28 there shall be a period of 30 days after receipt by the appropriate authorities before the request be
 29 honored, within which period the governor of the sending state may disapprove the request for
 30 temporary custody or availability, either upon the own motion of the governor or upon motion of
 31 the prisoner.

32 (b) Upon receipt of the officer's written request as provided in paragraph (a) of this Article, the
 33 appropriate authorities having the prisoner in custody shall furnish the officer with a certificate
 34 stating the term of commitment under which the prisoner is being held, the time already served, the
 35 time remaining to be served on the sentence, the amount of good time earned, the time of parole
 36 eligibility of the prisoner and any decisions of the state parole agency relating to the prisoner. Such
 37 authorities simultaneously shall furnish all other officers and appropriate courts in the receiving
 38 state who have lodged detainers against the prisoner with similar certificates and with notices in-
 39 forming them of the request for custody or availability and of the reasons therefor.

40 (c) In respect of any proceeding made possible by this Article, trial shall be commenced within
 41 120 days of the arrival of the prisoner in the receiving state, but for good cause shown in open
 42 court, the prisoner or the counsel of the prisoner being present, the court having jurisdiction of the
 43 matter may grant any necessary or reasonable continuance.

44 (d) Nothing contained in this Article shall be construed to deprive any prisoner of any right
 45 which the prisoner may have to contest the legality of the delivery of the prisoner as provided in

1 paragraph (a) of this Article, but such delivery may not be opposed or denied on the ground that the
 2 executive authority of the sending state has not affirmatively consented to or ordered such delivery.

3 (e) If trial is not had on any indictment, information or complaint contemplated hereby prior to
 4 the prisoner's being returned to the original place of imprisonment pursuant to paragraph (e) of
 5 Article V of this agreement, such indictment, information or complaint shall not be of any further
 6 force or effect, and the court shall enter an order dismissing the same with prejudice.

7 ARTICLE V

8 (a) In response to a request made under Article III or Article IV of this agreement, the appro-
 9 priate authority in a sending state shall offer to deliver temporary custody of such prisoner to the
 10 appropriate authority in the state where such indictment, information or complaint is pending
 11 against such person in order that speedy and efficient prosecution may be had. If the request for
 12 final disposition is made by the prisoner, the offer of temporary custody shall accompany the written
 13 notice provided for in Article III of this agreement. In the case of a federal prisoner, the appropriate
 14 authority in the receiving state shall be entitled to temporary custody as provided by this agreement
 15 or to the prisoner's presence in federal custody at the place for trial, whichever custodial arrange-
 16 ment may be approved by the custodian.

17 (b) The officer or other representative of a state accepting an offer of temporary custody shall
 18 present the following upon demand:

19 (1) Proper identification and evidence of authority to act for the state into whose temporary
 20 custody the prisoner is to be given.

21 (2) A duly certified copy of the indictment, information or complaint on the basis of which the
 22 detainer has been lodged and on the basis of which the request for temporary custody of the pris-
 23 oner has been made.

24 (c) If the appropriate authority shall refuse or fail to accept temporary custody of such prisoner,
 25 or in the event that an action on the indictment, information or complaint on the basis of which the
 26 detainer has been lodged is not brought to trial within the period provided in Article III or Article
 27 IV of this agreement, the appropriate court of the jurisdiction where the indictment, information or
 28 complaint has been pending shall enter an order dismissing the same with prejudice, and any
 29 detainer based thereon shall cease to be of any force or effect.

30 (d) The temporary custody referred to in this agreement shall be only for the purpose of per-
 31 mitting prosecution on the charge or charges contained in one or more untried indictments, infor-
 32 mations or complaints which form the basis of the detainer or detainers or for prosecution on any
 33 other charge or charges arising out of the same transaction. Except for attendance of the prisoner
 34 at court and while being transported to or from any place at which the presence of the prisoner
 35 may be required, the prisoner shall be held in a suitable jail or other facility regularly used for
 36 persons awaiting prosecution.

37 (e) At the earliest practicable time consonant with the purposes of this agreement, the prisoner
 38 shall be returned to the sending state.

39 (f) During the continuance of temporary custody or while the prisoner is otherwise being made
 40 available for trial as required by this agreement, time being served on the sentence shall continue
 41 to run but good time shall be earned by the prisoner only if, and to the extent that, the law and
 42 practice of the jurisdiction which imposed the sentence may allow.

43 (g) For all purposes other than that for which temporary custody as provided in this agreement
 44 is exercised, the prisoner shall be deemed to remain in the custody of and subject to the jurisdiction
 45 of the sending state and any escape from temporary custody may be dealt with in the same manner

1 as an escape from the original place of imprisonment or in any other manner permitted by law.

2 (h) From the time that a party state receives custody of a prisoner pursuant to this agreement
 3 until such prisoner is returned to the territory and custody of the sending state, the state in which
 4 the one or more untried indictments, informations or complaints are pending or in which trial is
 5 being had shall be responsible for the prisoner and shall also pay all costs of transporting, caring
 6 for, keeping and returning the prisoner. The provisions of this paragraph shall govern unless the
 7 states concerned shall have entered into a supplementary agreement providing for a different allo-
 8 cation of costs and responsibilities as between or among themselves. Nothing contained in this par-
 9 agraph shall be construed to alter or affect any internal relationship among the departments,
 10 agencies and officers of and in the government of a party state, or between a party state and its
 11 subdivisions, as to the payment of costs, or responsibilities therefor.

12 ARTICLE VI

13 (a) In determining the duration and expiration dates of the time periods provided in Articles III
 14 and IV of this agreement, the running of such time periods shall be tolled whenever and for as long
 15 as the prisoner is unable to stand trial, as determined by the court having jurisdiction of the matter.

16 (b) No provision of this agreement, and no remedy made available by this agreement, shall apply
 17 to any person who is adjudged to be [*mentally ill*] **a person with mental illness.**

18 ARTICLE VII

19 Each state party to this agreement shall designate an officer who, acting jointly with like offi-
 20 cers of other party states, shall promulgate rules and regulations to carry out more effectively the
 21 terms and provisions of this agreement, and who shall provide within and without the state, infor-
 22 mation necessary to the effective operation of this agreement.

23 ARTICLE VIII

24 This agreement shall enter into full force and effect as to a party state when such state has
 25 enacted the agreement into law. A state party to this agreement may withdraw herefrom by enacting
 26 a statute repealing the agreement. However, the withdrawal of any state shall not affect the status
 27 of any proceedings already initiated by prisoners or by state officers at the time such withdrawal
 28 takes effect, nor shall it affect their rights in respect thereof.

29 ARTICLE IX

30 This agreement shall be liberally construed so as to effectuate its purposes. The provisions of
 31 this agreement shall be severable and if any phrase, clause, sentence or provision of this agreement
 32 is declared to be contrary to the constitution of any party state or of the United States or the ap-
 33 plicability thereof to any government, agency, person or circumstance is held invalid, the validity
 34 of the remainder of this agreement and the applicability thereof to any government, agency, person
 35 or circumstance shall not be affected thereby. If this agreement shall be held contrary to the con-
 36 stitution of any state party to this agreement, the agreement shall remain in full force and effect
 37 as to the remaining states and in full force and effect as to the state affected as to all severable
 38 matters.

 41 **SECTION 5.** ORS 166.250 is amended to read:

42 166.250. (1) Except as otherwise provided in this section or ORS 166.260, 166.270, 166.274,
 43 166.291, 166.292 or 166.410 to 166.470 or section 5, chapter 826, Oregon Laws 2009, a person commits
 44 the crime of unlawful possession of a firearm if the person knowingly:

45 (a) Carries any firearm concealed upon the person;

- 1 (b) Possesses a handgun that is concealed and readily accessible to the person within any vehi-
 2 cle; or
- 3 (c) Possesses a firearm and:
- 4 (A) Is under 18 years of age;
- 5 (B)(i) While a minor, was found to be within the jurisdiction of the juvenile court for having
 6 committed an act which, if committed by an adult, would constitute a felony or a misdemeanor in-
 7 volving violence, as defined in ORS 166.470; and
- 8 (ii) Was discharged from the jurisdiction of the juvenile court within four years prior to being
 9 charged under this section;
- 10 (C) Has been convicted of a felony;
- 11 (D) Was committed to the Oregon Health Authority under ORS 426.130;
- 12 (E) Was found to be [*mentally ill*] **a person with mental illness** and subject to an order under
 13 ORS 426.130 that the person be prohibited from purchasing or possessing a firearm as a result of
 14 that mental illness; or
- 15 (F) Has been found guilty except for insanity under ORS 161.295 of a felony.
- 16 (2) This section does not prohibit:
- 17 (a) A minor, who is not otherwise prohibited under subsection (1)(c) of this section, from pos-
 18 sessed a firearm:
- 19 (A) Other than a handgun, if the firearm was transferred to the minor by the minor's parent or
 20 guardian or by another person with the consent of the minor's parent or guardian; or
- 21 (B) Temporarily for hunting, target practice or any other lawful purpose; or
- 22 (b) Any citizen of the United States over the age of 18 years who resides in or is temporarily
 23 sojourning within this state, and who is not within the excepted classes prescribed by ORS 166.270
 24 and subsection (1) of this section, from owning, possessing or keeping within the person's place of
 25 residence or place of business any handgun, and no permit or license to purchase, own, possess or
 26 keep any such firearm at the person's place of residence or place of business is required of any such
 27 citizen. As used in this subsection, "residence" includes a recreational vessel or recreational vehicle
 28 while used, for whatever period of time, as residential quarters.
- 29 (3) Firearms carried openly in belt holsters are not concealed within the meaning of this section.
- 30 (4)(a) Except as provided in paragraphs (b) and (c) of this subsection, a handgun is readily ac-
 31 cessible within the meaning of this section if the handgun is within the passenger compartment of
 32 the vehicle.
- 33 (b) If a vehicle, other than a vehicle described in paragraph (c) of this subsection, has no storage
 34 location that is outside the passenger compartment of the vehicle, a handgun is not readily acces-
 35 sible within the meaning of this section if:
- 36 (A) The handgun is stored in a closed and locked glove compartment, center console or other
 37 container; and
- 38 (B) The key is not inserted into the lock, if the glove compartment, center console or other
 39 container unlocks with a key.
- 40 (c) If a vehicle is a motorcycle, an all-terrain vehicle or a snowmobile, a handgun is not readily
 41 accessible within the meaning of this section if:
- 42 (A) The handgun is in a locked container within or affixed to the vehicle; or
- 43 (B) The handgun is equipped with a trigger lock or other locking mechanism that prevents the
 44 discharge of the firearm.
- 45 (5) Unlawful possession of a firearm is a Class A misdemeanor.

1 **SECTION 6.** ORS 166.250, as amended by section 11a, chapter 826, Oregon Laws 2009, and
 2 section 2, chapter 662, Oregon Laws 2011, is amended to read:

25 **SECTION 10.** ORS 166.470, as amended by section 11, chapter 826, Oregon Laws 2009, is
 26 amended to read:

27 166.470. (1) Unless relief has been granted under ORS 166.274 or 18 U.S.C. 925(c) or the
 28 expunction laws of this state or an equivalent law of another jurisdiction, a person may not inten-
 29 tionally sell, deliver or otherwise transfer any firearm when the transferor knows or reasonably

39 (g) Has been convicted of a misdemeanor involving violence or found guilty except for insanity
 40 under ORS 161.295 of a misdemeanor involving violence within the previous four years. As used in
 41 this paragraph, “misdemeanor involving violence” means a misdemeanor described in ORS 163.160,
 42 163.187, 163.190, 163.195 or 166.155 (1)(b); or

43 (h) Has been found guilty except for insanity under ORS 161.295 of a felony.

44 (2) A person may not sell, deliver or otherwise transfer any firearm that the person knows or
 45 reasonably should know is stolen.

1 (3) Subsection (1)(a) of this section does not prohibit:

2 (a) The parent or guardian, or another person with the consent of the parent or guardian, of a
3 minor from transferring to the minor a firearm, other than a handgun; or

4 (b) The temporary transfer of any firearm to a minor for hunting, target practice or any other
5 lawful purpose.

6 (4) Violation of this section is a Class A misdemeanor.

7 **SECTION 11.** ORS 179.473 is amended to read:

8 179.473. (1) Whenever the health and welfare of the person and the efficient administration of
9 the institution require the transfer of an inmate of a Department of Corrections institution or a
10 youth offender in a youth correction facility to another institution:

11 (a) The Department of Corrections or the Oregon Youth Authority, with the consent of the De-
12 partment of Human Services, may transfer a person at any institution under its jurisdiction to an
13 institution for persons with mental retardation, or, with the consent of the Oregon Health and Sci-
14 ence University, to the Oregon Health and Science University.

15 (b) The Department of Corrections may transfer an inmate of a Department of Corrections in-
16 stitution to a state [*mental*] hospital listed in ORS 426.010 for evaluation and treatment pursuant to
17 rules adopted jointly by the Department of Corrections and the Oregon Health Authority.

18 (c) The Oregon Youth Authority may transfer a youth offender or other person confined in a
19 youth correction facility to a hospital or facility designated by the Oregon Health Authority for
20 evaluation and treatment pursuant to rules adopted jointly by the Oregon Youth Authority and the
21 Oregon Health Authority.

22 (d) Except as provided in subsection (2) of this section, the Department of Corrections or the
23 Oregon Youth Authority may make a transfer of a person from any institution under the jurisdiction
24 of the department or the Oregon Youth Authority to any other institution under the jurisdiction of
25 the department or authority.

26 (2) A youth offender in a youth correction facility may not be transferred to a Department of
27 Corrections institution under subsection (1) of this section. A youth offender in a youth correction
28 facility who has been transferred to another institution may not be transferred from such other in-

1 Authority or an extension of the transfer is being considered. The notice required by this subpara-
2 graph must be provided far enough in advance of the hearing to permit the inmate or youth offender

4 (B) Disclosure to the inmate or youth offender, at the hearing, of the evidence that is being re-
5 lied upon for the administrative commitment or the extension of the transfer.

6 (C) An opportunity, at the hearing, for the inmate or youth offender to be heard in person and
7 to present documentary evidence.

8 (D) An opportunity, at the hearing, for the inmate or youth offender to present the testimony
9 of witnesses and to confront and cross-examine witnesses called by the state. The opportunity re-
10 quired by this subparagraph may be denied upon a finding by the decision maker of good cause for
11 not permitting the inmate or youth offender to present the testimony of witnesses or confront or
12 cross-examine witnesses called by the state.

13 (E) An independent decision maker for the hearing.

14 (F) A written statement by the decision maker of the evidence relied upon by the decision maker
15 and the reasons for administratively committing the inmate or youth offender or extending the
16 transfer.

17 (G) A qualified and independent assistant for the inmate or youth offender to be provided by the
18 state if the inmate or youth offender is financially unable to provide one.

19 (H) Effective and timely notice of the procedures required by subparagraphs (A) to (G) of this

21 (e) Provide that an inmate or a youth offender may not be administratively committed involun-

33 or community mental health program director, as provided under ORS 426.060, may, upon receipt

45 419C.529. (1) After the entry of a jurisdictional order under ORS 419C.411 (2), if the court finds

1 by a preponderance of the evidence that the young person, at the time of disposition, has a serious
2 mental condition or has a mental disease or defect other than a serious mental condition and pre-
3 sents a substantial danger to others, requiring conditional release or commitment to a hospital or
4 facility designated on an individual case basis by the Department of Human Services or the Oregon

15 before the juvenile panel in accordance with ORS 419C.532, 419C.535, 419C.538, 419C.540 and
16 419C.542 and shall order the young person placed under the jurisdiction of the board.

18 treatment services if conditionally released and that necessary supervision and treatment services
19 are available, the court may order the young person conditionally released, subject to those super-

21 shall designate a qualified mental health or developmental disabilities treatment provider or state,
22 county or local agency to supervise the young person on release, subject to those conditions as the
23 court directs in the order for conditional release. Prior to the designation, the court shall notify the
24 qualified mental health or developmental disabilities treatment provider or agency to whom condi-
25 tional release is contemplated and provide the qualified mental health or developmental disabilities
26 treatment provider or agency an opportunity to be heard before the court. After receiving an order
27 entered under this paragraph, the qualified mental health or developmental disabilities treatment
28 provider or agency designated shall assume supervision of the young person subject to the direction
29 of the juvenile panel. The qualified mental health or developmental disabilities treatment provider
30 or agency designated as supervisor shall report in writing no less than once per month to the ju-
31 venile panel concerning the supervised young person's compliance with the conditions of release.

32 (c) For purposes of determining whether to order commitment to a hospital or facility or con-
33 ditional release, the primary concern of the court is the protection of society.

34 (3) In determining whether a young person should be conditionally released, the court may order

 20 needs of the young person, the resources available to the department or the authority and the safety
 21 of the public.

43 (B) If the transfer is from a facility in one class to a facility in a less restrictive class, by fol-

2 (c) At any time, for good cause and in the best interest of the [*mentally ill*] person **with mental**
 3 **illness**, the authority may transfer a person receiving emergency care and treatment under ORS
 4 426.070 or 426.228 to 426.235, or intensive treatment under ORS 426.237, between hospitals and
 5 nonhospital facilities approved by the authority to provide emergency care or treatment as defined
 6 by rule of the authority.

7 (d) Pursuant to its rules, the authority may delegate to a community mental health program di-
 8 rector the responsibility for assignment of [*mentally ill*] persons **with mental illness** to suitable fa-
 9 cilities or transfer between such facilities under conditions which the authority may define.

10 **SECTION 16.** ORS 426.070 is amended to read:

11 426.070. (1) Any of the following may initiate commitment procedures under this section by giv-
 12 ing the notice described under subsection (2) of this section:

- 13 (a) Two persons;
- 14 (b) The county health officer; or
- 15 (c) Any magistrate.

16 (2) For purposes of subsection (1) of this section, the notice must comply with the following:

- 17 (a) It must be in writing under oath;
- 18 (b) It must be given to the community mental health program director or a designee of the di-
 19 rector in the county where the [*allegedly mentally ill*] person **alleged to have a mental illness** re-
 20 sides;

21 (c) It must state that a person within the county other than the person giving the notice is a
 22 [*mentally ill*] person **with mental illness** and is in need of treatment, care or custody;

35 426.072. (1) A hospital or nonhospital facility and a treating physician must comply with the
 36 following when *[an allegedly mentally ill]* **a person alleged to have a mental illness** is placed in
 37 custody at the hospital or nonhospital facility:

38 (a) By a warrant of detention under ORS 426.070;

39 (b) By a peace officer under ORS 426.228 or other *[person]* **individual** authorized under ORS
 40 426.233; or

41 (c) By a physician under ORS 426.232.

42 (2) In circumstances described under subsection (1) of this section, the hospital or nonhospital
 43 facility and treating physician must comply with the following:

44 (a) The person shall receive the care, custody and treatment required for mental and physical
 45 health and safety;

1 (b) The treating physician shall report any care, custody and treatment to the court as required
 2 in ORS 426.075;

3 (c) All methods of treatment, including the prescription and administration of drugs, shall be the
 4 sole responsibility of the treating physician. However, the person shall not be subject to
 5 electroshock therapy or unduly hazardous treatment and shall receive usual and customary treat-
 6 ment in accordance with medical standards in the community;

7 (d) The treating physician shall be notified immediately of any use of mechanical restraints on
 8 the person. Every use of a mechanical restraint and the reasons therefor shall be made a part of the
 9 clinical record of the person over the signature of the treating physician; and

10 (e) The treating physician shall give the person the warning under ORS 426.123 at times the
 11 treating physician determines the person will reasonably understand the notice. This paragraph only

 18 program director, or a designee of the director, as part of commitment procedures under ORS
 19 426.070 and 426.228 to 426.235:

20 (1) If the [*allegedly mentally ill*] person **alleged to have a mental illness** is held in custody
 21 before the hearing the investigation shall be completed at least 24 hours before the hearing under
 22 ORS 426.095, otherwise the investigation shall comply with the following time schedule:

23 (a) If the [*allegedly mentally ill*] person can be located, the investigator shall contact the person
 24 within three judicial days from the date the community mental health program director or a
 25 designee receives a notice under ORS 426.070 alleging that the person [*is mentally ill*] **has a mental**
 26 **illness and is in need of treatment.**

27 (b) Within 15 days from the date the community mental health program director or a designee
 28 receives a notice under ORS 426.070 [*alleging that a person is mentally ill*], one of the following shall
 29 occur:

30 (A) The investigation shall be completed and submitted to the court.

31 (B) An application for extension shall be made to the court under paragraph (c) of this sub-
 32 section.

33 (c) The community mental health program director, a designee or the investigator may file for
 34 an extension of the time under paragraph (b) of this subsection only if one of the following occurs:

35 (A) A treatment option less restrictive than involuntary in-patient commitment is actively being
 36 pursued.

37 (B) The [*allegedly mentally ill*] person **alleged to have a mental illness** cannot be located.

38 (d) A court may grant an extension under paragraph (c) of this subsection for a time and upon
 39 the terms and conditions the court considers appropriate.

40 (2) This subsection establishes a nonexclusive list of provisions applicable to the content of the
 41 investigation, as follows:

42 (a) The investigation conducted should, where appropriate, include an interview or examination
 43 of the [*allegedly mentally ill*] person **alleged to have a mental illness** in the home of the person
 44 or other place familiar to the person.

45 (b) Whether or not the [*allegedly mentally ill*] person consents, the investigation should include

1 interviews with any [*persons*] **individuals** that the investigator has probable cause to believe have

4 (c) The investigator shall be allowed access to physicians, nurses or social workers and to

 6 probable cause and to develop alternatives to commitment. If commitment is proposed because the
 7 person appears to be a [*mentally ill*] person **with mental illness** as defined in ORS 426.005 (1)(e)(C),
 8 the investigator shall be allowed access to medical records necessary to verify the existence of cri-
 9 teria described in ORS 426.005 (1)(e)(C). The investigator shall include pertinent parts of the medical
 10 record in the investigation report. Records and communications described in this paragraph and
 11 **related** communications [*related thereto*] are not privileged under ORS 40.230, 40.235, 40.240 or
 12 40.250.

13 (3) A copy of the investigation report shall be provided as soon as possible, but in no event later
 14 than 24 hours prior to the hearing, to the [*allegedly mentally ill*] person and to [*that*] **the** person's
 15 counsel. Copies shall likewise be provided to counsel assisting the court, to the examiners and to
 16 the court for use in questioning witnesses.

17 **SECTION 19.** ORS 426.075 is amended to read:

18 426.075. This section establishes procedures that are required to be followed before the hearing
 19 if a court, under ORS 426.070, orders a hearing under ORS 426.095. The following apply as described:

20 (1) The court shall be fully advised of all drugs and other treatment known to have been ad-
 21 ministered to the [*allegedly mentally ill*] person **alleged to have a mental illness** that may sub-
 22 stantially affect the ability of the person to prepare for or function effectively at the hearing. The
 23 following shall advise the court as required by this subsection:

20 the misconduct of a *[mentally ill]* person **with mental illness** while the *[mentally ill]* person is on
21 outpatient commitment under ORS 426.127 if the designated *[person]* **individual** acts without willful
22 and wanton neglect of duty. This subsection is applicable to all of the following:

23 (a) The community mental health program director and the designee of the director for the
24 county in which the committed person resides.

25 (b) The superintendent or director of any staff of any facility where the *[mentally ill]* person
26 **with mental illness** receives treatment during the outpatient commitment.

27 (c) The Director of the Oregon Health Authority.

28 (d) The physician and the facility *[granting an outpatient commitment]* **providing care or treat-**
29 **ment** to a *[patient]* **person on outpatient commitment.**

30 (9) For trial visits granted under ORS 426.273 and 426.275:

31 (a) *[None of]* The following *[shall]* **individuals and entities may not** be liable for a *[patient's]*
32 **person's** expenses while on trial visit:

33 (A) The physician and the facility *[granting a trial visit]* **providing care or treatment** to a
34 *[patient]* **person on a trial visit;**

35 (B) The superintendent or director of the facility *[granting]* **providing care or treatment to a**
36 **person on** a trial visit;

37 (C) The Director of the Oregon Health Authority; and

38 (D) The chief medical officer of the facility.

39 (b) The *[following persons shall]* **individuals designated in this paragraph may not** be liable
40 for damages that *[are sustained by any person on account of]* **result from** the misconduct of *[such*

42 **vidual** acts without willful and wanton neglect of duty:

43 (A) The community mental health program director for the county in which the person resides;

44 (B) The superintendent, director or chief medical officer of any facility *[granting a trial visit]*
45 **providing care or treatment** to a patient **on a trial visit;**

2 (D) The Director of the Oregon Health Authority; or

3 (E) The employees and agents of [*persons listed in*] **individuals or facilities under** this para-

5 **SECTION 57.** ORS 426.370 is amended to read:

6 426.370. A community mental health program director or designee may withhold information
7 obtained during an investigation under ORS 426.070, 426.228, 426.232, 426.233 or 426.234 if the com-
8 munity mental health program director determines:

9 (1) That information was not included in its investigation report or otherwise used in a material
10 way to support a determination by the community mental health program director that there was
11 probable cause to believe a person was a [*mentally ill*] person **with mental illness**; and

12 (2) Release of the information would constitute a clear and immediate danger to any person.

13 **SECTION 58.** ORS 426.385 is amended to read:

14 426.385. (1) Every [*mentally ill*] person **with mental illness** committed to the Oregon Health
15 Authority shall have the right to:

16 (a) Communicate freely in person and by reasonable access to telephones;

17 (b) Send and receive sealed mail, except that this right may be limited for security reasons in
18 state institutions as described in ORS 426.010;

19 (c) Wear the clothing of the person;

20 (d) Keep personal possessions, including toilet articles;

21 (e) Religious freedom;

22 (f) A private storage area with free access thereto;

23 (g) Be furnished with a reasonable supply of writing materials and stamps;

24 (h) A written treatment plan, kept current with the progress of the person;

25 (i) Be represented by counsel whenever the substantial rights of the person may be affected;

26 (j) Petition for a writ of habeas corpus;

27 (k) Not be required to perform routine labor tasks of the facility except those essential for
28 treatment;

29 (L) Be given reasonable compensation for all work performed other than personal housekeeping

32 would create significant risk of harm to the person or others;

33 (n) Such other rights as may be specified by rule; and

34 (o) Exercise all civil rights in the same manner and with the same effect as one not admitted

37 dicated incompetent and has not been restored to legal capacity. Disposal of personal property in
38 possession of the person in a state institution described in ORS 426.010 is subject to limitation for

 9 *persons*] **a person** for good cause as defined in administrative rule only by the director of the facility

 11 examining physician. Any denial shall be entered into the [*patient's*] **person's** treatment record and
 12 shall include the reasons for the denial. [*No patient shall*] **A person with mental illness may not**

14 (4) Mechanical restraints shall not be applied to a person admitted to a facility unless it is de-
 15 termined by the chief medical officer of the facility or designee to be required by the medical needs

 28 terminate a compact on behalf of the State of Oregon with any state, territory or possession of the
 29 United States, the District of Columbia and the Commonwealth of Puerto Rico joining therein, in the
 30 form substantially as follows:

 33 The contracting states solemnly agree that:

34 **ARTICLE I**

35 The party states find that the proper and expeditious treatment of [*the mentally ill and mentally*
 36 *deficient*] **persons with mental illness or intellectual disabilities** can be facilitated by cooperative
 37 action, to the benefit of the patients, their families, and society as a whole. Further, the party states
 38 find that the necessity of and desirability for furnishing such care and treatment bears no primary
 39 relation to the residence or citizenship of the patient but that, on the contrary, the controlling fac-
 40 tors of community safety and humanitarianism require that facilities and services be made available
 41 for all who are in need of them. Consequently, it is the purpose of this compact and of the party
 42 states to provide the necessary legal basis for the institutionalization or other appropriate care and
 43 treatment of [*the mentally ill and mentally deficient*] **persons with mental illness or intellectual**
 44 **disabilities** under a system that recognizes the paramount importance of patient welfare and to es-
 45 tablish the responsibilities of the party states in terms of such welfare.

ARTICLE II

As used in this compact:

(a) "Sending state" shall mean a party state from which a patient is transported pursuant to the provisions of the compact or from which it is contemplated that a patient may be so sent.

(b) "Receiving state" shall mean a party state to which a patient is transported pursuant to the provisions of the compact or to which it is contemplated that a patient may be so sent.

(c) "Institution" shall mean any hospital or other facility maintained by a party state or political subdivision thereof for the care and treatment of mental illness or *[mental deficiency]* **intellectual disabilities**.

(d) "Patient" shall mean any person subject to or eligible as determined by the laws of the sending state, for institutionalization or other care, treatment or supervision pursuant to the provisions of this compact.

(e) "After-care" shall mean care, treatment and services provided a patient, as defined herein, on convalescent status or conditional release.

(f) "Mental illness" shall mean mental disease to such extent that a person so afflicted requires care and treatment for his own welfare, or the welfare of others, or of the community.

(g) [*"Mental deficiency"*] "**Intellectual disability**" shall mean [*mental deficiency*] **intellectual disability** as defined by appropriate clinical authorities to such extent that a person so afflicted is incapable of managing himself and his affairs, but shall not include mental illness as defined herein.

(h) "State" shall mean any state, territory or possession of the United States, the District of Columbia and the Commonwealth of Puerto Rico.

ARTICLE III

(a) Whenever a person physically present in any party state shall be in need of institutionalization by reason of mental illness or *[mental deficiency]* **intellectual disability**, the person shall be eligible for care and treatment in an institution in that state irrespective of the residence, settlement or citizenship qualifications of the person.

(b) The provisions of paragraph (a) of this article to the contrary notwithstanding, any patient may be transferred to an institution in another state whenever there are factors based upon clinical determinations indicating that the care and treatment of said patient would be facilitated or improved thereby. Any such institutionalization may be for the entire period of care and treatment or for any portion or portions thereof. The factors referred to in this paragraph shall include the patient's full record with due regard for the location of the patient's family, character of the illness and probable duration thereof, and such other factors as shall be considered appropriate.

(c) No state shall be obliged to receive any patient pursuant to the provisions of paragraph (b) of this article unless the sending state has given advance notice of its intention to send the patient; furnished all available medical and other pertinent records concerning the patient; given the qualified medical or other appropriate clinical authorities of the receiving state an opportunity to examine the patient if said authorities so wish; and unless the receiving state shall agree to accept the patient.

(d) In the event that the laws of the receiving state establish a system of priorities for the admission of patients, an interstate patient under this compact shall receive the same priority as a local patient and shall be taken in the same order and at the same time that the patient would be taken if the patient were a local patient.

(e) Pursuant to this compact, the determination as to the suitable place of institutionalization for a patient may be reviewed at any time and such further transfer of the patient may be made as

1 seems likely to be in the best interest of the patient.

2 ARTICLE IV

3 (a) Whenever, pursuant to the laws of the state in which a patient is physically present, it shall
 4 be determined that the patient should receive after-care or supervision, such care or supervision
 5 may be provided in a receiving state. If the medical or other appropriate clinical authorities having
 6 responsibility for the care and treatment of the patient in the sending state shall have reason to
 7 believe that after-care in another state would be in the best interest of the patient and would not
 8 jeopardize the public safety, they shall request the appropriate authorities in the receiving state to
 9 investigate the desirability of affording the patient such after-care in said receiving state, and such
 10 investigation shall be made with all reasonable speed. The request for investigation shall be ac-
 11 companied by complete information concerning the patient's intended place of residence and the
 12 identity of the person in whose charge it is proposed to place the patient, the complete medical
 13 history of the patient, and such other documents as may be pertinent.

14 (b) If the medical or other appropriate clinical authorities having responsibility for the care and
 15 treatment of the patient in the sending state and the appropriate authorities in the receiving state
 16 find that the best interest of the patient would be served thereby, and if the public safety would not
 17 be jeopardized thereby, the patient may receive after-care or supervision in the receiving state.

18 (c) In supervising, treating or caring for a patient on after-care pursuant to the terms of this
 19 article, a receiving state shall employ the same standards of visitation, examination, care and
 20 treatment that it employs for similar local patients.

21 ARTICLE V

22 Whenever a dangerous or potentially dangerous patient escapes from an institution in any party
 23 state, that state shall promptly notify all appropriate authorities within and without the jurisdiction
 24 of the escape in a manner reasonably calculated to facilitate the speedy apprehension of the escapee.
 25 Immediately upon the apprehension and identification of any such dangerous or potentially danger-
 26 ous patient, the patient shall be detained in the state where found pending disposition in accordance
 27 with law.

28 ARTICLE VI

29 The duly accredited officers of any state party to this compact, upon the establishment of their
 30 authority and the identity of the patient, shall be permitted to transport any patient being moved
 31 pursuant to this compact through any and all states party to this compact, without interference.

32 ARTICLE VII

33 (a) No person shall be deemed a patient of more than one institution at any given time. Com-
 34 pletion of transfer of any patient to an institution in a receiving state shall have the effect of mak-
 35 ing the person a patient of the institution in the receiving state.

36 (b) The sending state shall pay all costs of and incidental to the transportation of any patient
 37 pursuant to this compact, but any two or more party states may, by making a specific agreement for
 38 that purpose, arrange for a different allocation of costs as among themselves.

39 (c) No provision of this compact shall be construed to alter or affect any internal relationships
 40 among the departments, agencies and officers of and in the government of a party state, or between
 41 a party state and its subdivisions, as to the payment of costs, or responsibilities therefor.

42 (d) Nothing in this compact shall be construed to prevent any party state or subdivision thereof
 43 from asserting any right against any person, agency or other entity in regard to costs for which
 44 such party state or subdivision thereof may be responsible pursuant to any provision of this com-
 45 pact.

1 (e) Nothing in this compact shall be construed to invalidate any reciprocal agreement between
 2 a party state and a nonparty state relating to institutionalization, care or treatment of [*the mentally*
 3 *ill or mentally deficient*] **persons with mental illness or intellectual disabilities**, or any statutory
 4 authority pursuant to which such agreements may be made.

5 ARTICLE VIII

6 (a) Nothing in this compact shall be construed to abridge, diminish, or in any way impair the
 7 rights, duties and responsibilities of any patient’s guardian on the guardian’s own behalf or in re-
 8 spect of any patient for whom the guardian may serve, except that where the transfer of any patient
 9 to another jurisdiction makes advisable the appointment of a supplemental or substitute guardian,
 10 any court of competent jurisdiction in the receiving state may make such supplemental or substitute
 11 appointment and the court which appointed the previous guardian shall upon being duly advised of
 12 the new appointment, and upon the satisfactory completion of such accounting and other acts as
 13 such court may by law require, relieve the previous guardian of power and responsibility to what-
 14 ever extent shall be appropriate in the circumstances; provided, however, that in the case of any
 15 patient having settlement in the sending state, the court of competent jurisdiction in the sending
 16 state shall have the sole discretion to relieve a guardian appointed by it or continue the power and

24 (a) No provision of this compact except Article V shall apply to any person institutionalized
 25 while under sentence in a penal or correctional institution or while subject to trial on a criminal

 27 of mental illness or [*mental deficiency*] **intellectual disability**, said person would be subject to
 28 incarceration in a penal or correctional institution.

34 (a) Each party state shall appoint a “compact administrator” who, on behalf of the state of the
 35 compact administrator, shall act as general coordinator of activities under the compact in the state

 37 documents relating to any patient processed under the compact by the state of the compact admin-
 38 istrator either in the capacity of sending or receiving state. The compact administrator or the duly
 39 designated representative of the compact administrator shall be the official with whom other party

41 (b) The compact administrators of the respective party states shall have power to promulgate

45 The duly constituted administrative authorities of any two or more party states may enter into

 41 practitioners, physician assistants or midwives.

42 (e) Patients whose income is less than the federal poverty level.

ARTICLE I

Purpose

The purpose of this compact is to provide for the development and execution of programs to facilitate the use of offenders in the forest fire suppression efforts of the party states for the ultimate protection of life, property and natural resources in the party states. The purpose of this compact is also, in emergent situations, to allow a sending state to cross state lines with an inmate when, because of weather or road conditions, it is necessary to cross state lines to facilitate the transport of an inmate.

ARTICLE II

Definitions

(1) "Sending state" means a state party to this compact from which a fire suppression unit is traveling.

(2) "Receiving state" means a state party to this compact to which a fire suppression unit is traveling.

(3) "Inmate" means a male or female offender who is under sentence to or confined in a prison or other correctional institution.

(4) "Institution" means any prison, reformatory, honor camp or other correctional facility, except facilities for *[the mentally ill or mentally handicapped]* **persons with mental illness or intellectual disabilities**, in which inmates may lawfully be confined.

(5) "Fire suppression unit" means a group of inmates selected by the sending states, corrections personnel and any other persons deemed necessary for the transportation, supervision, care, security and discipline of inmates to be used in forest fire suppression efforts in the receiving state.

(6) "Forest fire" means any fire burning in any land designated by a party state or the federal land management agencies as forestland.

ARTICLE III

Contracts

(1) Each party state may make one or more contracts with any one or more of the other party states for the assistance of one or more fire suppression units in forest fire suppression efforts. Any such contract shall provide for matters as may be necessary and appropriate to fix the obligations, responsibilities and rights of the sending and receiving states.

(2) The terms and provisions of this compact shall be part of any contract entered into by the authority of, or pursuant to, this compact. Nothing in any such contract may be inconsistent with this compact.

ARTICLE IV

Procedures and Rights

(1) Each party state shall appoint a liaison for the coordination and deployment of the fire suppression units of each party state.

(2) Whenever the duly constituted judicial or administrative authorities in a state party to this compact, which has entered into a contract pursuant to this compact, decide that the assistance of a fire suppression unit of a party state is required for forest fire suppression efforts, the authorities may request the assistance of one or more fire suppression units of any state party to this compact through an appointed liaison.

(3) Inmates who are members of a fire suppression unit shall at all times be subject to the ju-

1 jurisdiction of the sending state and at all times shall be under the ultimate custody of corrections
 2 officers duly accredited by the sending state.

3 (4) The receiving state must make adequate arrangements for the confinement of inmates who
 4 are members of a fire suppression unit of a sending state in the event corrections officers duly ac-
 5 credited by the sending state make a discretionary determination that an inmate requires institu-
 6 tional confinement.

7 (5) Cooperative efforts shall be made by corrections officers and personnel of the receiving state
 8 located at a fire camp with the corrections officers and other personnel in the establishment and
 9 maintenance of fire suppression unit base camps.

10 (6) All inmates who are members of a fire suppression unit of a sending state shall be cared for
 11 and treated equally with such similar inmates of the receiving state.

12 (7) Further, in emergent situations, a sending state shall be granted authority and all the pro-
 13 tections of this compact to cross state lines with an inmate when, because of road conditions, it is
 14 necessary to facilitate the transport of an inmate.

15 ARTICLE V

16 Acts Not Reviewable

17 in Receiving State: Extradition

18 (1) If while located within the territory of a receiving state there occurs against the inmate
 19 within such state any criminal charge or if the inmate is suspected of committing within such state
 20 a criminal offense, the inmate shall not be returned without the consent of the receiving state until
 21 discharged from prosecution or other form of proceeding, imprisonment or detention for such offense.
 22 The duly accredited officers of the sending state shall be permitted to transport inmates pursuant
 23 to this compact through any and all states party to this compact without interference.

24 (2) An inmate member of a fire suppression unit of the sending state who is deemed to have
 25 escaped by a duly accredited corrections officer of a sending state shall be under the jurisdiction
 26 of both the sending state and the receiving state. Nothing contained in this Article shall be con-
 27 strued to prevent or affect the activities of officers and guards of any jurisdiction directed toward
 28 the apprehension and return of an escapee.

29 ARTICLE VI

30 Entry into Force

31 This compact shall enter into force and become effective and binding upon approval of this
 32 compact by at least two of the states from among the States of Idaho, Oregon and Washington.

33 ARTICLE VII

34 Withdrawal and Termination

35 This compact shall continue in force and remain binding upon a party state until it shall have
 36 enacted a statute repealing the same and providing for the sending of formal written notice of
 37 withdrawal from the compact to the appropriate officials of all other party states.

38 ARTICLE VIII

39 Other Arrangements Unaffected

40 Nothing contained in this compact shall be construed to abrogate or impair any agreement
 41 which a party state may have with a nonparty state for the confinement, rehabilitation or treatment
 42 of inmates nor to repeal any other laws of a party state authorizing the making of cooperative in-
 43 stitutional arrangements.

44 ARTICLE IX

45 Construction and Severability

1 The provisions of this compact shall be liberally construed and shall be severable. If any phrase,
 2 clause, sentence or provision of this compact is declared to be contrary to the constitution of any
 3 participating state or of the United States or the applicability thereof to any government, agency,
 4 person or circumstance is held invalid, the validity of the remainder of this compact and the appli-
 5 cability thereof to any government, agency, person or circumstance shall not be affected thereby.
 6 If this compact shall be held contrary to the constitution of any state participating therein, the
 7 compact shall remain in full force and effect as to the remaining states and in full force and effect
 8 as to the state affected as to all severable matters.

4 (5) The board shall grant the relief requested in the petition if the petitioner demonstrates,
