

House Bill 2660

Sponsored by Representative FREDERICK (Presession filed.)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Renames crime of intimidation as hate crime.

Includes commission of assault in fourth degree as hate crime in first degree when committed by one person and motivated by perception of victim's race, color, religion, ethnicity, gender, sexual orientation, disability or national origin.

Requires court to impose term of incarceration of at least 60 days when person is convicted of hate crime.

Modifies authority of certain law enforcement officials to bring civil action based on commission of hate crime.

Directs law enforcement agencies to report statistics regarding hate crimes to Department of Justice.

Declares emergency, effective on passage.

4 **Be It Enacted by the People of the State of Oregon:**

5 **SECTION 1.** ORS 166.165 is amended to read:

6 166.165. (1) Two or more persons acting together commit [*the crime of intimidation*] **a hate crime**
7 in the first degree, if the persons:

8 (a)(A) Intentionally, knowingly or recklessly cause physical injury to another person because of
9 the actors' perception of that person's race, color, religion, **ethnicity, gender**, sexual orientation,
10 disability or national origin; or

11 (B) With criminal negligence cause physical injury to another person by means of a deadly
12 weapon because of the actors' perception of that person's race, color, religion, **ethnicity, gender**,
13 sexual orientation, disability or national origin;

14 (b) Intentionally, because of the actors' perception of another person's race, color, religion,
15 **ethnicity, gender**, sexual orientation, disability or national origin, place another person in fear of
16 imminent serious physical injury; or

17 (c) Commit [*such*] acts [*as*] **that** would constitute [*the crime of intimidation*] **a hate crime** in the
18 second degree, if undertaken by one person acting alone.

19 **(2) A person commits a hate crime in the first degree if the person:**

20 (a) **Intentionally, knowingly or recklessly causes physical injury to another person be-**
21 **cause of the actor's perception of that person's race, color, religion, ethnicity, gender, sexual**
22 **orientation, disability or national origin; or**

23 (b) **With criminal negligence causes physical injury to another person by means of a**
24 **deadly weapon because of the actor's perception of that person's race, color, religion,**
25 **ethnicity, gender, sexual orientation, disability or national origin.**

26 [(2)] (3) [*Intimidation*] **A hate crime** in the first degree is a Class C felony.

1 (4) When a person is convicted of violating subsection (1)(a) or (2) of this section, in ad-
 2 dition to any other sentence the court may impose, the court shall impose a term of
 3 incarceration of at least 60 days.

4 **SECTION 2.** ORS 166.155 is amended to read:

5 166.155. (1) A person commits [*the crime of intimidation*] a **hate crime** in the second degree if
 6 the person:

7 (a) Tamper or interferes with property, having no right to do so nor reasonable ground to be-
 8 lieve that the person has such right, with the intent to cause substantial inconvenience to another
 9 because of the person's perception of the other's race, color, religion, **ethnicity, gender,** sexual
 10 orientation, disability or national origin;

11 (b) Intentionally subjects another to offensive physical contact because of the person's percep-
 12 tion of the other's race, color, religion, **ethnicity, gender,** sexual orientation, disability or national
 13 origin; or

14 (c) Intentionally, because of the person's perception of race, color, religion, **ethnicity, gender,**
 15 sexual orientation, disability or national origin of another or of a member of the other's family,
 16 subjects the other person to alarm by threatening:

17 (A) To inflict serious physical injury upon or to commit a felony affecting the other person, or
 18 a member of the person's family; or

19 (B) To cause substantial damage to the property of the other person or of a member of the other
 20 person's family.

21 (2) [*Intimidation*] **A hate crime** in the second degree is a Class A misdemeanor.

22 (3) For purposes of this section, "property" means any tangible personal property or real prop-
 23 erty.

24 **SECTION 3.** ORS 30.200 is amended to read:

25 30.200. (1) If [*any*] **the Attorney General or a** district attorney has reasonable cause to believe
 26 that [*any*] a person or group of persons is engaged in violation of ORS 166.155 or 166.165, the **At-**
 27 **torney General or** district attorney may bring a civil claim for relief in the appropriate court,
 28 setting forth facts pertaining to [*such*] **the** violation, and request [*such*] relief as may be necessary
 29 to restrain or prevent [*such*] **the** violation. **In addition to any other available remedy, the court:**

30 (a) **May order the person or group to make restitution in specific amounts to a person**
 31 **who suffered an ascertainable loss of money or property as a result of the violation.**

32 (b) **May make additional orders or judgments as may be necessary to restore to a person**
 33 **in interest any moneys or property, real or personal, of which the person was deprived as a**
 34 **result of the violation.**

35 (c) **May impose a penalty of not more than \$250,000.**

36 (d) **Shall award reasonable attorney fees, expert witness fees and investigative costs to**
 37 **the Attorney General or district attorney if the Attorney General or district attorney pre-**
 38 **ails in an action under this section.**

39 (e) **May award reasonable attorney fees and expert witness fees to a defendant who pre-**
 40 **ails in an action under this section if the court determines that the Attorney General or**
 41 **district attorney had no objectively reasonable basis for asserting the claim or no reasonable**
 42 **basis for appealing an adverse decision of the trial court.**

43 (2) **A temporary restraining order may be granted without prior notice to the person or**
 44 **group if the court finds there is a threat of immediate harm to the public health, safety or**
 45 **welfare. A temporary restraining order issued under this subsection may not exceed 10 days,**

1 **except that:**

2 (a) **The order may be extended by court order for good cause shown for an amount of**
 3 **time equal to the terms of the original order; or**

4 (b) **The order may be for any amount of time if the restrained person or group consents**
 5 **to the terms of the order.**

6 (3) Any claim for relief under this section does not prevent *[any]* a person from seeking any
 7 other remedy otherwise available under law.

8 **SECTION 4.** ORS 30.198 is amended to read:

9 30.198. (1) Irrespective of any criminal prosecution or the result thereof, any person injured by
 10 a violation of ORS 166.155 or 166.165 shall have a civil action to secure an injunction, damages or
 11 other appropriate relief against any and all persons whose actions are unlawful under ORS 166.155
 12 and 166.165.

13 (2) Upon prevailing in such action, the plaintiff may recover:

14 (a) Both special and general damages, including damages for emotional distress; and

15 (b) Punitive damages.

16 (3) The court shall award reasonable attorney fees to the prevailing plaintiff in an action under
 17 this section. The court may award reasonable attorney fees and expert witness fees incurred by a
 18 defendant who prevails in the action if the court determines that the plaintiff had no objectively
 19 reasonable basis for asserting a claim or no reasonable basis for appealing an adverse decision of
 20 a trial court.

21 (4) The parent, parents or legal guardian of an unemancipated minor shall be liable for any
 22 judgment recovered against such minor under this section, in an amount not to exceed \$5,000.

23 **(5) Actions brought under this section shall be commenced within one year from the vi-**
 24 **olation. However, whenever a claim is filed by the Attorney General or a district attorney**
 25 **under ORS 30.200, running of the statute of limitations with respect to a private right of**
 26 **action under this section and based in whole or in part on a matter in the claim shall be**
 27 **suspended during the pendency of the proceeding held under ORS 30.200.**

39 90.396. (1) Except as provided in subsection (2) of this section, after at least 24 hours' written

40 notice specifying the acts and omissions constituting the cause and specifying the date and time of

41 the termination, the landlord may terminate the rental agreement and take possession as provided

42 in ORS 105.105 to 105.168, if:

43 (a) The tenant, someone in the tenant's control or the tenant's pet seriously threatens to inflict

44 substantial personal injury, or inflicts any substantial personal injury, upon a person on the prem-

45 ises other than the tenant;

1 (b) The tenant or someone in the tenant’s control recklessly endangers a person on the premises
 2 other than the tenant by creating a serious risk of substantial personal injury;

3 (c) The tenant, someone in the tenant’s control or the tenant’s pet inflicts any substantial per-
 4 sonal injury upon a neighbor living in the immediate vicinity of the premises;

5 (d) The tenant or someone in the tenant’s control intentionally inflicts any substantial damage
 6 to the premises or the tenant’s pet inflicts substantial damage to the premises on more than one
 7 occasion;

8 (e)(A) The tenant intentionally provided substantial false information on the application for the
 9 tenancy within the past year;

10 (B) The false information was with regard to a criminal conviction of the tenant that would have
 11 been material to the landlord’s acceptance of the application; and

12 (C) The landlord terminates the rental agreement within 30 days after discovering the falsity
 13 of the information; or

14 (f) The tenant, someone in the tenant’s control or the tenant’s pet commits any act that is out-
 15 rageous in the extreme, on the premises or in the immediate vicinity of the premises. For purposes
 16 of this paragraph, an act is outrageous in the extreme if the act is not described in paragraphs (a)
 17 to (e) of this subsection, but is similar in degree and is one that a reasonable person in that com-
 18 munity would consider to be so offensive as to warrant termination of the tenancy within 24 hours,
 19 considering the seriousness of the act or the risk to others. An act that is outrageous in the extreme
 20 is more extreme or serious than an act that warrants a 30-day termination under ORS 90.392. Acts
 21 that are “outrageous in the extreme” include, but are not limited to, the following acts by a person:

22 (A) Prostitution, patronizing a prostitute or promoting prostitution, as described in ORS 167.007,
 23 167.008 and 167.012;

24 (B) Manufacture, delivery or possession of a controlled substance, as described in ORS 475.005,
 25 but not including:

26 (i) The medical use of marijuana in compliance with ORS 475.300 to 475.346;

27 (ii) Possession of, or delivery for no consideration of, less than one avoirdupois ounce of
 28 marijuana as described in ORS 475.860 (3) or 475.864 (3); or

29 (iii) Possession of prescription drugs;

30 (C) *[Intimidation]* **A hate crime**, as described in ORS 166.155 and 166.165; or

31 (D) Burglary as described in ORS 164.215 and 164.225.

32 (2) If the cause for a termination notice given pursuant to subsection (1) of this section is based
 33 upon the acts of the tenant’s pet, the tenant may cure the cause and avoid termination of the
 34 tenancy by removing the pet from the premises prior to the end of the notice period. The notice
 35 must describe the right of the tenant to cure the cause. If the tenant returns the pet to the premises
 36 at any time after having cured the violation, the landlord, after at least 24 hours’ written notice
 37 specifying the subsequent presence of the offending pet, may terminate the rental agreement and
 38 take possession as provided in ORS 105.105 to 105.168. The tenant does not have a right to cure this
 39 subsequent violation.

40 (3) For purposes of subsection (1) of this section, someone is in the tenant’s control if that per-
 41 son enters or remains on the premises with the tenant’s permission or consent after the tenant
 42 reasonably knows or should know of that person’s act or likelihood to commit any act of the type
 43 described in subsection (1) of this section.

44 (4) An act can be proven to be outrageous in the extreme even if the act is one that does not
 45 violate a criminal statute. Notwithstanding the references to criminal statutes in subsection (1)(f)

1 of this section, the landlord’s burden of proof in an action for possession under subsection (1) of this
 2 section is the civil standard of proof by a preponderance of the evidence.

3 (5) If a good faith effort by a landlord to terminate the tenancy under subsection (1)(f) of this
 4 section and to recover possession of the rental unit under ORS 105.105 to 105.168 fails by decision
 5 of the court, the landlord may not be found in violation of any state statute or local ordinance re-
 6 quiring the landlord to remove that tenant upon threat of fine, abatement or forfeiture as long as
 7 the landlord continues to make a good faith effort to terminate the tenancy.

10 137.225. (1)(a) At any time after the lapse of three years from the date of pronouncement of
 11 judgment, any defendant who has fully complied with and performed the sentence of the court and
 12 whose conviction is described in subsection (5) of this section by motion may apply to the court
 13 where the conviction was entered for entry of an order setting aside the conviction; or

14 (b) At any time after the lapse of one year from the date of any arrest, if no accusatory in-
 15 strument was filed, or at any time after an acquittal or a dismissal of the charge, the arrested per-

 22 to prosecute the charge if there was no accusatory instrument filed, and opportunity shall be given
 23 to contest the motion. The fingerprint card with the notation “motion for setting aside conviction,”
 24 or “motion for setting aside arrest record” as the case may be, shall be forwarded to the Department
 25 of State Police. Information resulting from the fingerprint search along with the fingerprint card
 26 shall be returned to the prosecuting attorney.

27 (b) When a prosecuting attorney is served with a copy of a motion to set aside a conviction
 28 under this section, the prosecuting attorney shall provide a copy of the motion and notice of the
 29 hearing date to the victim, if any, of the crime by mailing a copy of the motion and notice to the

 11 rest or other proceeding shall be deemed not to have occurred, and the applicant may answer ac-
 12 cordingly any questions relating to its occurrence.

 15 felony as that term is defined in the rules of the Oregon Criminal Justice Commission.

16 (b) A Class C felony, except for criminal mistreatment in the first degree under ORS 163.205
 17 when it would constitute child abuse as defined in ORS 419B.005 or any sex crime.

18 (c) The crime of possession of the narcotic drug marijuana when that crime was punishable as
 19 a felony only.

20 (d) A crime punishable as either a felony or a misdemeanor, in the discretion of the court, ex-
 21 cept for:

22 (A) Any sex crime; or

23 (B) The following crimes when they would constitute child abuse as defined in ORS 419B.005:

24 (i) Criminal mistreatment in the first degree under ORS 163.205; and

25 (ii) Endangering the welfare of a minor under ORS 163.575 (1)(a).

26 (e) A misdemeanor, including a violation of a municipal ordinance, for which a jail sentence may
 27 be imposed, except for endangering the welfare of a minor under ORS 163.575 (1)(a) when it would
 28 constitute child abuse as defined in ORS 419B.005 or any sex crime.

29 (f) A violation, whether under state law or local ordinance.

30 (g) An offense committed before January 1, 1972, that if committed after that date would be:

31 (A) A Class C felony, except for any sex crime or for the following crimes when they would

12 the crime was 65 years of age or older; and

15 (8) Notwithstanding subsection (5) of this section, the provisions of subsection (1)(a) of this sec-

- 18 (L) Supplying contraband, ORS 162.185.
- 19 (m) Unlawful use of a weapon, ORS 166.220.

20 (15) As used in this section, “sex crime” has the meaning given that term in ORS 181.594.

21 **SECTION 9.** ORS 137.712 is amended to read:

22 137.712. (1)(a) Notwithstanding ORS 137.700 and 137.707, when a person is convicted of
 23 manslaughter in the second degree as defined in ORS 163.125, assault in the second degree as de-
 24 fined in ORS 163.175 (1)(b), kidnapping in the second degree as defined in ORS 163.225, rape in the
 25 second degree as defined in ORS 163.365, sodomy in the second degree as defined in ORS 163.395,
 26 unlawful sexual penetration in the second degree as defined in ORS 163.408, sexual abuse in the first
 27 degree as defined in ORS 163.427 (1)(a)(A) or robbery in the second degree as defined in ORS

 36 which information can be obtained or from which information can be translated into usable form,
 37 or other tangible item.

38 (2) “Enterprise” includes any individual, sole proprietorship, partnership, corporation, business

14 **SECTION 13. This 2013 Act being necessary for the immediate preservation of the public**
15 **peace, health and safety, an emergency is declared to exist, and this 2013 Act takes effect**
