## A-Engrossed House Bill 2733

Ordered by the House April 5 Including House Amendments dated April 5

## SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Adjusts distance adjustment calculations for remote small elementary schools to provide greater level of funding for schools located between 8 and 12 miles from nearest elementary school. Declares emergency, effective July 1, 2013.

have received under this section for the small high school based on the ADMa of each of the high
schools prior to the merger; or

(B) In the case of a high school that remains qualified as a small high school under subsection(3) of this section after a merger, the ADMa of the merged small high school.

(b) The department shall add the additional amount under this subsection only for the first four
fiscal years after the merger of the two high schools is final. If the merger of the two high schools
becomes final on or before September 1, for purposes of this paragraph the merger shall be considered final in the prior fiscal year.

34 <u>SECTION 3.</u> The amendments to ORS 327.077 by sections 1 and 2 of this 2013 Act apply 35 to State School Fund distributions commencing with the 2013-2014 distributions.

36 <u>SECTION 4.</u> This 2013 Act being necessary for the immediate preservation of the public 37 peace, health and safety, an emergency is declared to exist, and this 2013 Act takes effect 38 July 1, 2013.
